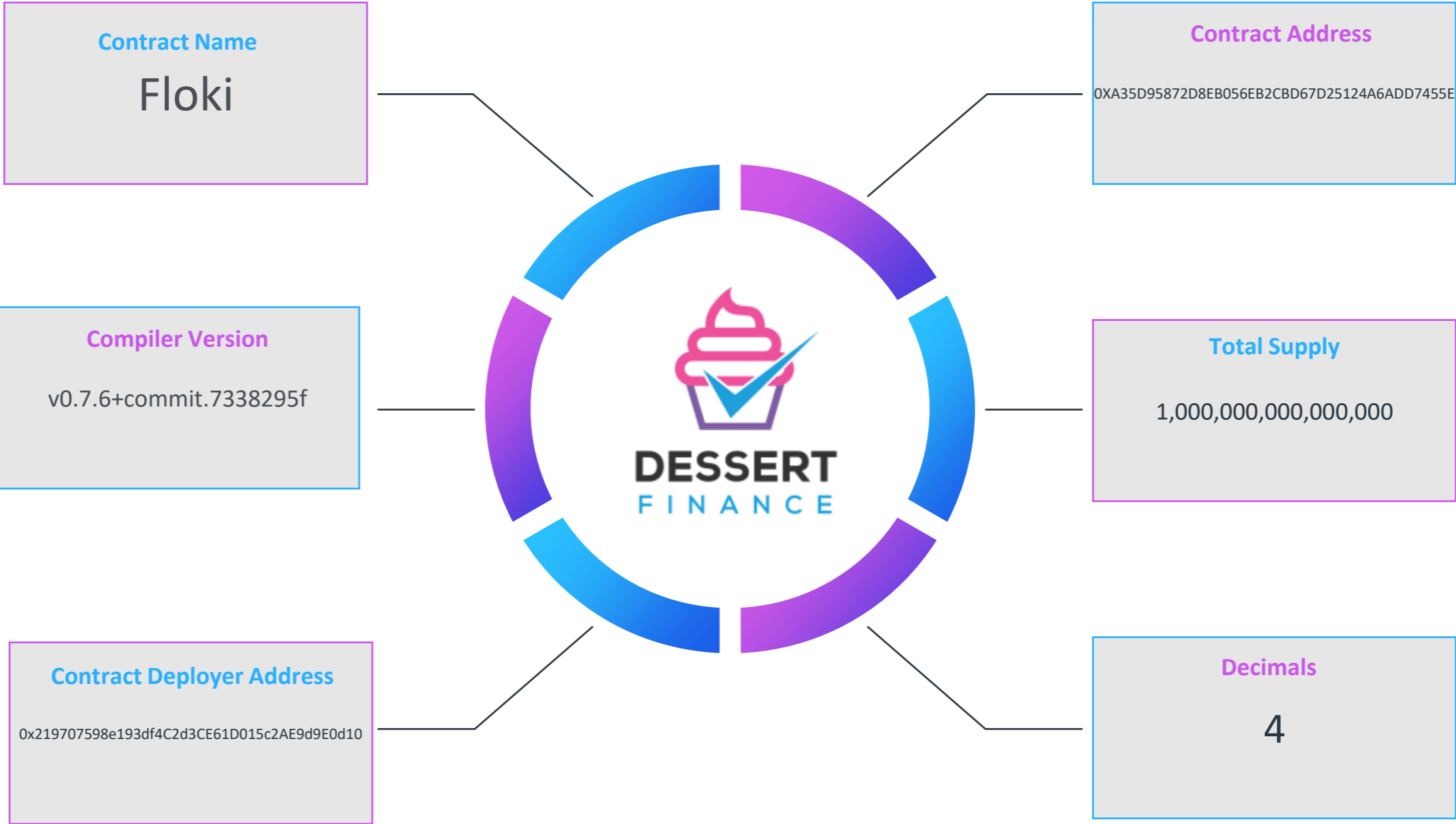

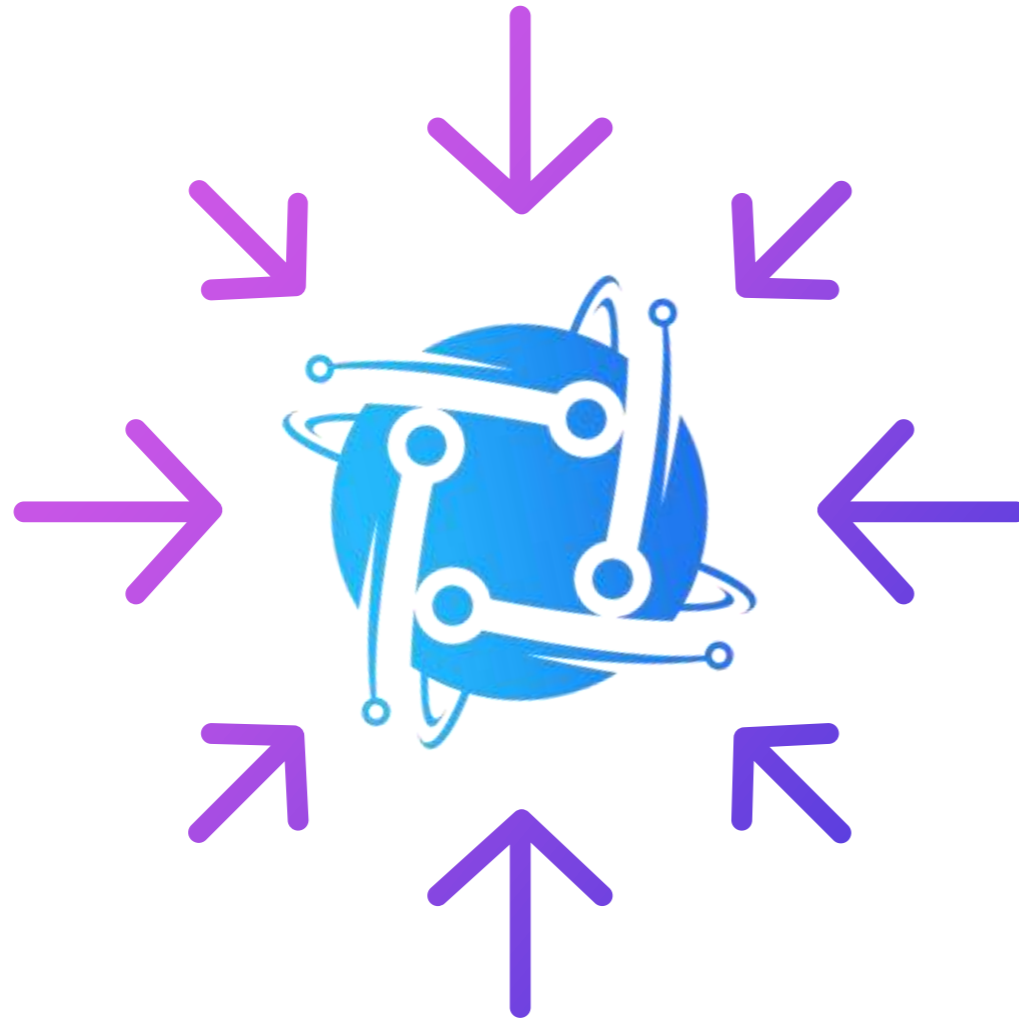

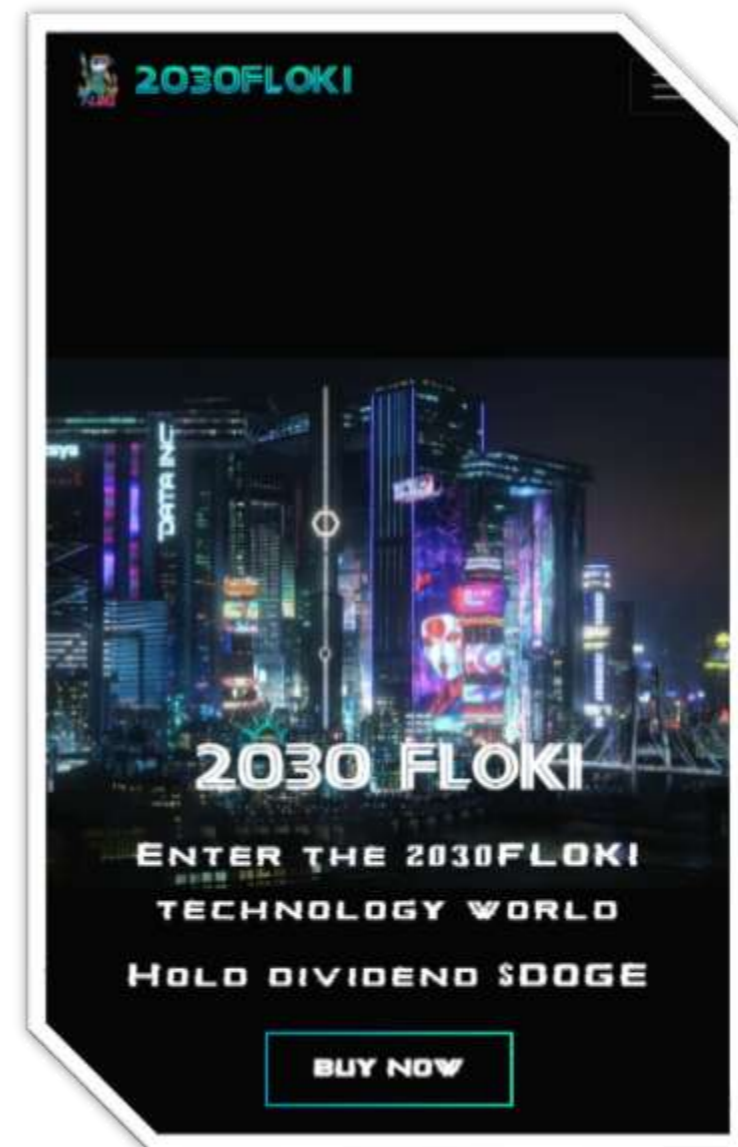
No additional issues were found on the website.

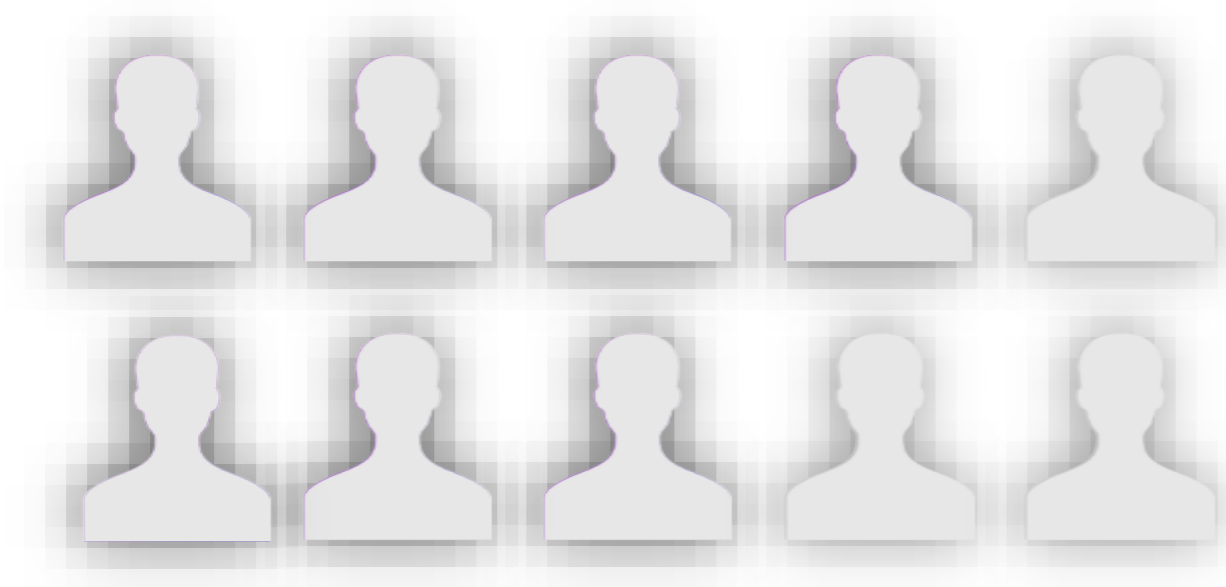
