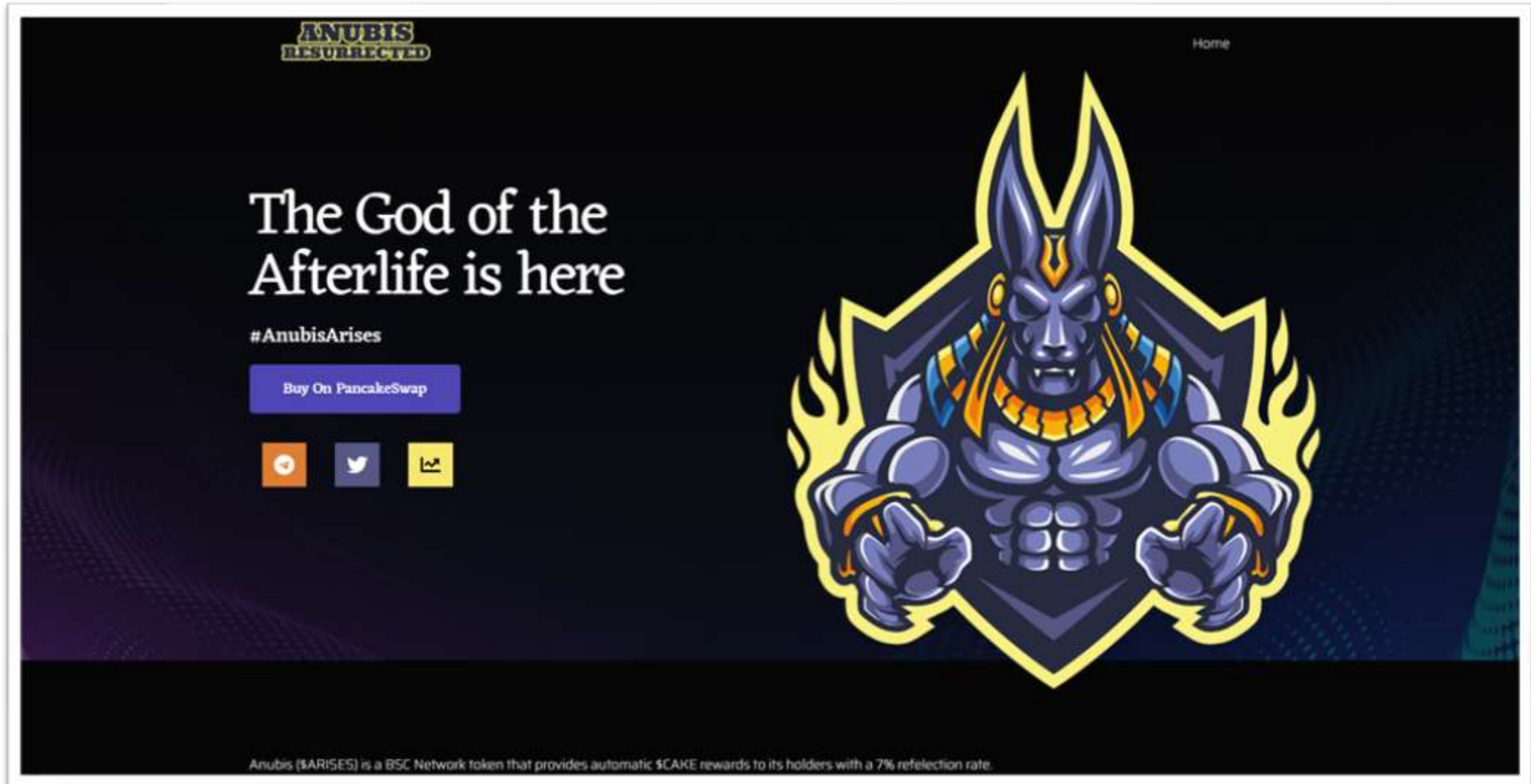
Dessert Finance Revised Score: **100 / 100**

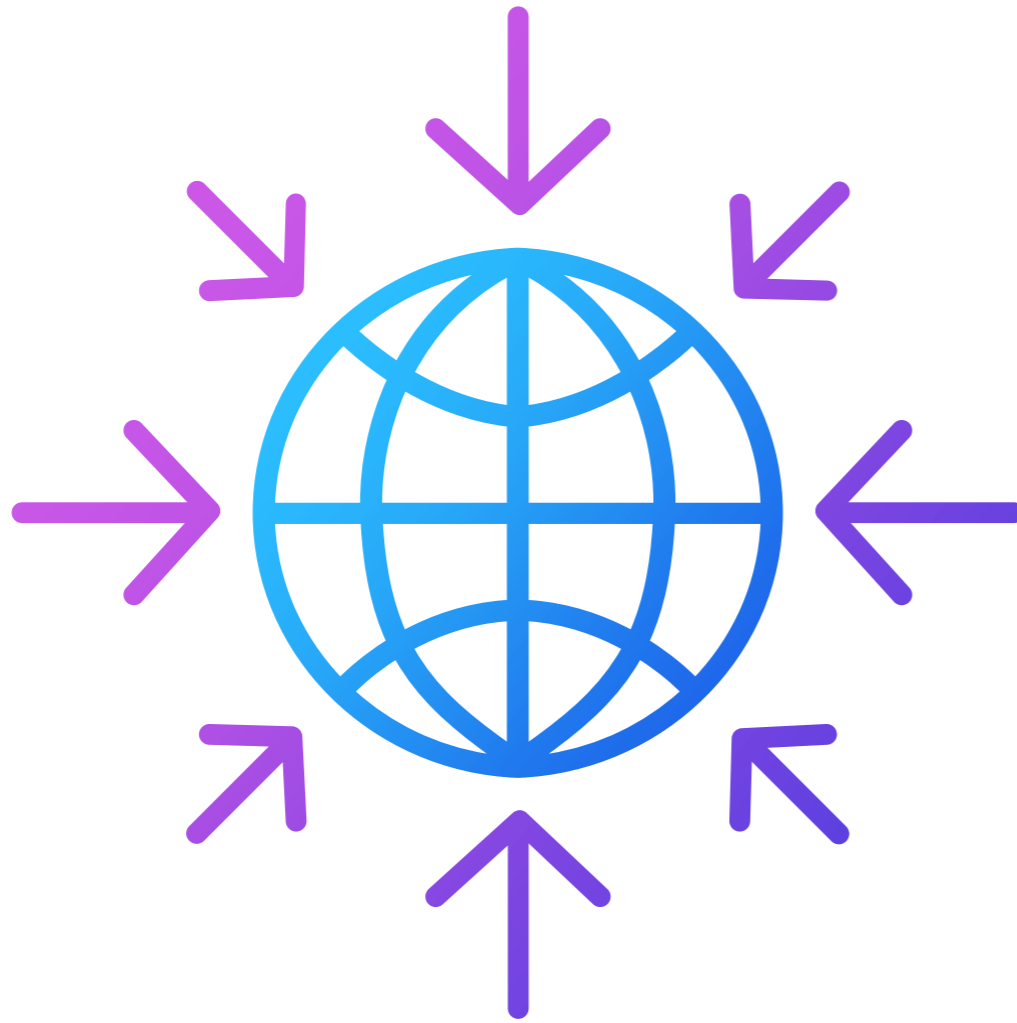

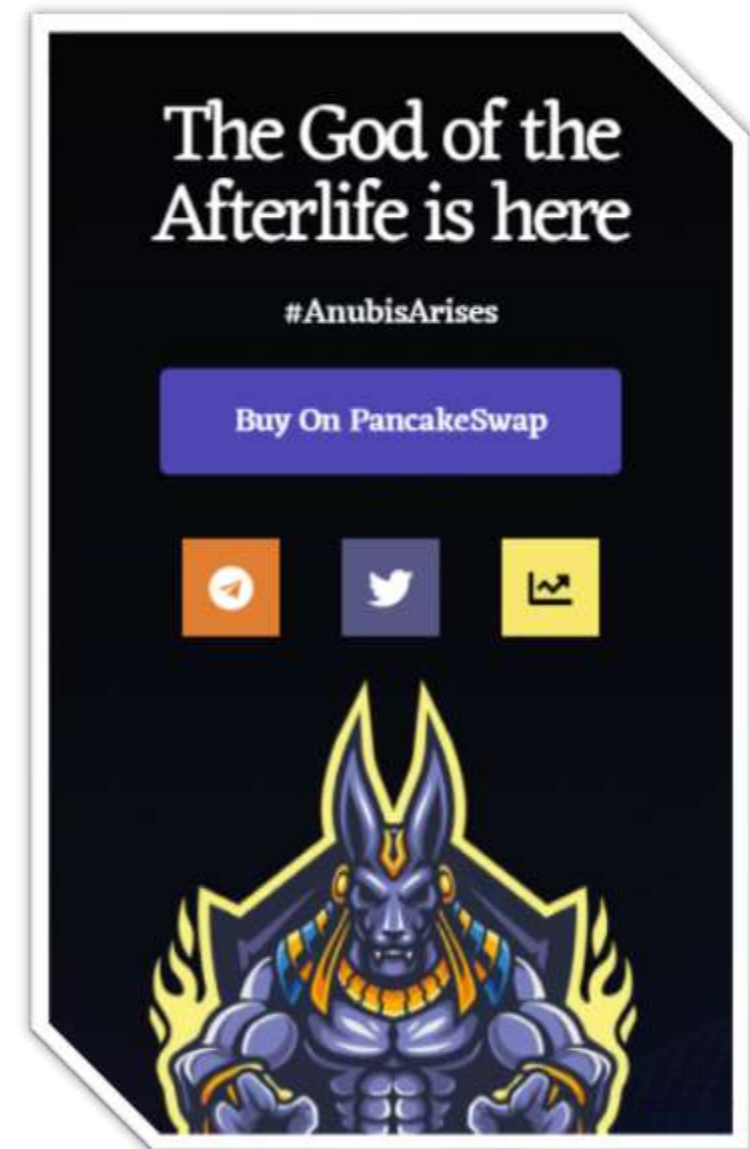
The website contained no JavaScript errors. No typos, or grammatical errors were present, and we found a valid SSL certificate allowing for access via https.

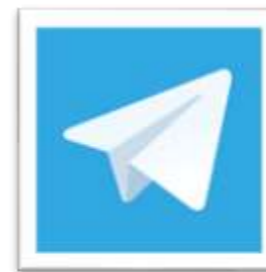
Social Media

Social and Web – Final Thoughts & Suggestions for Improvement

We were able to track down multiple social media channels for the project. Social Media channels included Twitter, Instagram and Telegram. All social media channels had a healthy amount of activity.

It is important to note that the website states there is an 14% tax on EVERY transaction including buys and sells. 3.5% goes to providing liquidity, and 7% is distributed to the token holders in \$CAKE and 3.5% is sent to the marketing wallet. The contract code shows a different fee schedule of 8% distributed to token holders, 4% liquidity and 3% marketing. We would like to see this clarified / align on the website and contract code. *✓ Resolved*

We were unable to find a contact email on the main website. We would like to see this added as a more official means of communication. *✓ Resolved*

Suggestions for Improvement

1. Correct contract code or website to show correct fee schedule *✓ Resolved*
2. Update domain registration to 3+ years *✓ Resolved*
3. Add contact email or form to the website *✓ Resolved*
4. Add additional Social Media channels *✓ Resolved*
5. Home button on website is a dead link – update or remove *✓ Resolved*

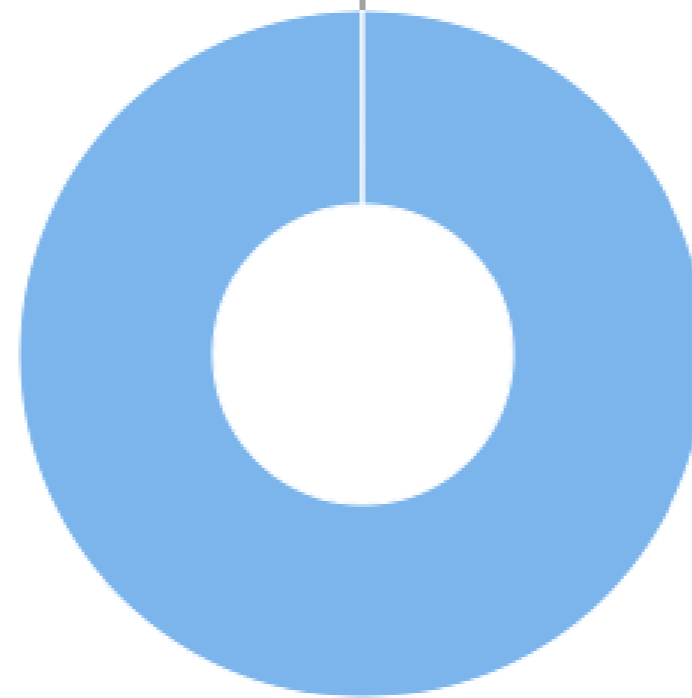

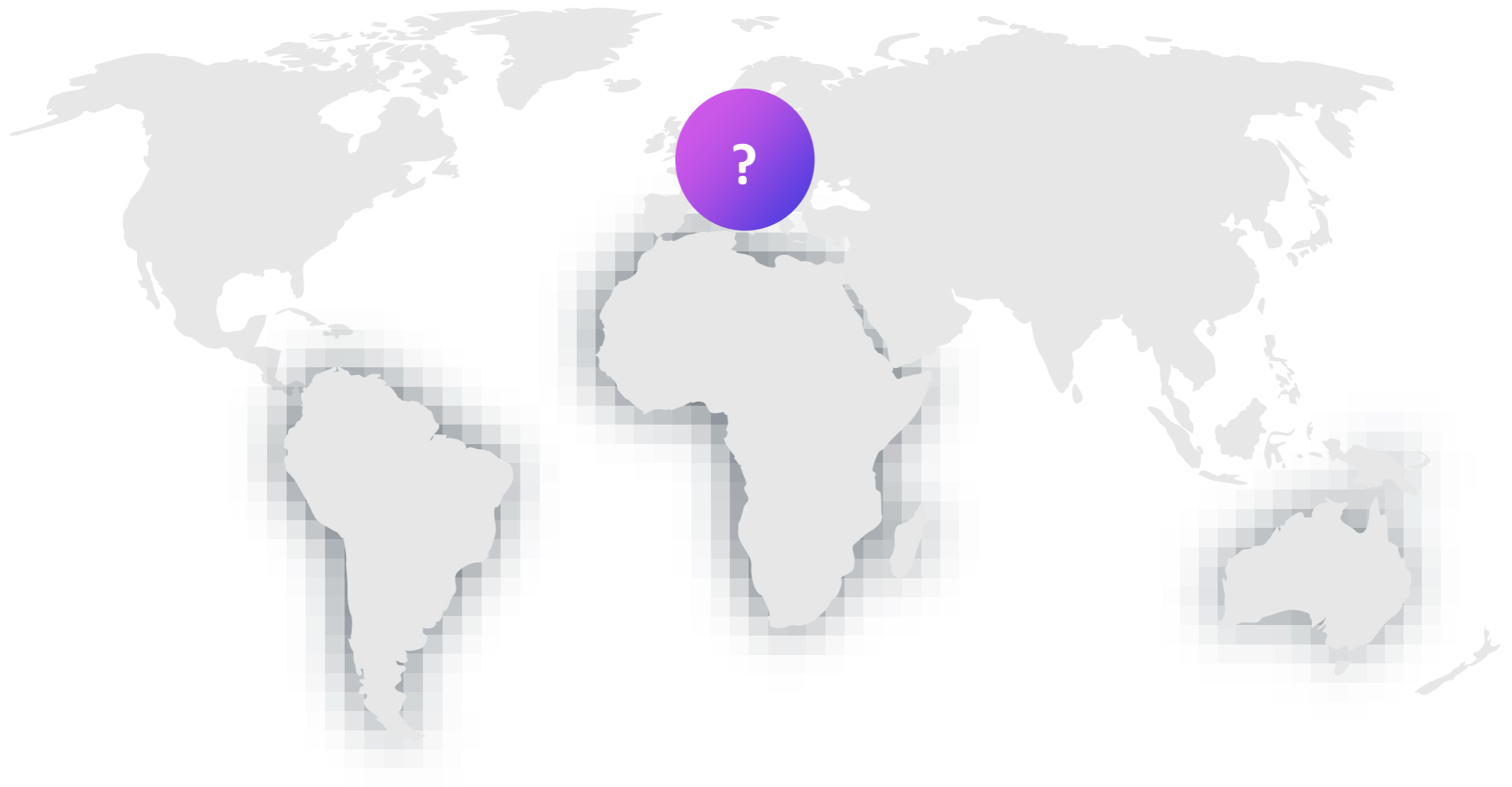

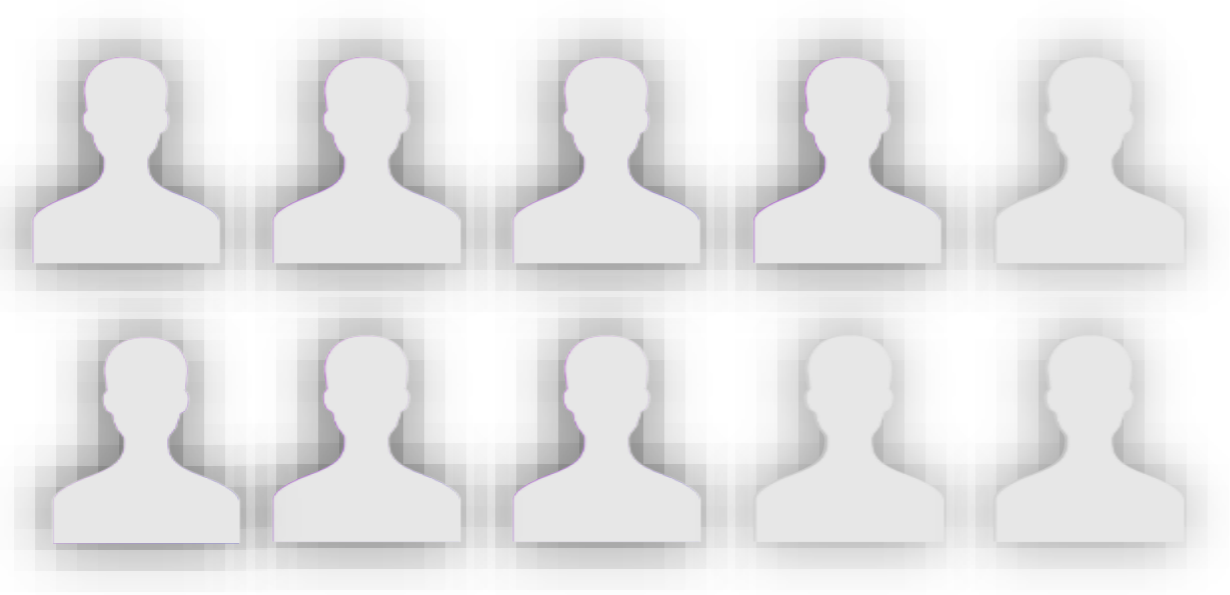
