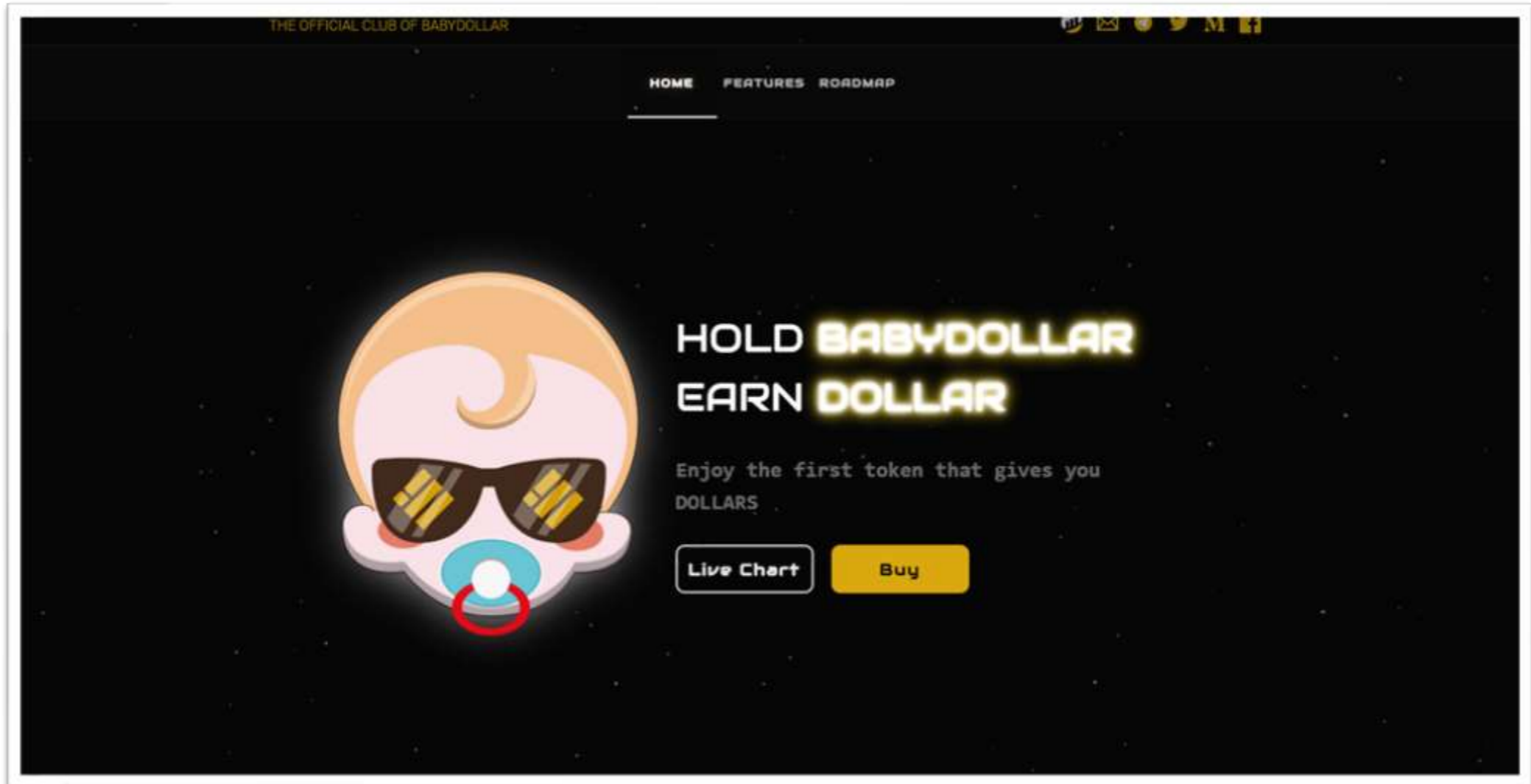

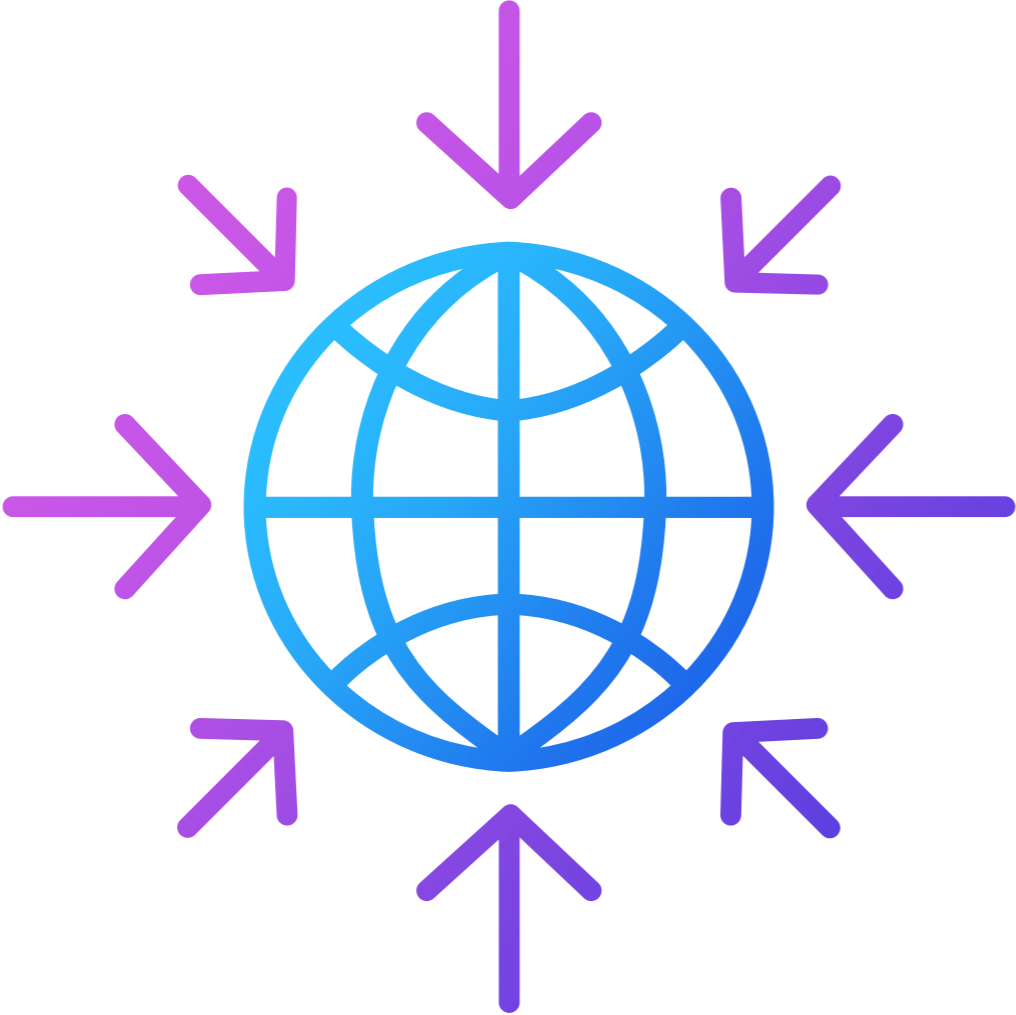

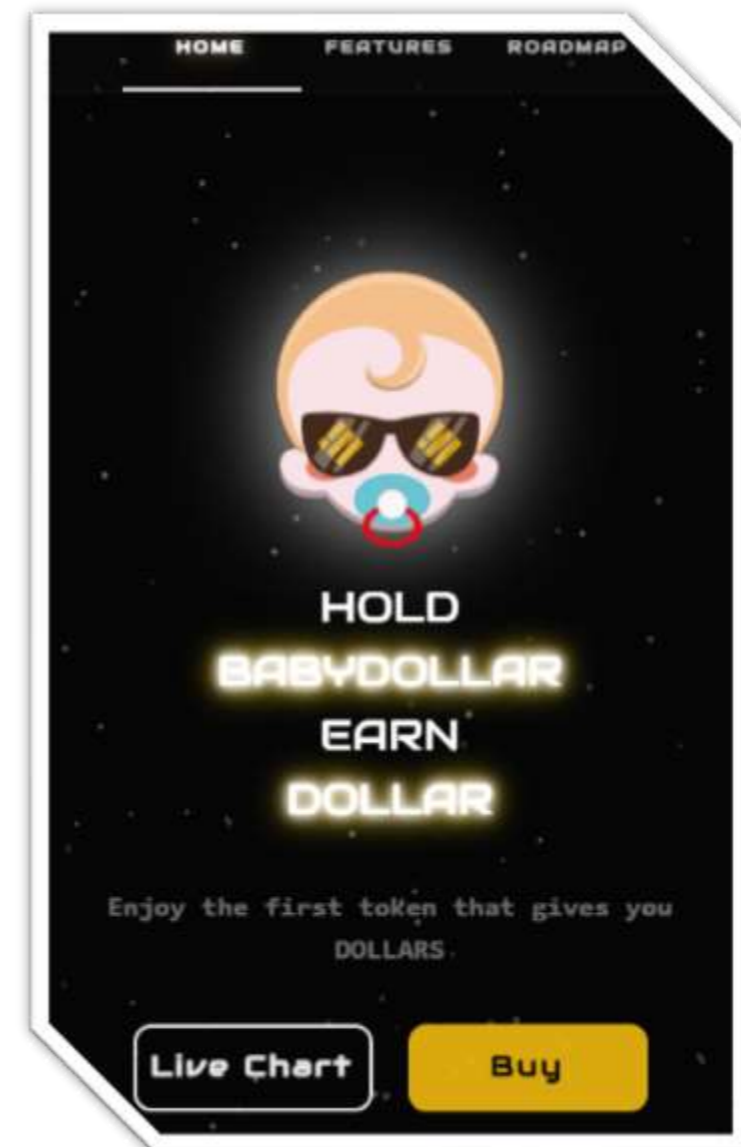
The website contained no JavaScript errors. No typos, or grammatical errors were present, and we found a valid SSL certificate allowing for access via https.

Social and Web – Final Thoughts & Suggestions for Improvement

We were able to track down multiple social media channels for the project. Social Media channels included Twitter, Telegram, Medium and Facebook. Most social media channels had a healthy amount of activity.

It is important to note that there is an 15% tax on EVERY transaction including buys and sells. 3% goes to providing liquidity, and 7% is distributed to the token holders in BUSD and 5% is redistributed back to the team for marketing purposes.

The top holder of the token is the PancakeSwap liquidity pool holding 17.63% of the supply. At Dessert Finance we like to see the PancakeSwap liquidity pool in the top 3 holders.

Suggestions for Improvement

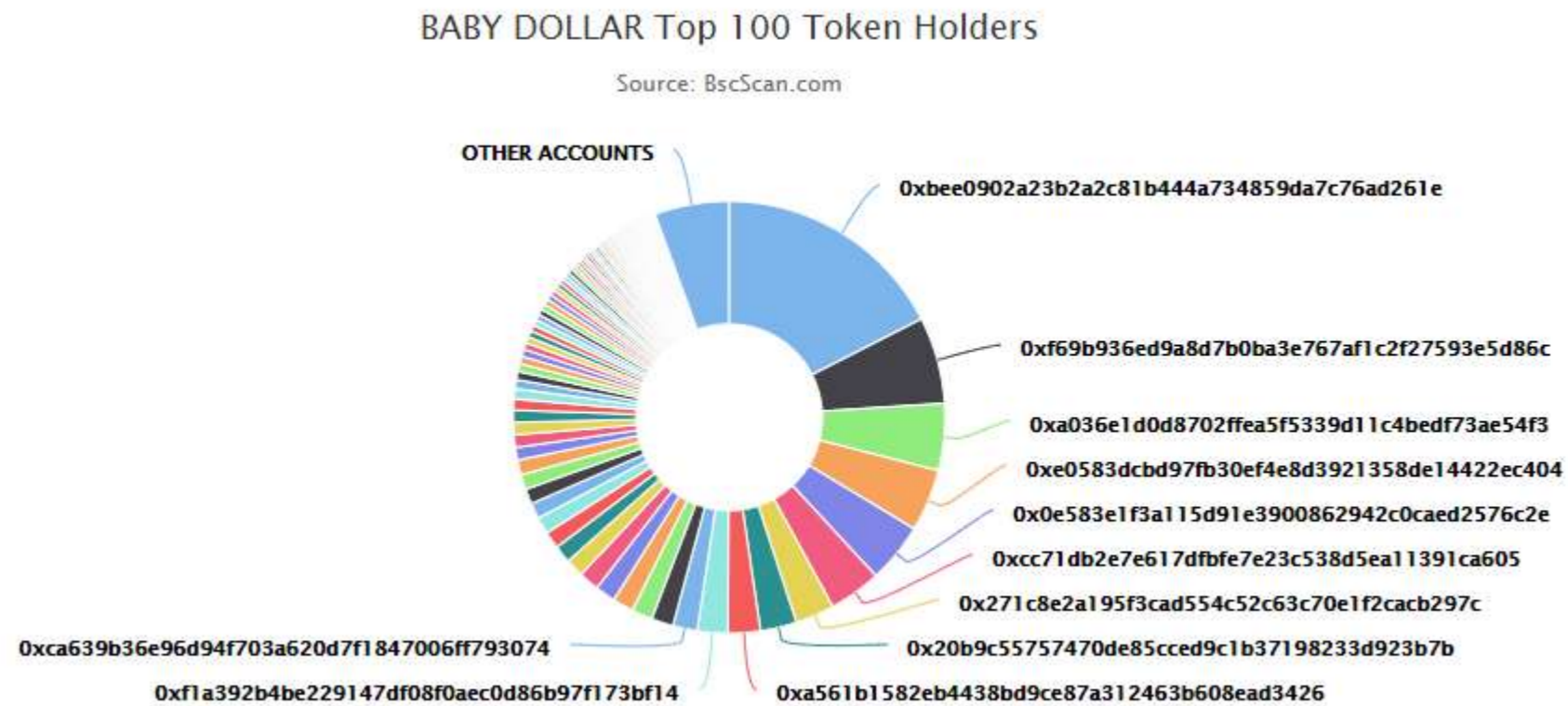
1. Medium showed no stories posted, We suggest posting an article about the token on medium.

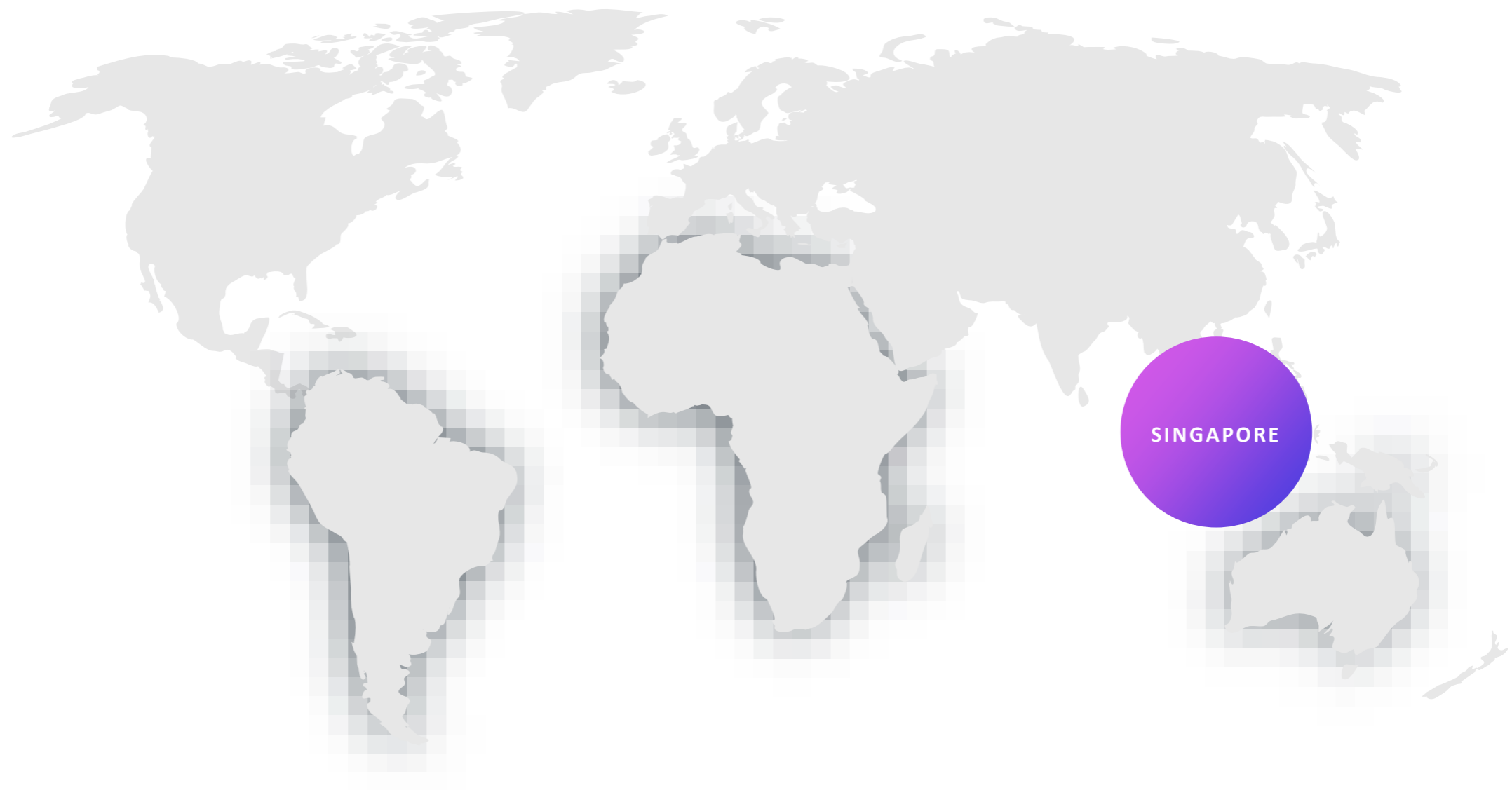

1. [0xbee0902a23b2a2c81b444a734859da7c76ad261e](#)– the top token holder was a contract holding 17.48% of the total supply. This is PancakeSwap’s liquidity pool.
2. [0xf69b936ed9a8d7b0ba3e767af1c2f27593e5d86c](#)– the 2nd largest holder was a wallet containing 6.49% of the supply.
3. [0xa036e1d0d8702ffea5f5339d11c4bedf73ae54f3](#)– the 3rd largest holder was a wallet containing 5% of the supply. This is a team controlled wallet.

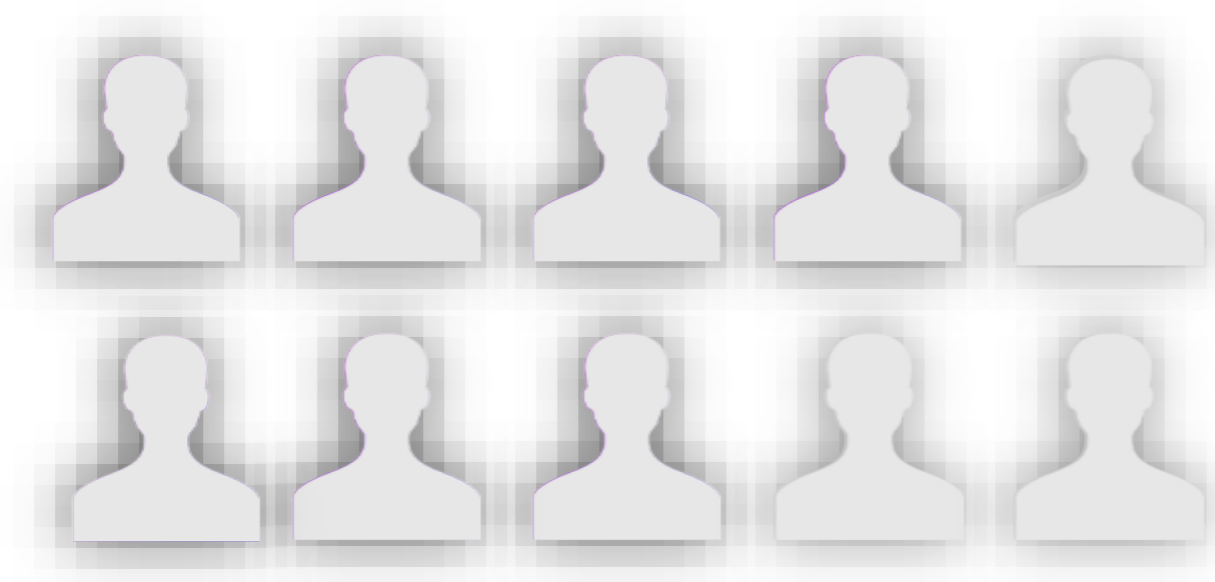

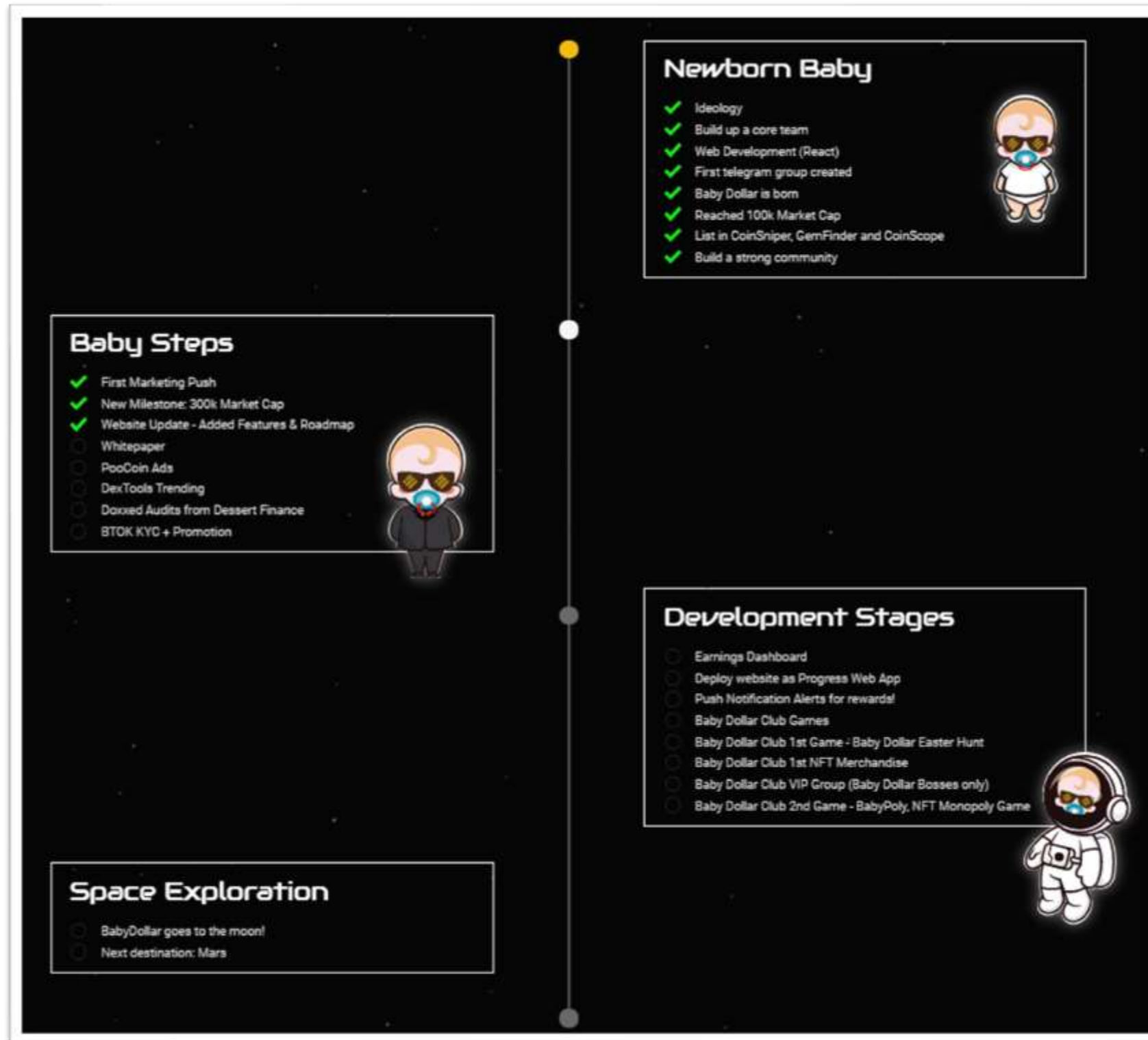
