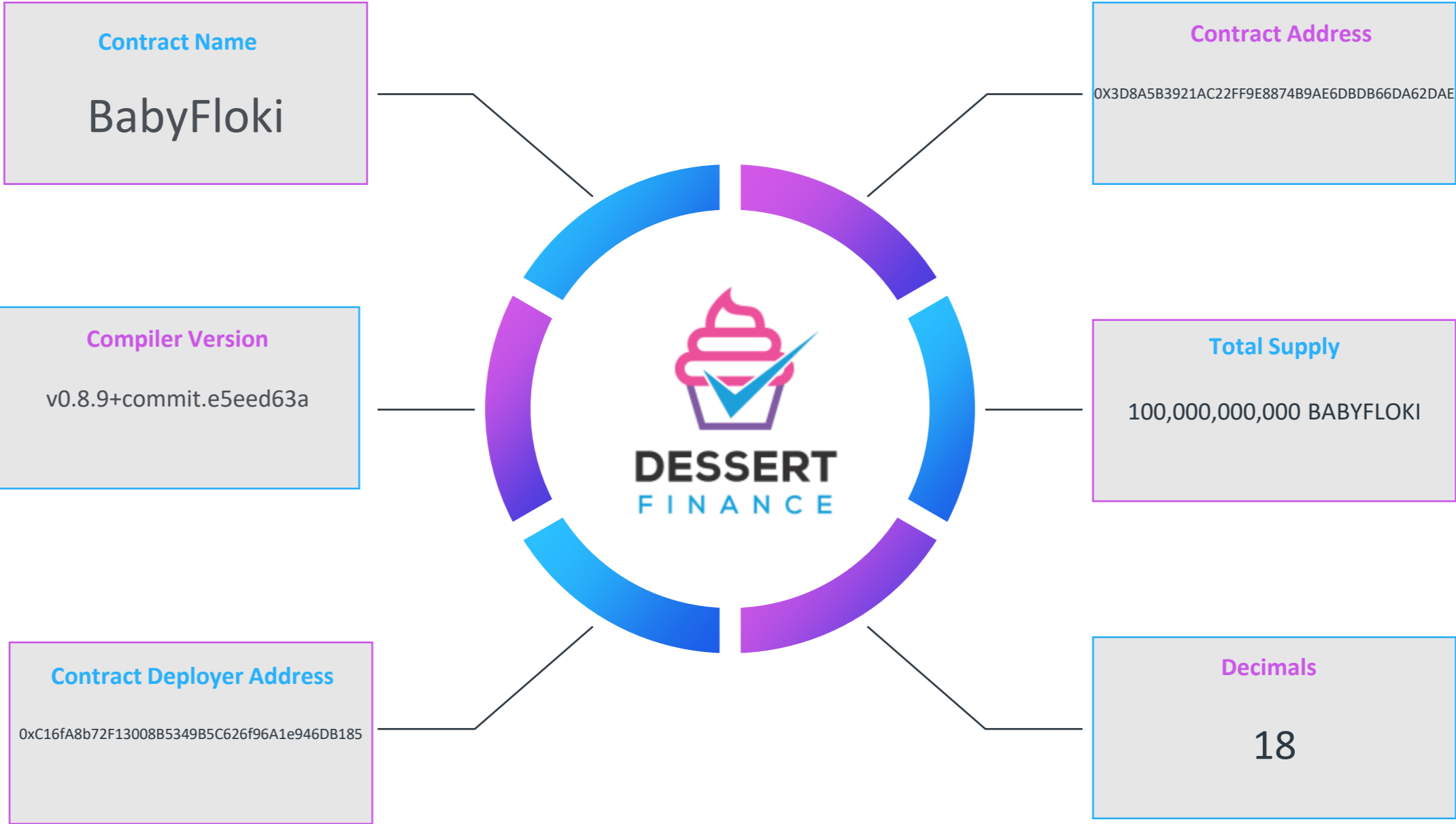

An extra 1% fee is applied to all sells. This will allow us to reduce swing-trading and break whales' control.



Secured By PinkLock

Initial Liquidity Provided will be locked for 3 months with PinkLock. Contract Code has already been audited by Dessert Finance and will be audited once more, this time by CertiK!

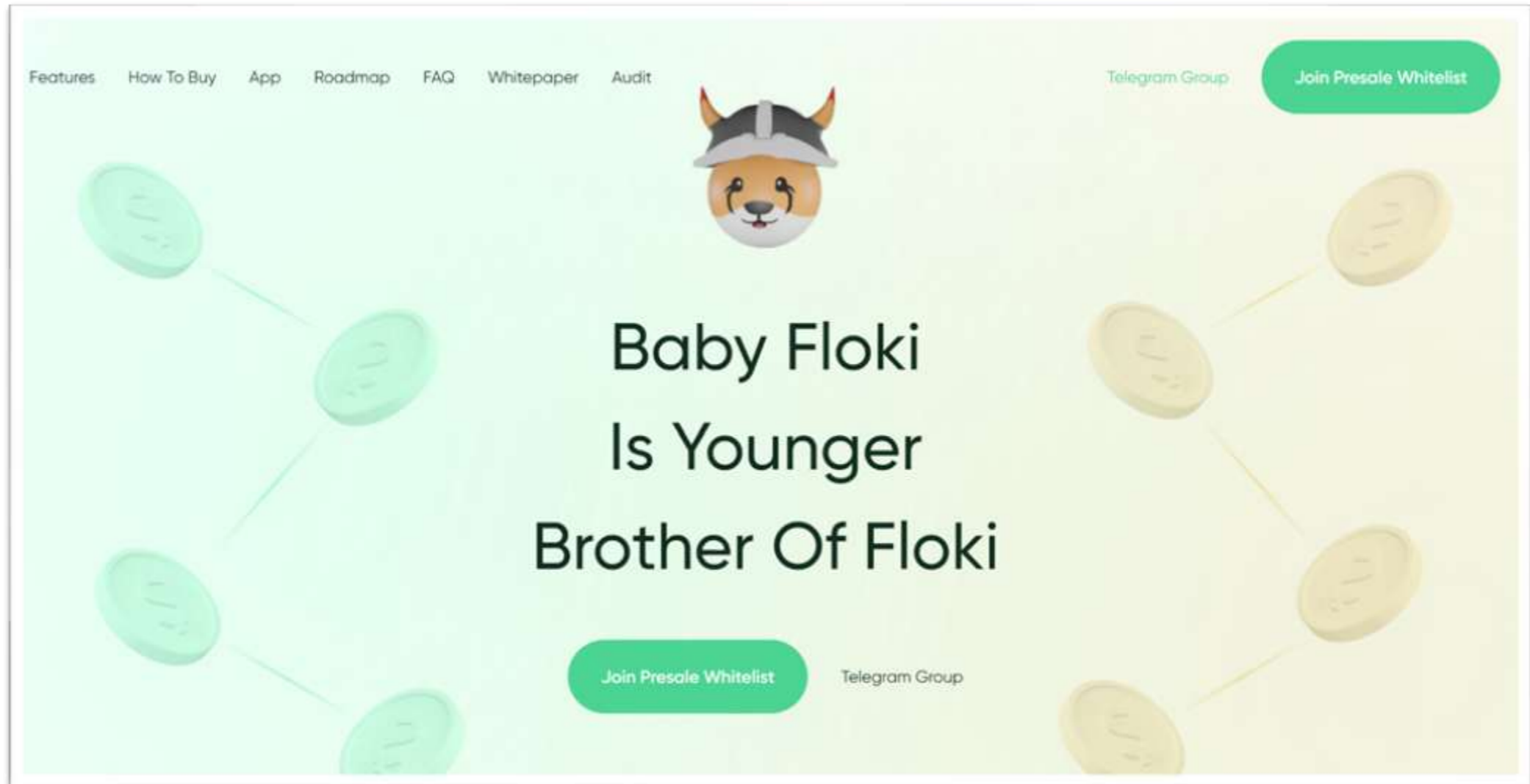


2% Auto Liquidity Pool

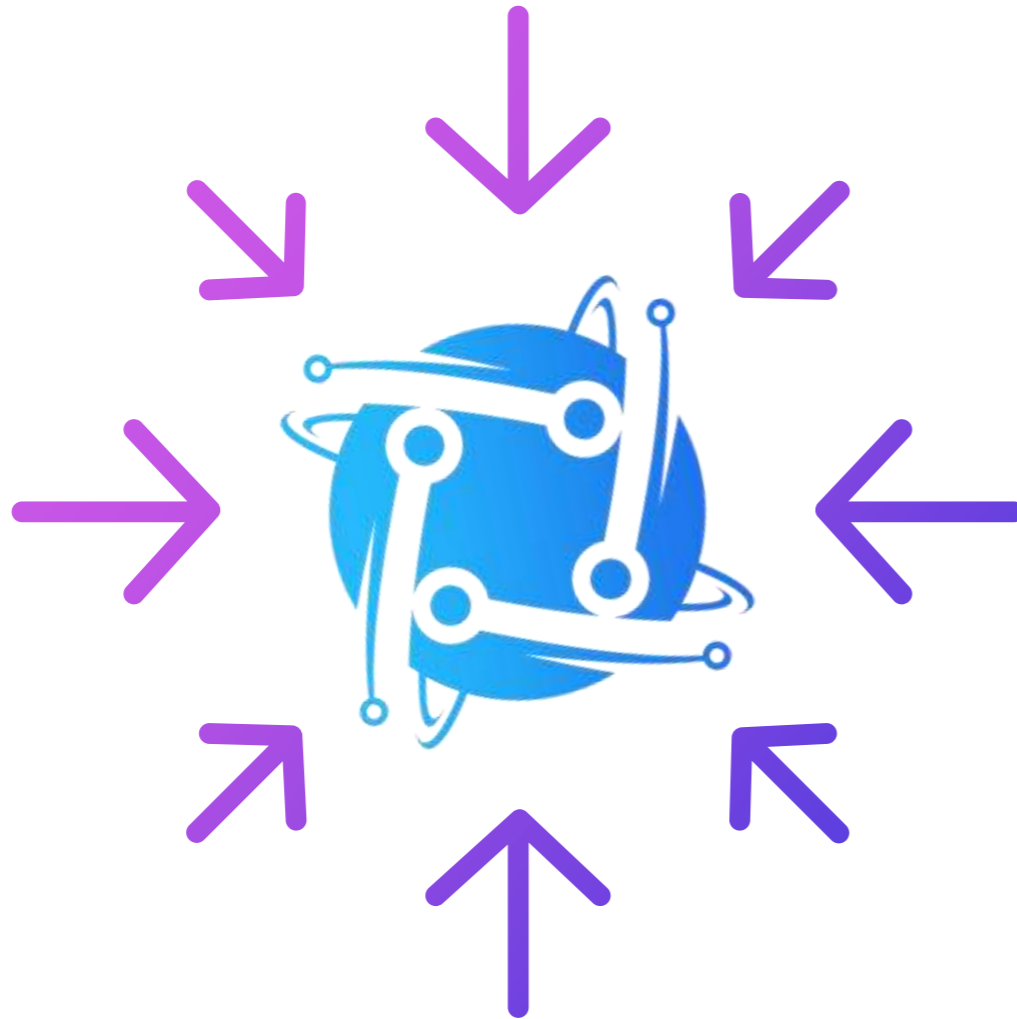

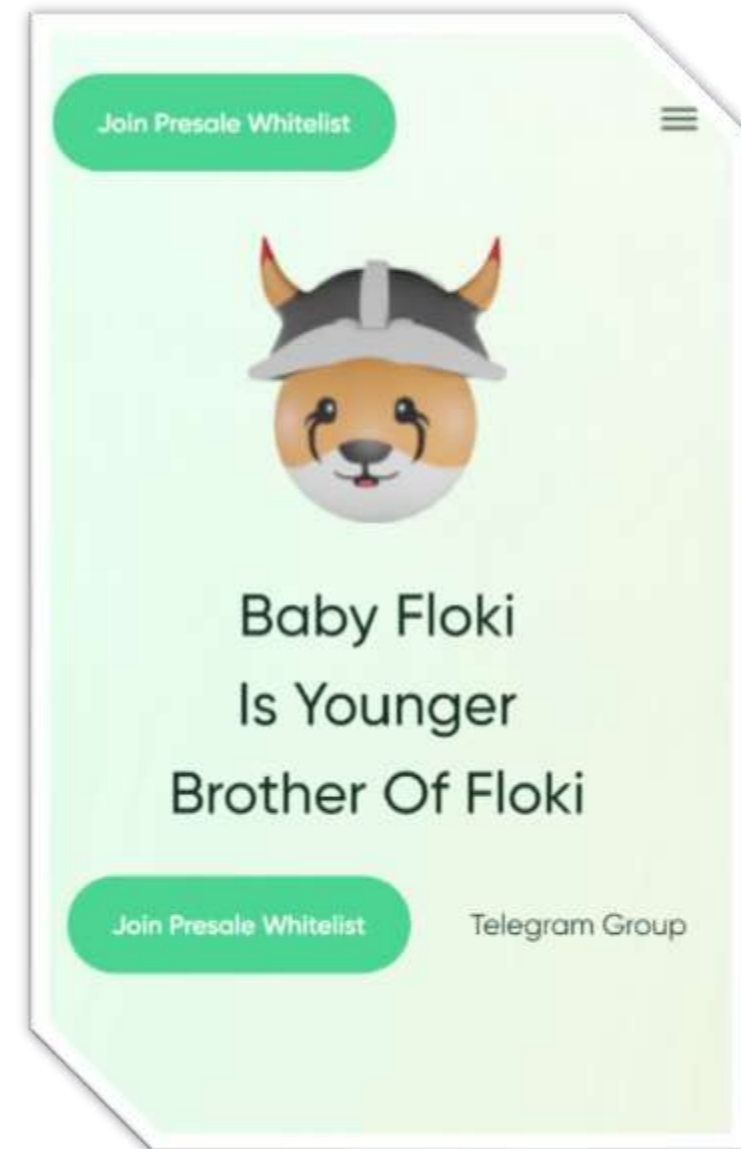
The website contained no JavaScript errors. No typos, or grammatical errors were present, and we found a valid SSL certificate allowing for access via https.

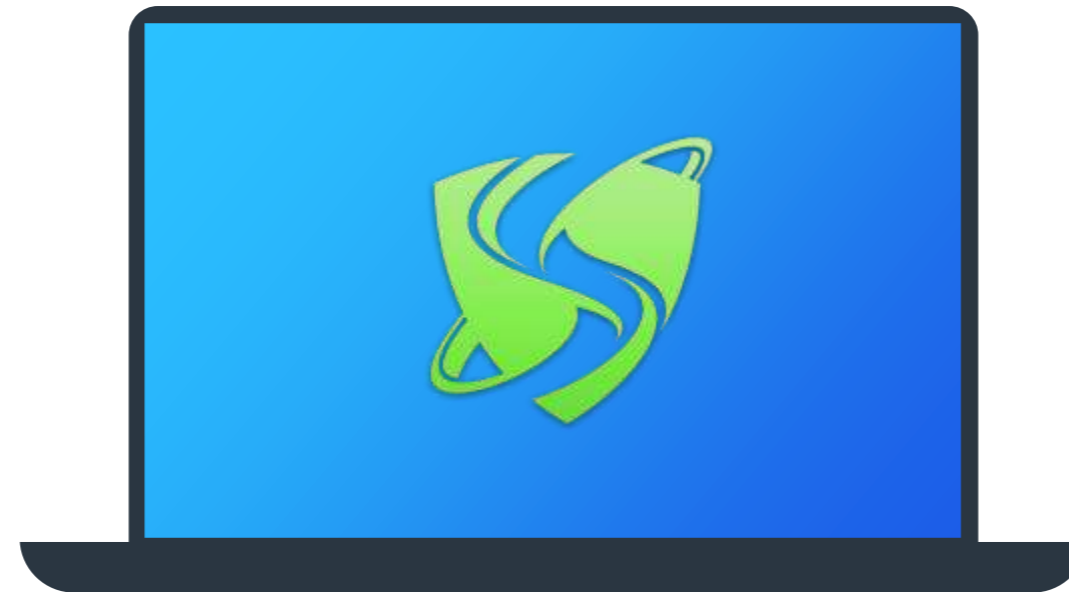

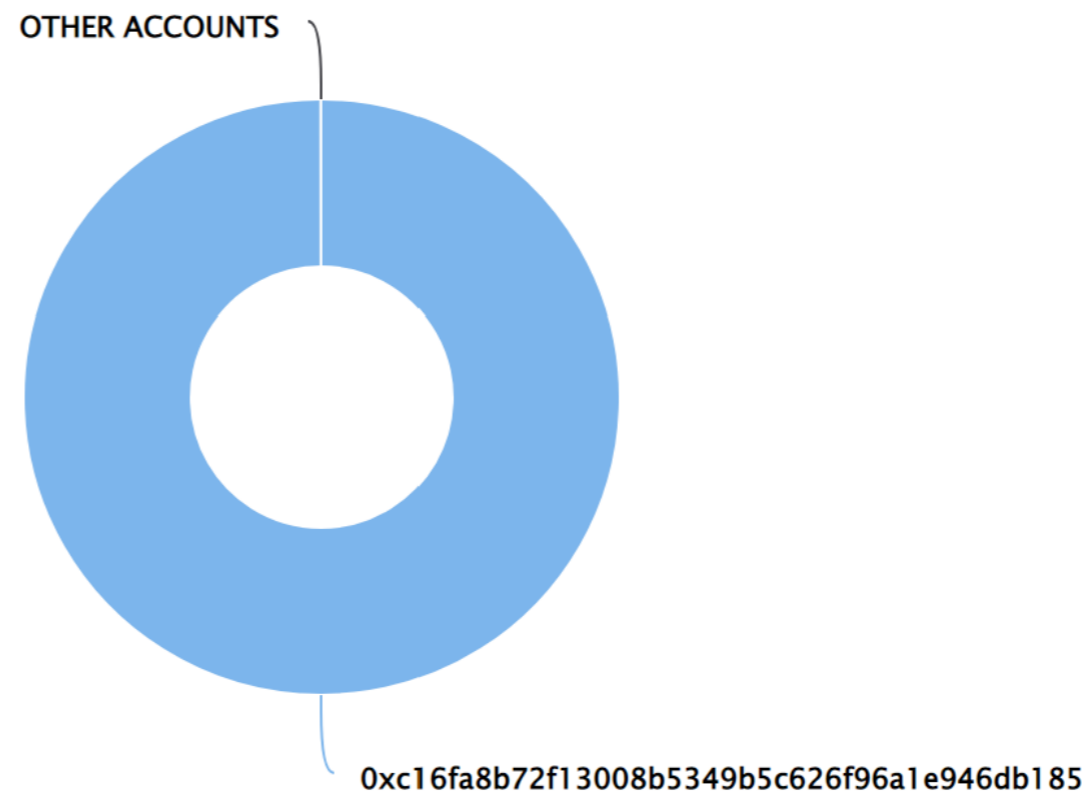

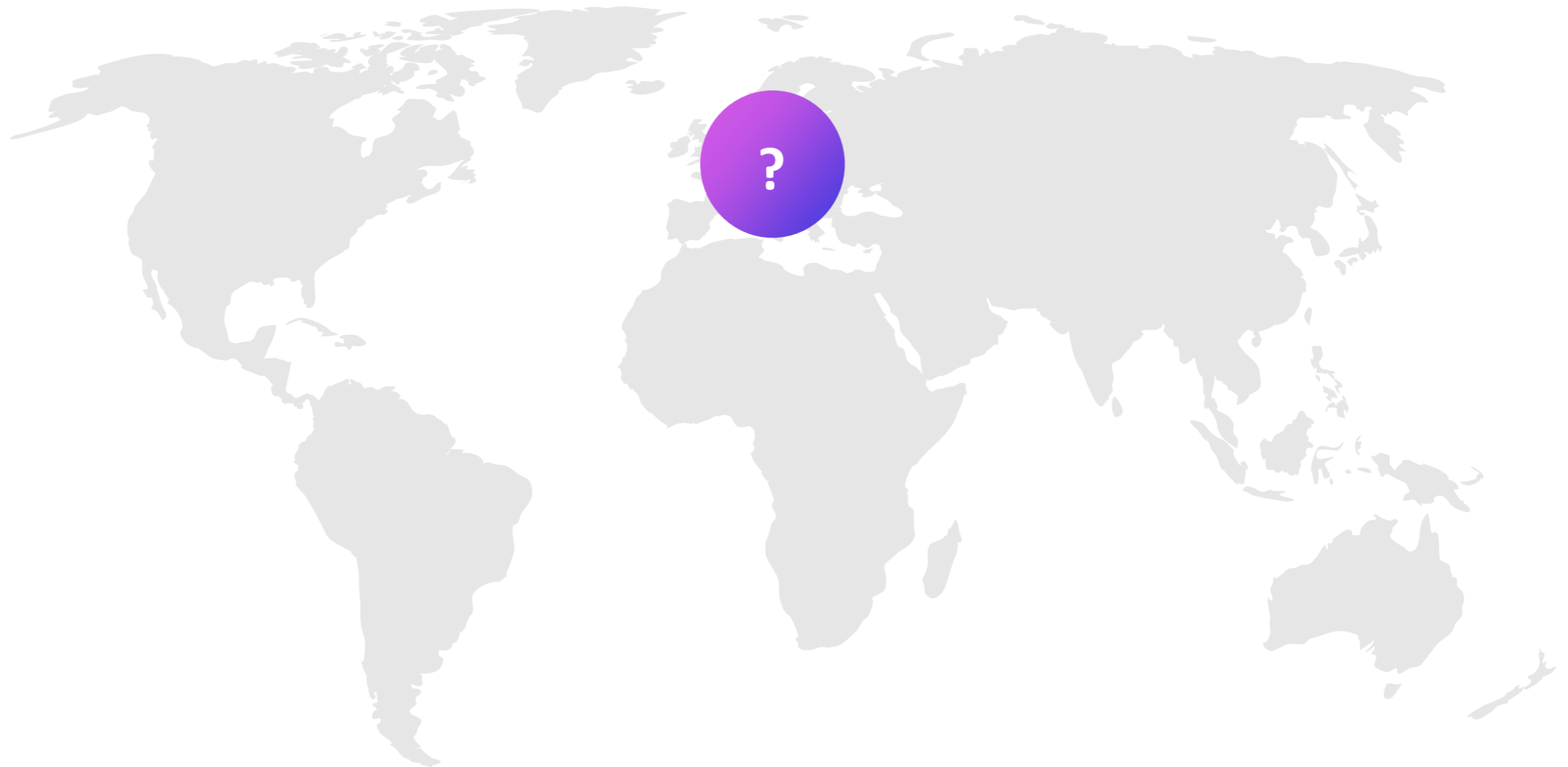
BabyFloki Top 100 Token Holders

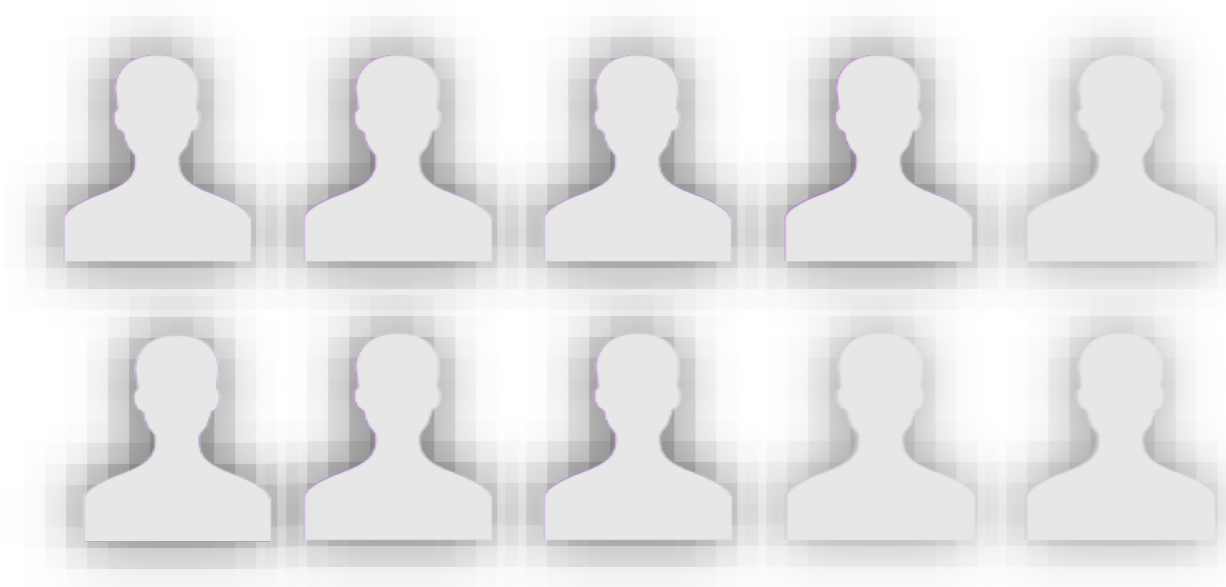
