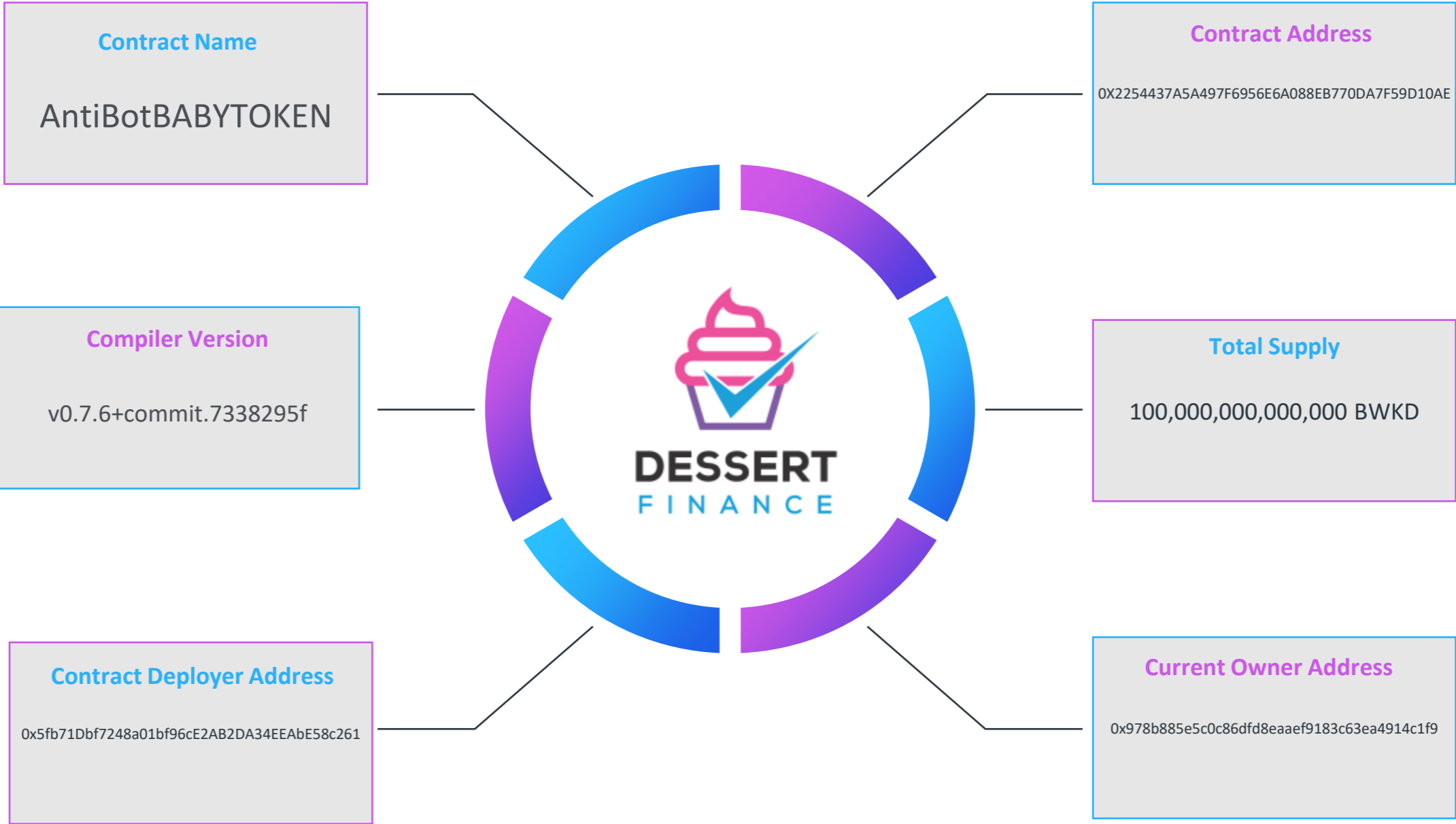

# Contract Transaction Fees

At the time of Audit the transaction fees (“tax”) listed below are the fees associated with trading. These fees are taken from every buy and sell transaction unless otherwise stated.

## ΓΔΧΔΓΙΟΝ

There is a 13% buy tax. An extra 1% fee is applied to all sales to encourage holding, discourage swing trading and to lessen whale manipulation. At times, our Tokenomics may change in response to market conditions.

The token contract employs a static rewards system. The 13% buy tax is split as follows:

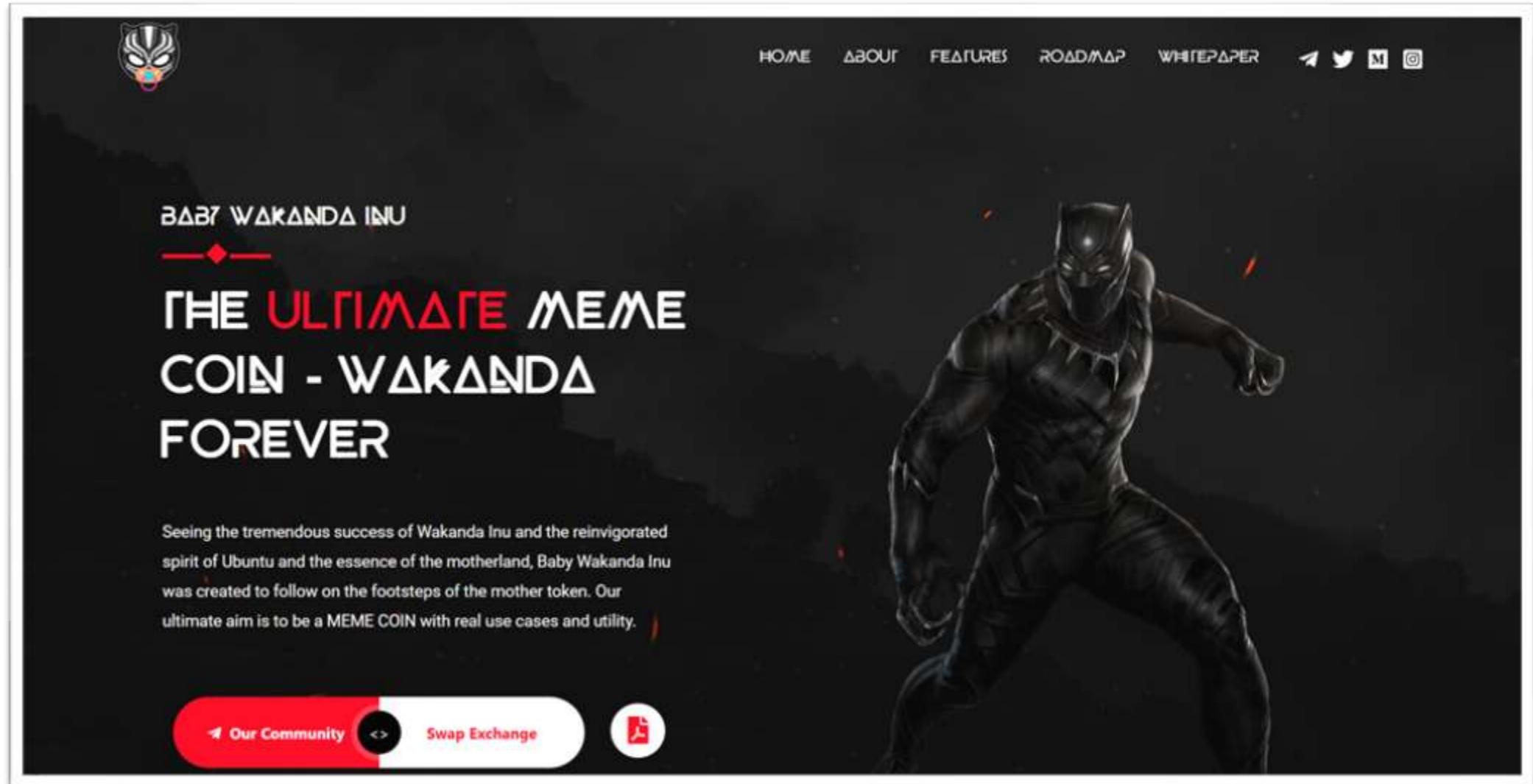
5% is redistributed to holders in \$WKD

3% is used to fuel the liquidity pool

5% is allocated to the Marketing wallet.

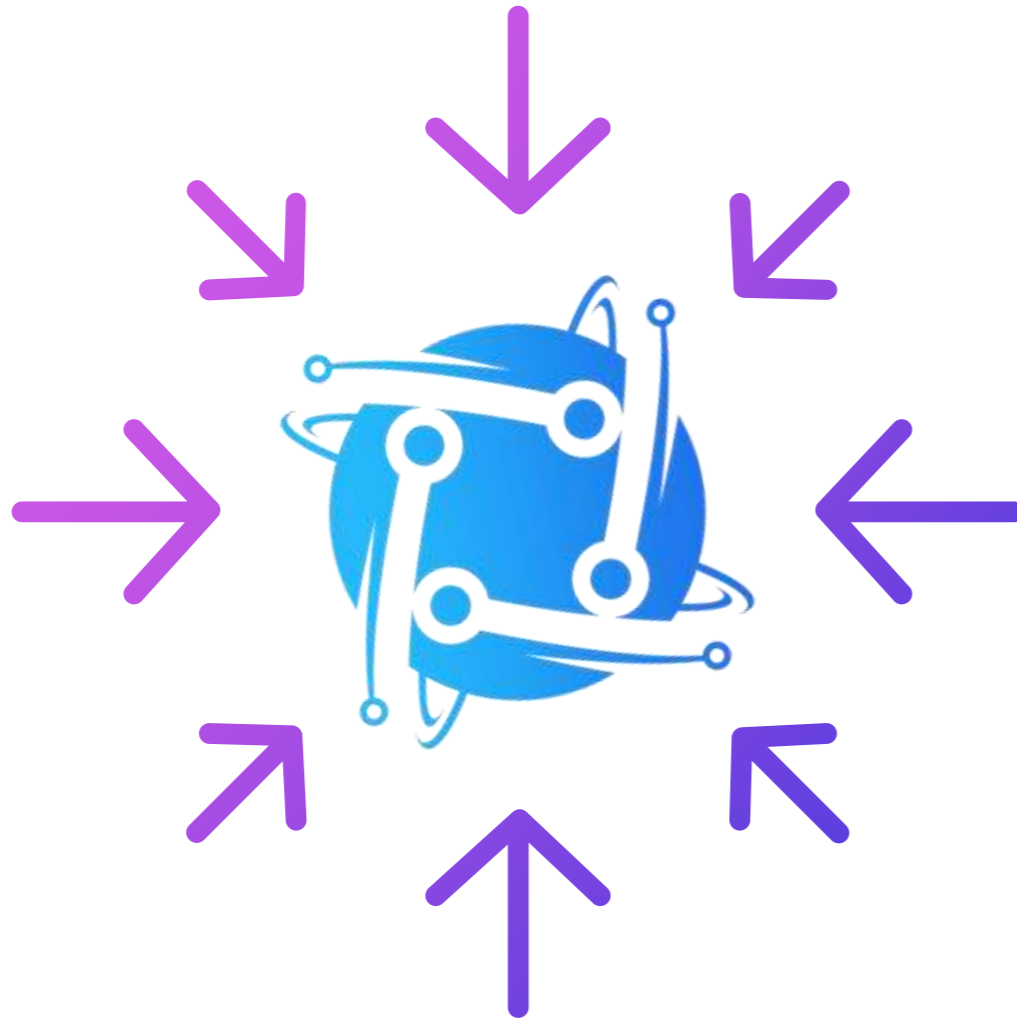

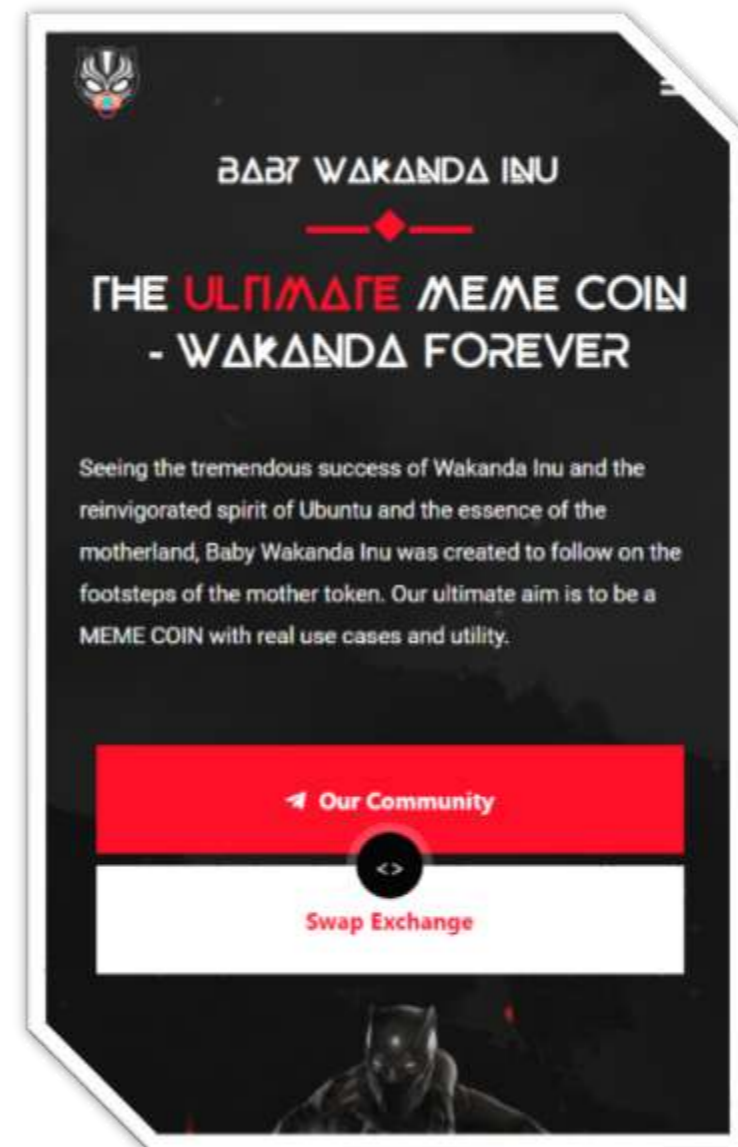
The website contained no JavaScript errors. No typos, or grammatical errors were present, and we found a valid SSL certificate allowing for access via https.
