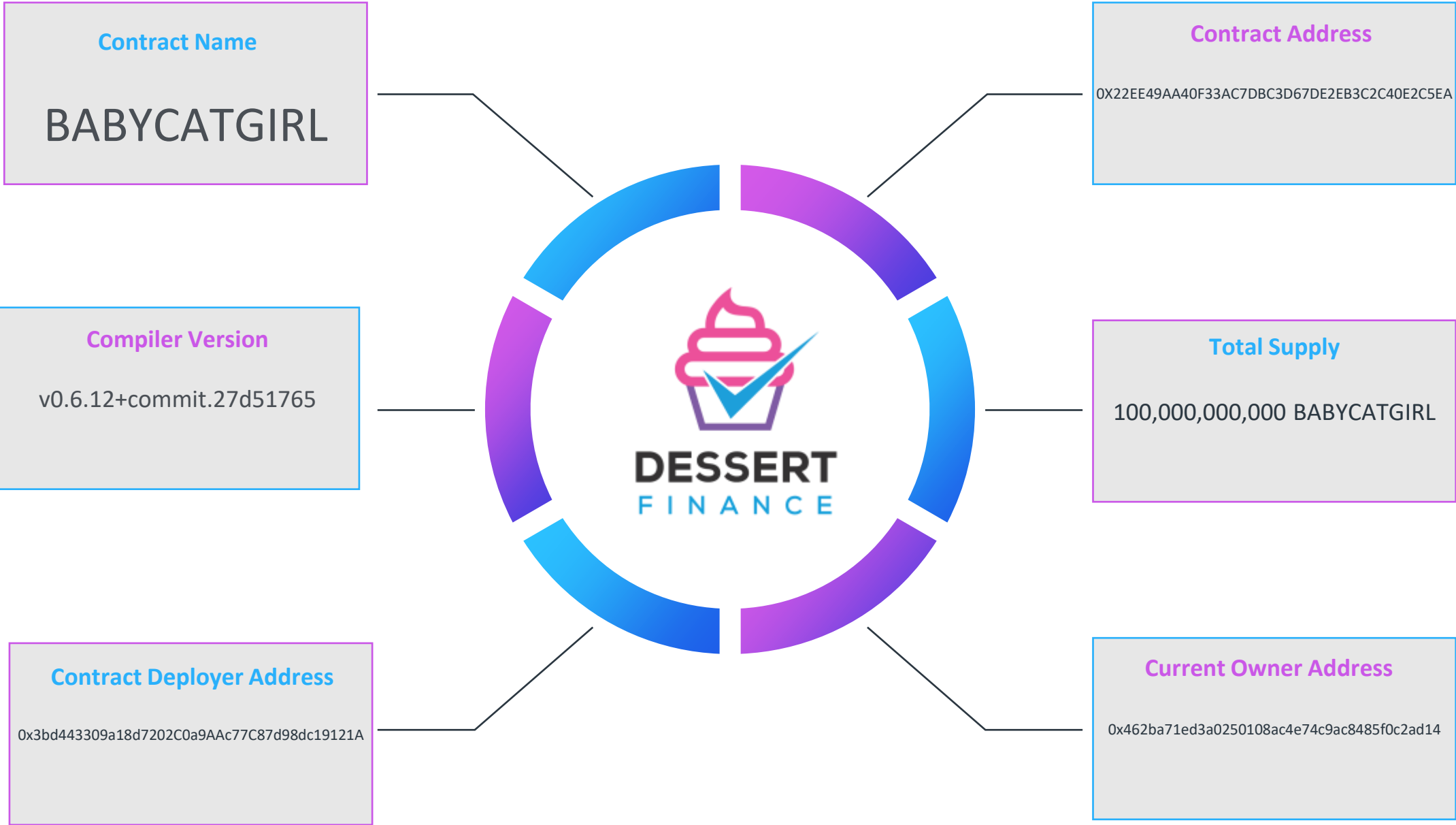

A mint function was not found in the contract code.

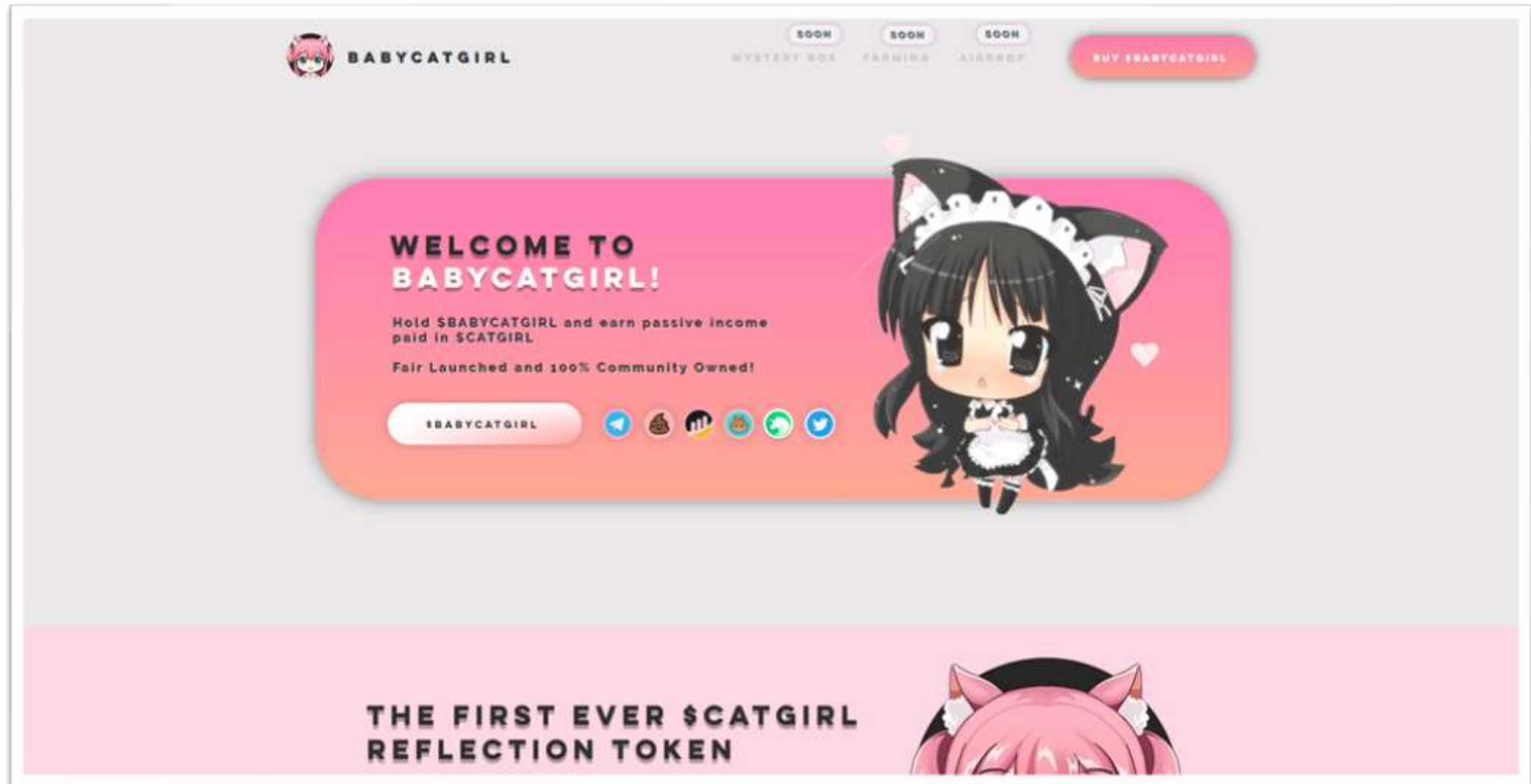

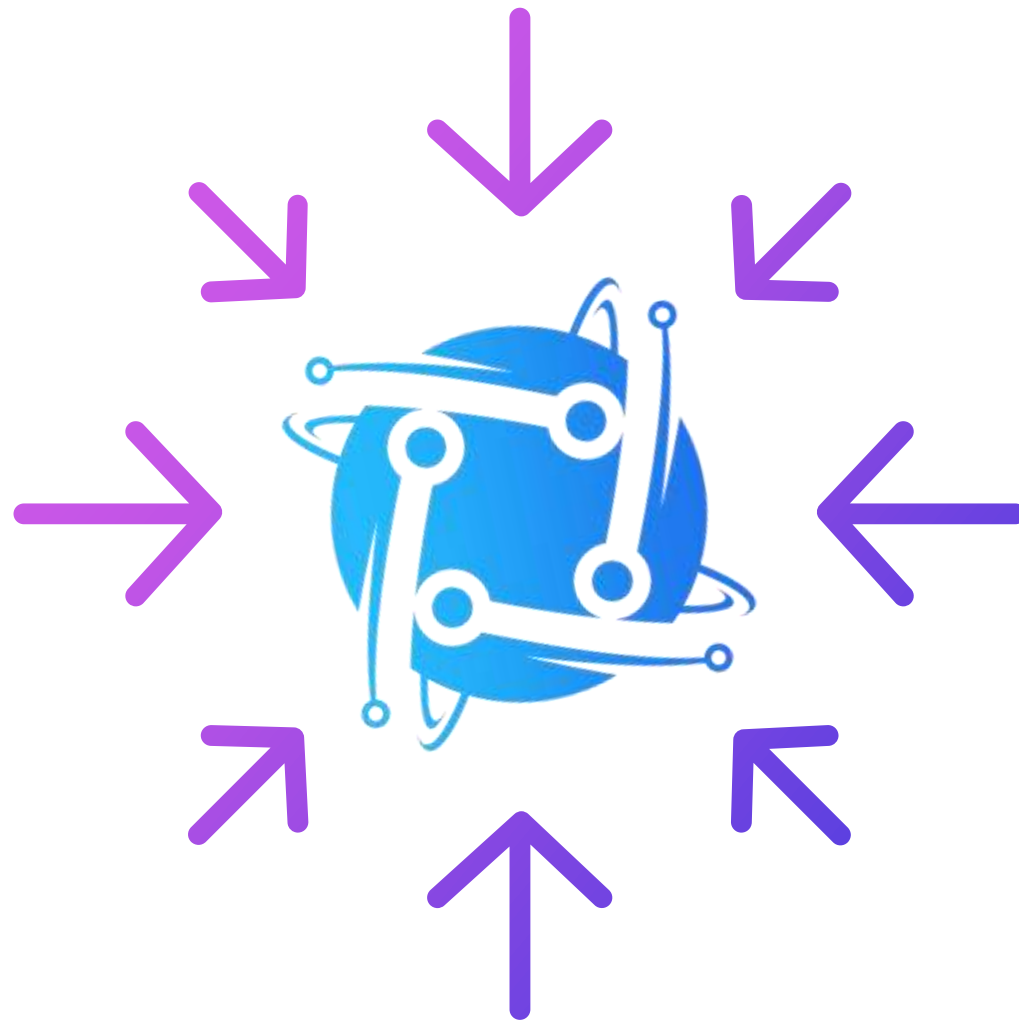
