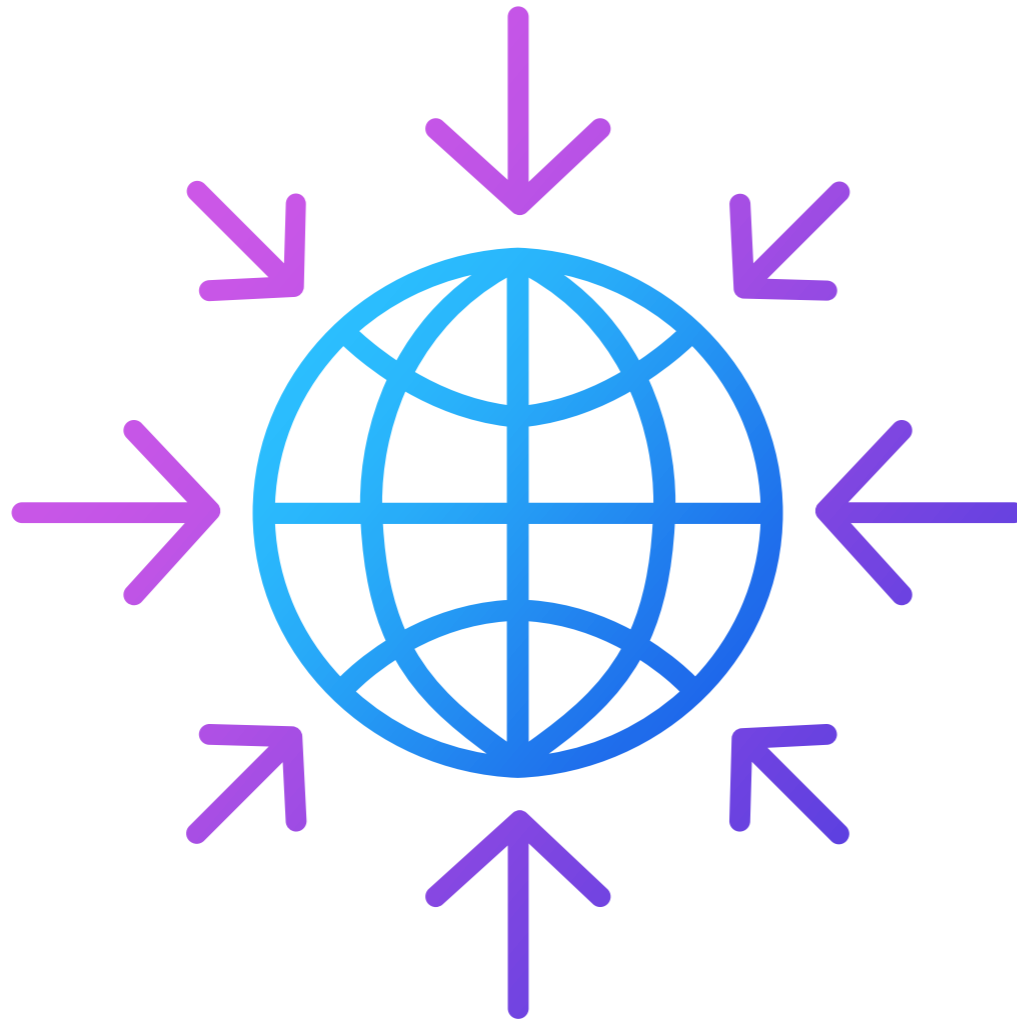

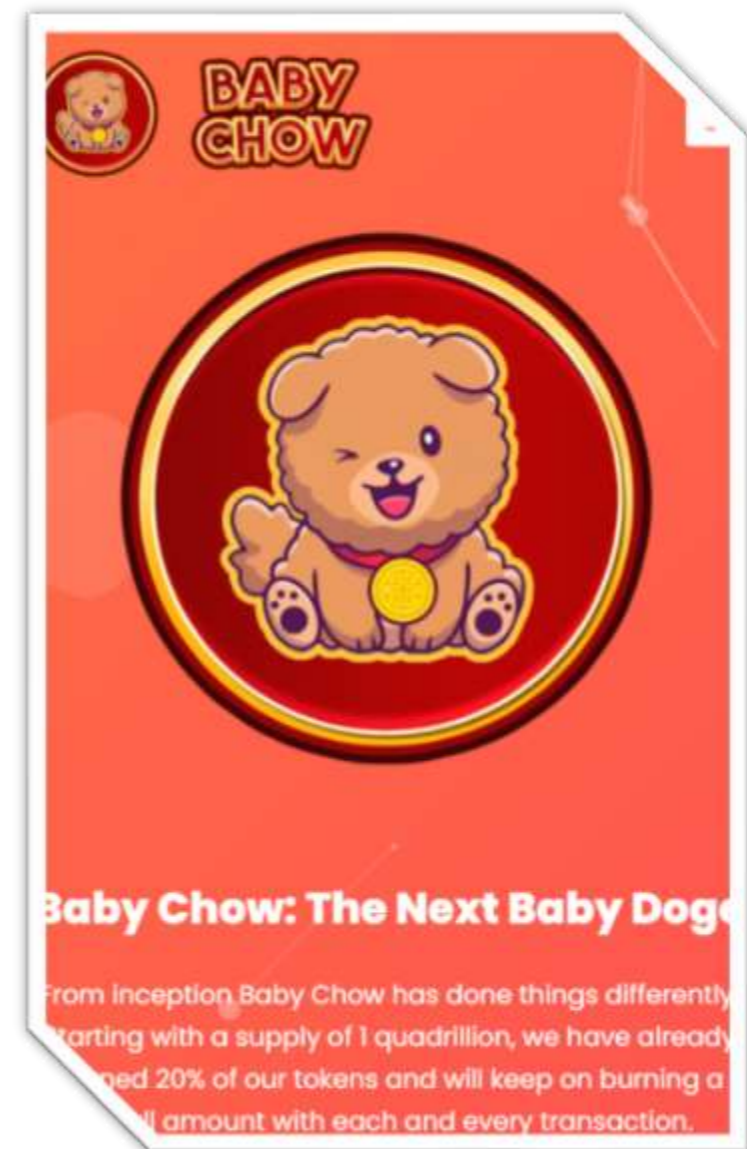
The website contained no JavaScript errors. No typos, or grammatical errors were present, and we found a valid SSL certificate allowing for access via https.

# Social and Web – Final Thoughts & Suggestions for Improvement

We were able to track down multiple social media channels for the project. Social Media channels included Twitter, Telegram, TikTok, and Instagram. All social media channels had a healthy amount of activity.

It is important to note that there is an 12% tax on EVERY transaction including buys and sells. 6% goes to buybacks, and 4% is sent back to the team for marketing and 2% is distributed to the token holders.

There is also a note on the website that states a percentage of every transaction is sent to a charity wallet. It is not clearly written where this tax comes from.

Multiple dead links were found on the website, most are coming soon with proper dates noted, we do not believe this to be a risk as they are future dates and the project has not entered pre-sale yet.

Presale block covers most of the social media Icons on the website, this block should be moved down further.

## Suggestions for Improvement

1. Update domain registration to 3+ years
2. Provide clarity as to where the charity tax is being taken from
3. Fix formatting errors on presale block

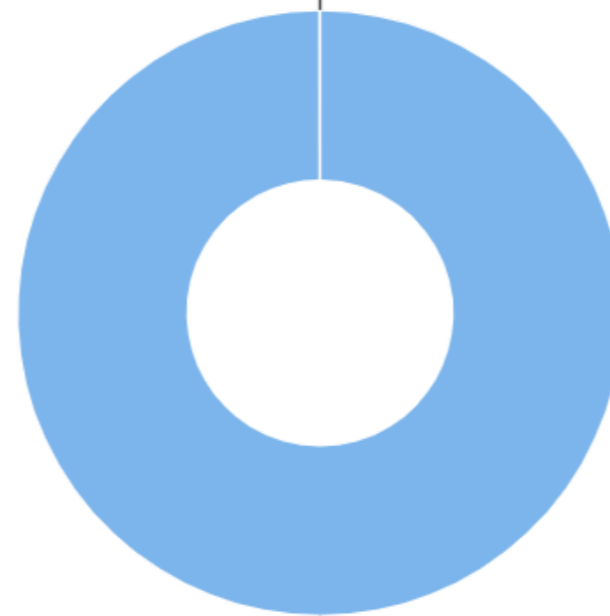
