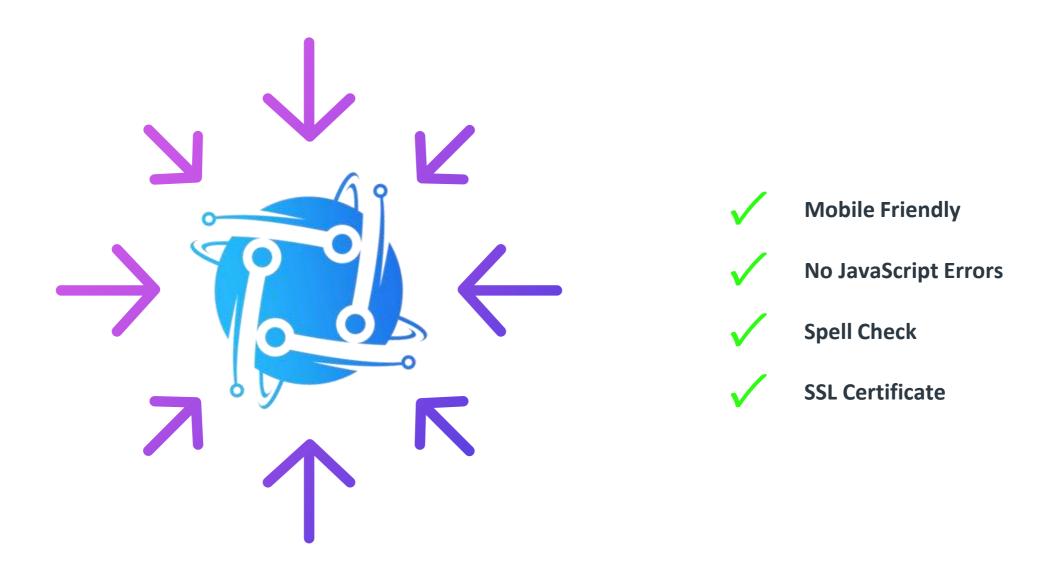

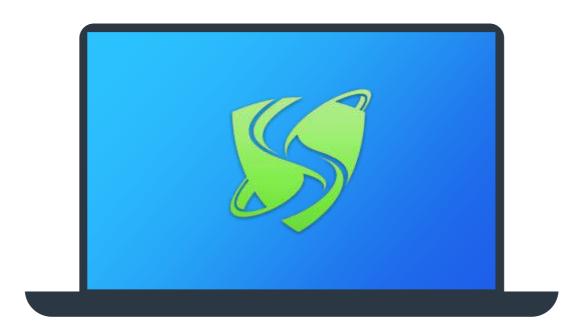






Location Audit

We were unable to identify a primary location for the project at this time or a location has not been declared.




