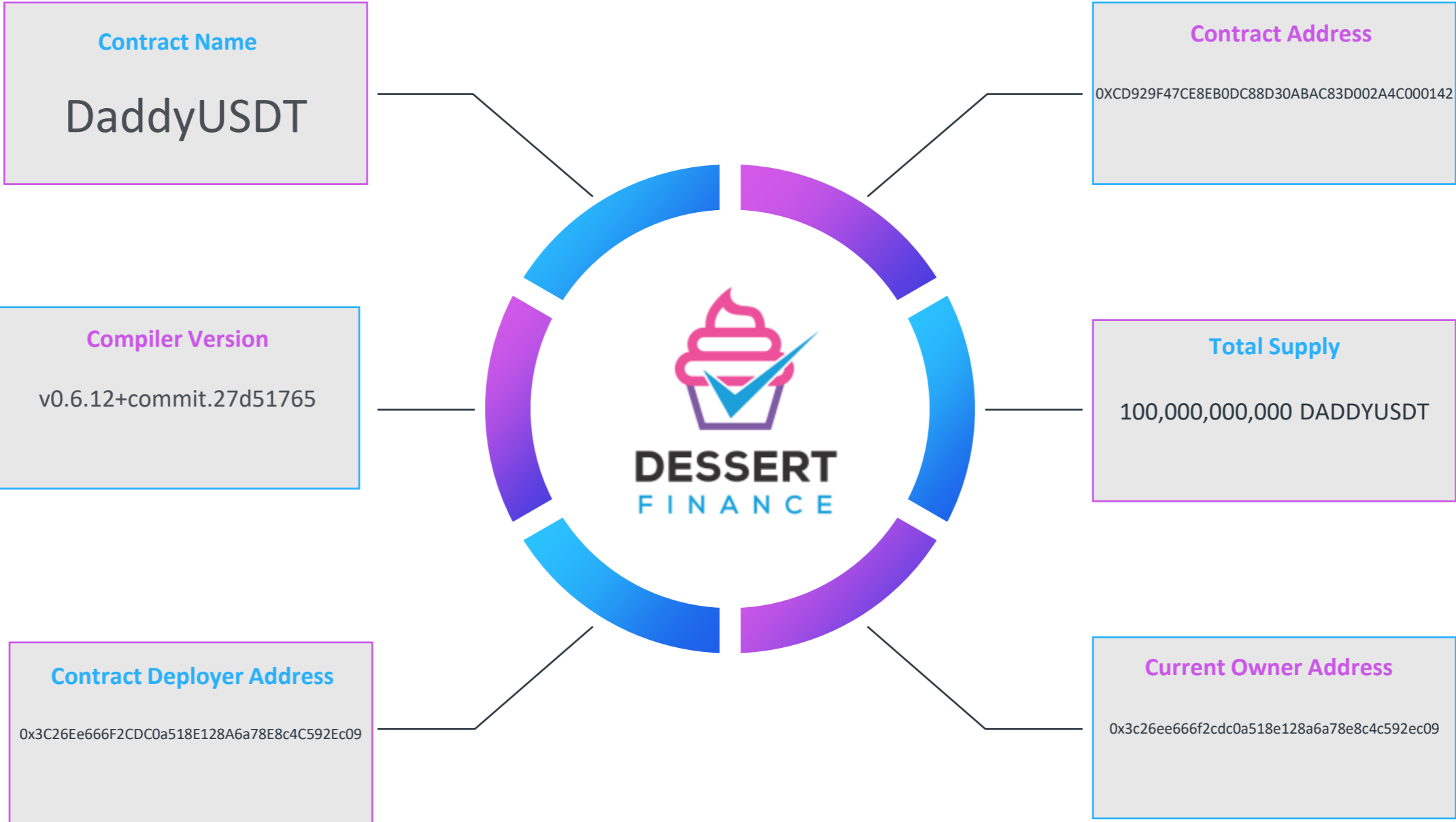

# Contract Transaction Fees

At the time of Audit the transaction fees (“tax”) listed below are the fees associated with trading. These fees are taken from every buy and sell transaction unless otherwise stated.

## Tokenomics



**2% Buy Baby and burn**  
On every transaction daddy will always buy 2% of BabyUSD and burn it.

**6% Redistribution In USDT**  
6% of every buy/sell is taken and redistributed to all holders. Hold \$DaddyUSD tokens, earn USDT. Minimum 200,000 tokens.

**Auto Paid Every 60 Minutes**  
You don't need to claim your earned USDT. It's automatically sent to your wallet every 60 minutes. Note: in periods of lower volume this may take longer, but you always get your USDT.

**1% Auto Liquidity Pool**  
1% of every transaction is transformed into liquidity for Pancakeswap. It's automatic and helps create a price floor (stability).

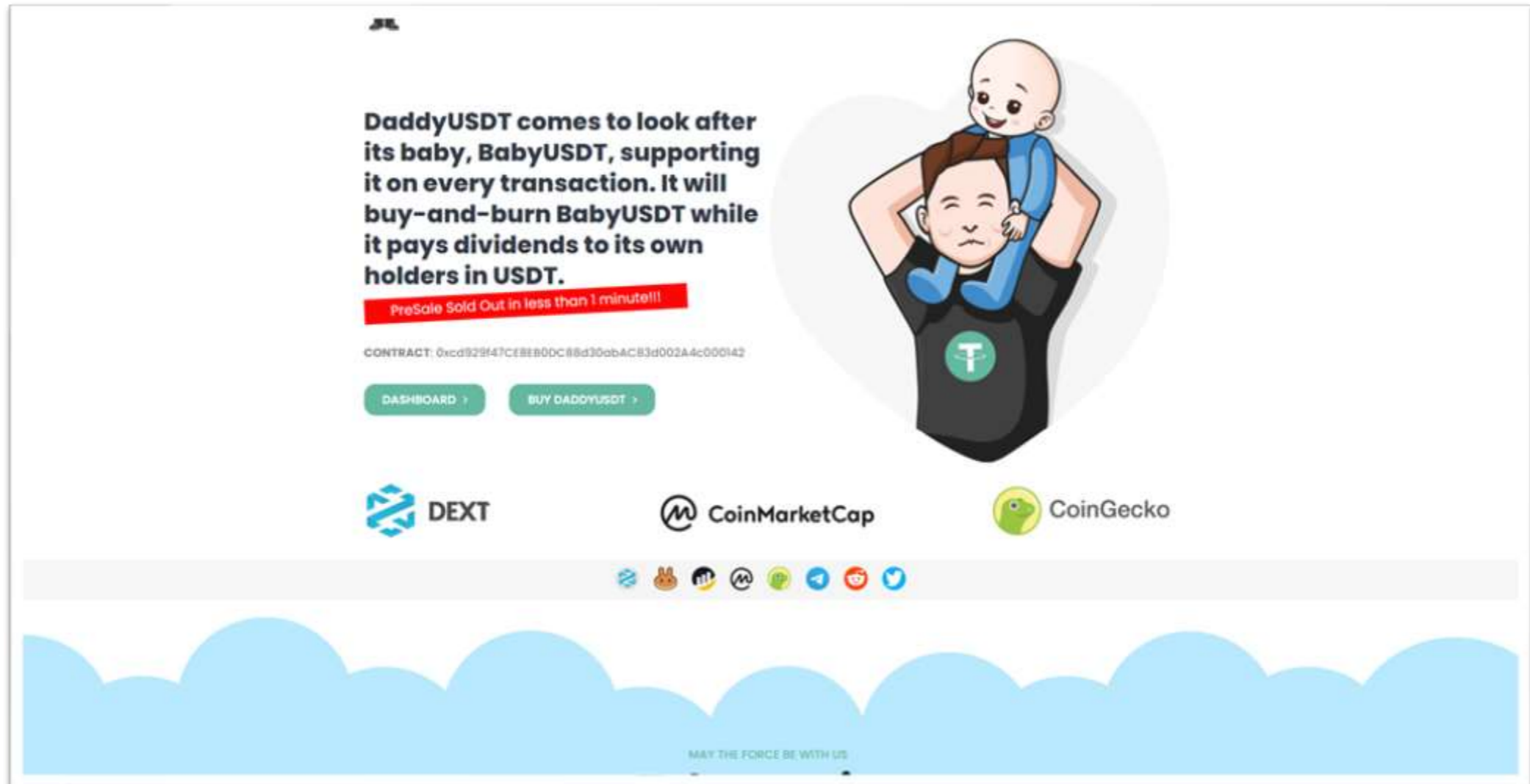
**Massive Marketing Plan**  
4% of every transaction is allocated to Marketing in USDT (swapped to USDT in real time to avoid dumps). So we can fuel the most ambitious projects and reward our active community.

**4% extra fee for sells**  
Extra 4% fee is applied to all sells. This will allow us to reduce swing-trading and break whales' control.

**Secured By Design**  
Initial Liquidity Provided will be locked with DXLock.

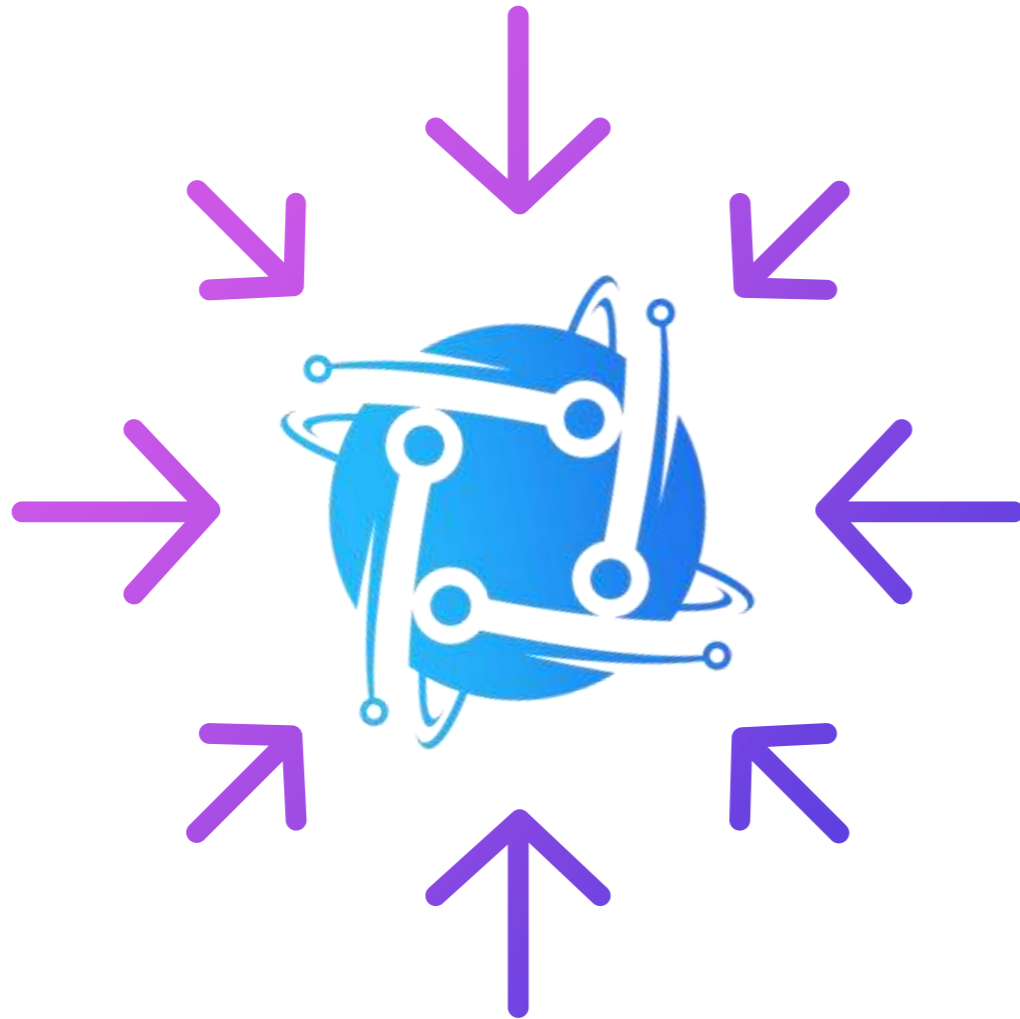
