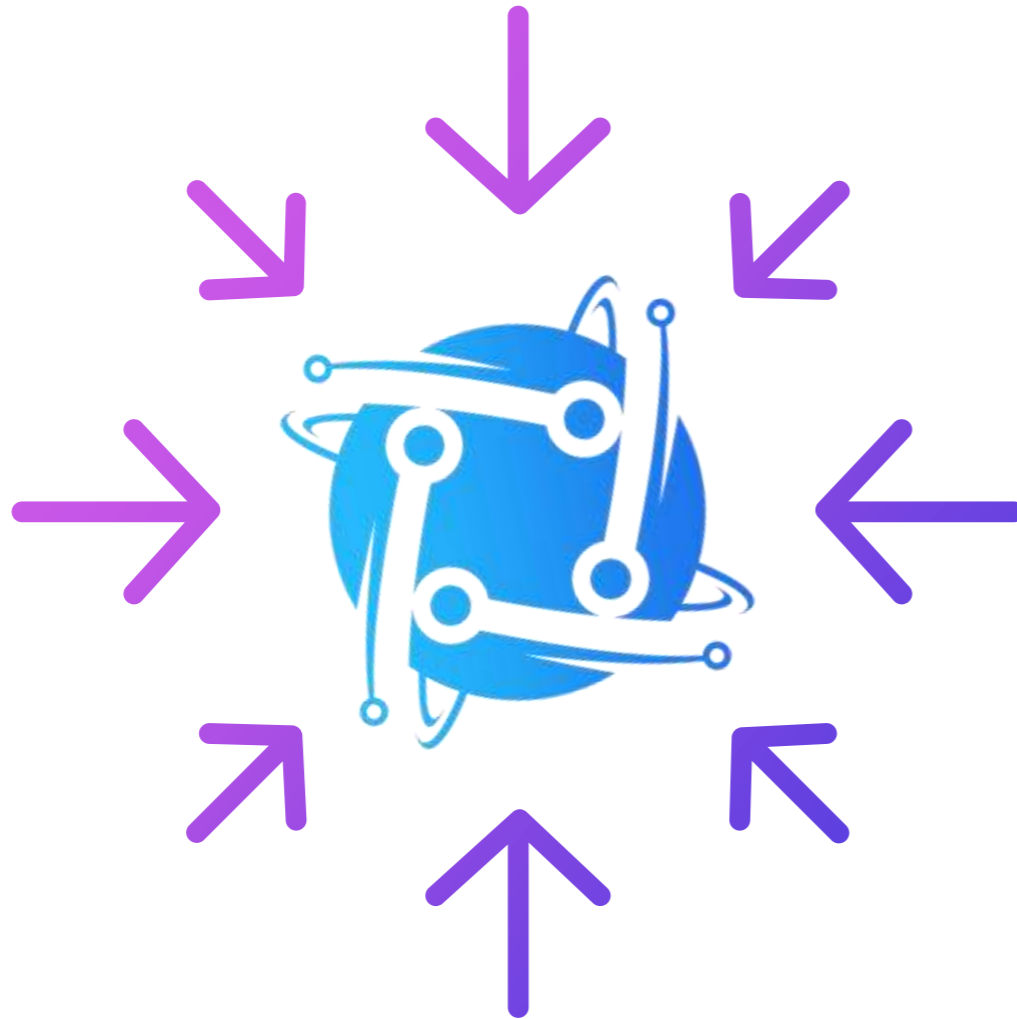

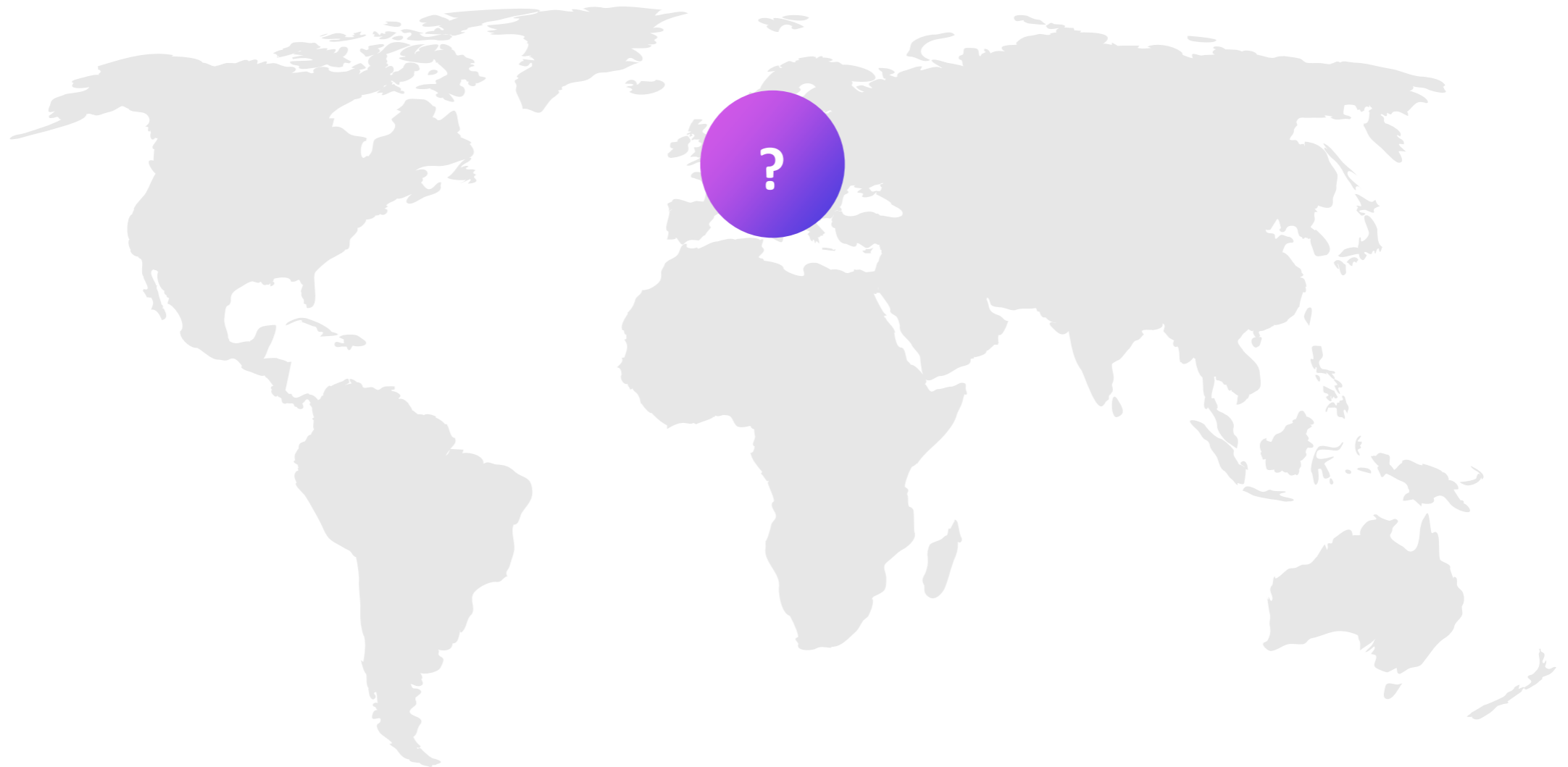
DogeMania Top 100 Token Holders

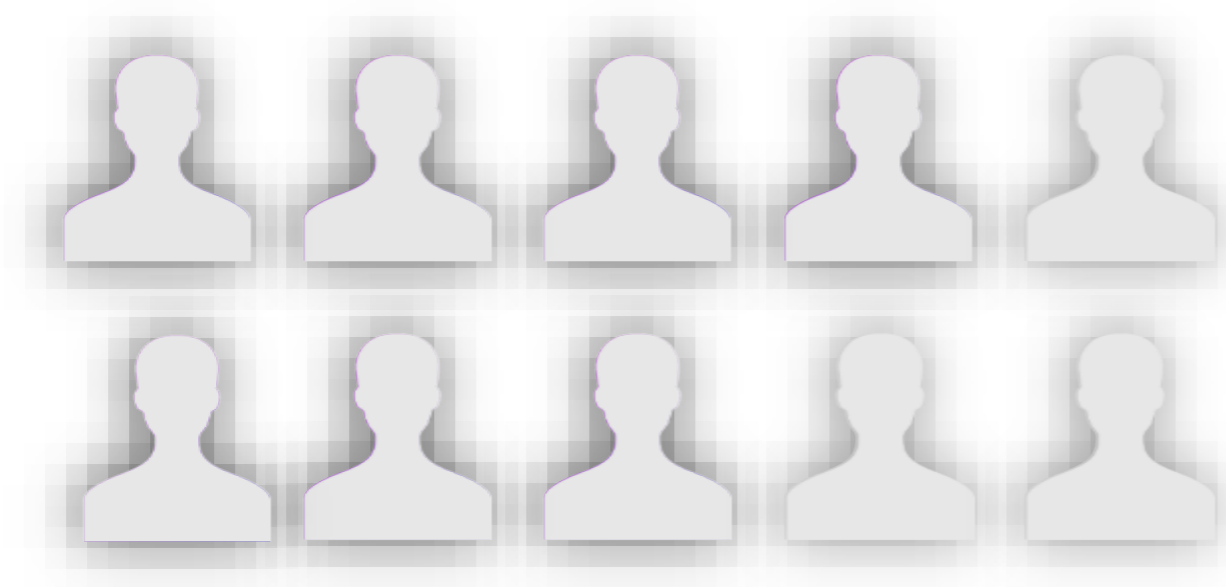

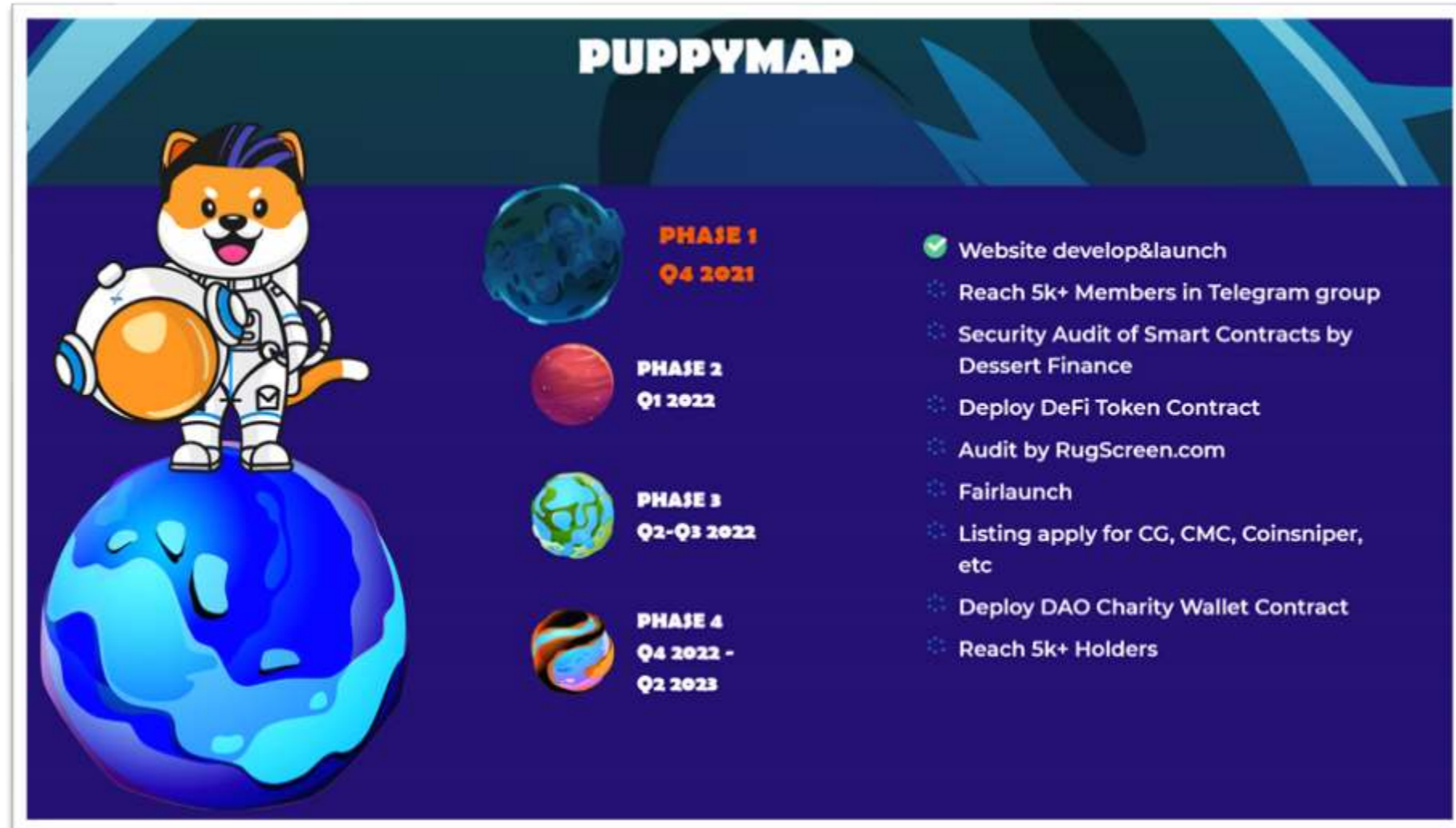
