

## **Tokenomics**

Liquidity 4%
Redistribution 2%
Marketing 3%
Dev wallet 3%

**Dogeville** has a total of **12%** tax on every transaction. For every buy/sell:

4% is taken and converted to the liquidity pool.

2% is redistributed back to the holders in BUSD.

3% is used for Marketing purposes.

3% is used for the updates of the game. This will be used to update our game constantly.




The website contained no JavaScript errors. No typos, or grammatical errors were present, and we found a valid SSL certificate allowing for access via https.


