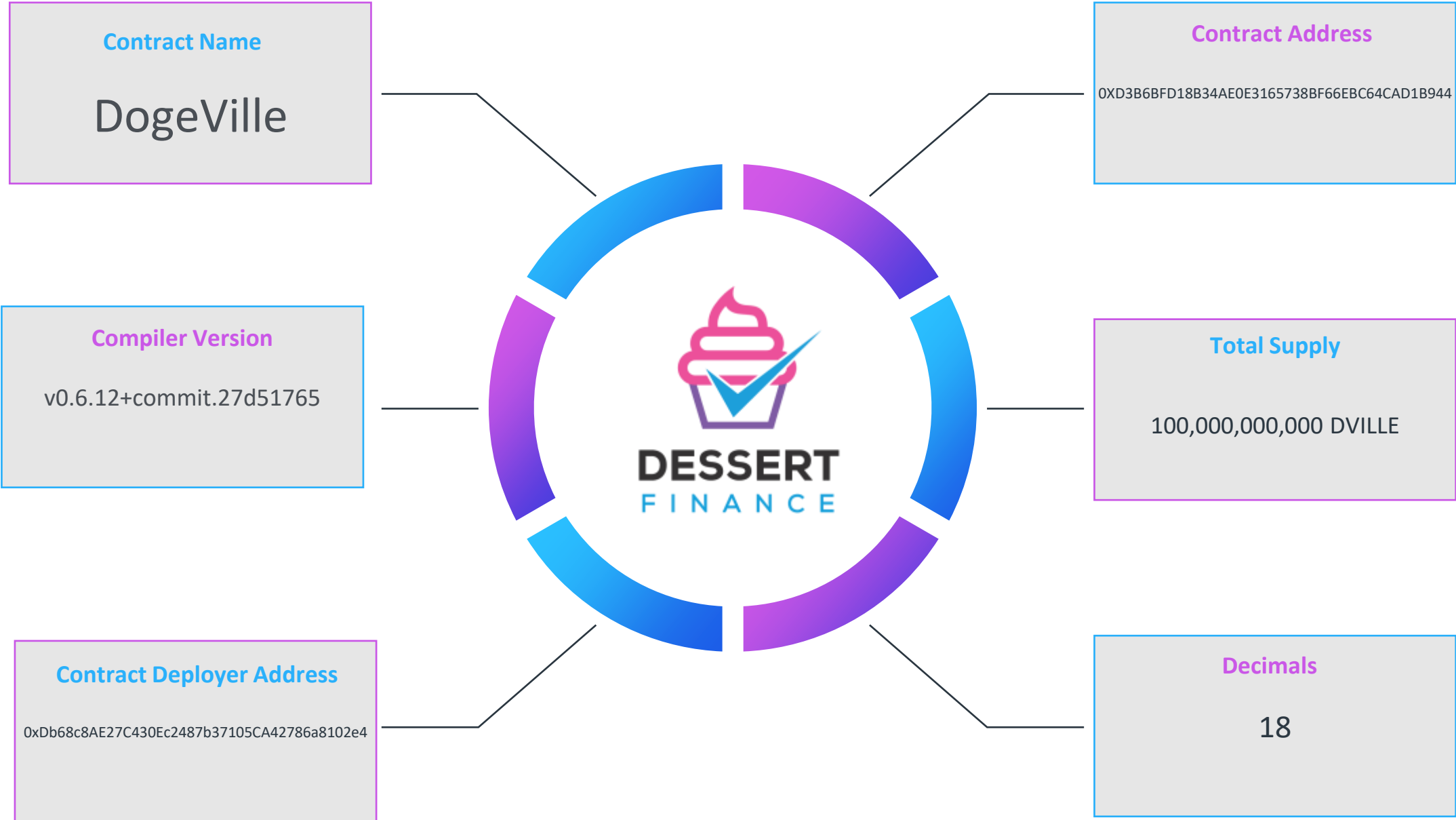

We do understand that sometimes mint functions are essential to the functionality of the project.

A mint function was not found in the contract code.

Contract Transaction Fees

At the time of Audit the transaction fees (“tax”) listed below are the fees associated with trading. These fees are taken from every buy and sell transaction unless otherwise stated.

Tokenomics

- Liquidity 4%
- Redistribution 2%
- Marketing 3%
- Dev wallet 3%

Dogeville has a total of **12%** tax on every transaction. For every buy/sell:

- 4%** is taken and converted to the liquidity pool.
- 2%** is redistributed back to the holders in BUSD.
- 3%** is used for Marketing purposes.
- 3%** is used for the updates of the game. This will be used to update our game constantly.

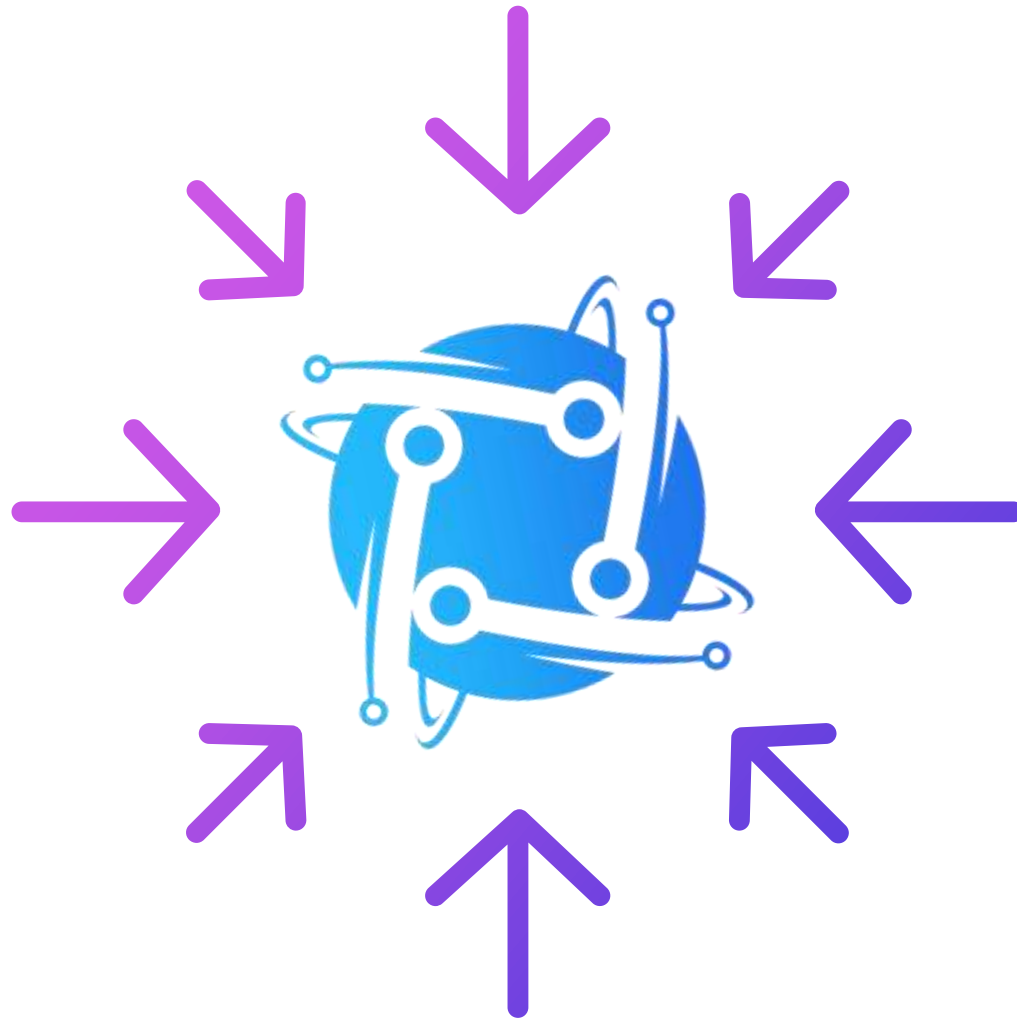
