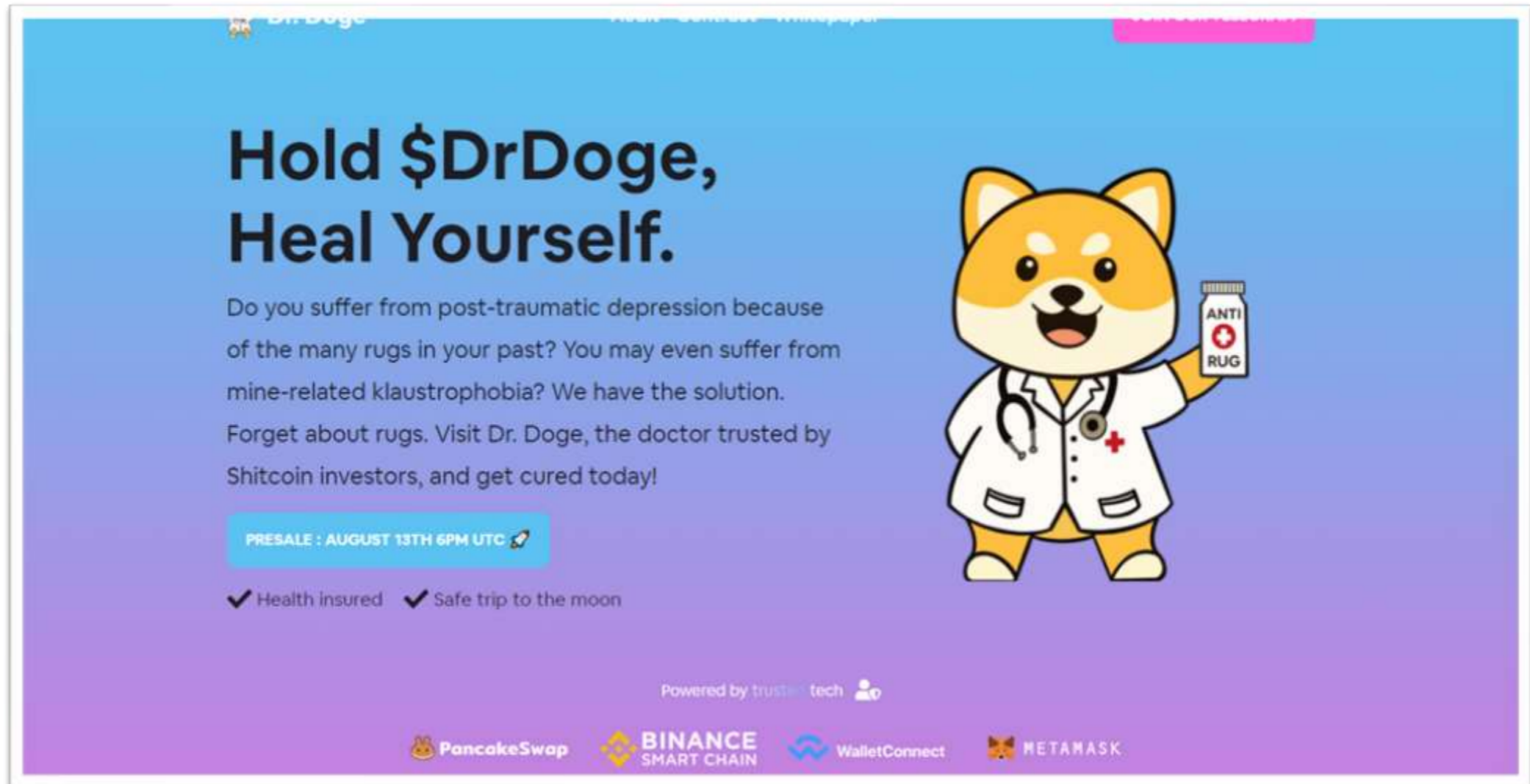

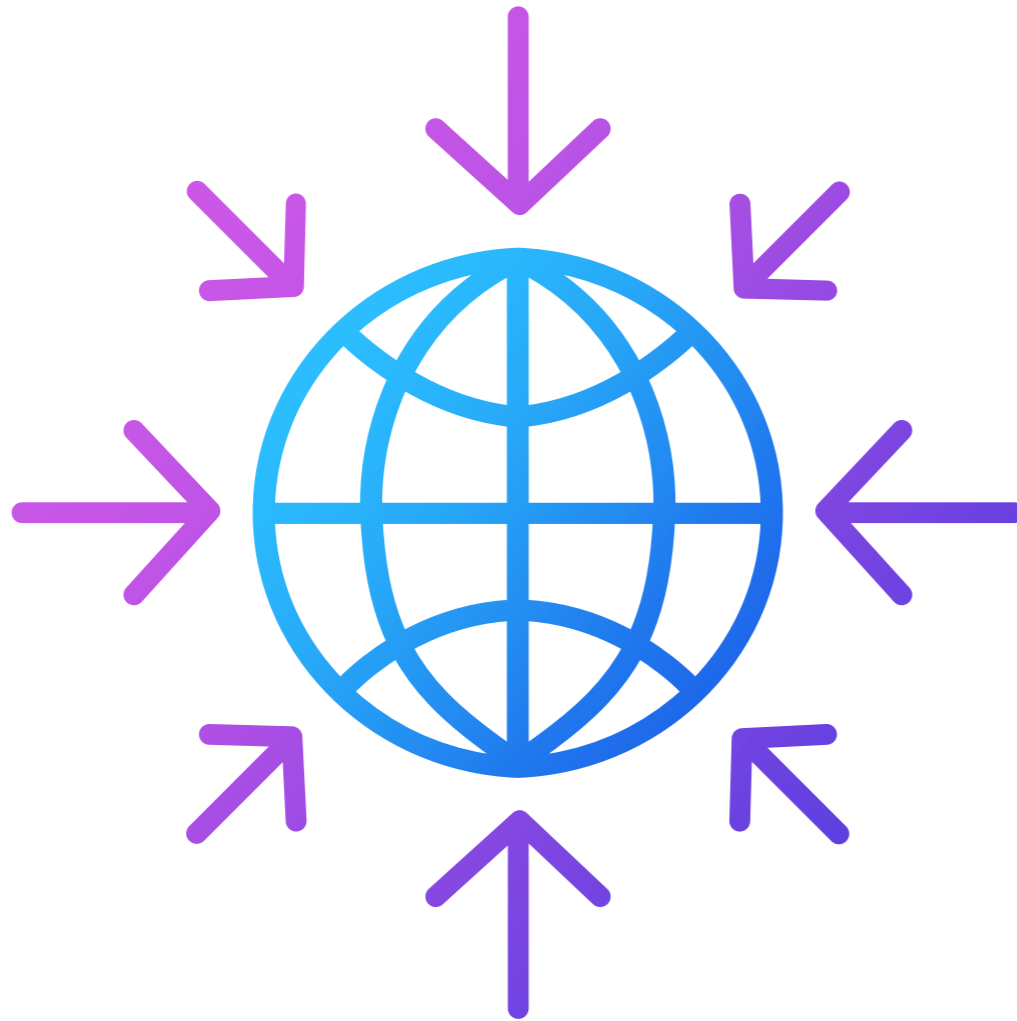

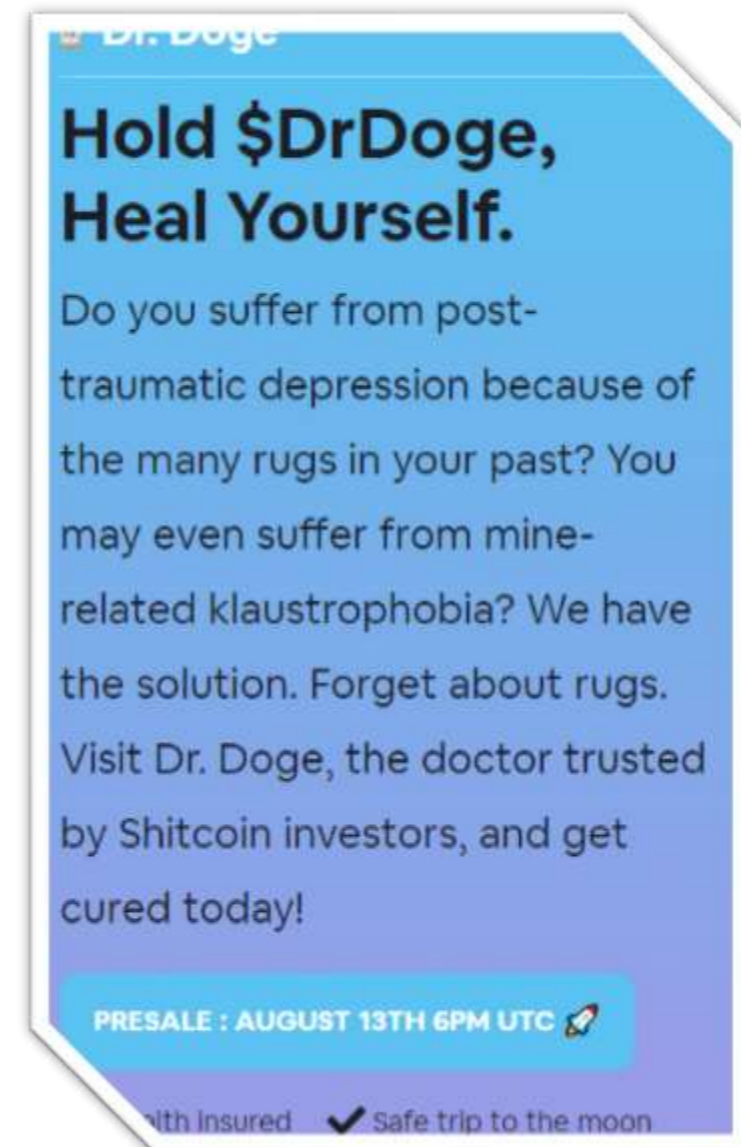
The website contained no JavaScript errors. No typos, or grammatical errors were present, and we found a valid SSL certificate allowing for access via https.

Social and Web – Final Thoughts & Suggestions for Improvement

We were able to track down multiple social media channels for the project. Social Media channels included Twitter, Telegram, Reddit, Medium, Instagram and TikTok. All social media channels had a healthy amount of activity.

It is important to note that there is an 17% tax on EVERY buy transaction and a 20% tax on EVERY sell transaction. 3% goes to providing liquidity, 10% is distributed to the token holders in DOGE coin, 2% of every transaction will be sent back to the development team for marketing purposes and 2% is sent back to the team.

Dessert Finance appreciates projects that self identify as meme coins without the need to solve a greater purpose as long as it is clearly stated as in the case with Dr. Doge.

Suggestions for Improvement

1. TikTok was the only social media with no content posted, consider adding content for further market reach

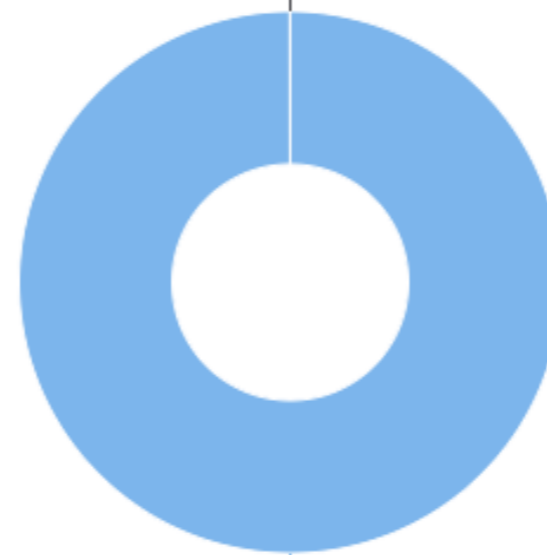
