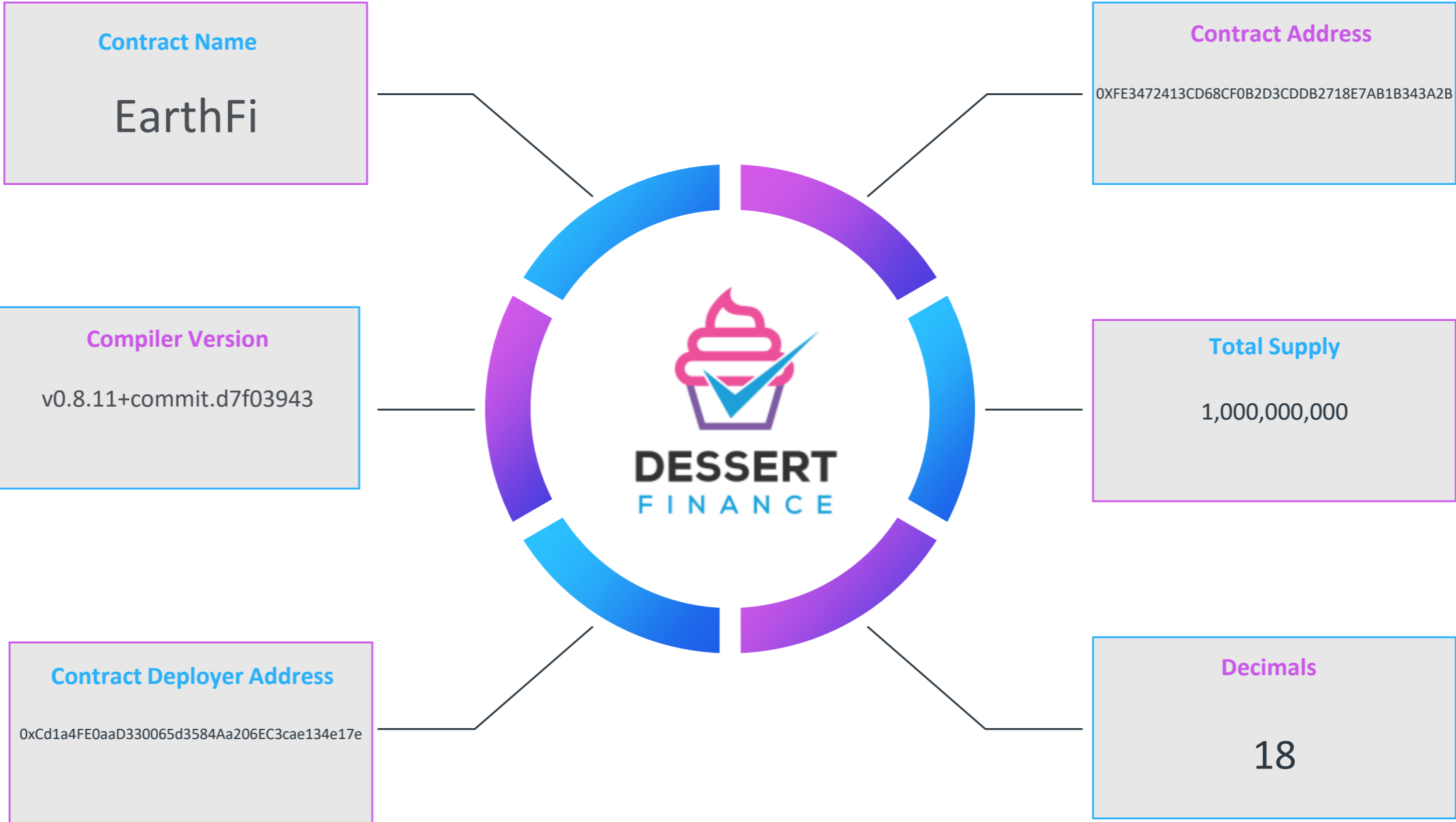

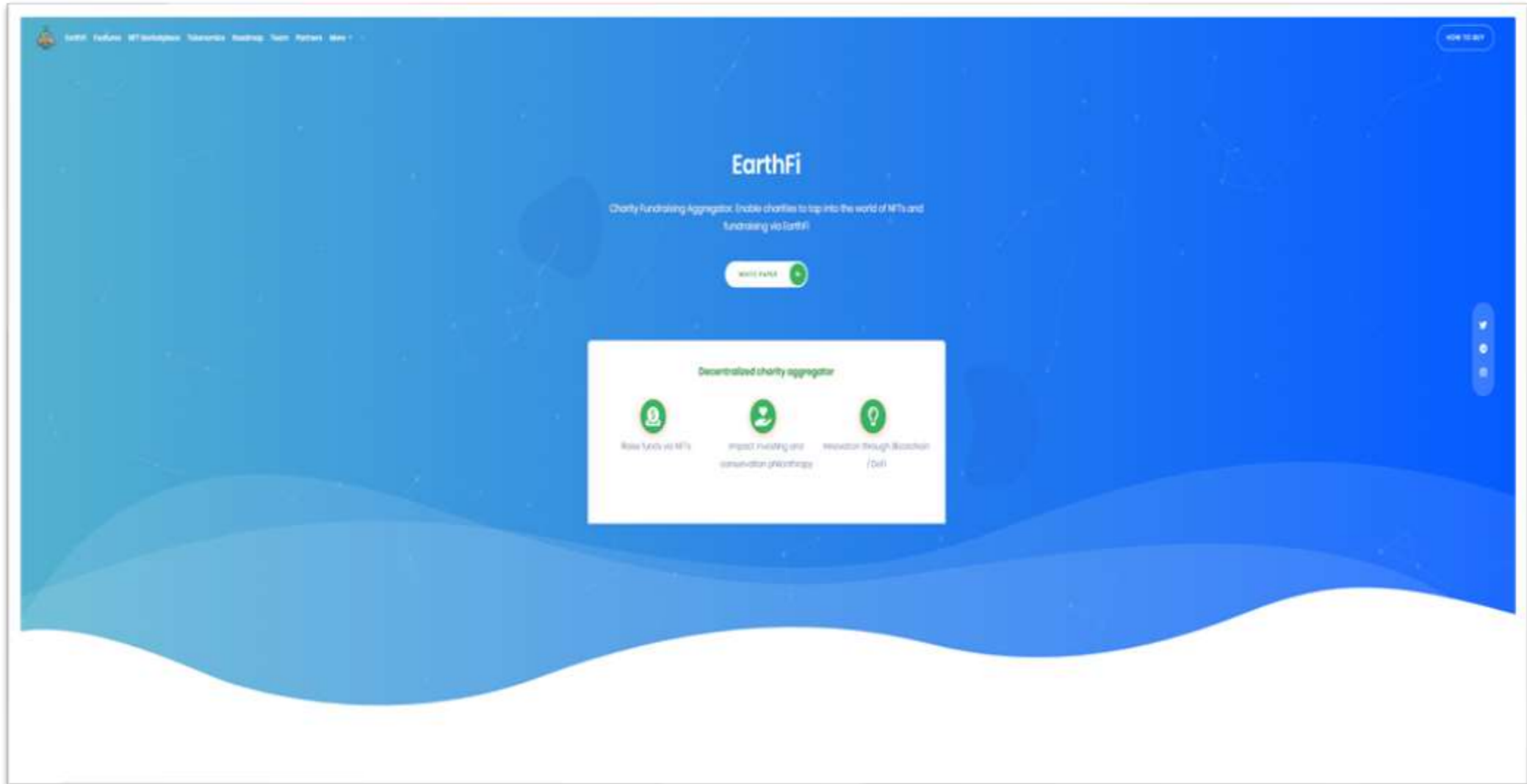

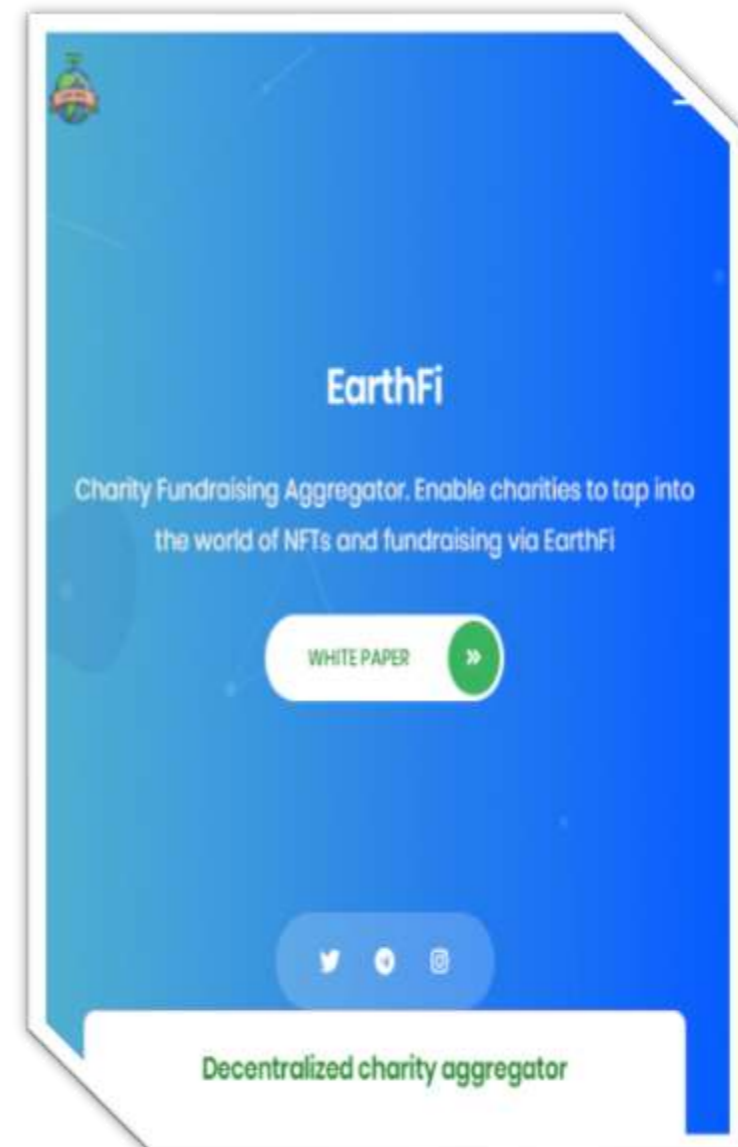
The website contained no JavaScript errors. No typos, or grammatical errors were present, and we were able to find a valid SSL certificate allowing for access via https.

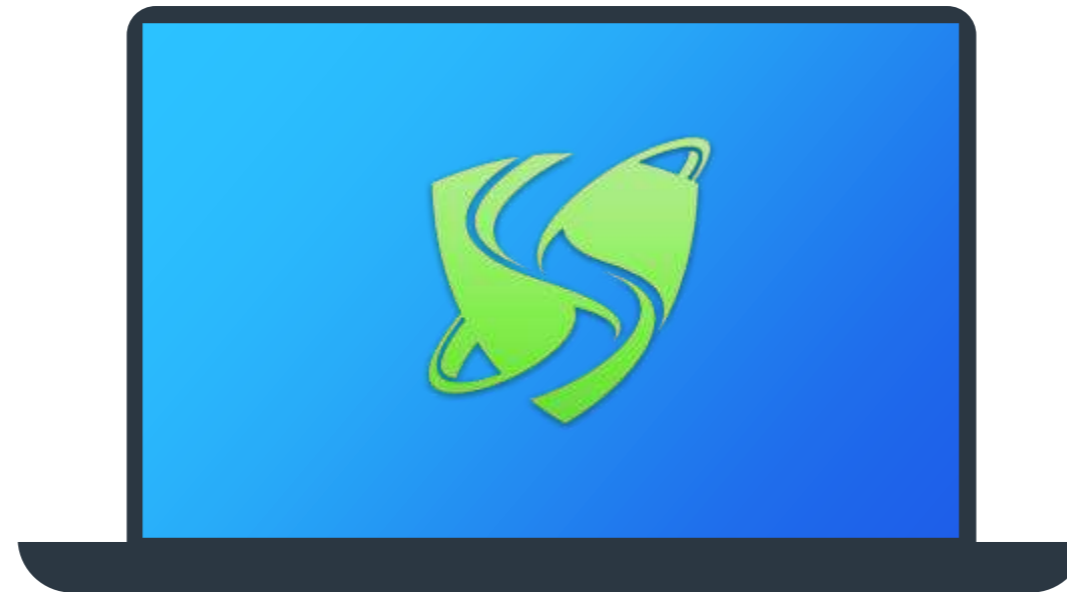

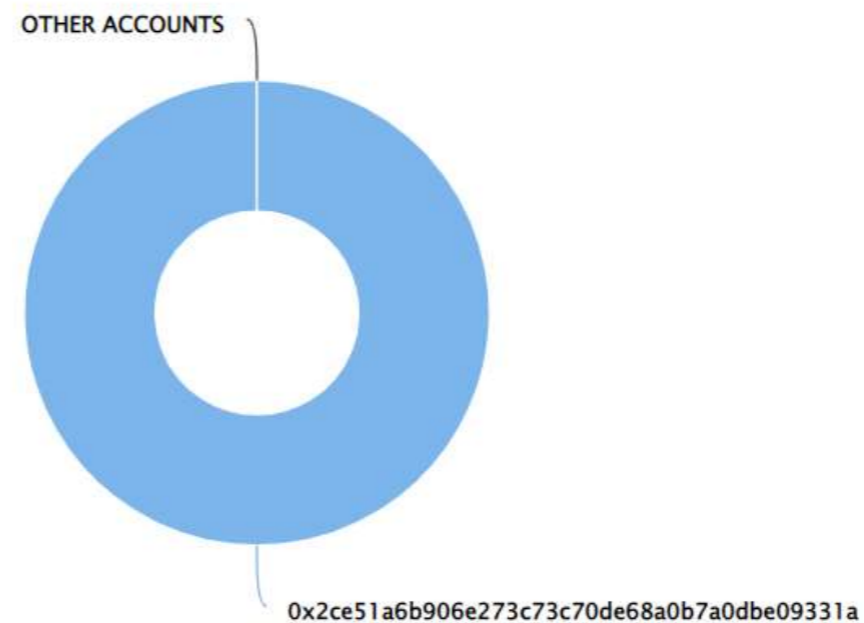

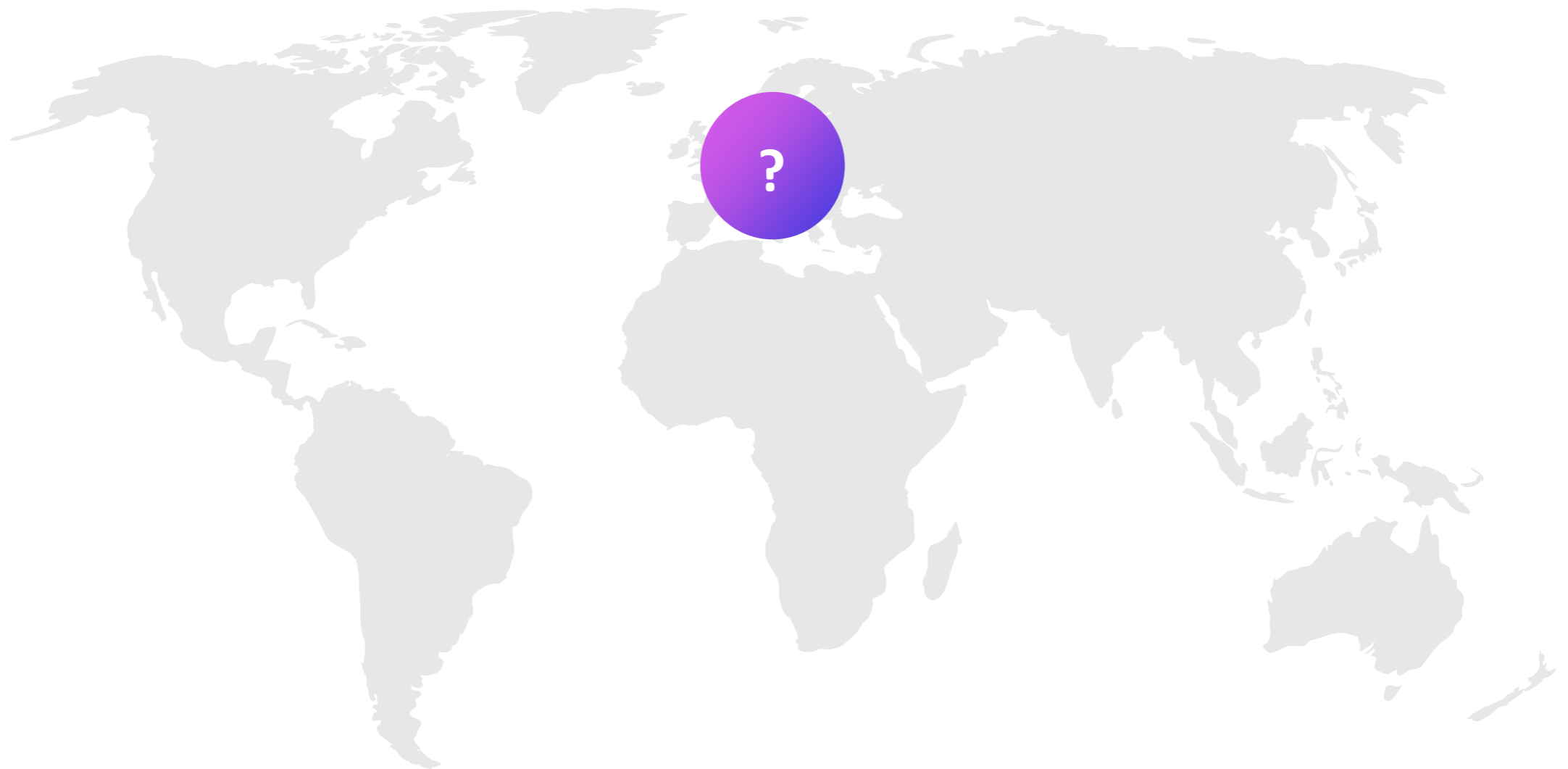
