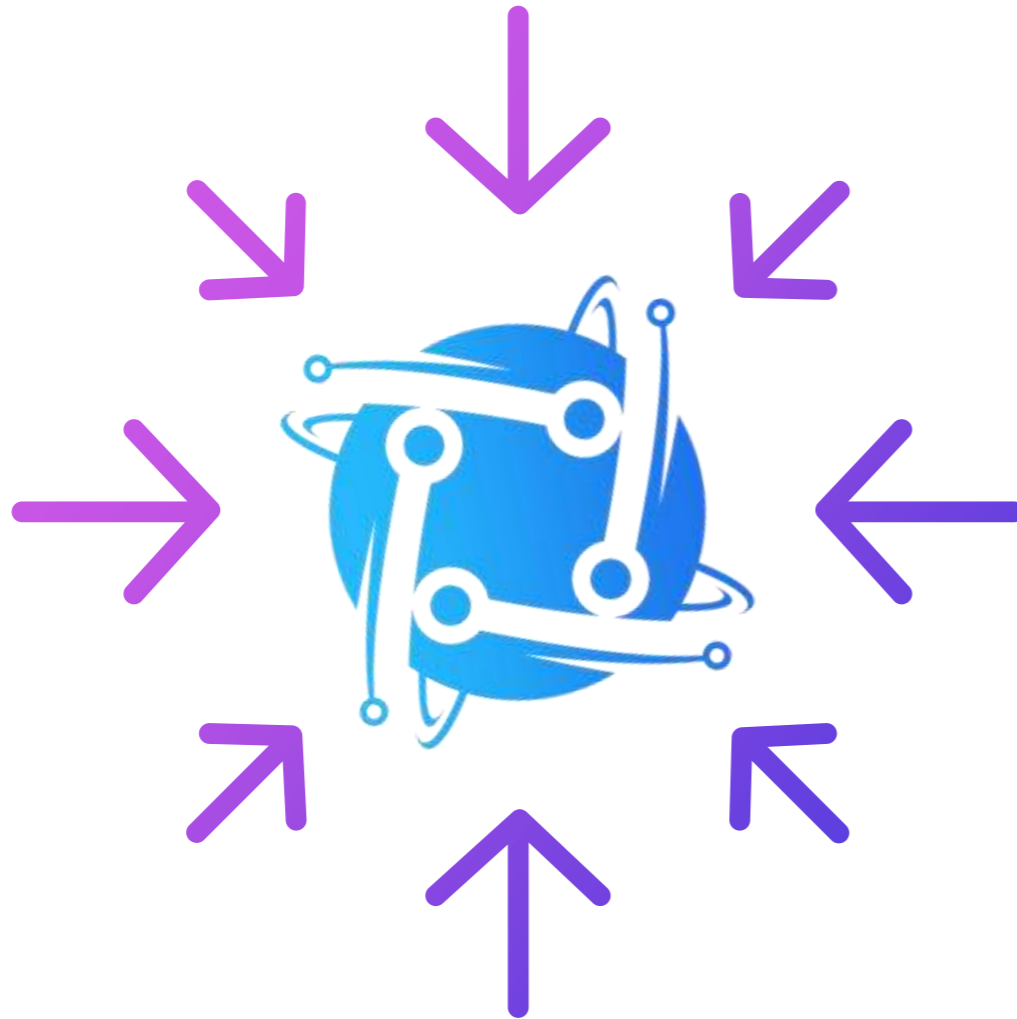

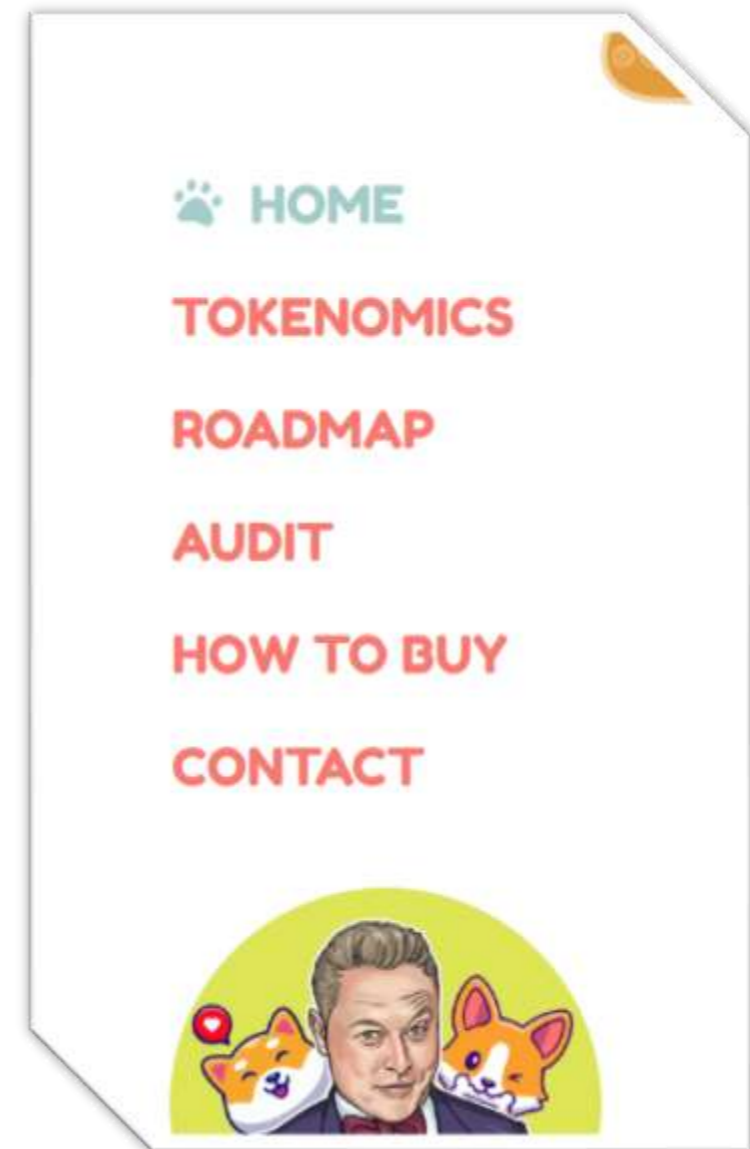
The website contained no JavaScript errors. No typos, or grammatical errors were present, and we did not find a valid SSL certificate allowing for access via https.

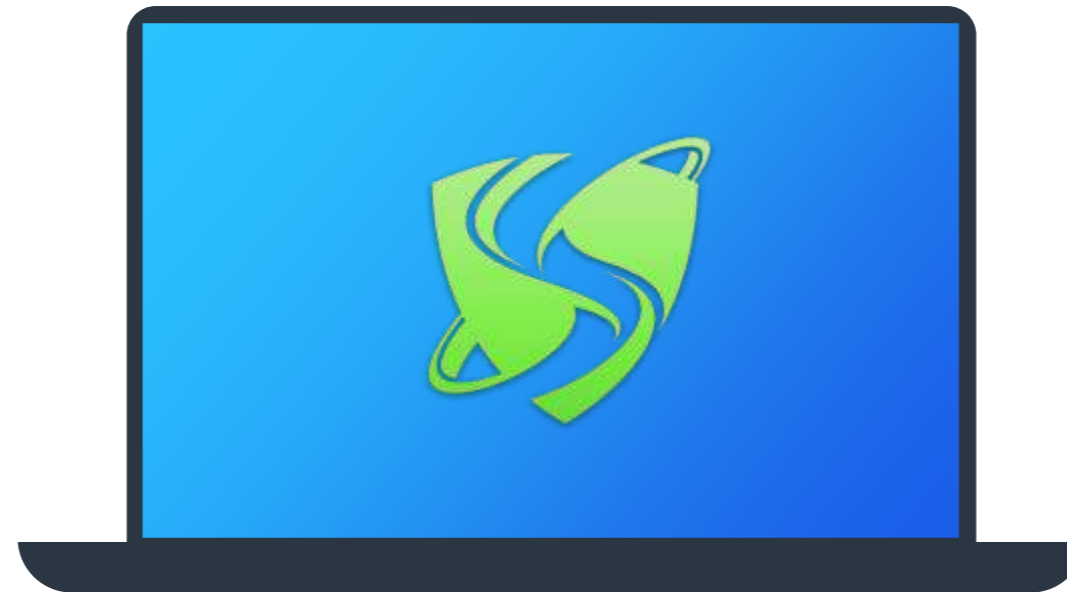

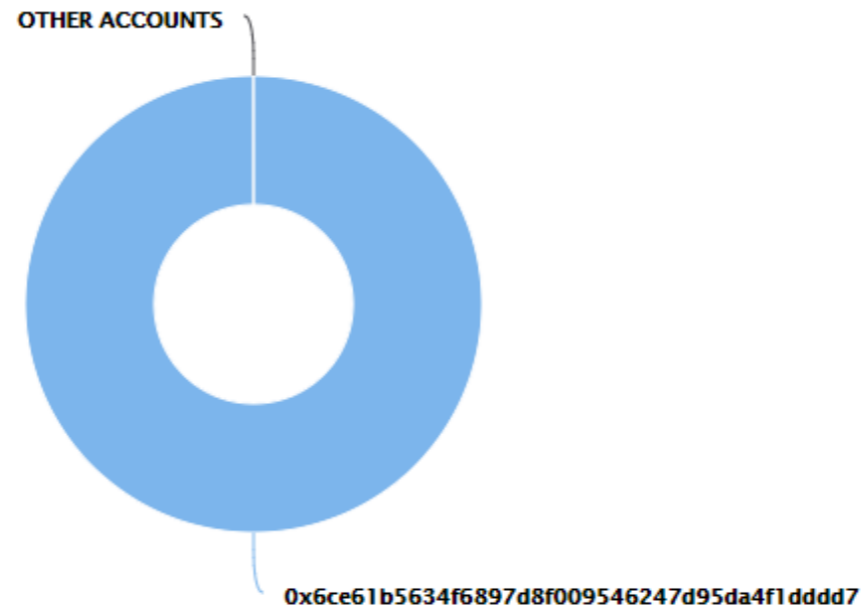

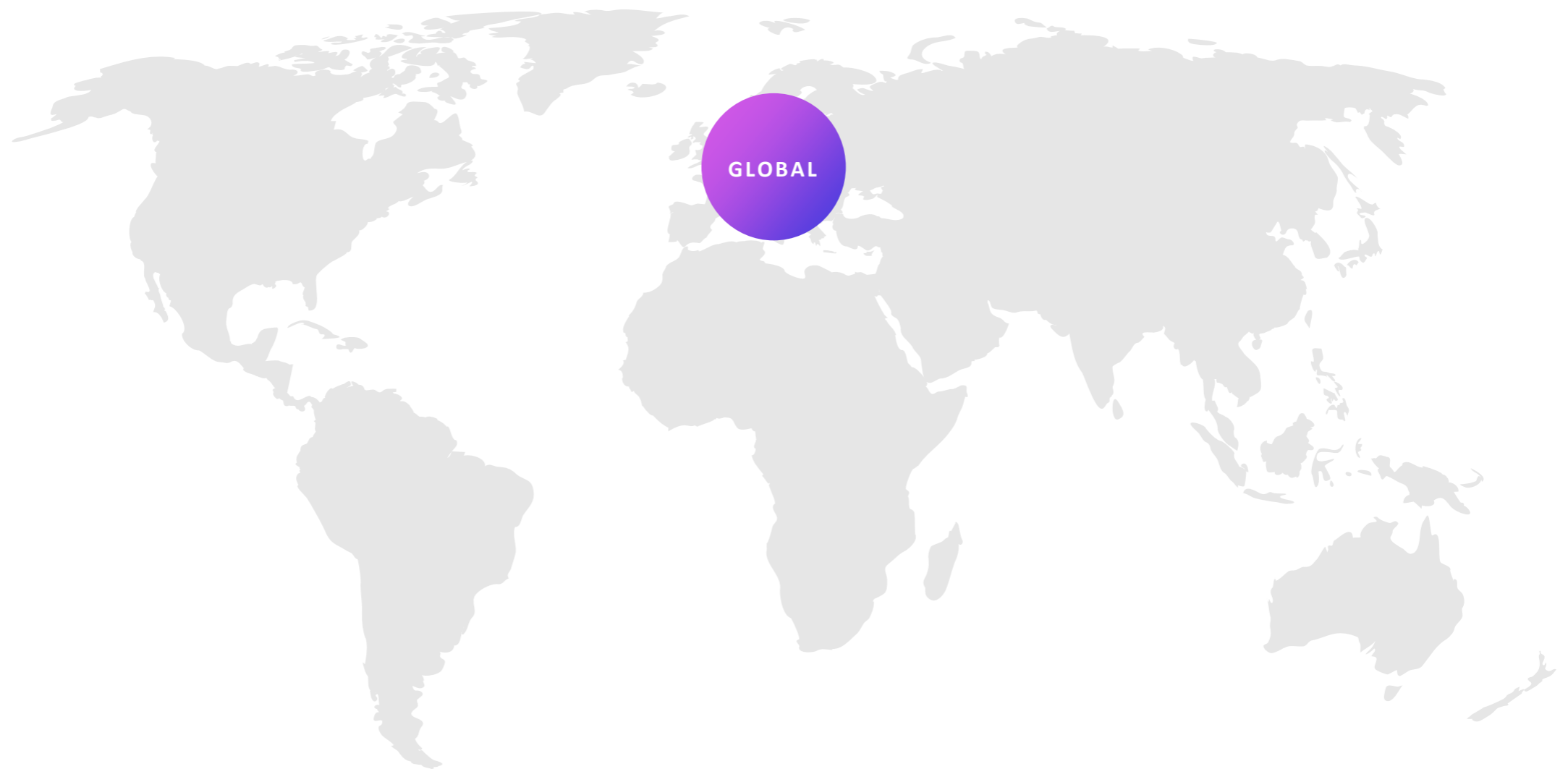
ElonPetsKingdom Top 100 Token Holders

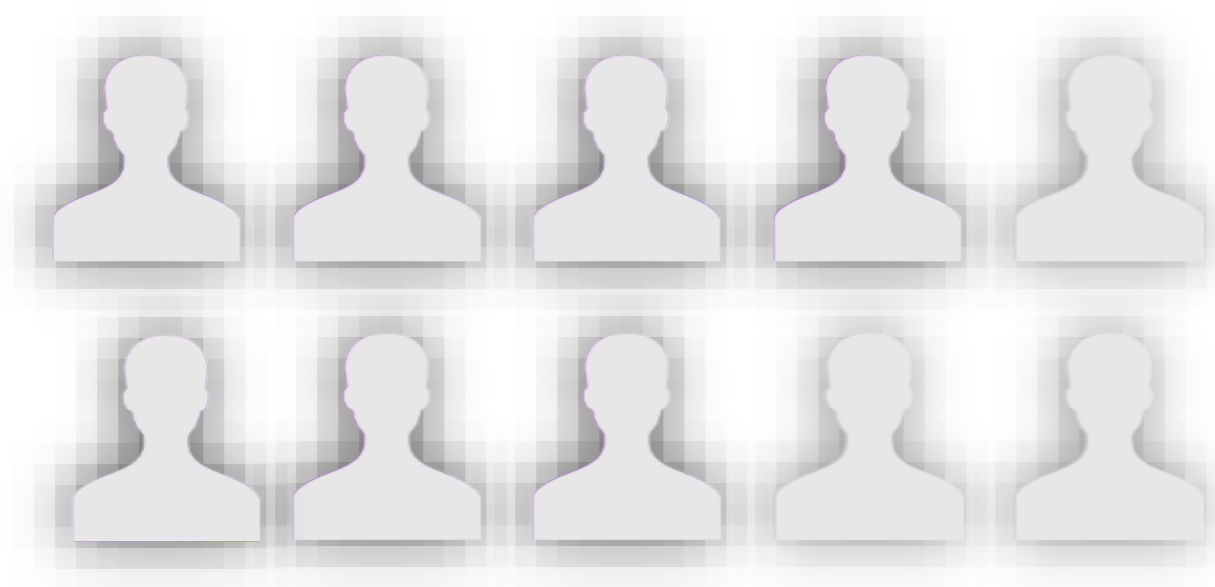
