

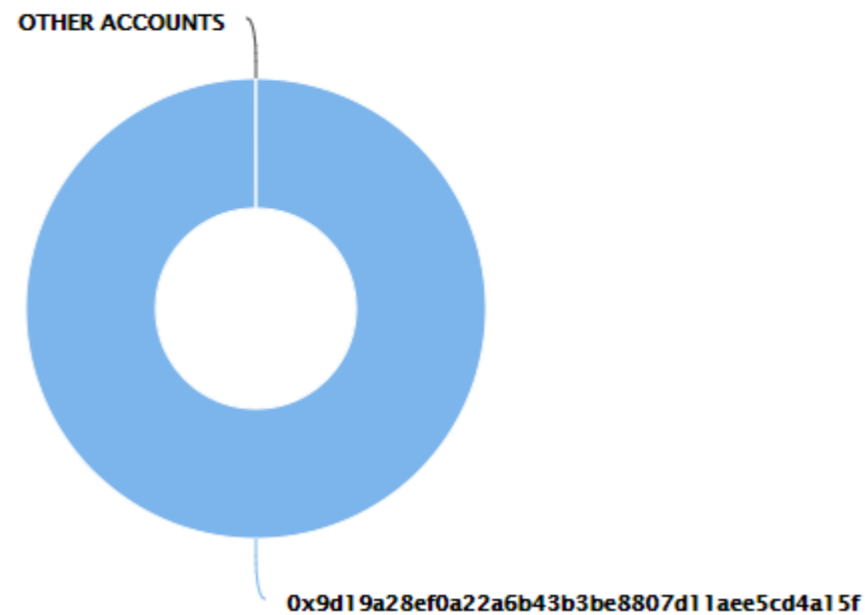

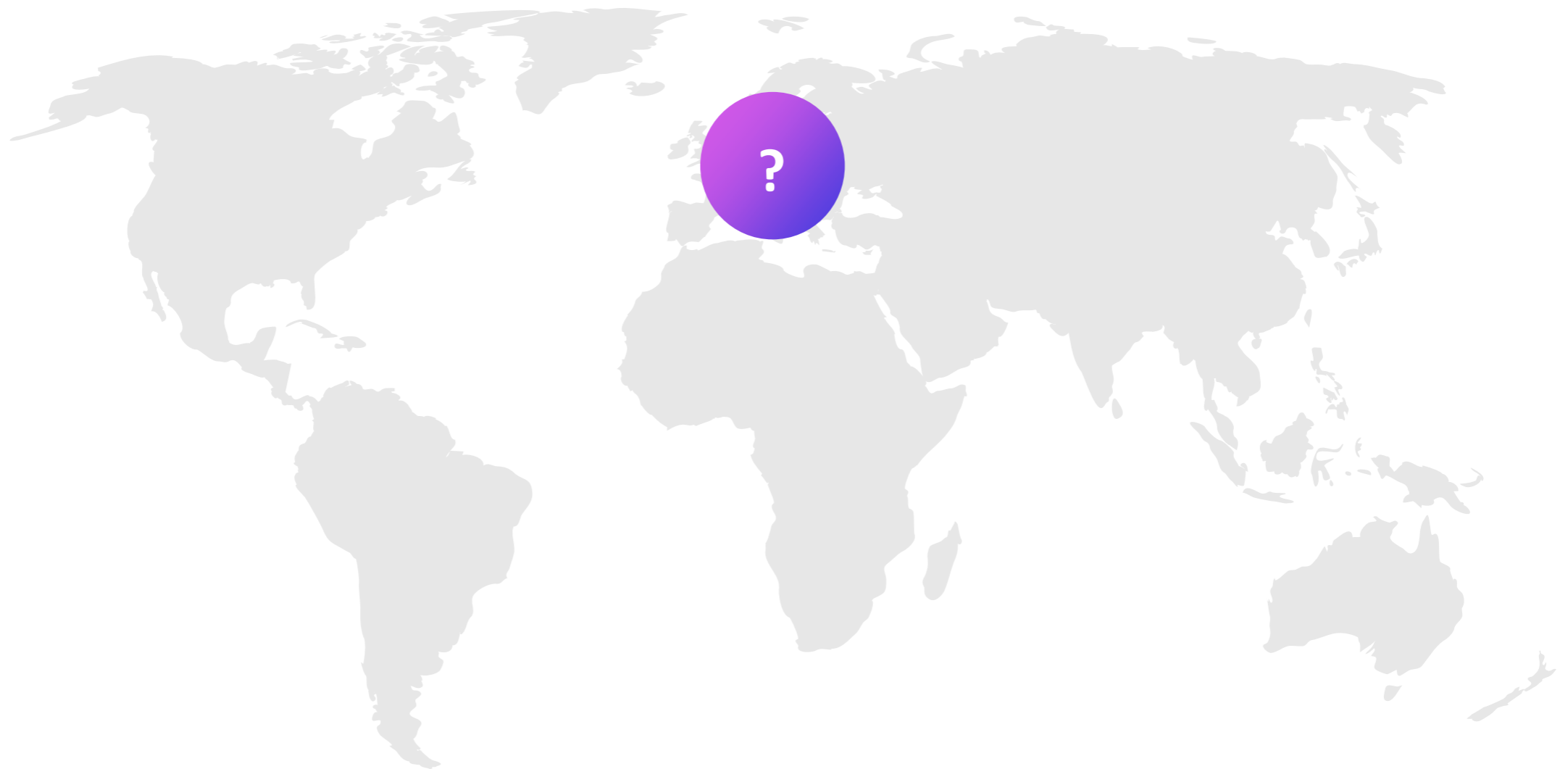
Emperor Doge Top 100 Token Holders

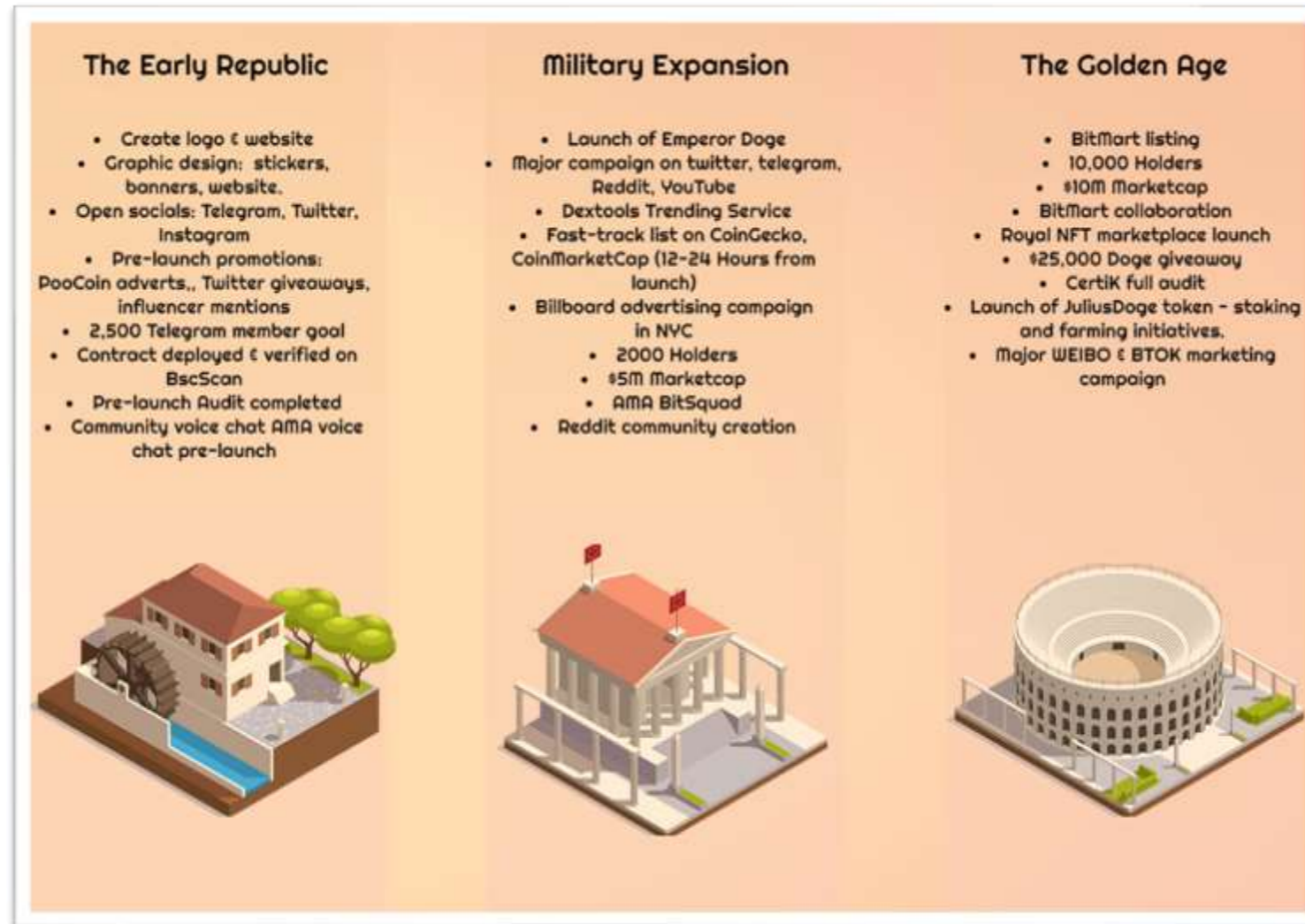
