

# Website Part 1 – Overview <u>www.fiestacoin.org</u>

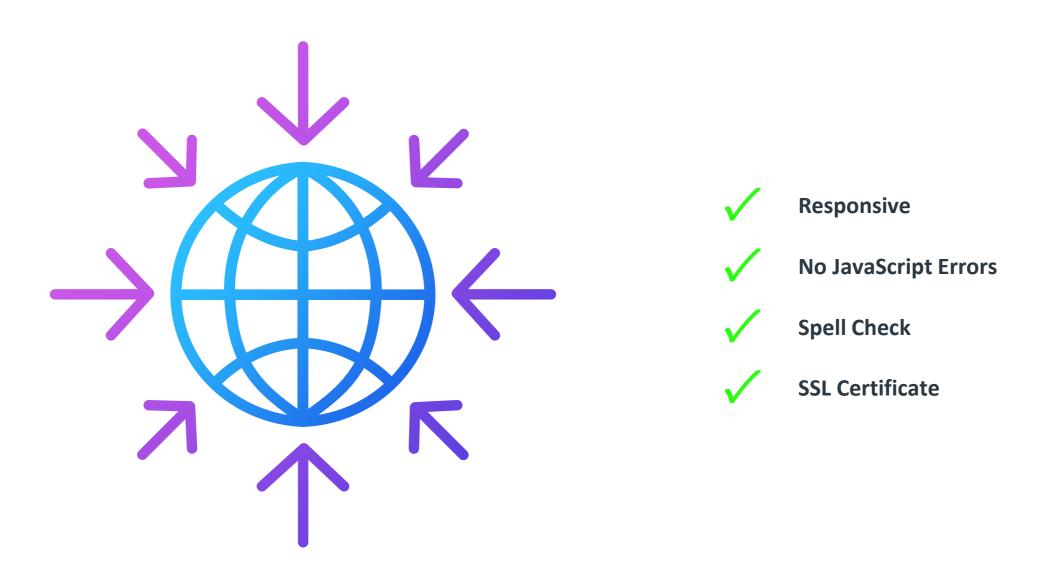


Above images are actual snapshots of the current live website of the project. Website was registered on 04/27/2021, registration expires 04/27/2025.

The website contained no JavaScript errors. No typos, or grammatical errors were present, and we found a valid SSL certificate allowing for access via https.


No additional issues were found on the website.

## Website Part 3 – Responsive HTML5 & CSS3



No minor or severe JavaScript errors were found. No issues with loading elements, code, or stylesheets.




The contract code is verified on BSCScan.

# Social and Web – Final Thoughts & Suggestions for Improvement

We were able to track down multiple social media channels for the project. Social Media channels included Twitter, Telegram, Reddit, Discord, and Facebook. All social media channels had a healthy amount of activity.

It is important to note that there is an 10% tax on EVERY transaction including buys and sells. 5% goes directly to token holders, 3% is burned forever, 1% goes to the development wallet, and 1% is granted to the Fiesta Philanthropy wallet.

According to the whitepaper: "*Philanthropy grants* will be awarded to projects that are hand-clicked from a limited list of entries by the Fiesta community, who will act as the judge and jury for all types of small and elaborate acts alike."


#### **Suggestions for Improvement**


We were able to identify the primary project location as Romania.






