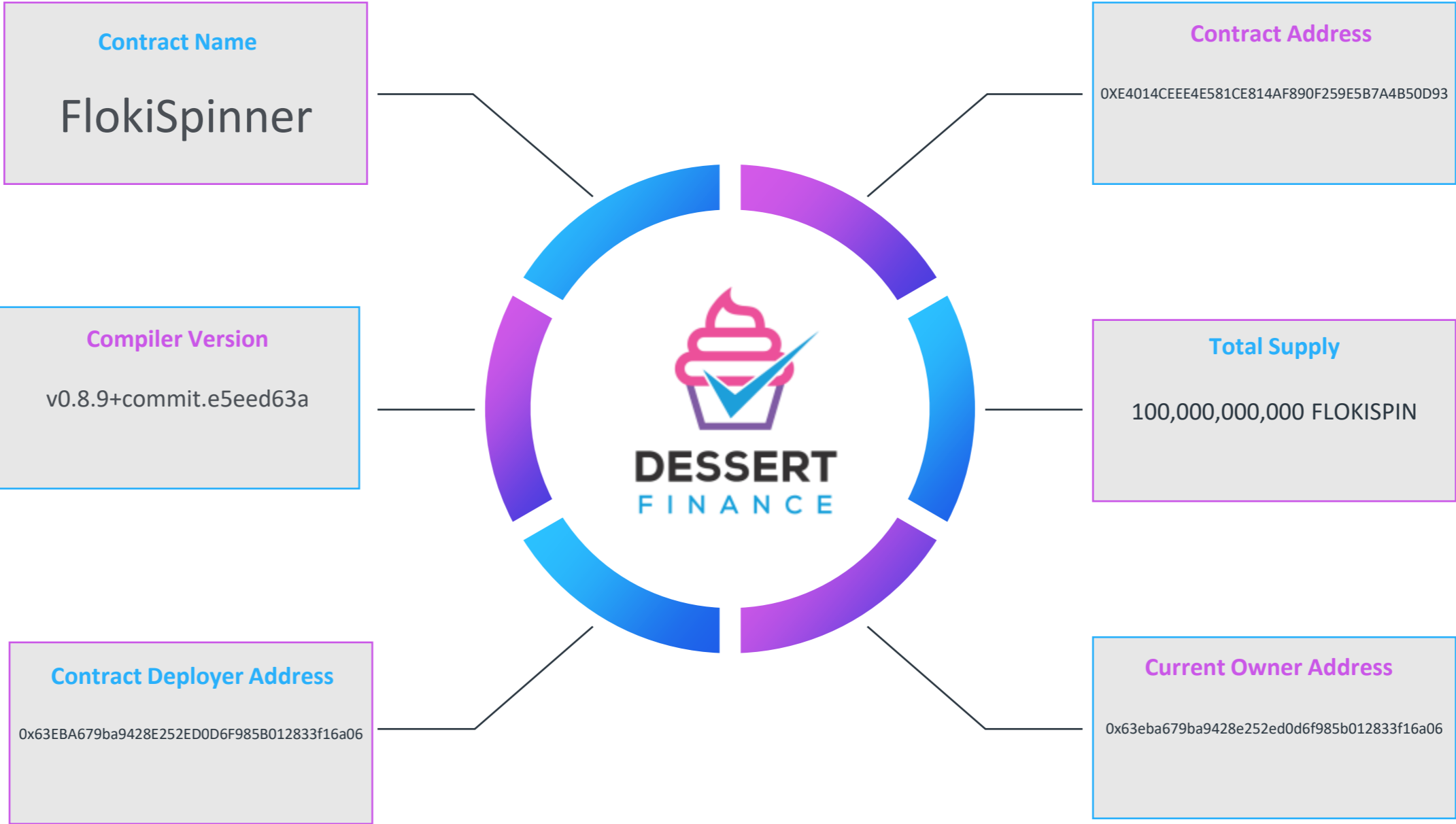

FlokiSpinner has an advanced set of fees designed to enable a forever raising price floor. A small portion of each transaction is taken to fund a community-focused jackpot game, multiple buyback mechanisms, and liquidity.

In addition, instead of the conventional high fee structures seen on many projects, we offset more of the fee to the sellers to ensure that their money ends up in the pockets of long term HODLers like yourself!

Fee Category	Buy	Sell
Jackpot Fee Money that's sent to the community jackpot pool, used to pay out prizes in our spin wheel game.	2%	2%
Buyback Fee Money that's set aside to be pumped into the token and burned forever, whenever the community says.	2%	8%
Liquidity Fee Money that's added to liquidity and burnt forever, creating an ever increasing price floor.	2%	2%
M & D Fee Money reinvested into marketing and development, to reach more buyers and make you more money.	2%	4%
Operations Fee Money spent towards maintaining current and further operations, including our NFTs and games.	2%	4%
