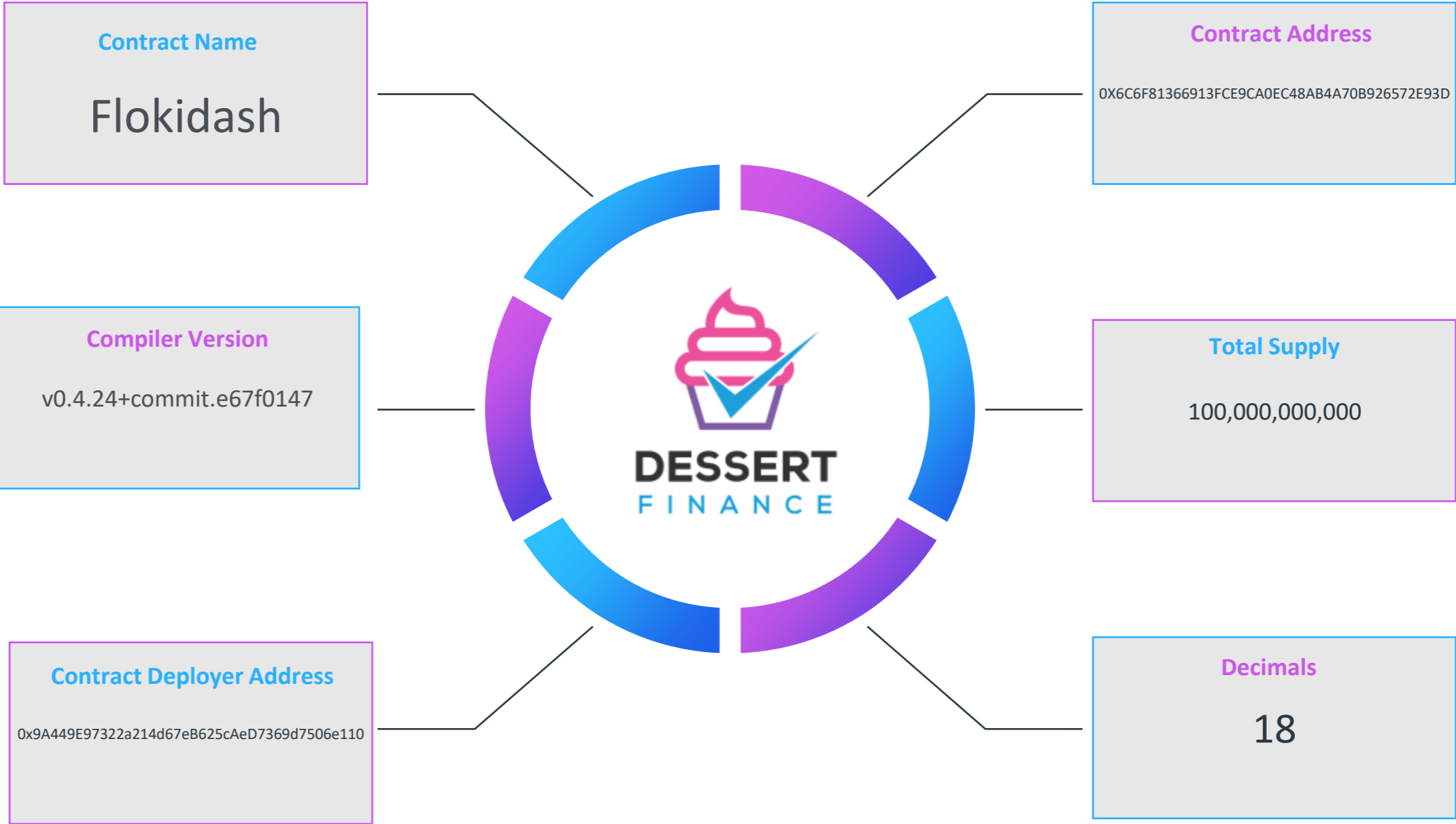

A mint function was not found in the contract code.

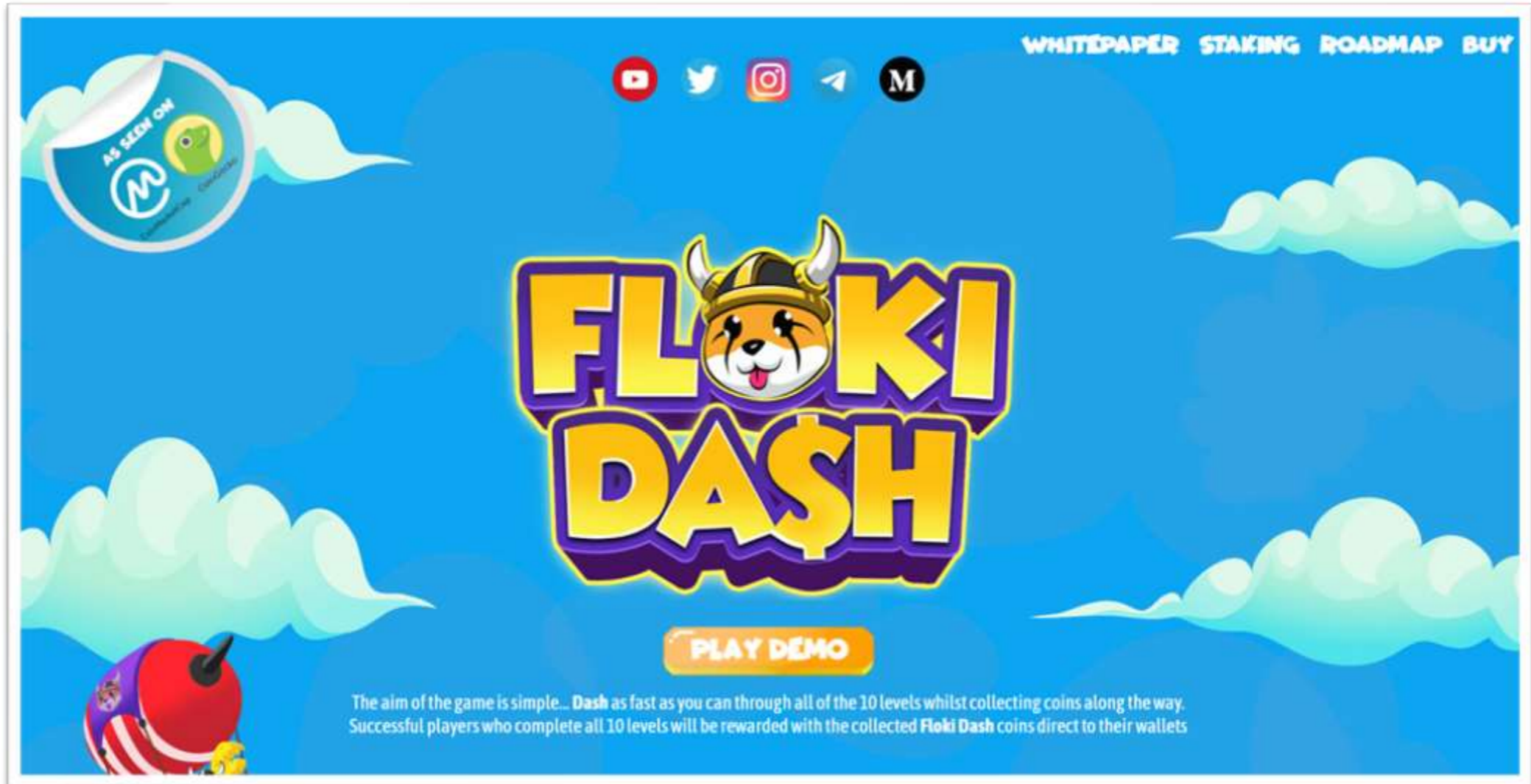

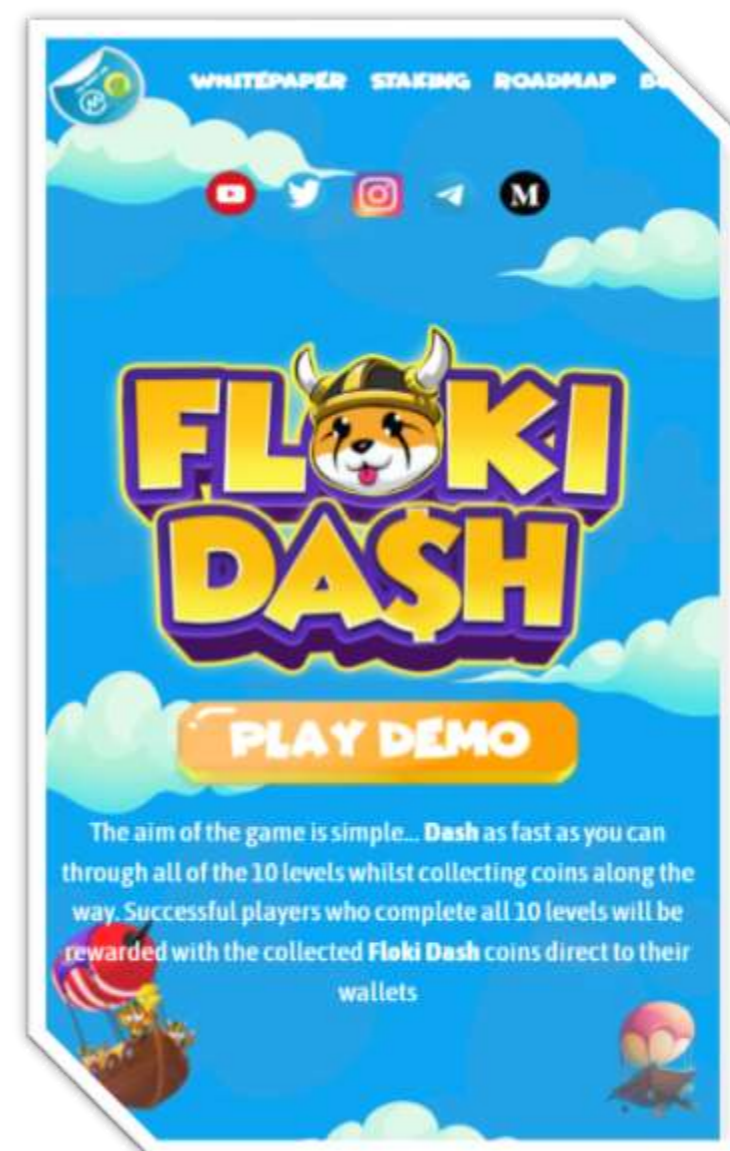
No additional issues were found on the website.
