- Establishing a Time-Lock with reasonable latency
- Assignment of privileged roles to multi-signature wallets

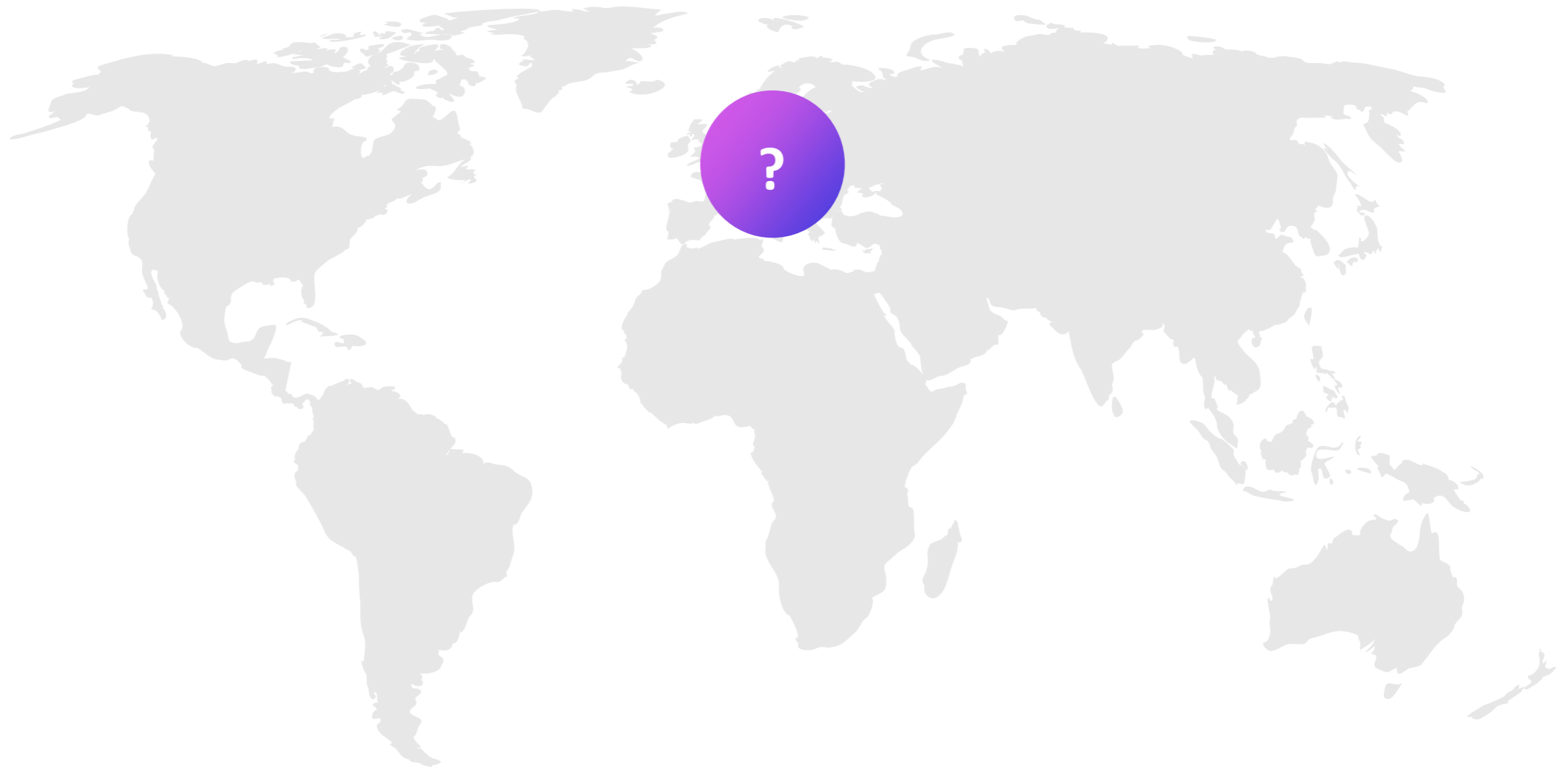
