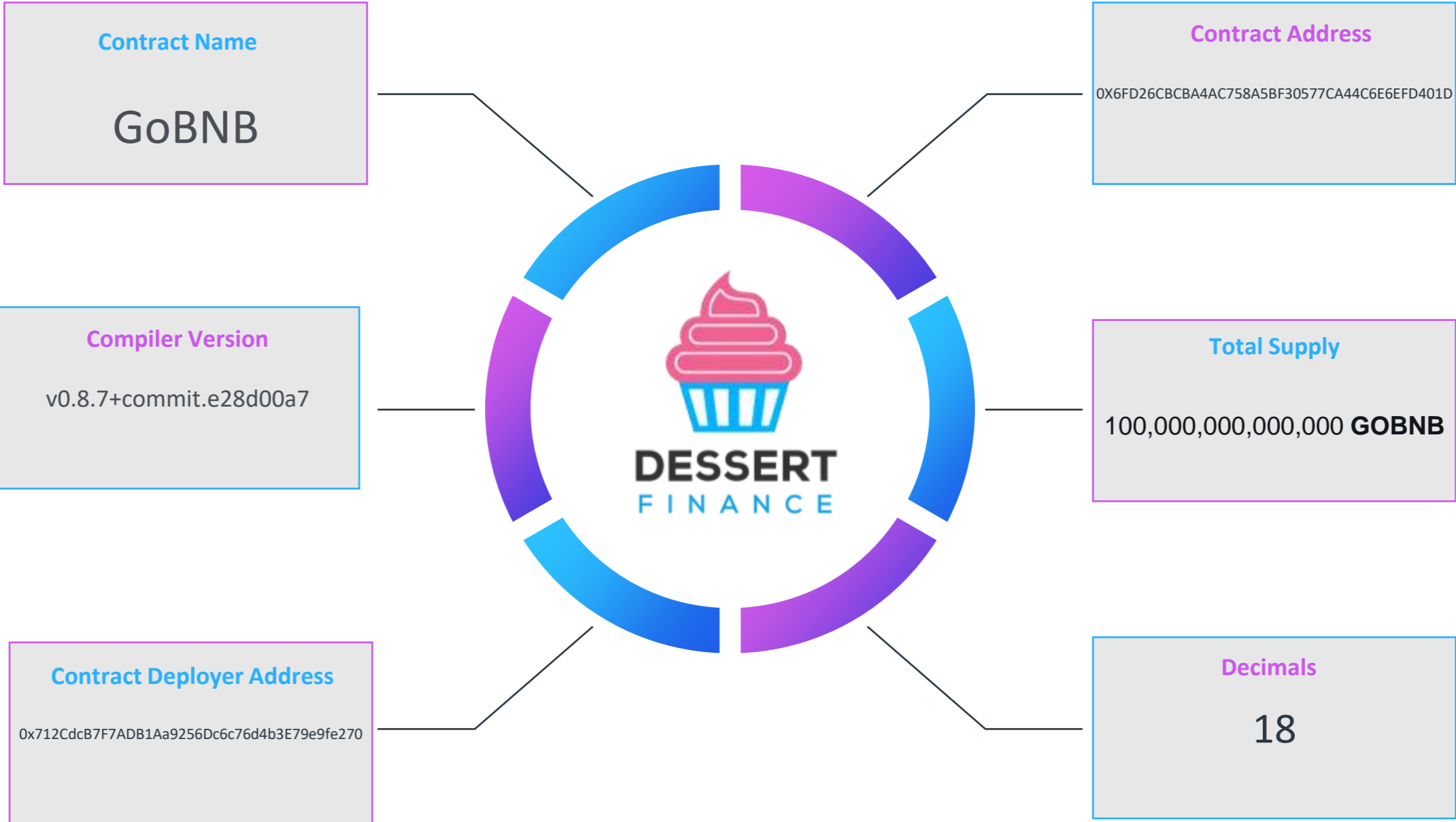

A mint function was not found in the contract code.

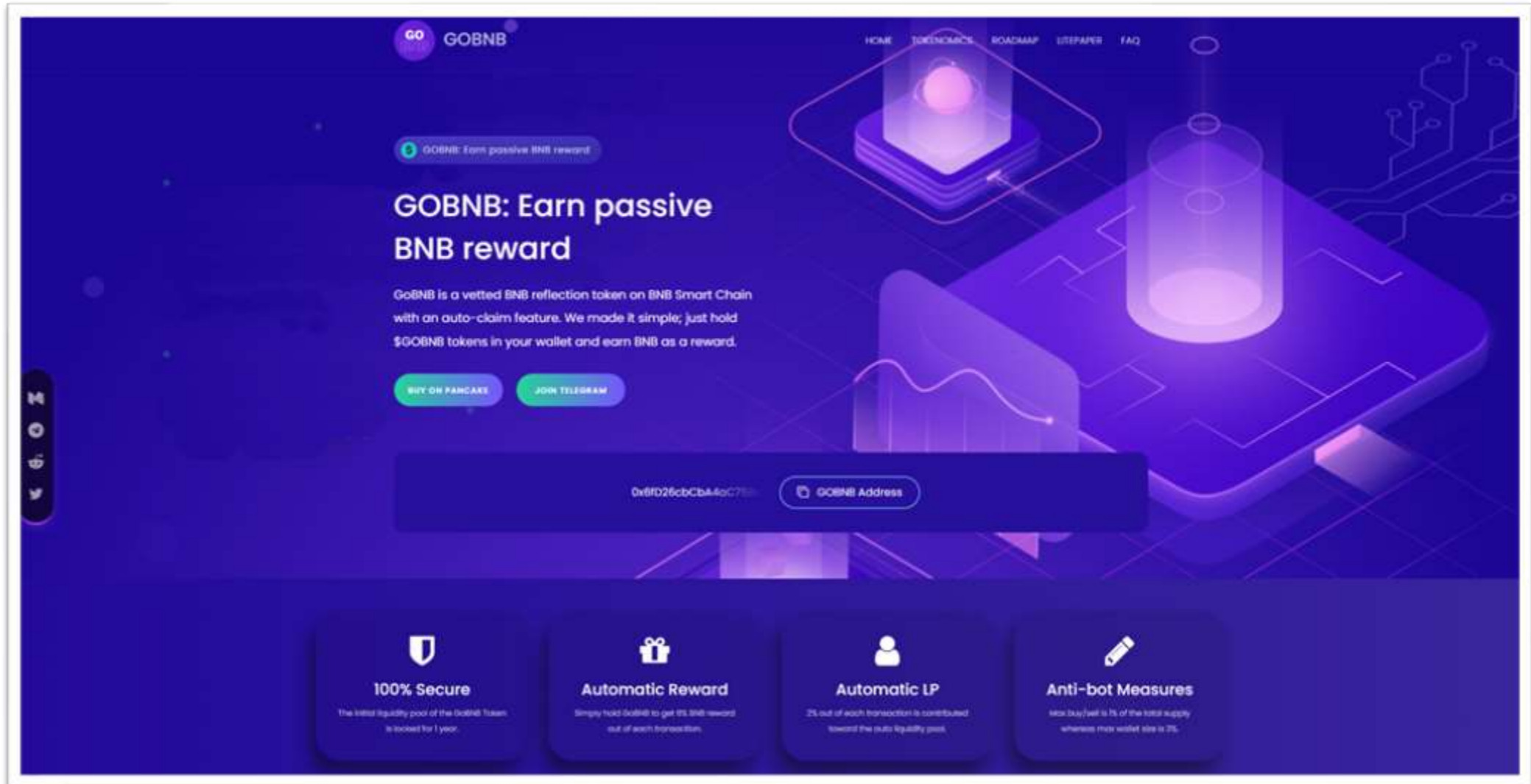
Contract Transaction Fees

 GoBNB Total Supply The total supply of the GoBNB Token is 100,000,000,000,000 (100 Trillion) with 18 decimals ($100 * 1e12 * 1e18$)	 10% Total tax There is a 10% total tax in each GoBNB Token transactions. The total tax is split as 6%, 2% and 2% respectively.	 6% Reward in BNB 6% out of each transaction is redistributed as a reward among the GoBNB Token holders. Holders are rewarded.
 Automatic Liquidity Pool 2% out of each transaction is contributed toward the automatically generating liquidity pool in order to minimize the slippage. 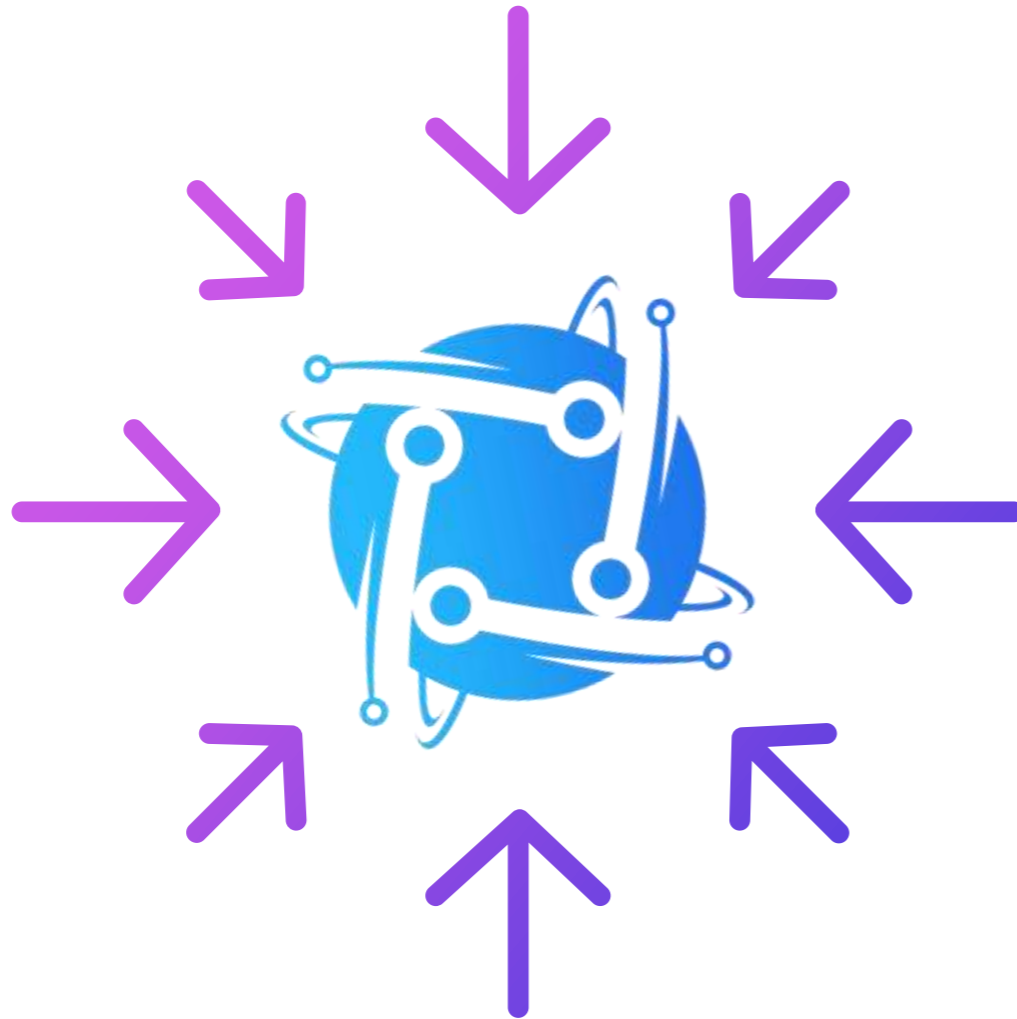

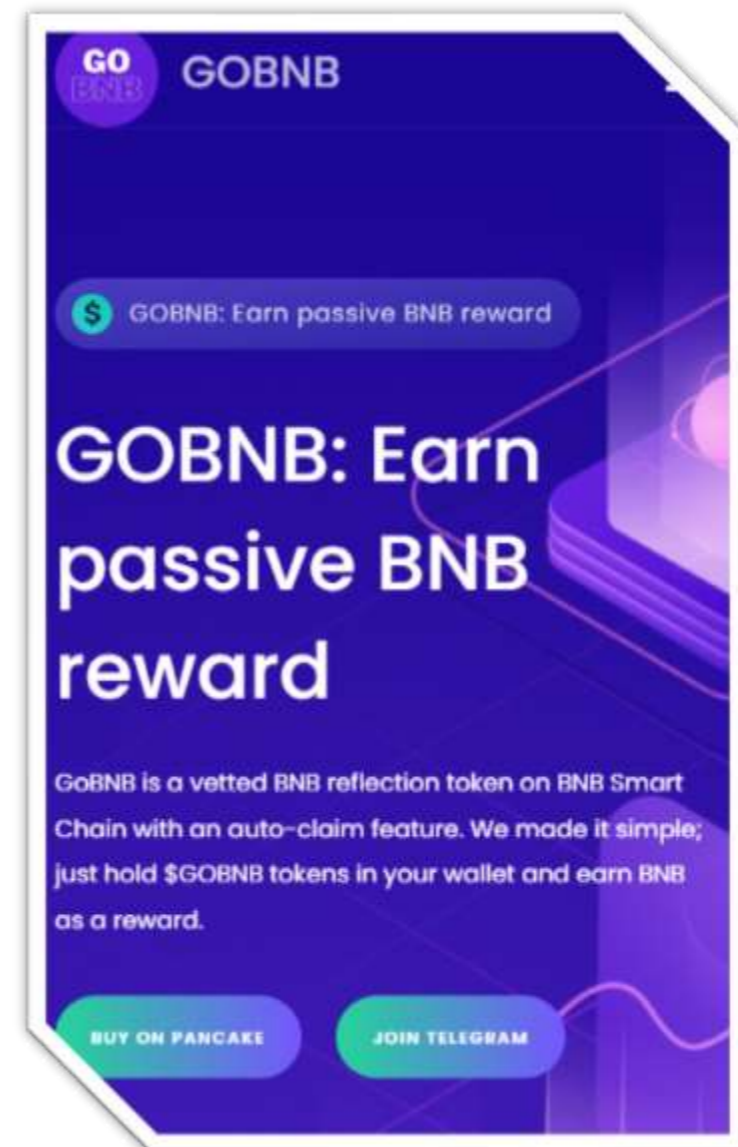
The website contained no JavaScript errors. No typos, or grammatical errors were present, and we found a valid SSL certificate allowing for access via https.

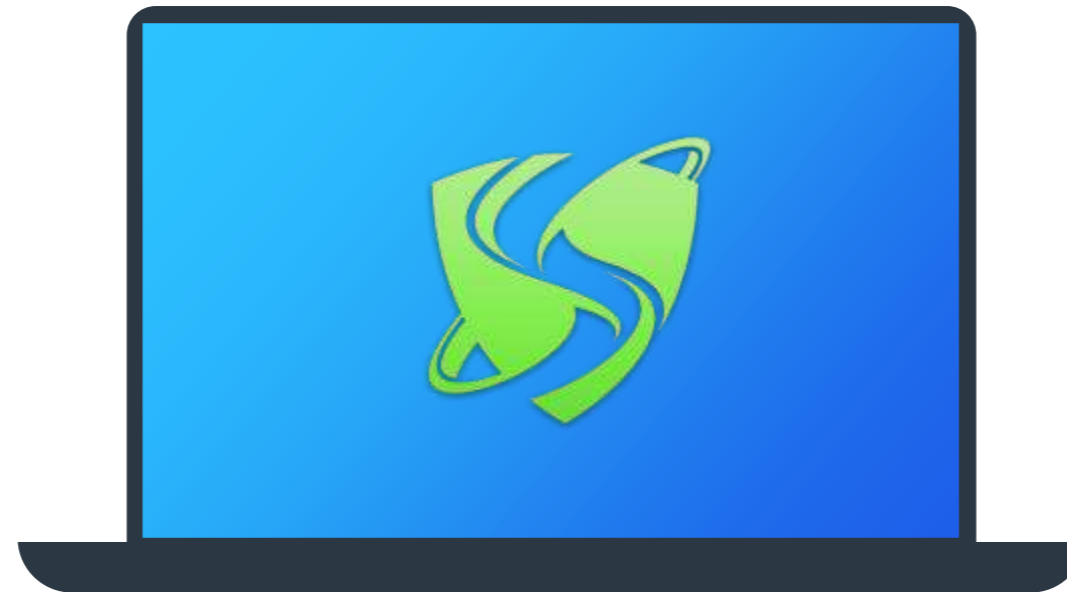

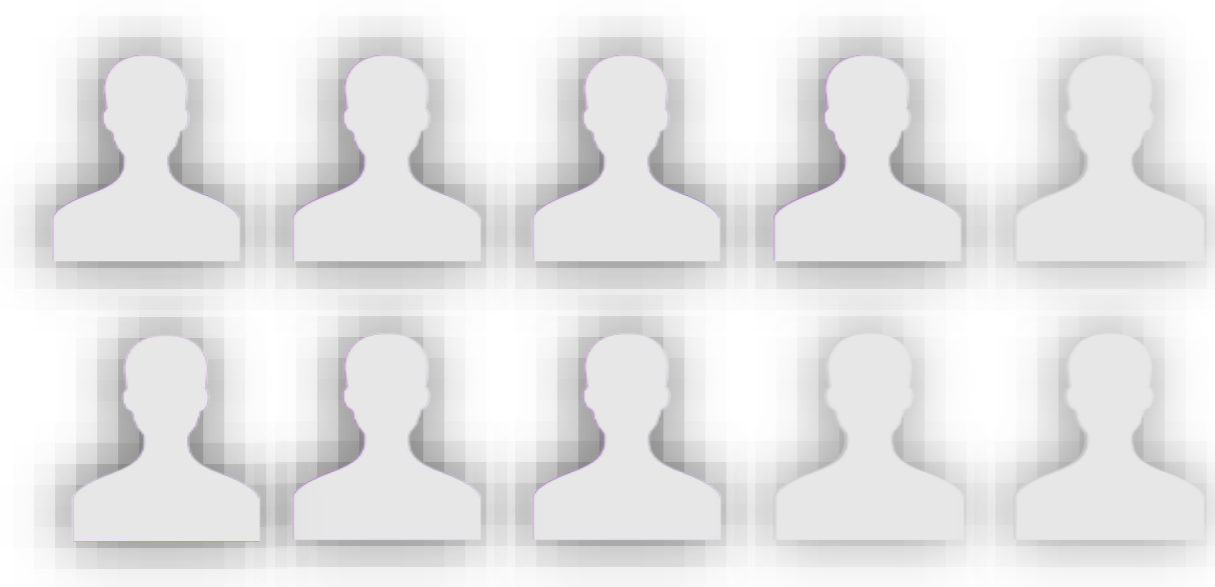
