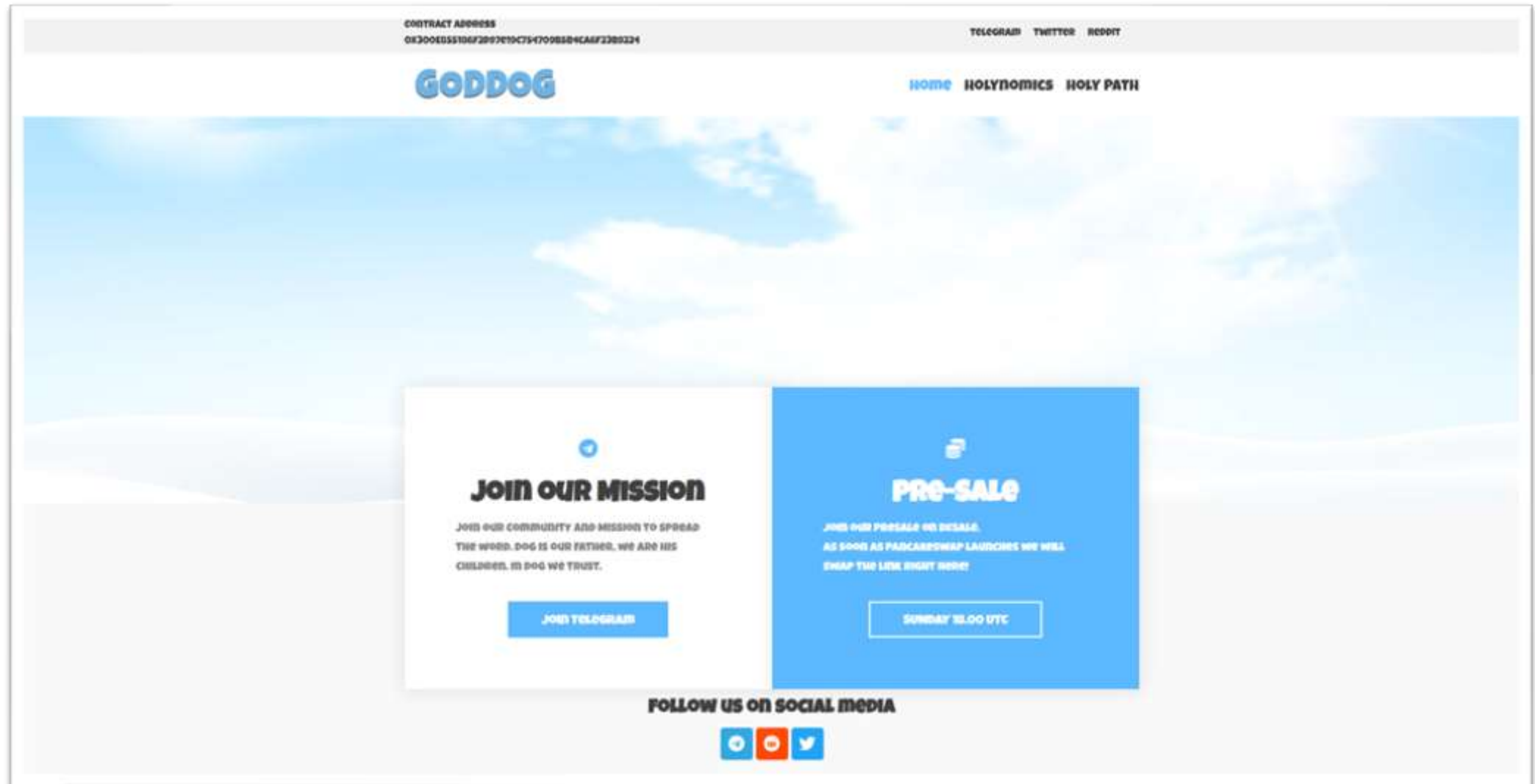

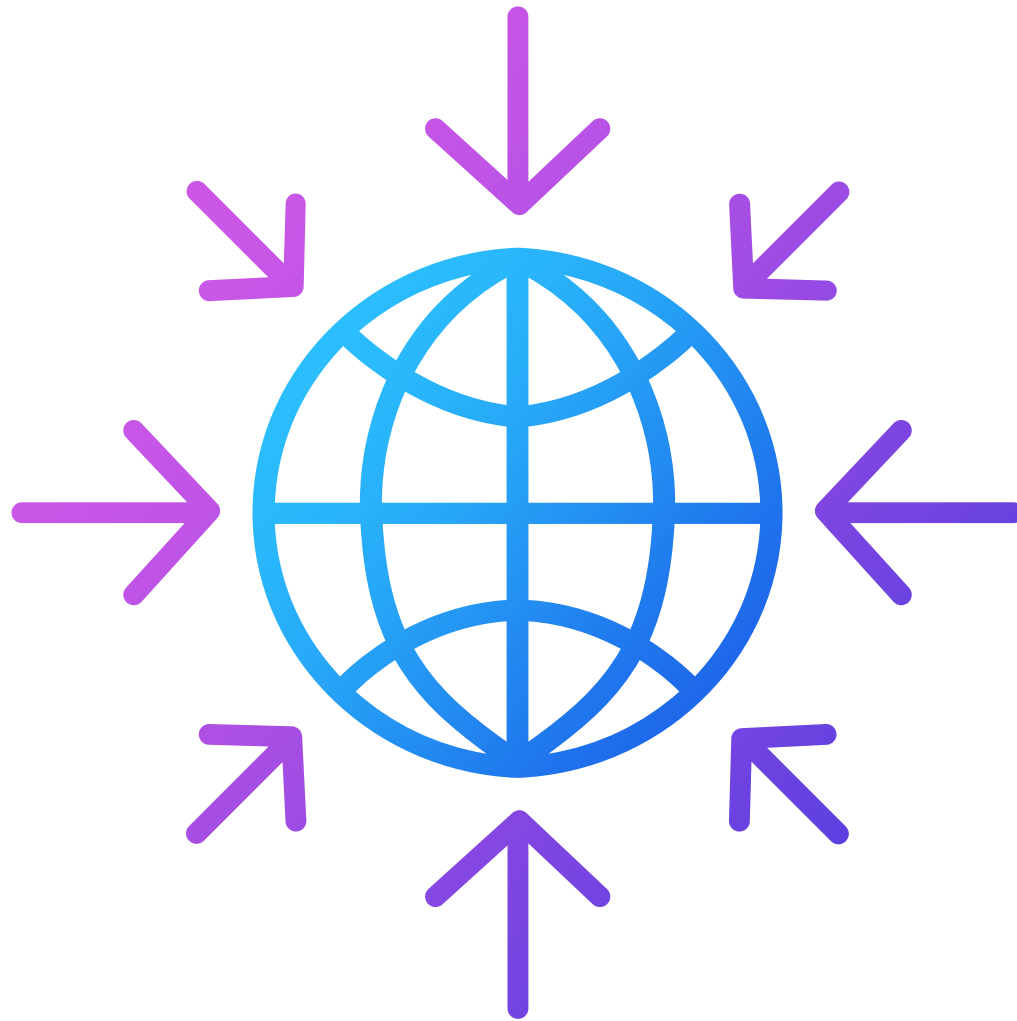

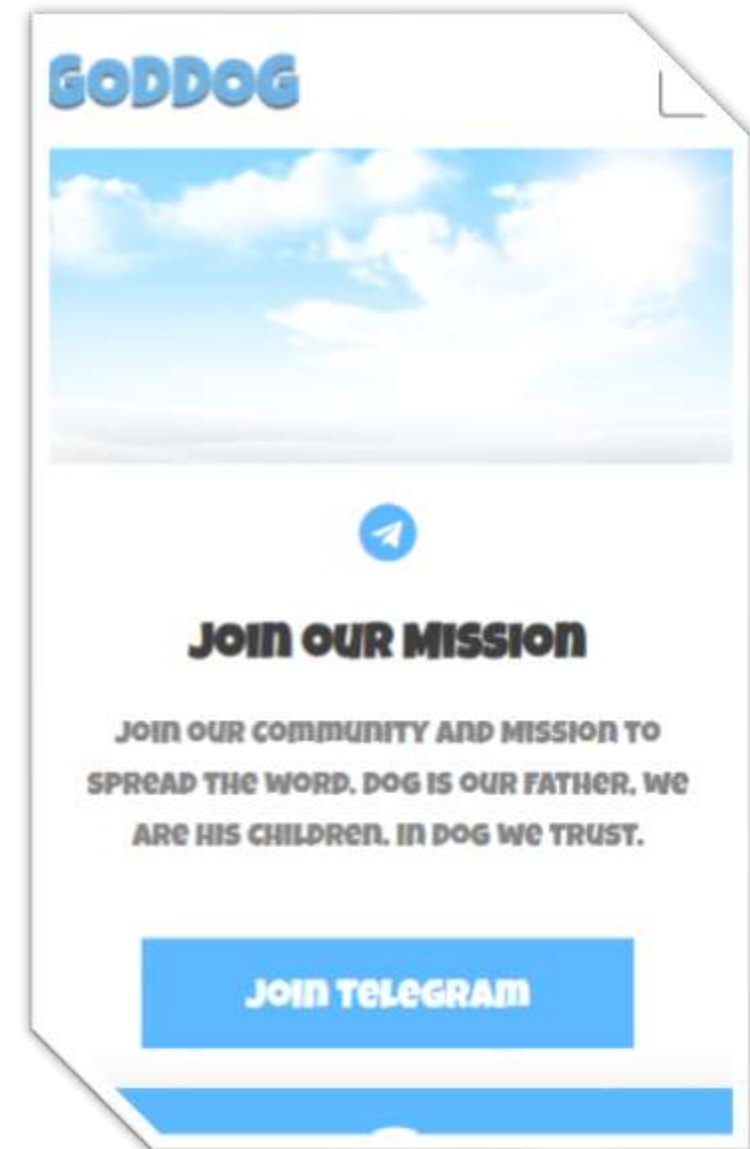
The website contained no JavaScript errors. No typos, or grammatical errors were present, and we found a valid SSL certificate allowing for access via https.

We were able to track down multiple social media channels for the project. Social Media channels included Twitter, Telegram, and Reddit. All social media channels had a healthy amount of activity. It's important to note that the Twitter account is temporarily restricted.

It is important to note that there is an 9% tax on EVERY transaction including buys and sells. 3% goes to providing liquidity, 3% is distributed to the token holders and 3% is distributed to the team for marketing.

The project does not have a contact form or email address listed on their website, we would like to see this added for users who do not use social media channels.

GodDog plans to renounce ownership at launch, at the time of the audit it is not currently renounced.

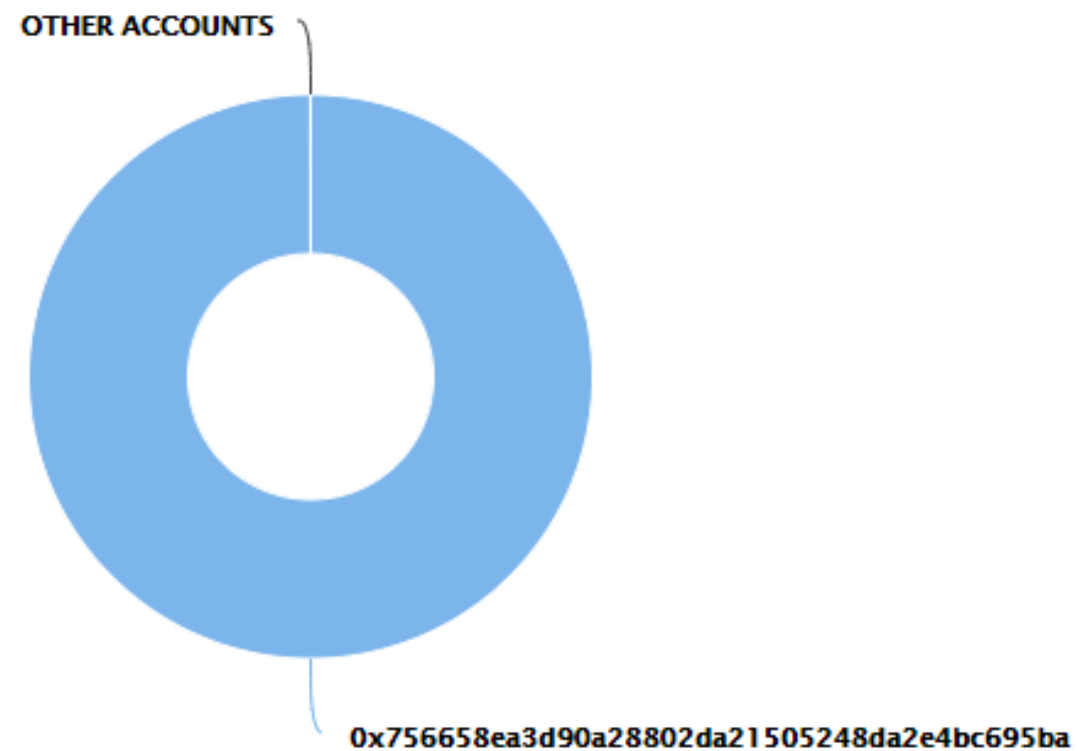

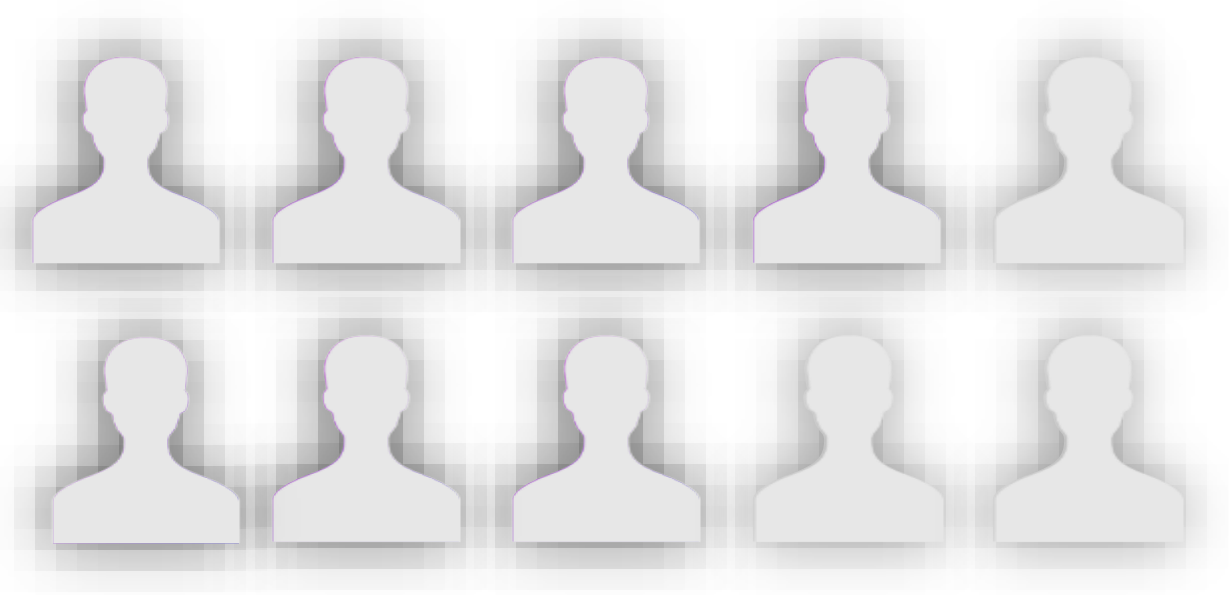
