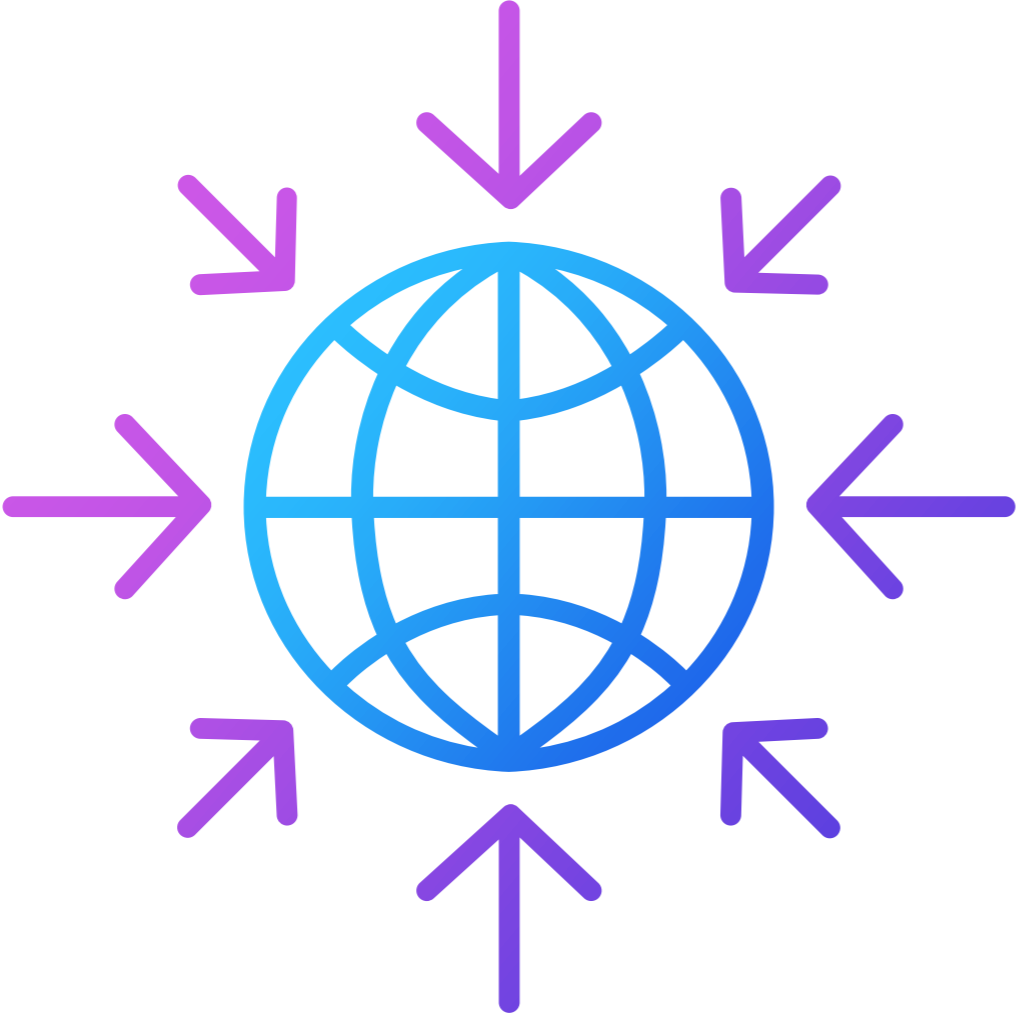

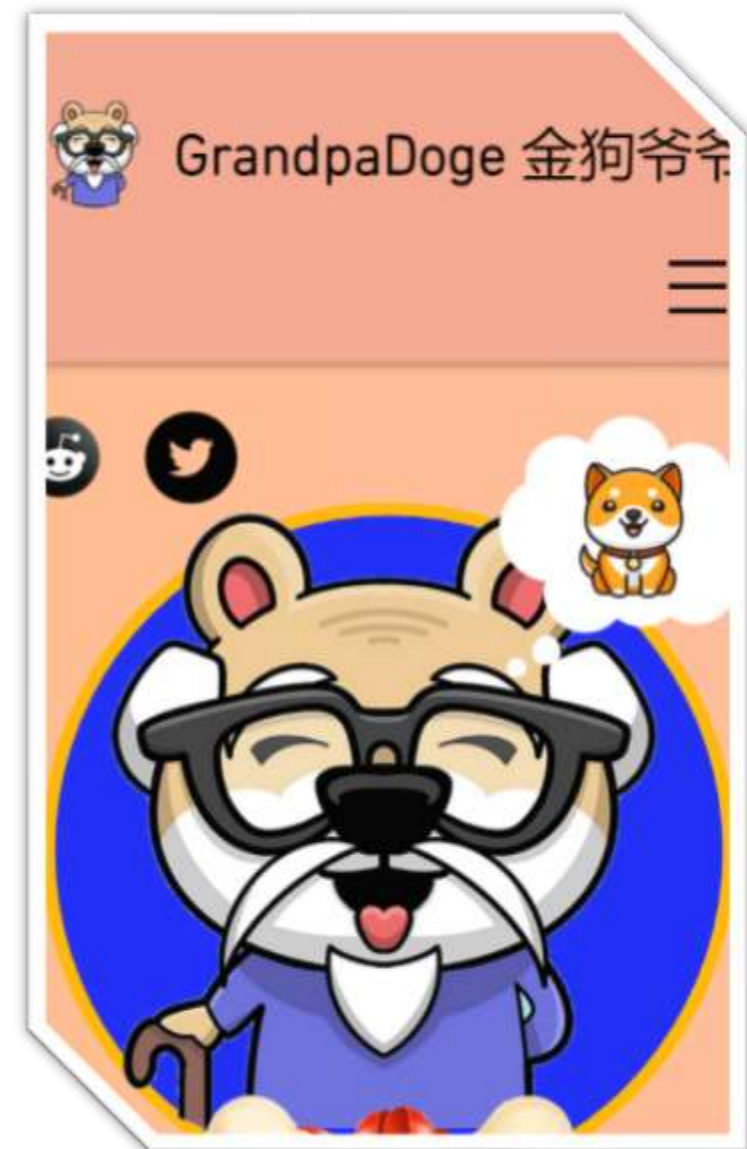
The website contained no JavaScript errors. No typos, or grammatical errors were present, and we found a valid SSL certificate allowing for access via https.

# Social and Web – Final Thoughts & Suggestions for Improvement

We were able to track down multiple social media channels for the project. Social Media channels included Twitter, Telegram, and Reddit. All social media channels had a healthy amount of activity although the subreddit only had two posts at the time of audit.

It is important to note that there is an 12.5% fee on EVERY transaction including buys and sells. 8% goes to providing liquidity, 0.5% goes to marketing, and 4% is distributed to the token holders.

**It is important to note that there is a double tax for any sell transaction higher than 0.8% of the total supply.** For anyone considering large buys and sells of this token, we highly encourage you to heed this warning as it will result in double fees.

The “BUY \$GrandpaDoge” button is not yet functional, but we anticipate that it is a placeholder as the project has not officially launched at the time this audit was conducted.

## Suggestions for Improvement

1. Add contact email to website
2. Update domain registration to 3+ years

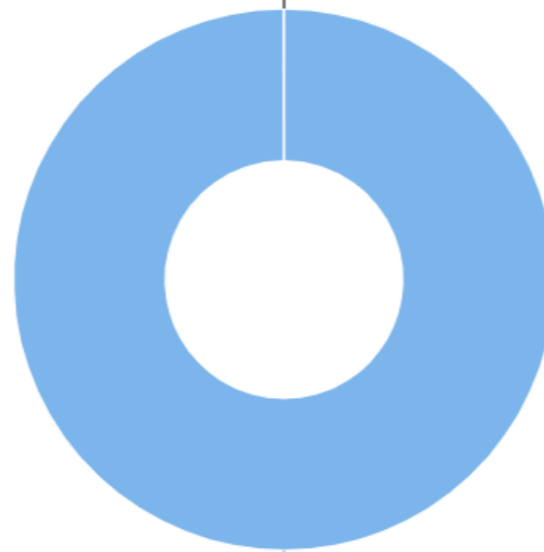

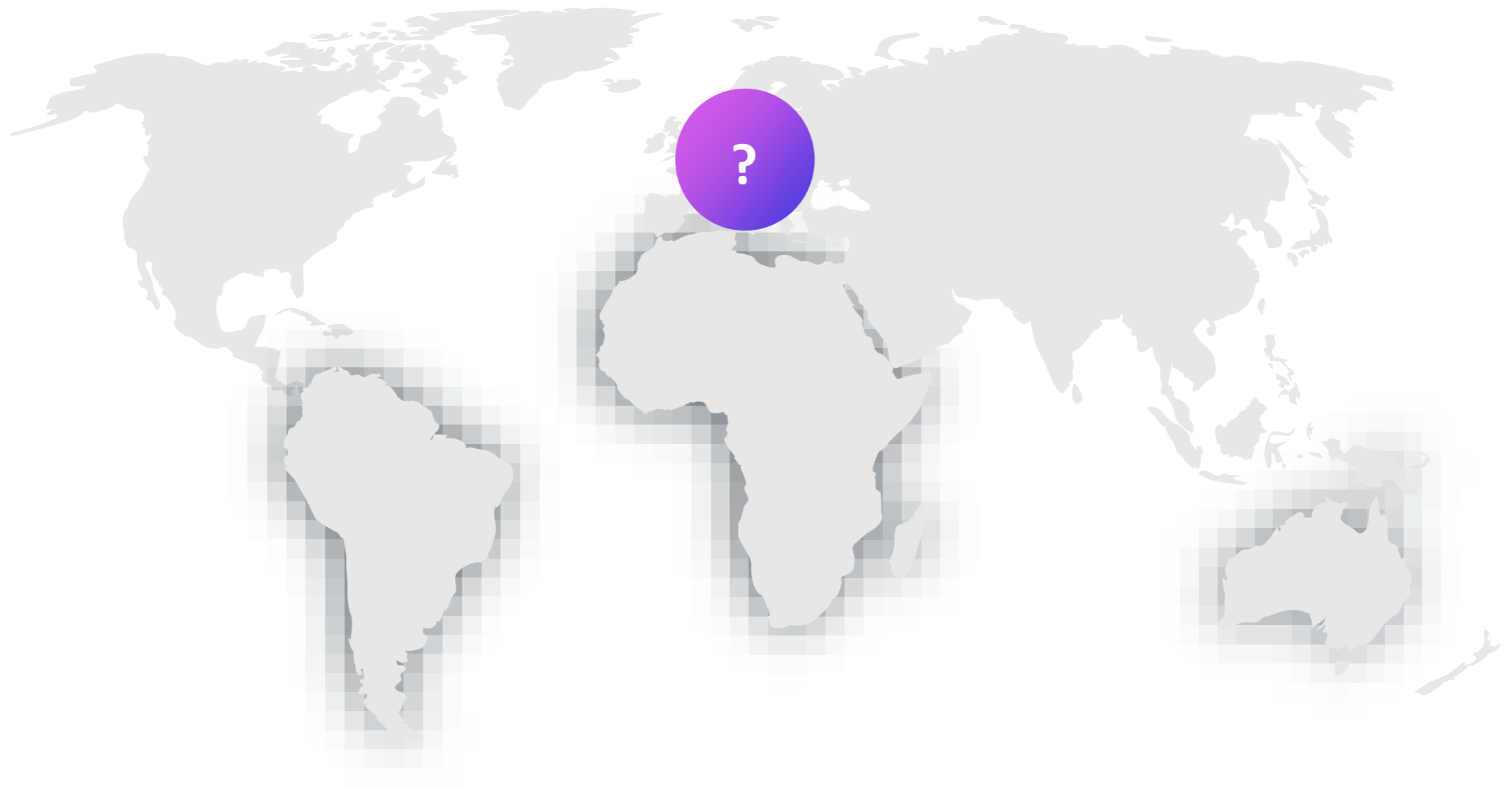

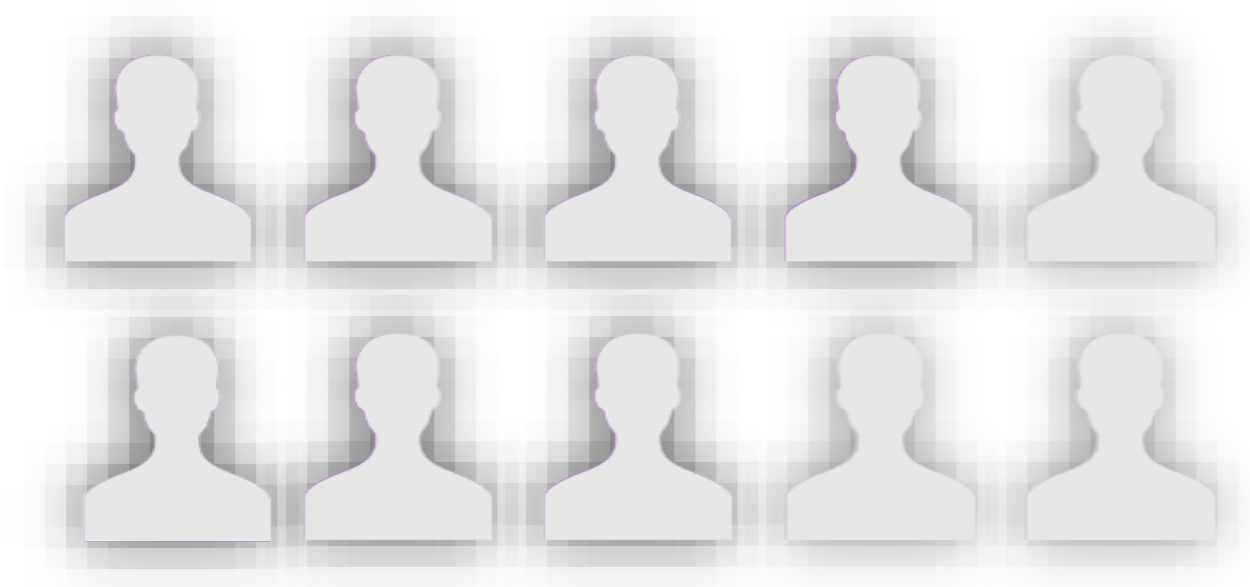
