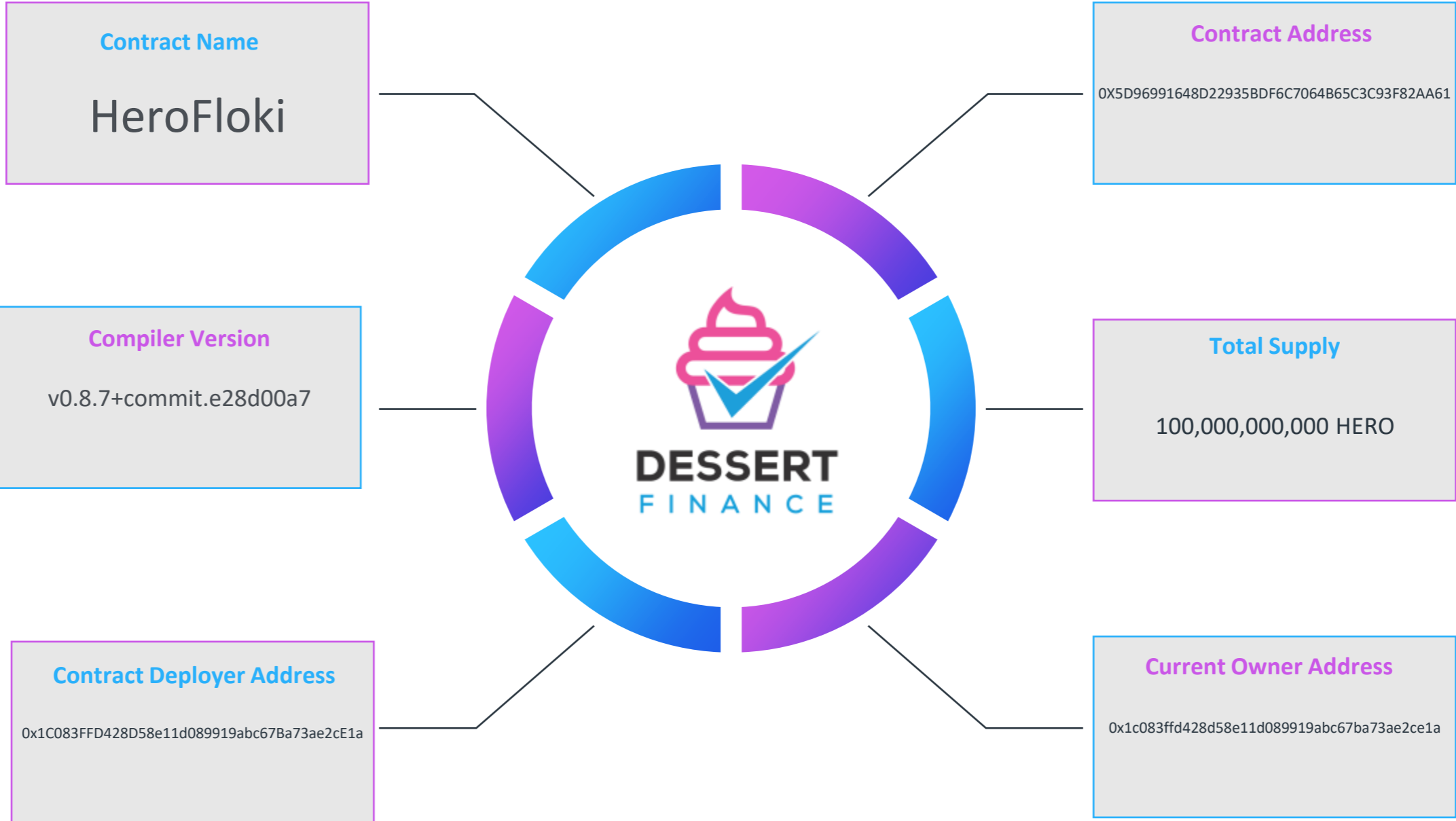

A mint function was found in the contract code. The mint function has the `onlyOwner` modifier allowing the owner to mint. If ownership is renounced – minting will no longer be possible.

The project has let us know that the Mint function will be used for a farming feature that will be implemented in the coming months.

At the time of Audit the transaction fees (“tax”) listed below are the fees associated with trading. These fees are taken from every buy and sell transaction unless otherwise stated.

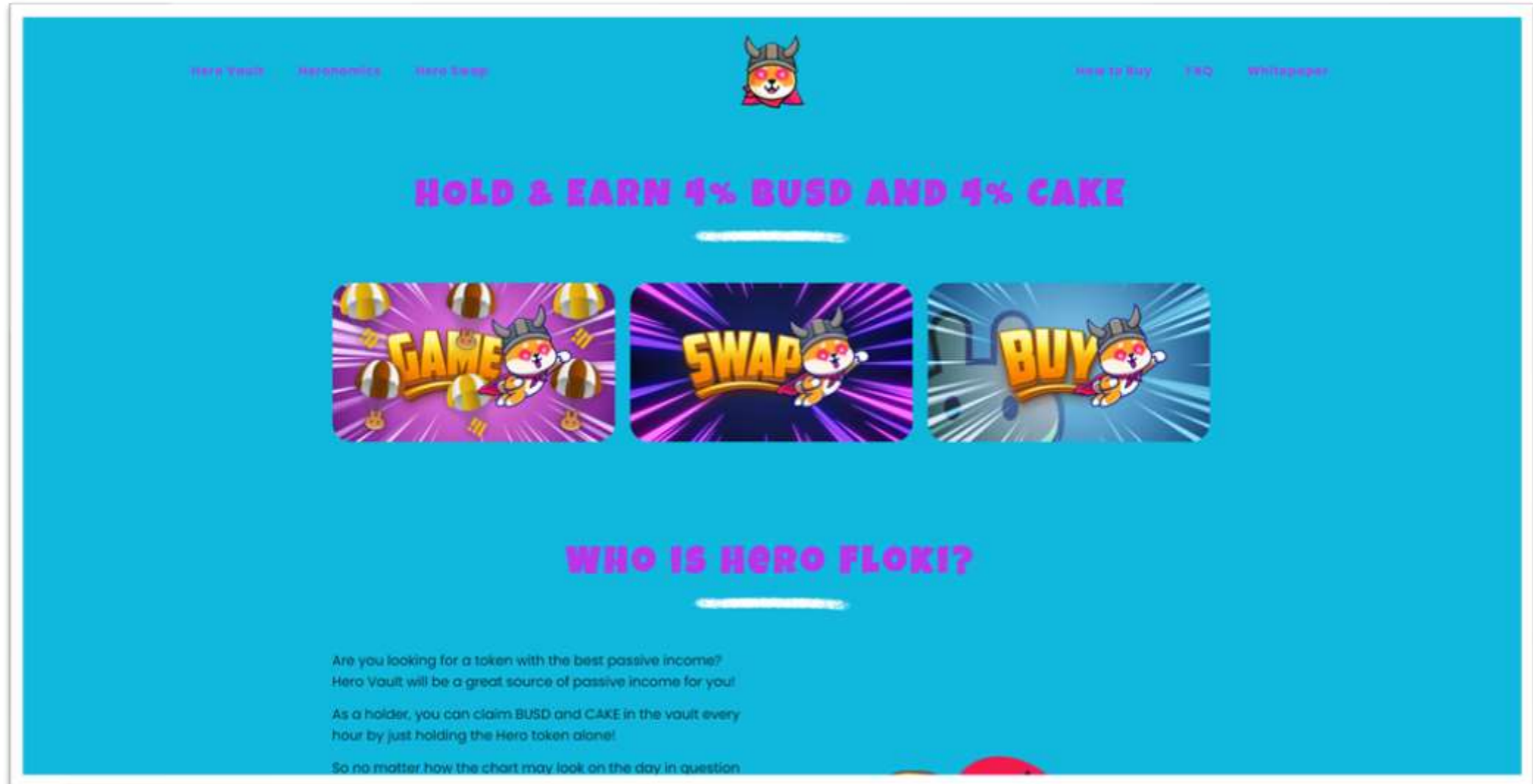

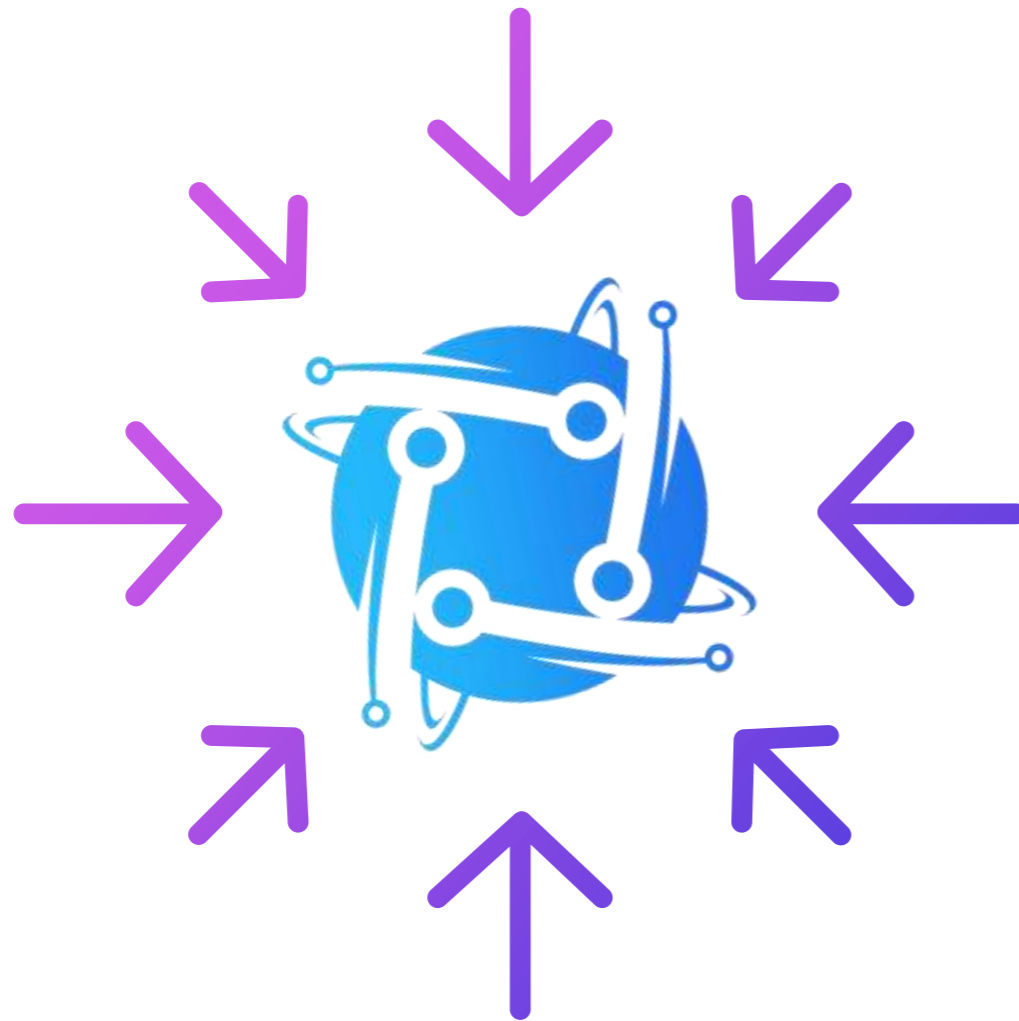

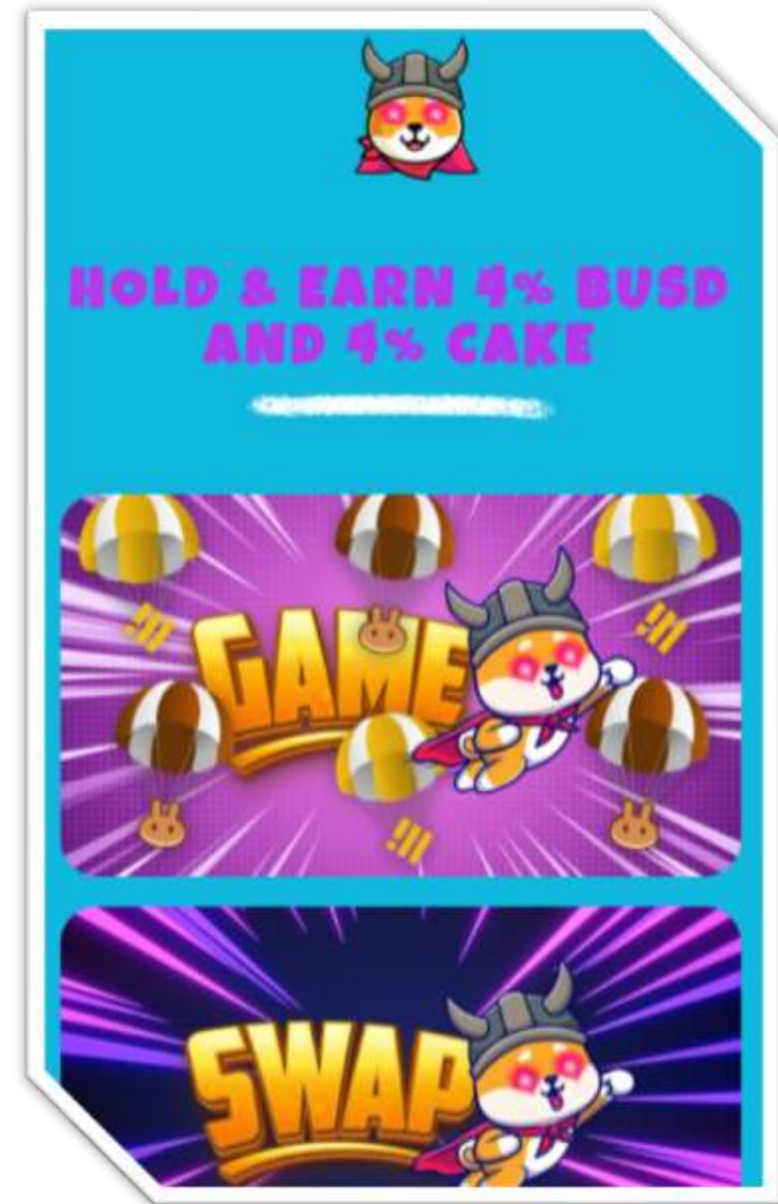
The website contained no JavaScript errors. No typos, or grammatical errors were present, and we found a valid SSL certificate allowing for access via https.

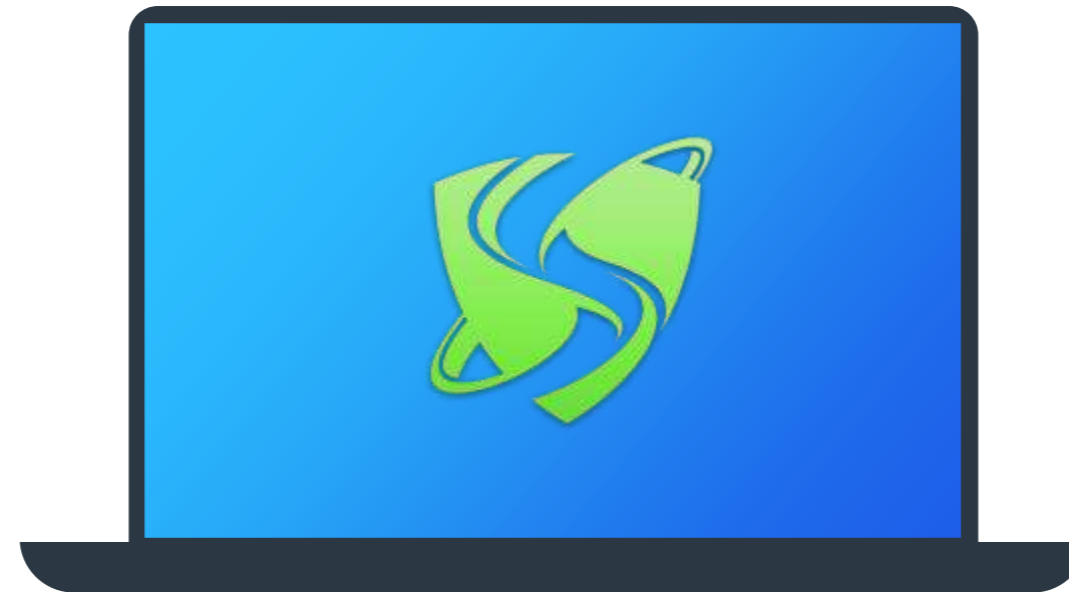

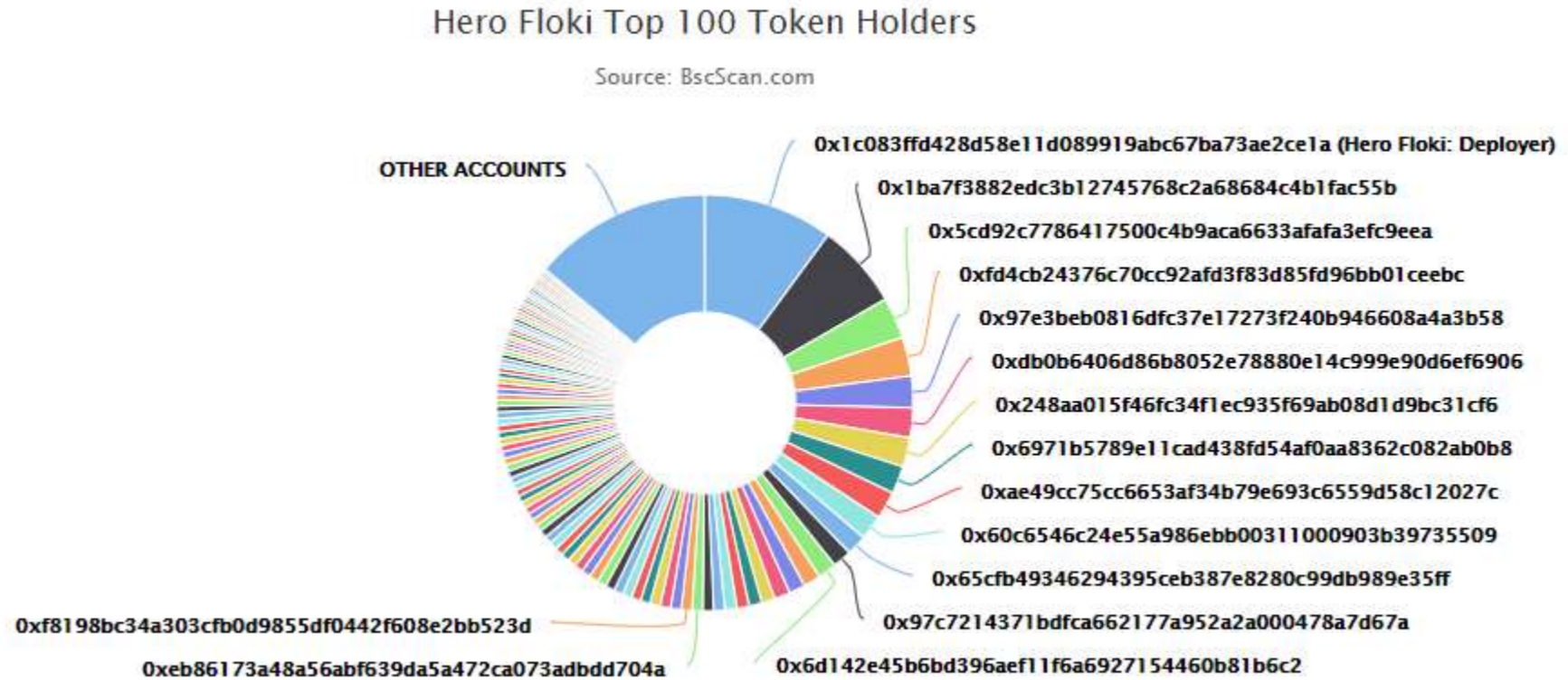

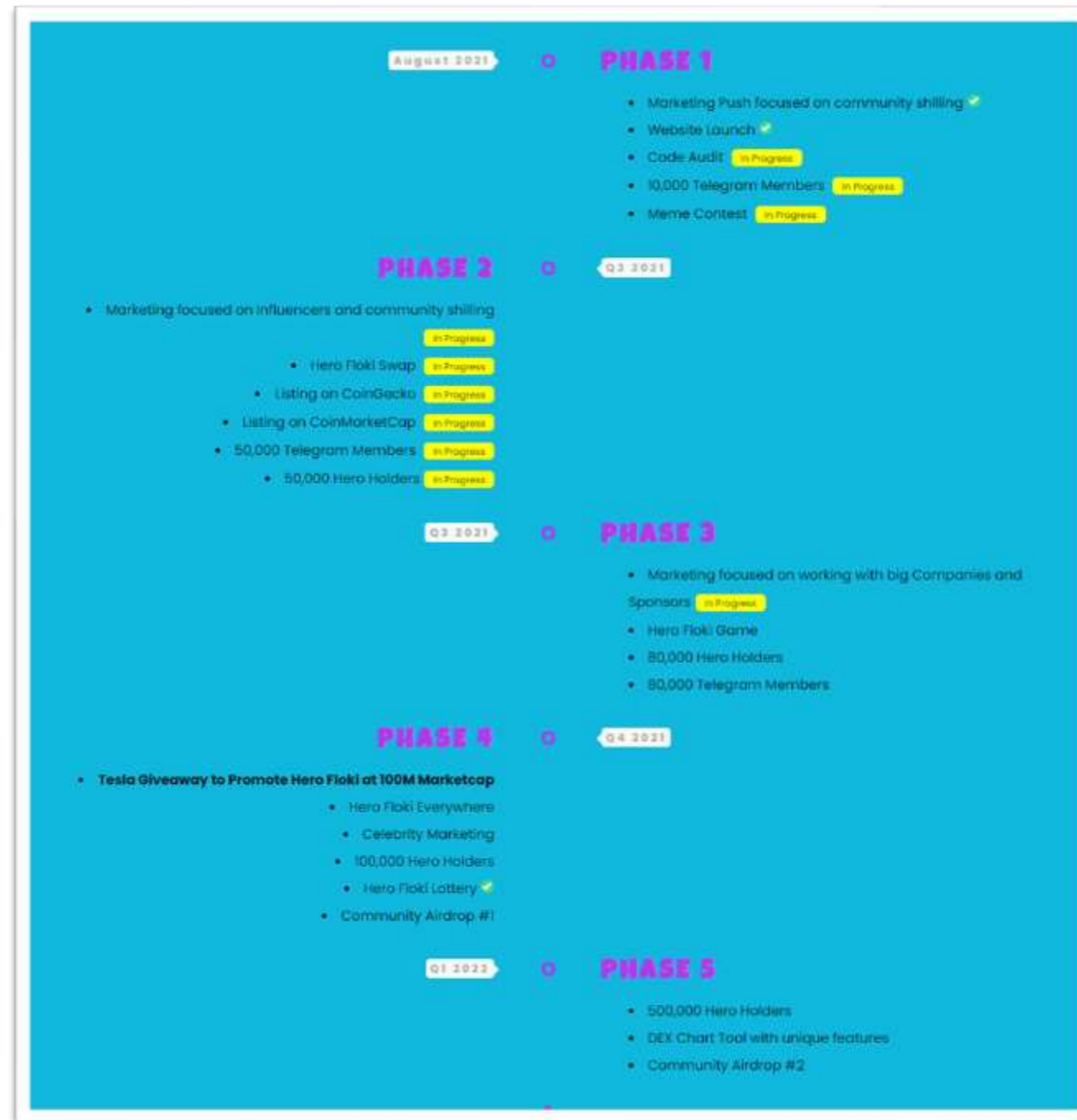
