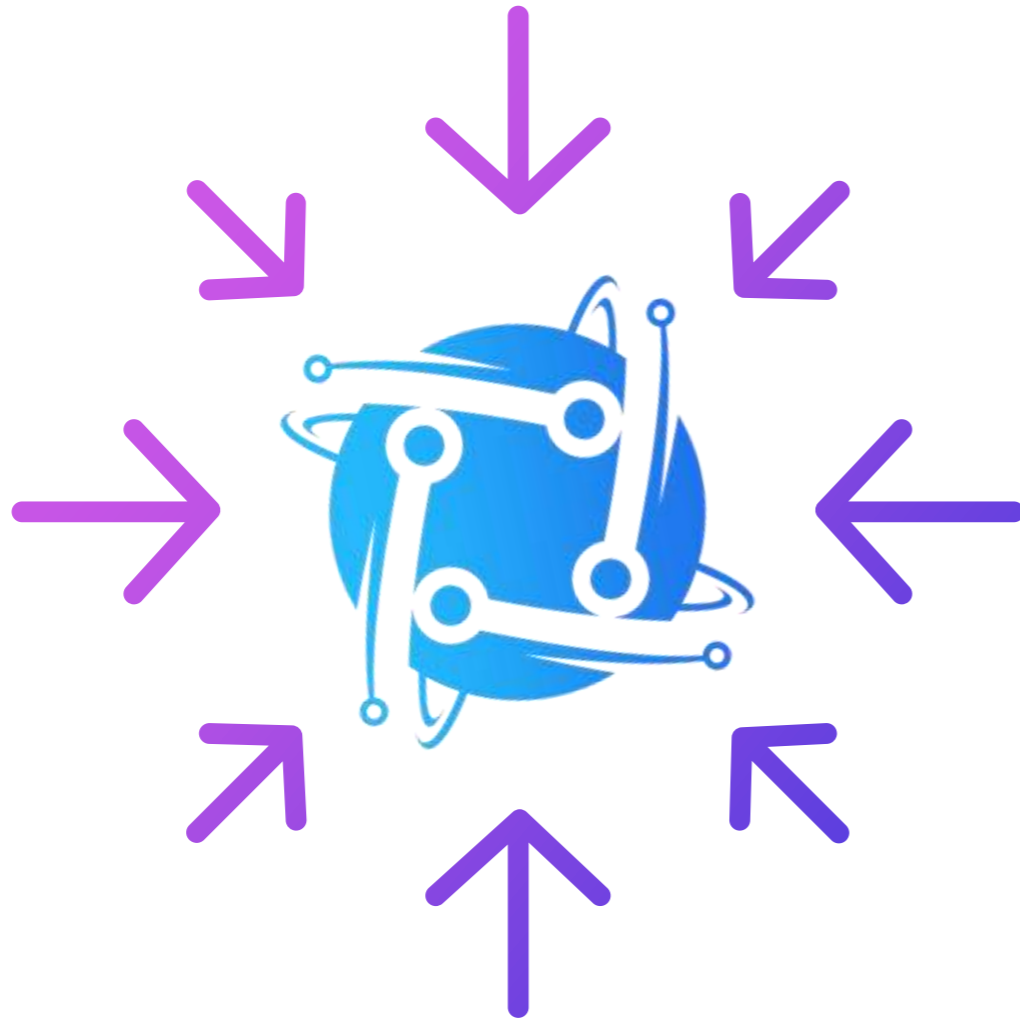

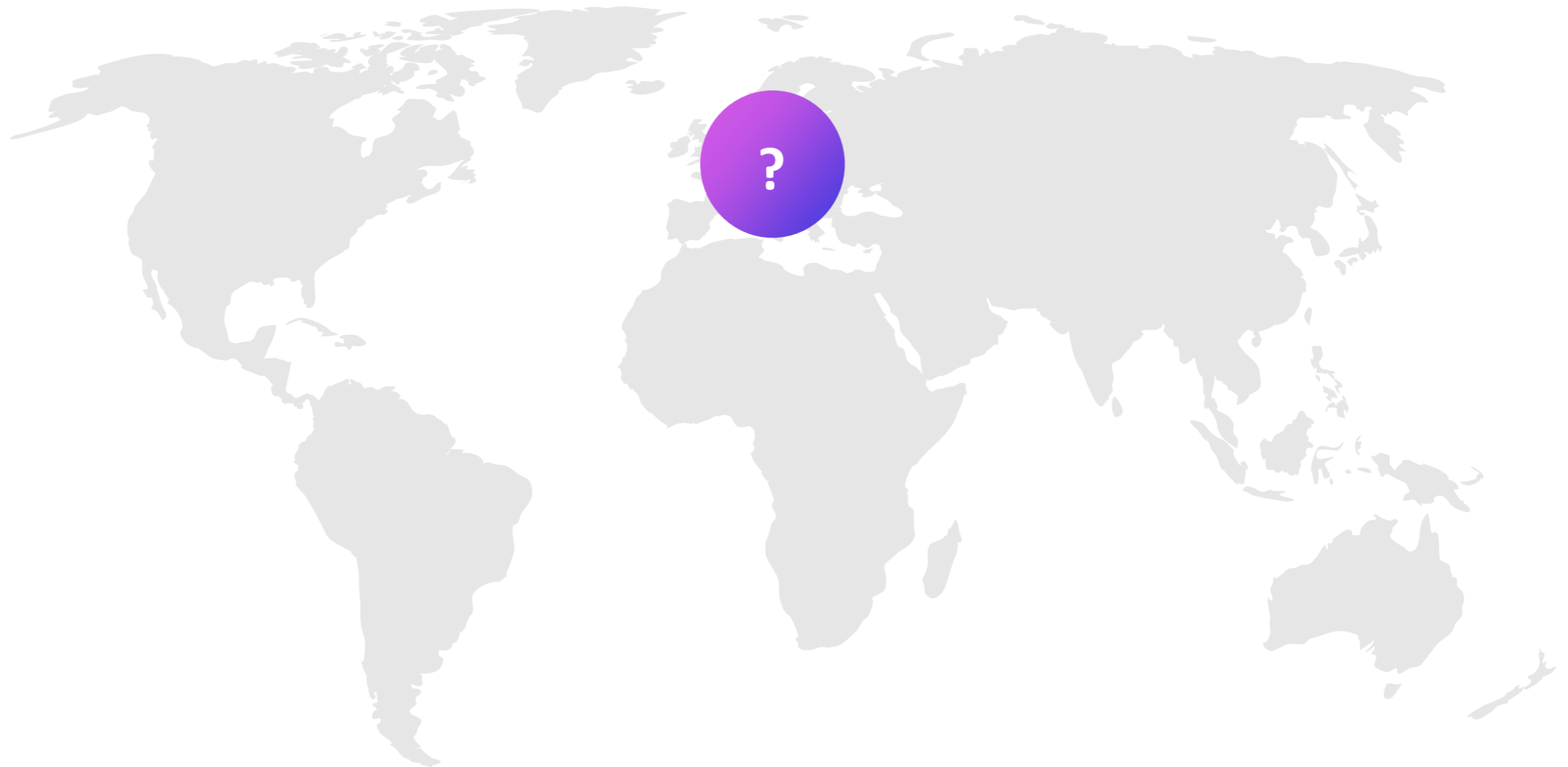
JungleFEG Top 100 Token Holders

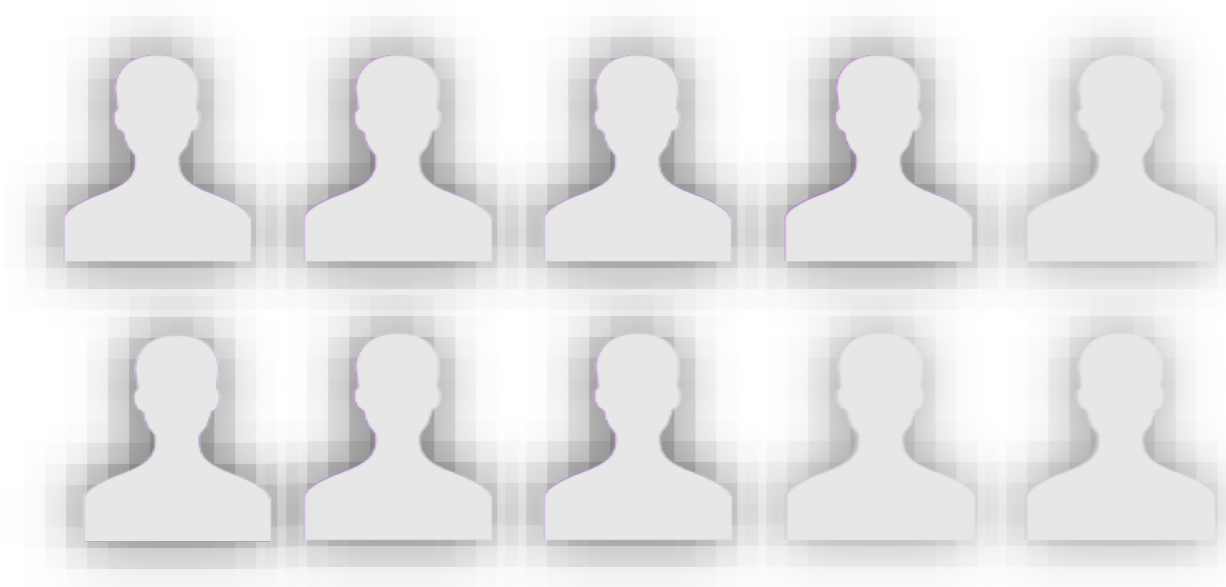

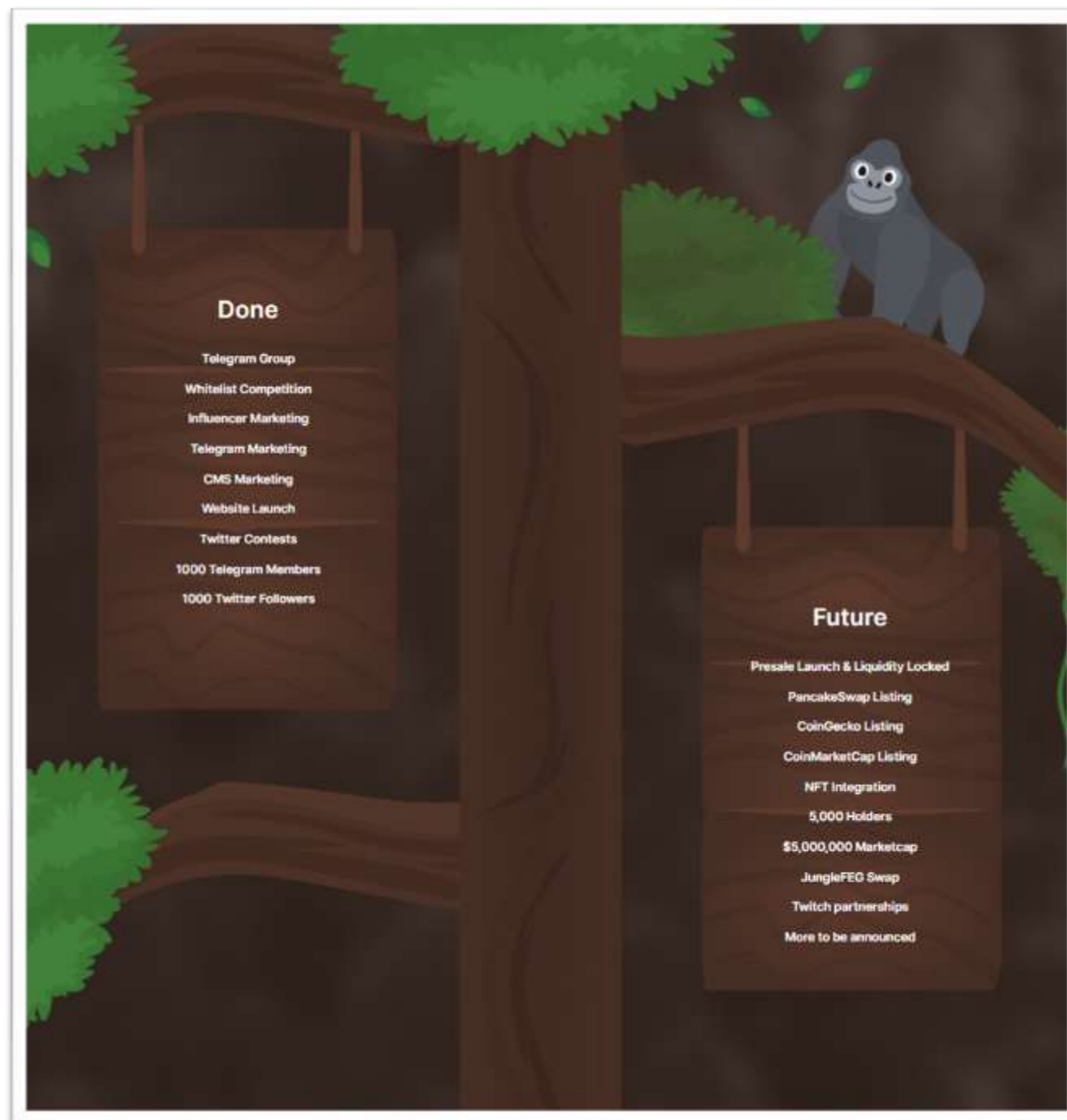
