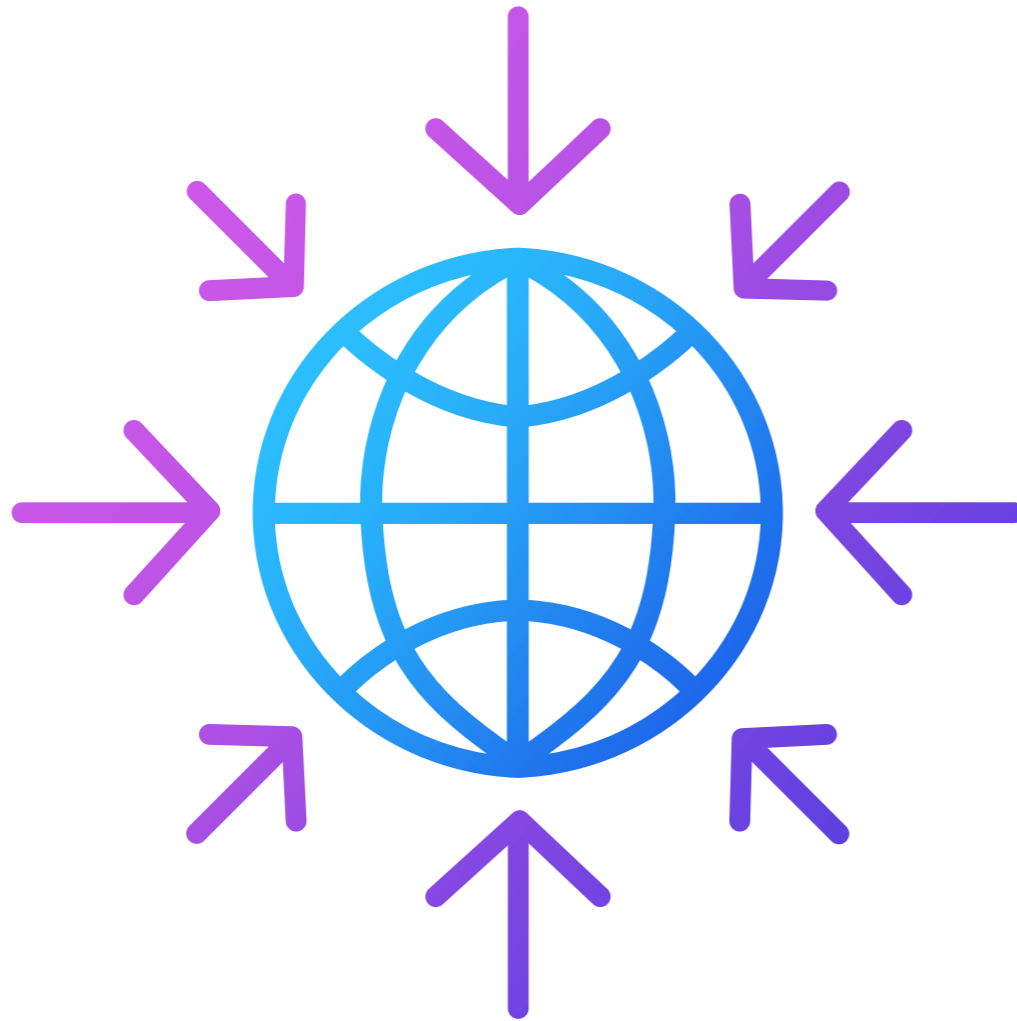

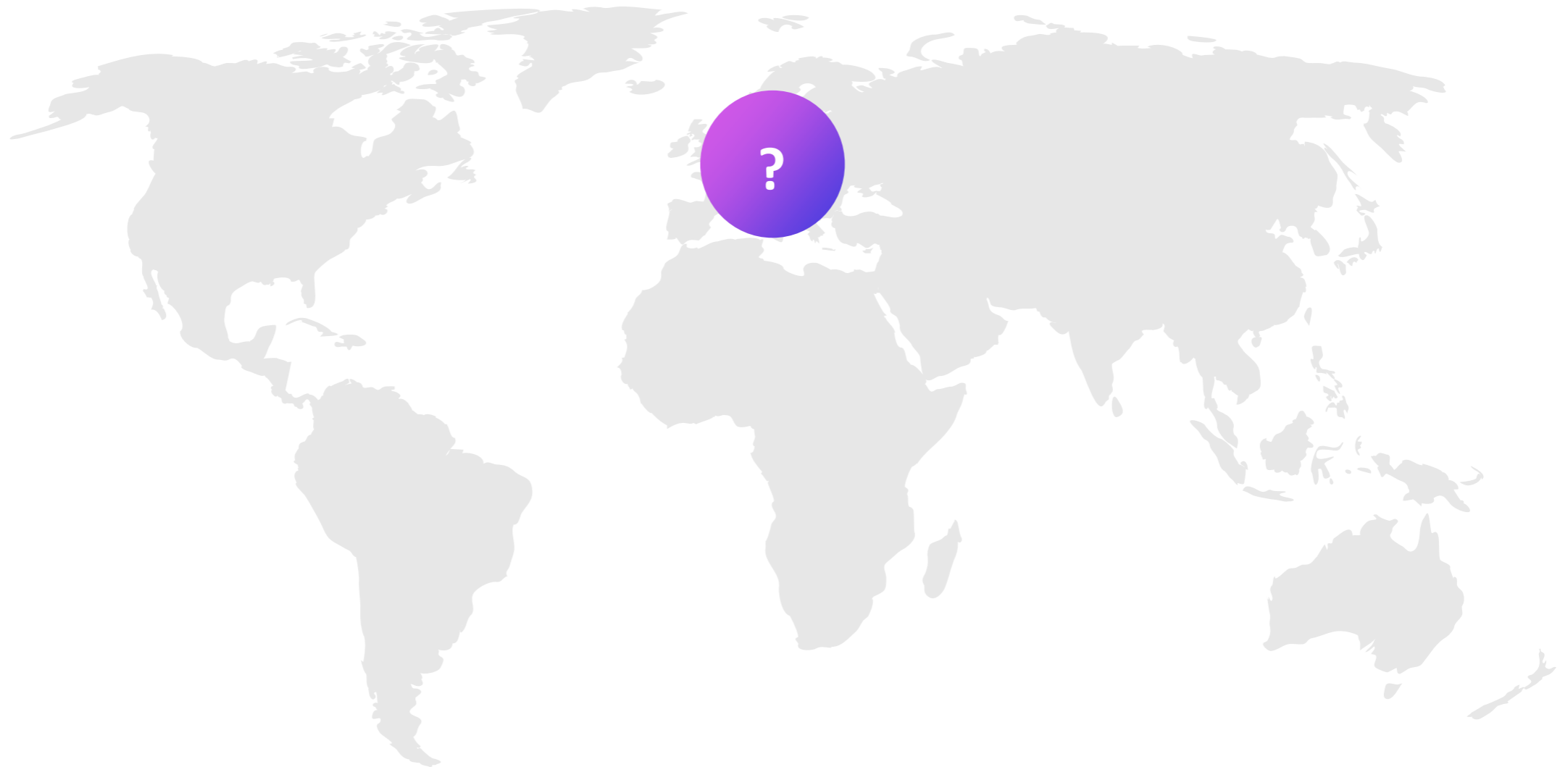
Kamiland Games Top 100 Token Holders

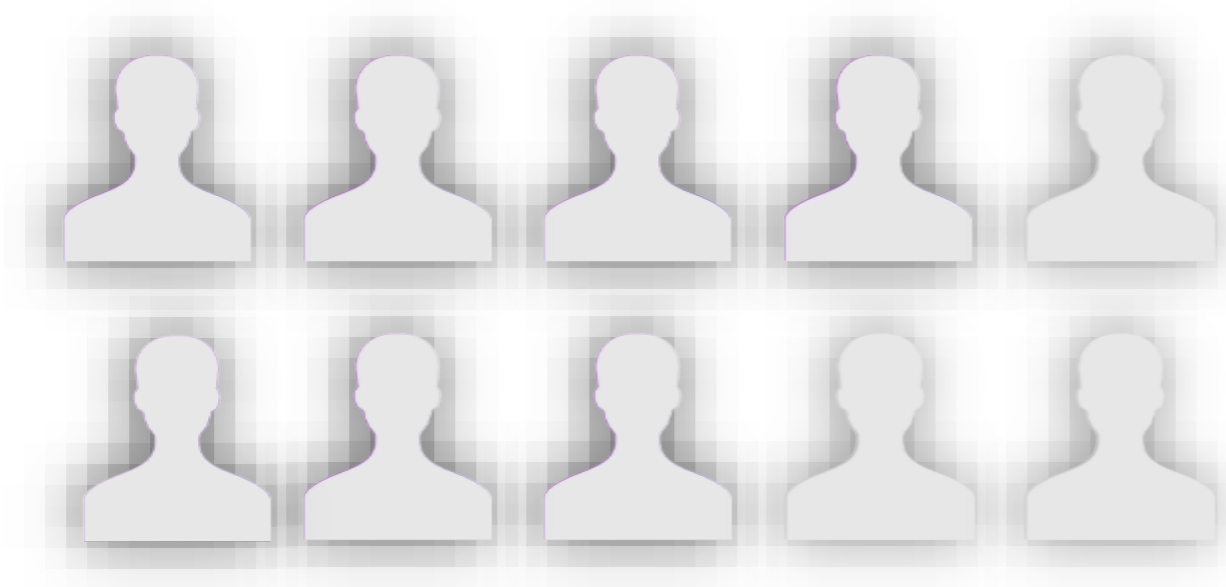
