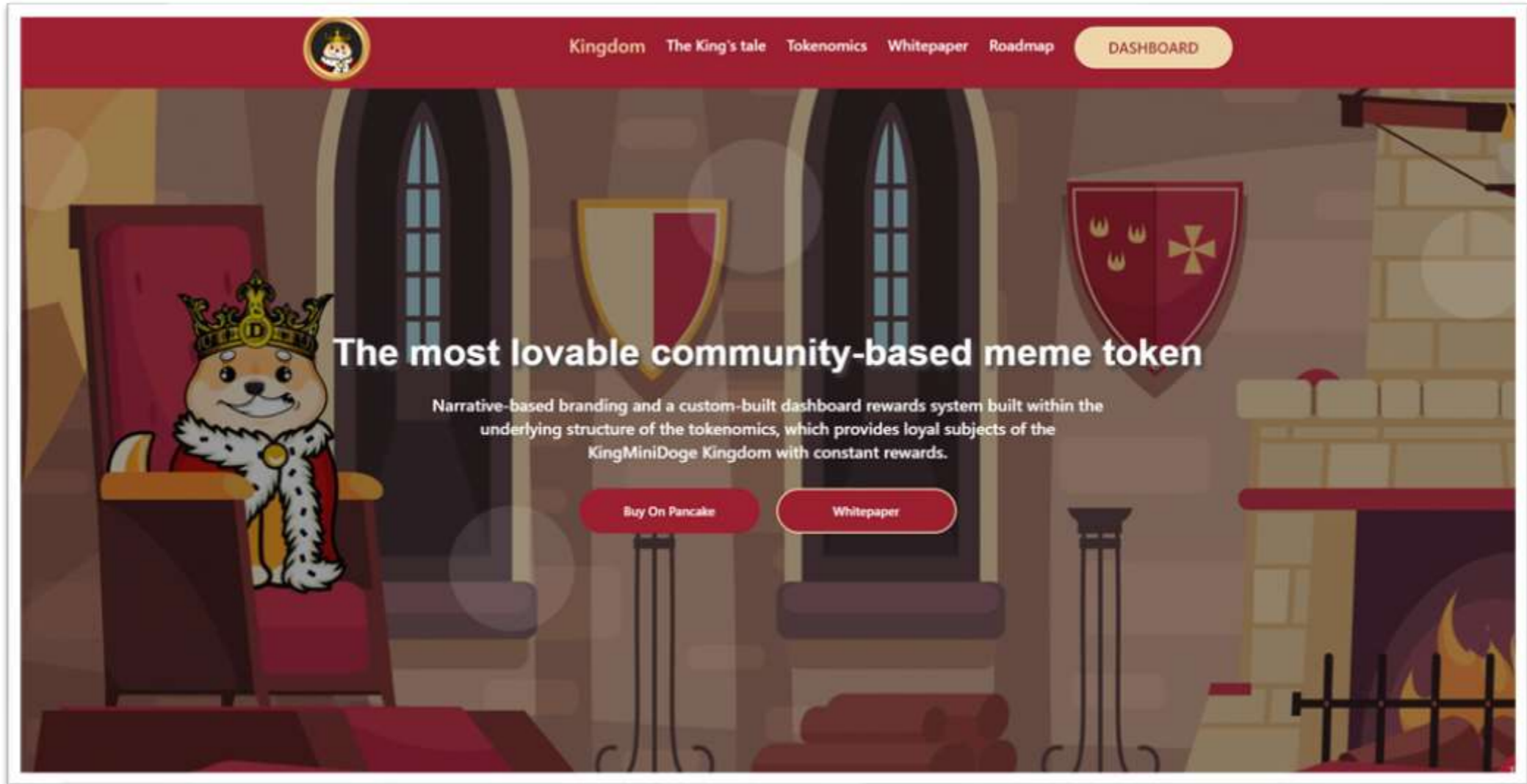

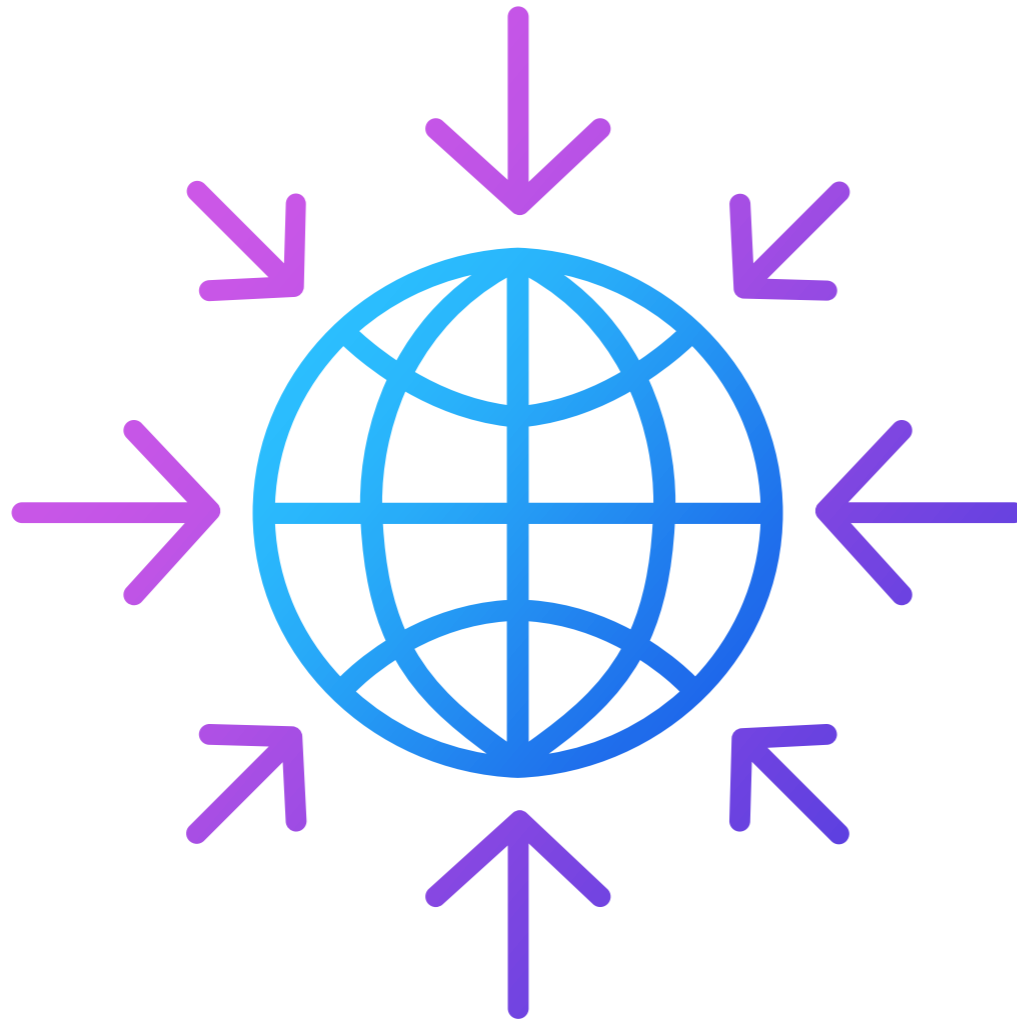

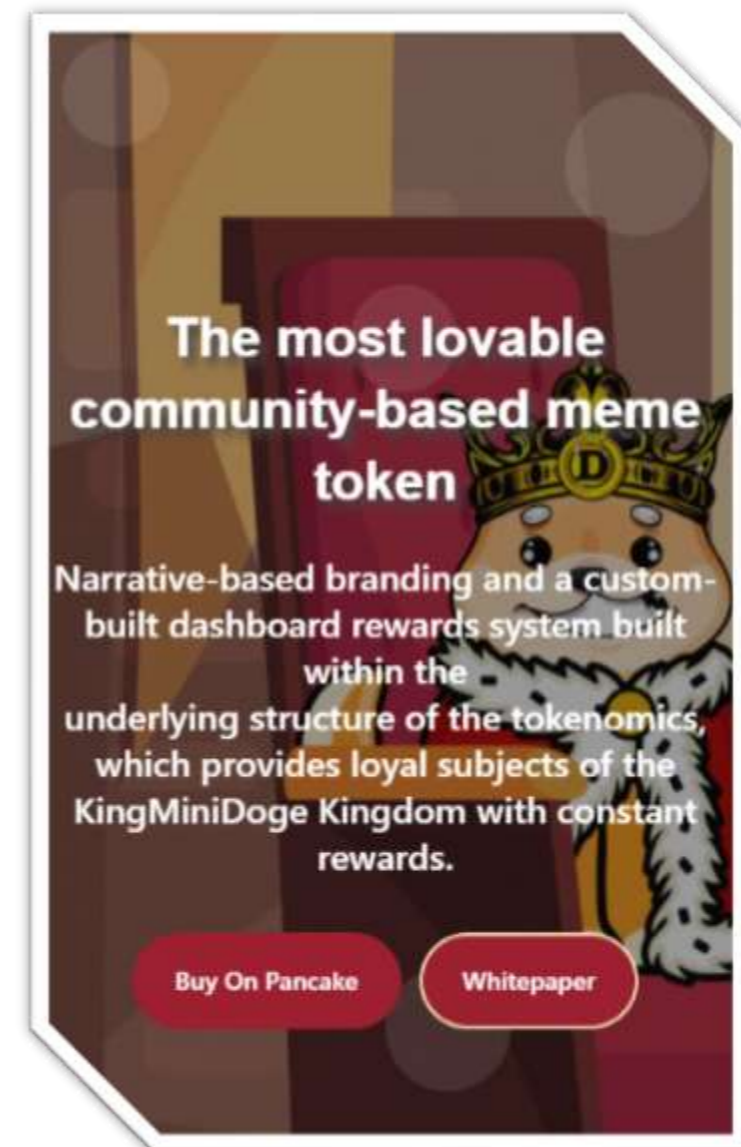
The website contained no JavaScript errors. No typos, or grammatical errors were present, and we found a valid SSL certificate allowing for access via https.

Social and Web – Final Thoughts & Suggestions for Improvement

We were able to track down social media channels for the project. Social Media channels included Twitter and Telegram. All social media channels had a healthy amount of activity.

It is important to note that there at least a 17% tax on EVERY transaction and it appears there is a 20% tax on all sells. 4% goes to providing liquidity, and 12% is distributed to the token holders in BNB and 1% is distributed back to the team for marketing. The team has been transparent that they will not be locking the marketing wallet and intend to use the distributed tokens to maintain operations and scale the project. We were unable to find where the additional 3% tax on sells is directed.

We recommend adding in an email or contact form to the website as all holders do not use social media as their main form of communication.

Suggestions for Improvement

1. Update Tokenomics to reflect what the additional 3% tax on sells will be used for.
2. Update domain registration to 3+ years.
3. Add contact email to the website.
4. Add additional social media channels.



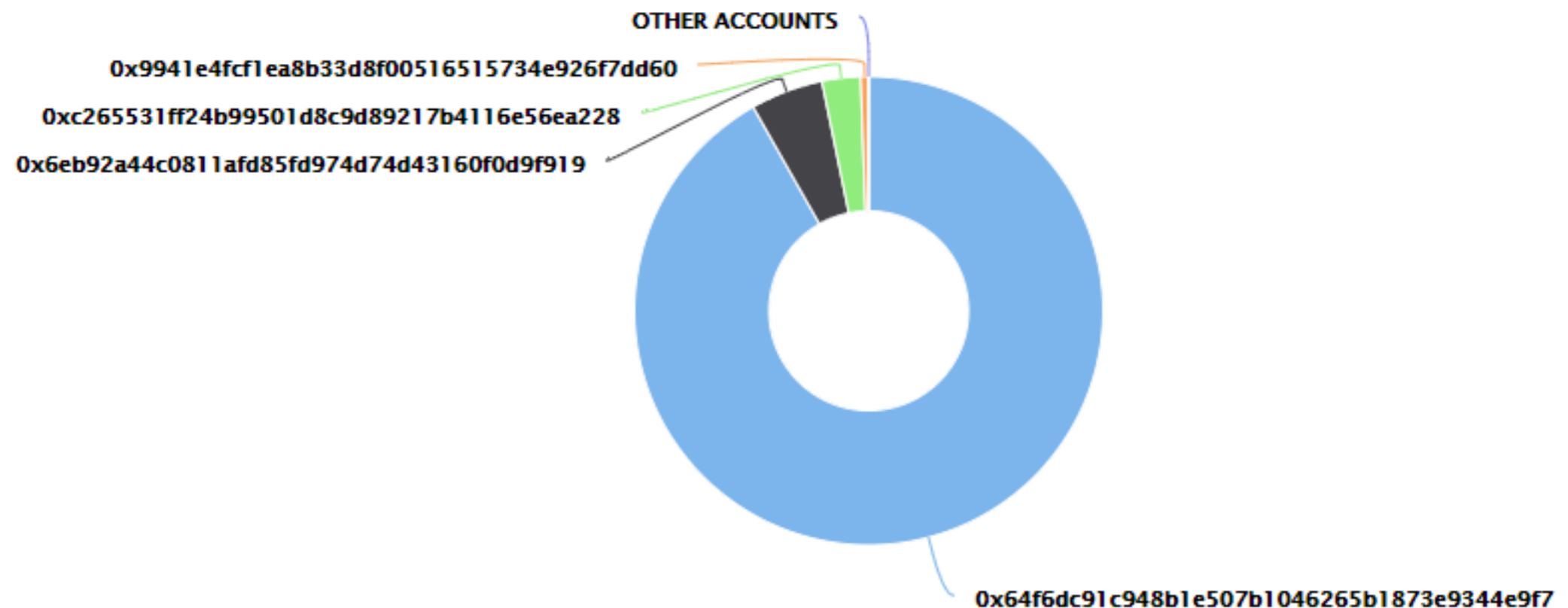
Top Token Holders

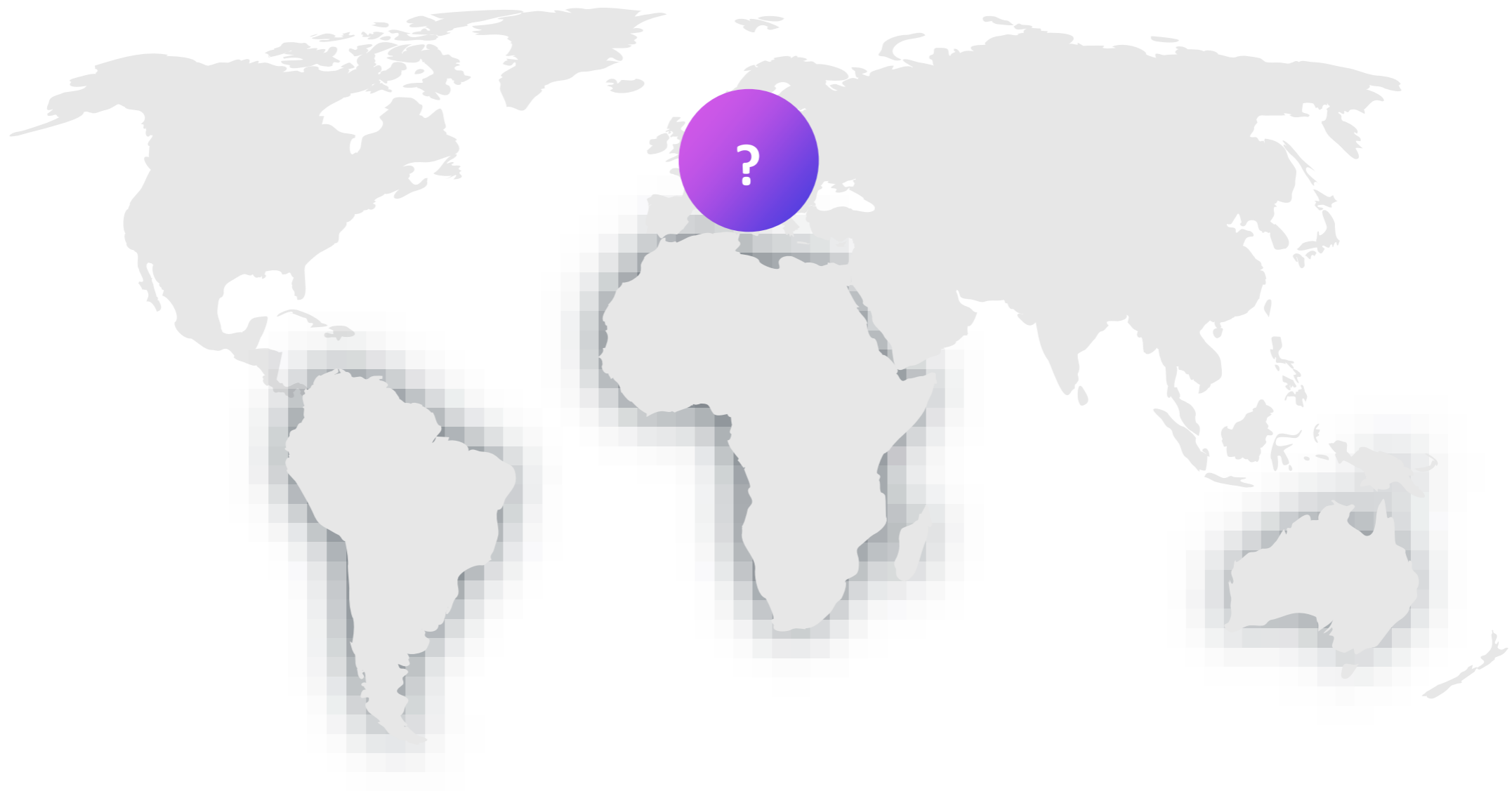
KingMiniDoge Top 100 Token Holders

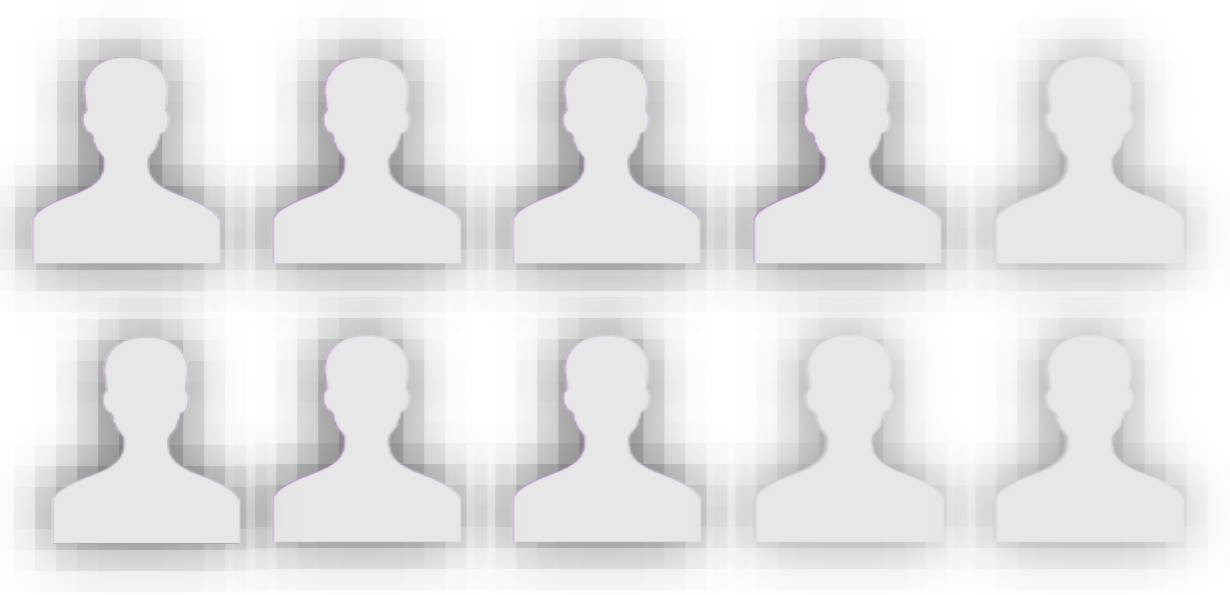

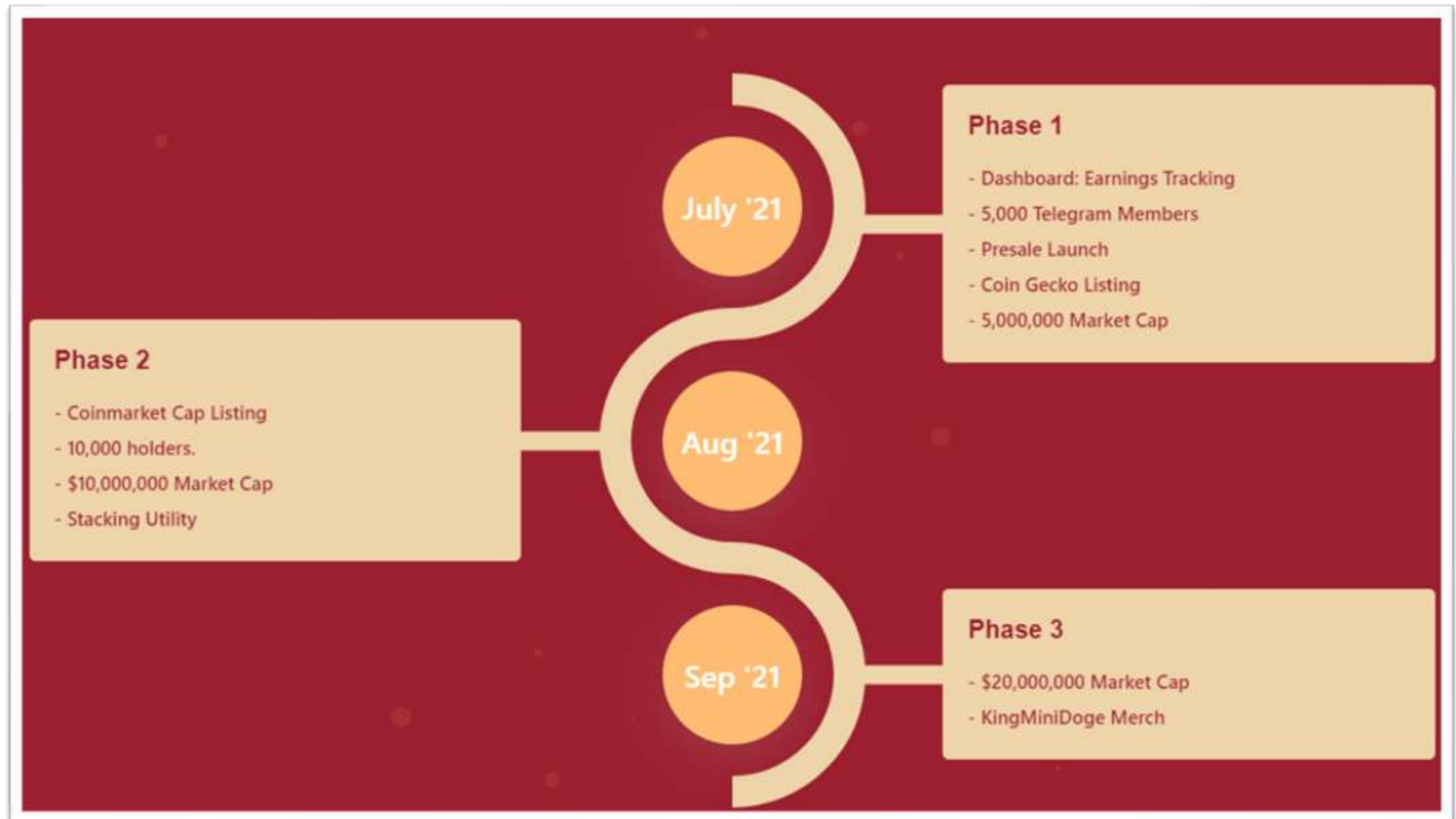
