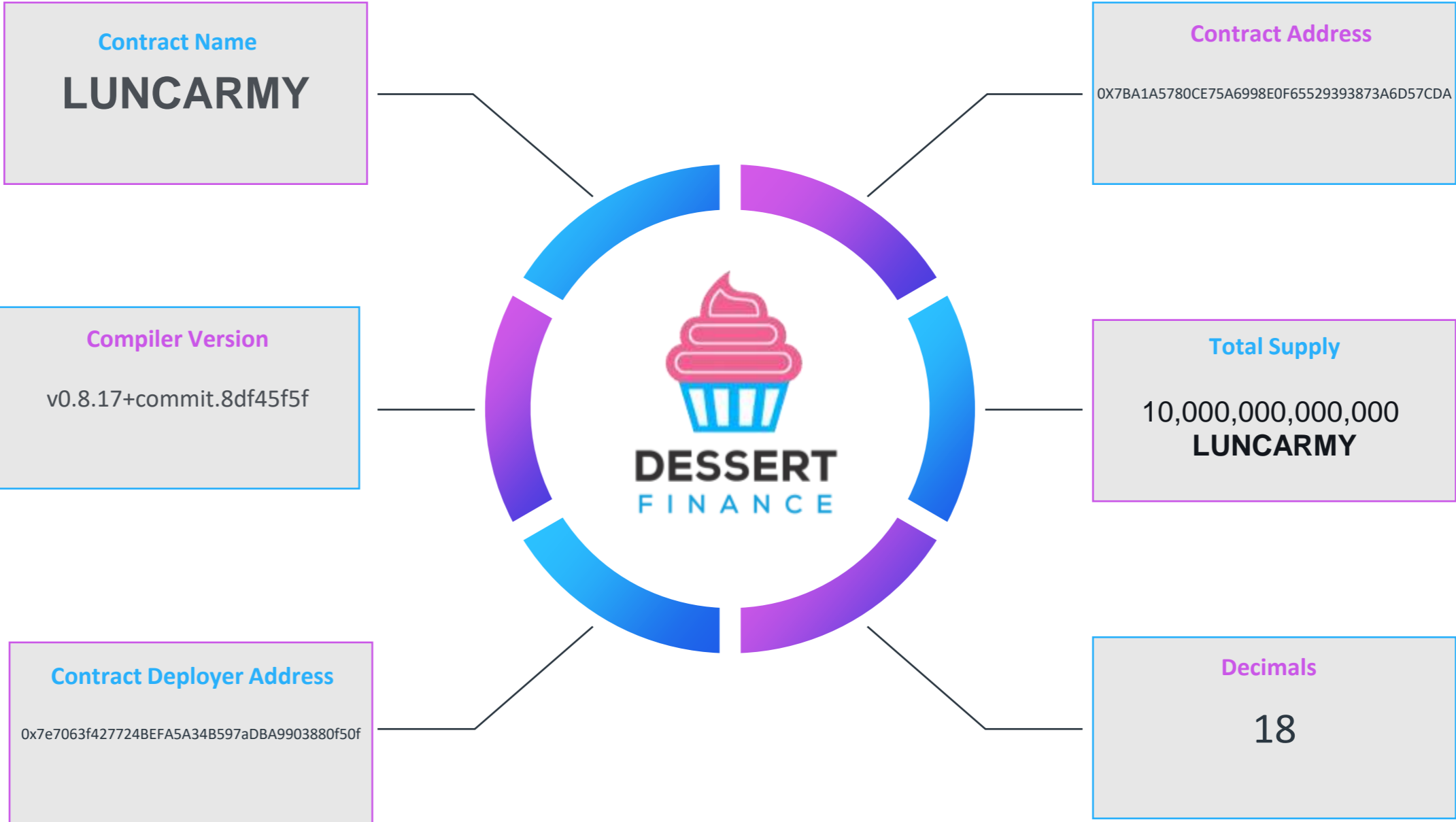

- Assignment of privileged roles to multi-signature wallets

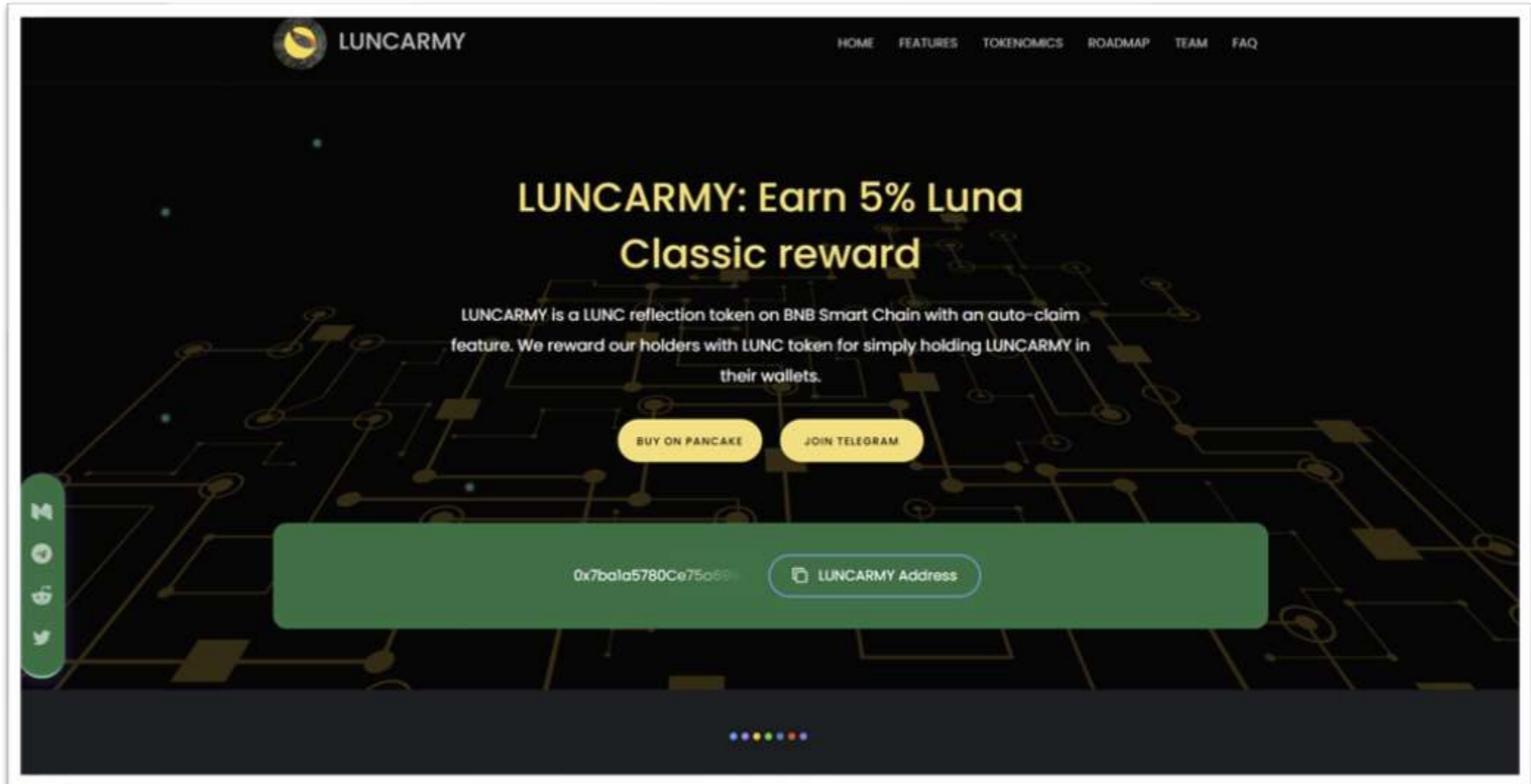

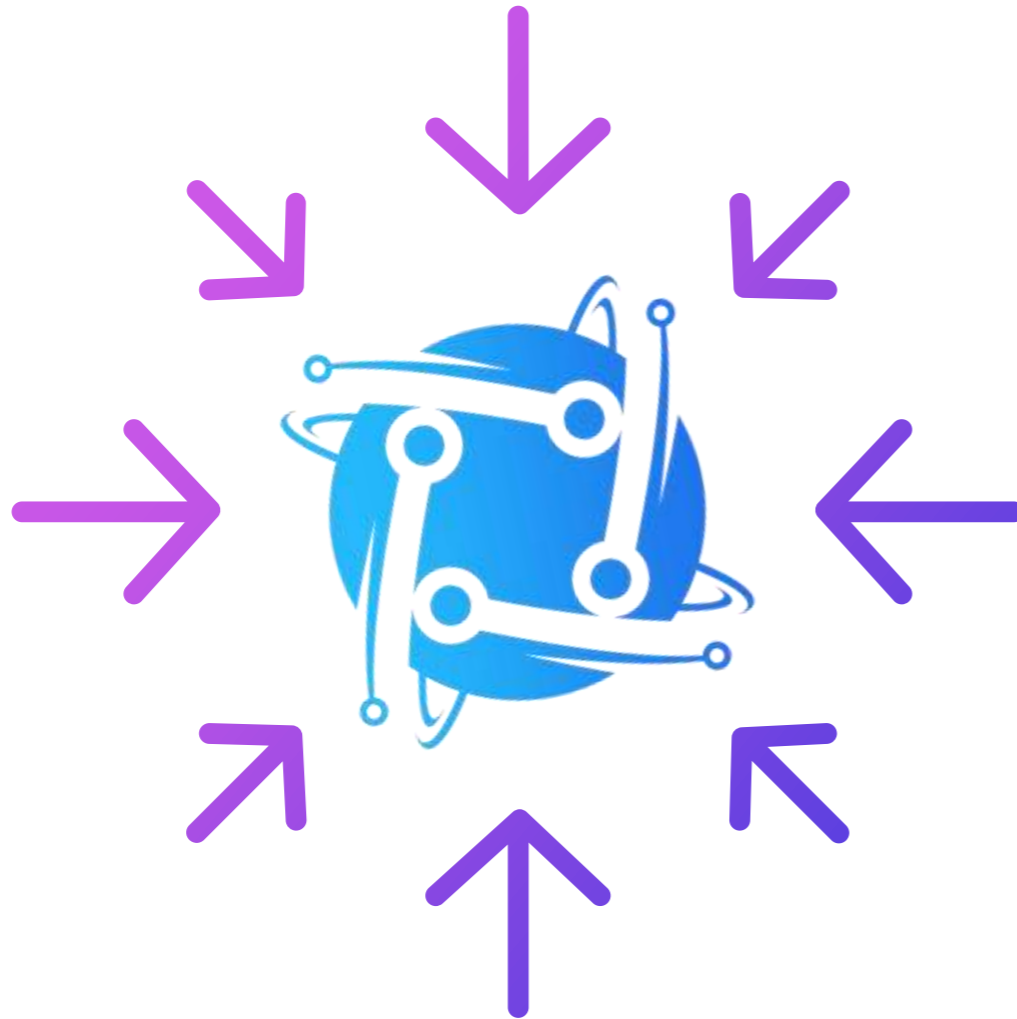

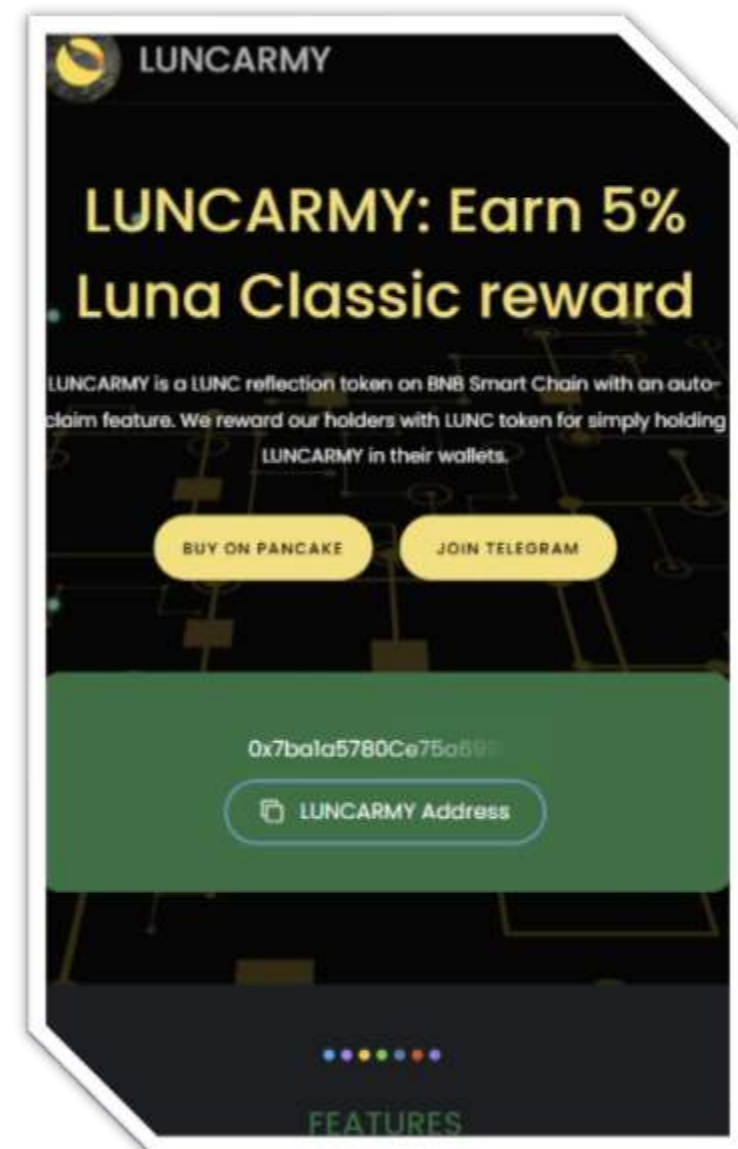
No additional issues were found on the website.

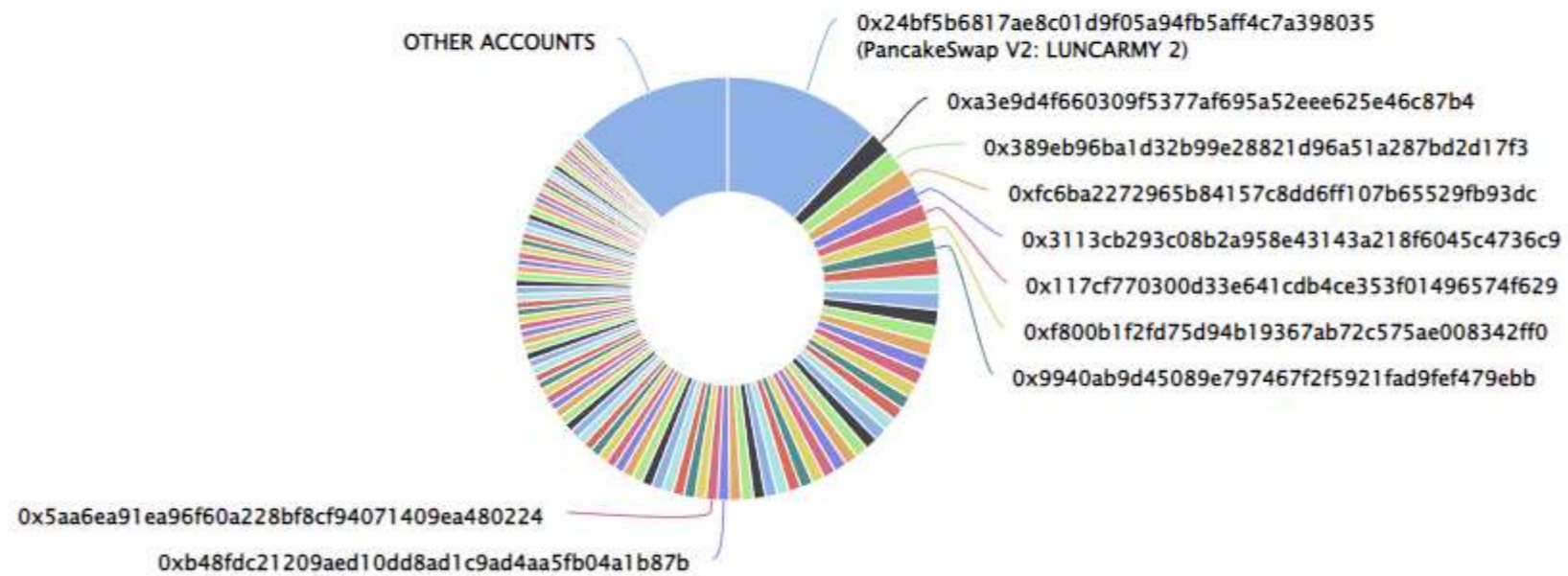

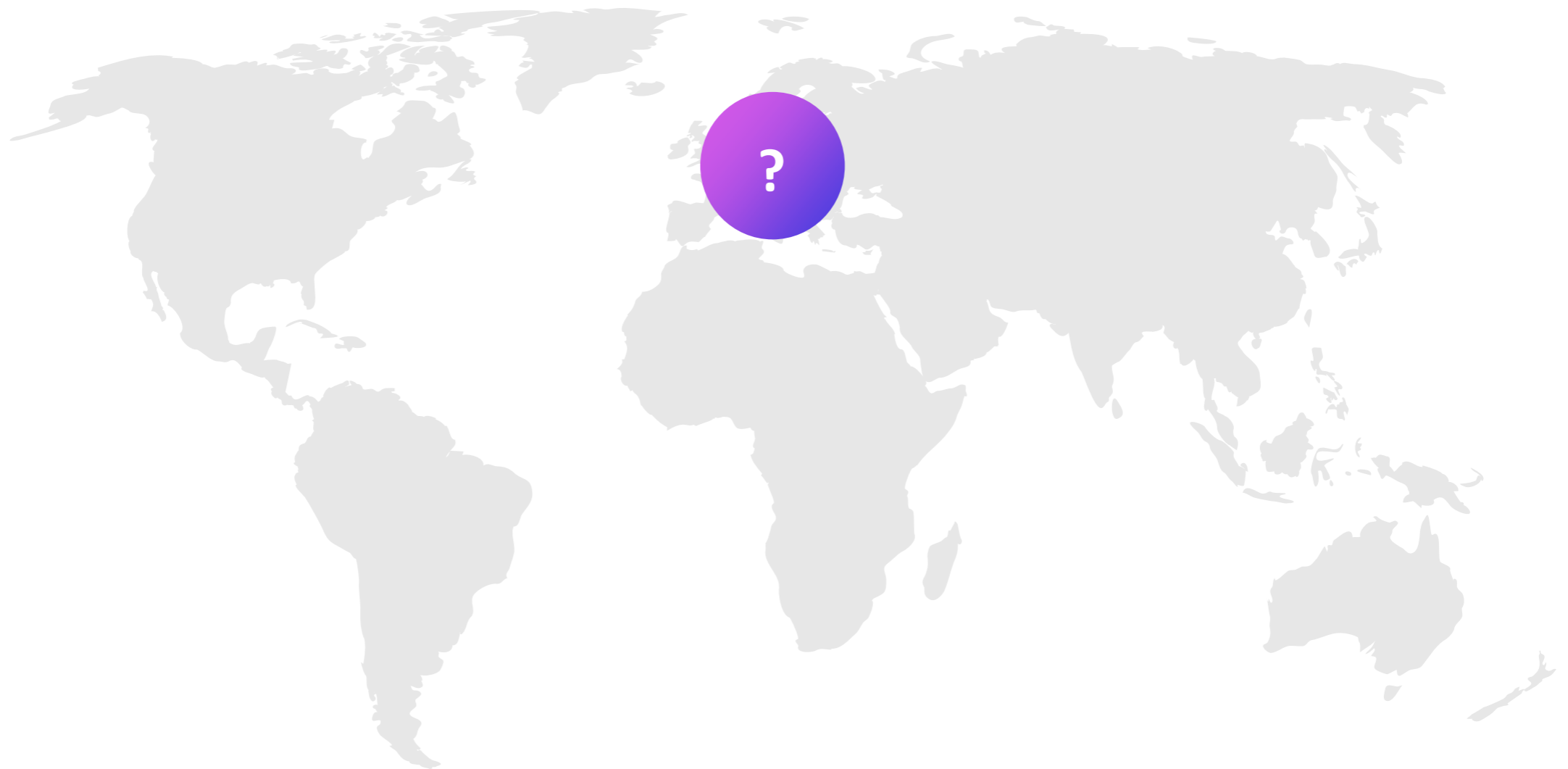

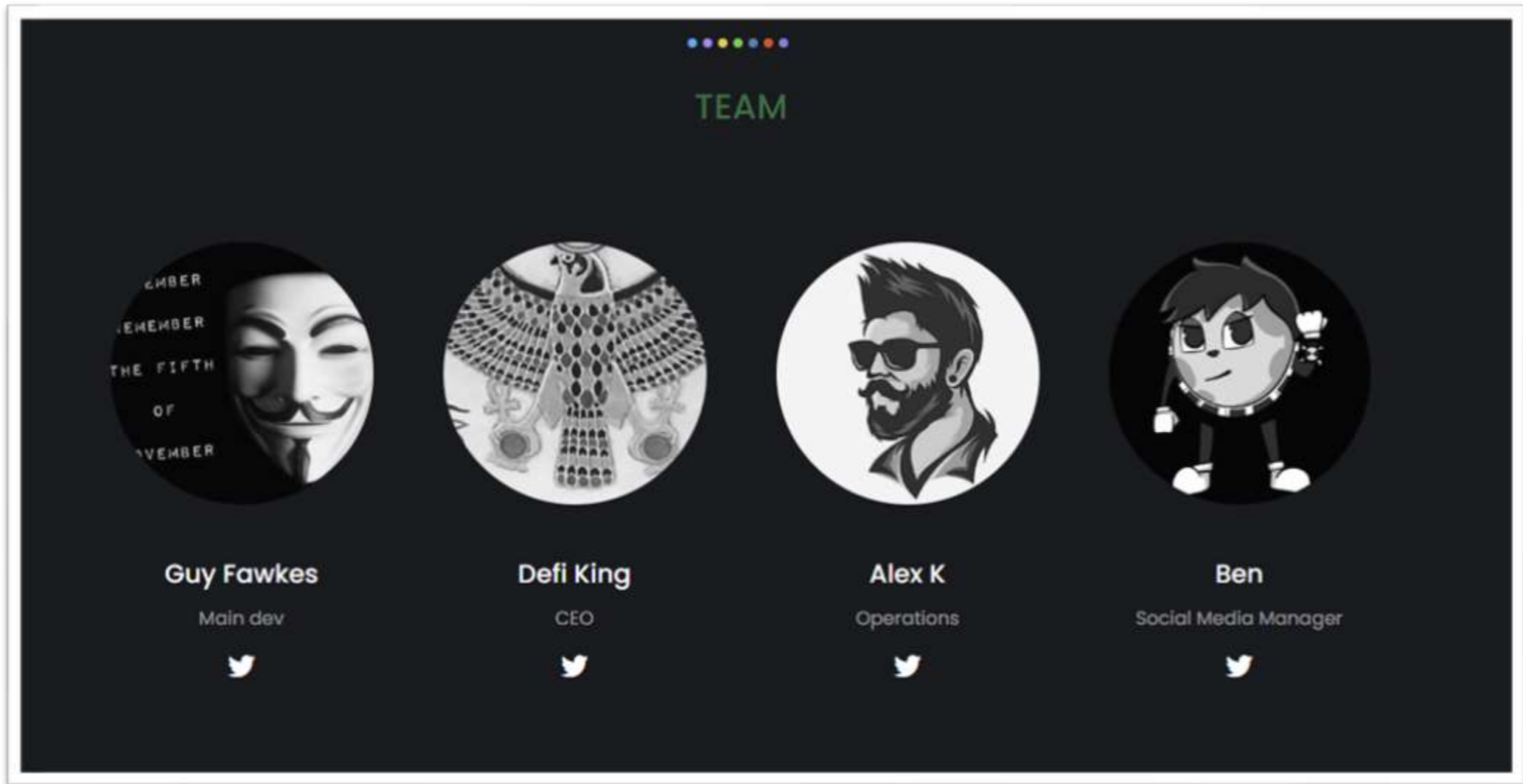
