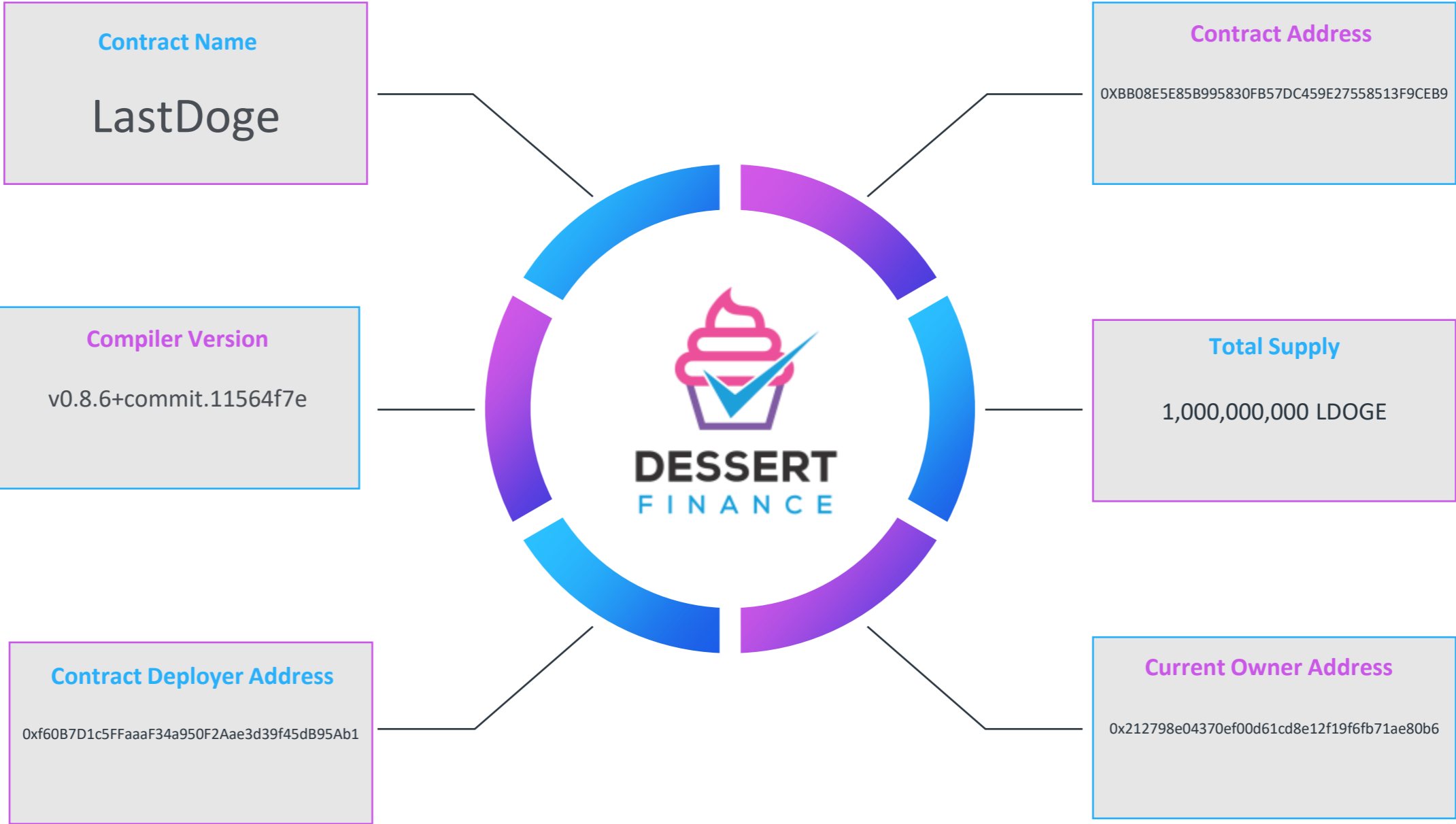

## **AUTO CLAIM EVERY 60 MIN**

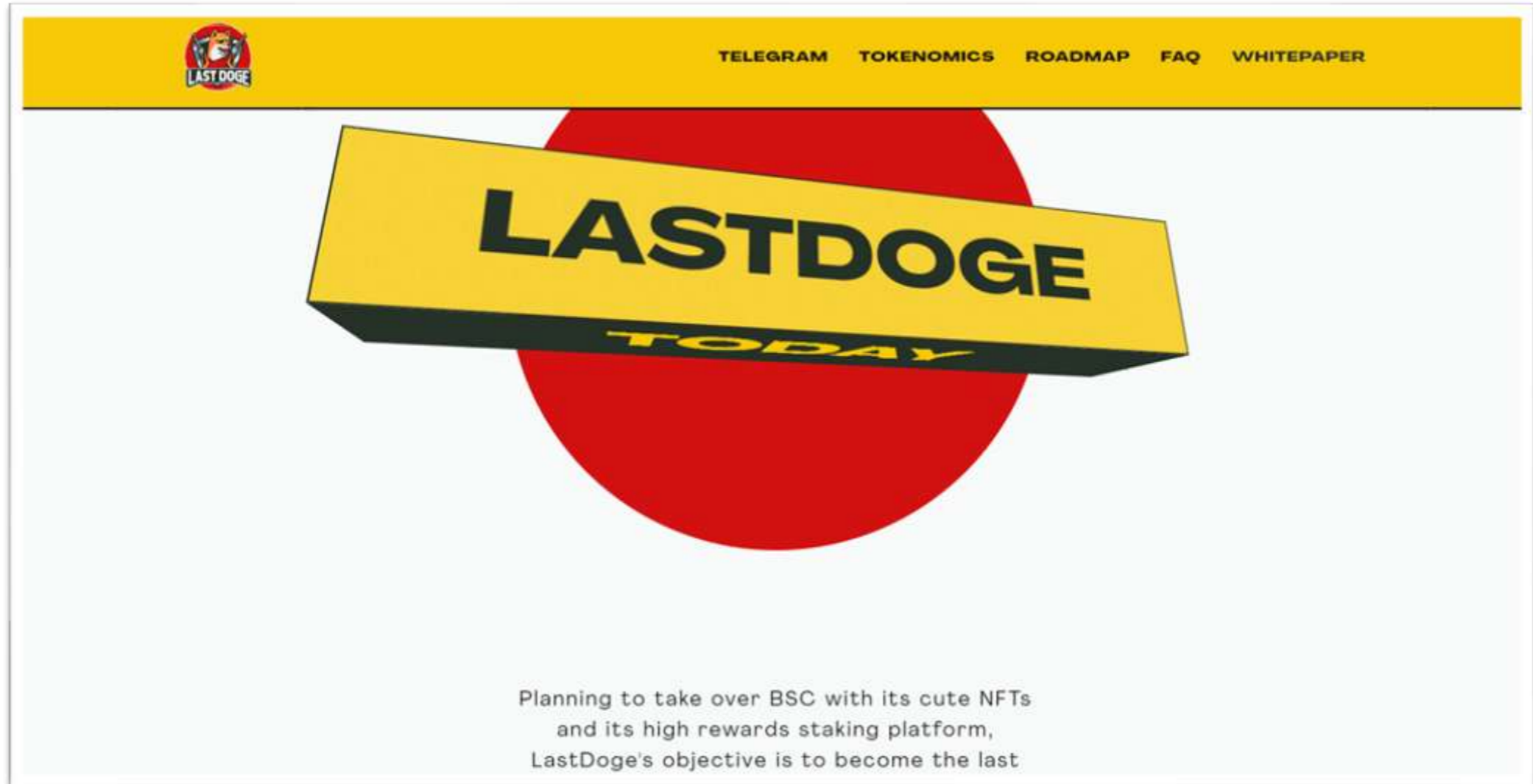
No action needed to actually claim the BNB, this will be sent to the holders wallet every 60 minutes.

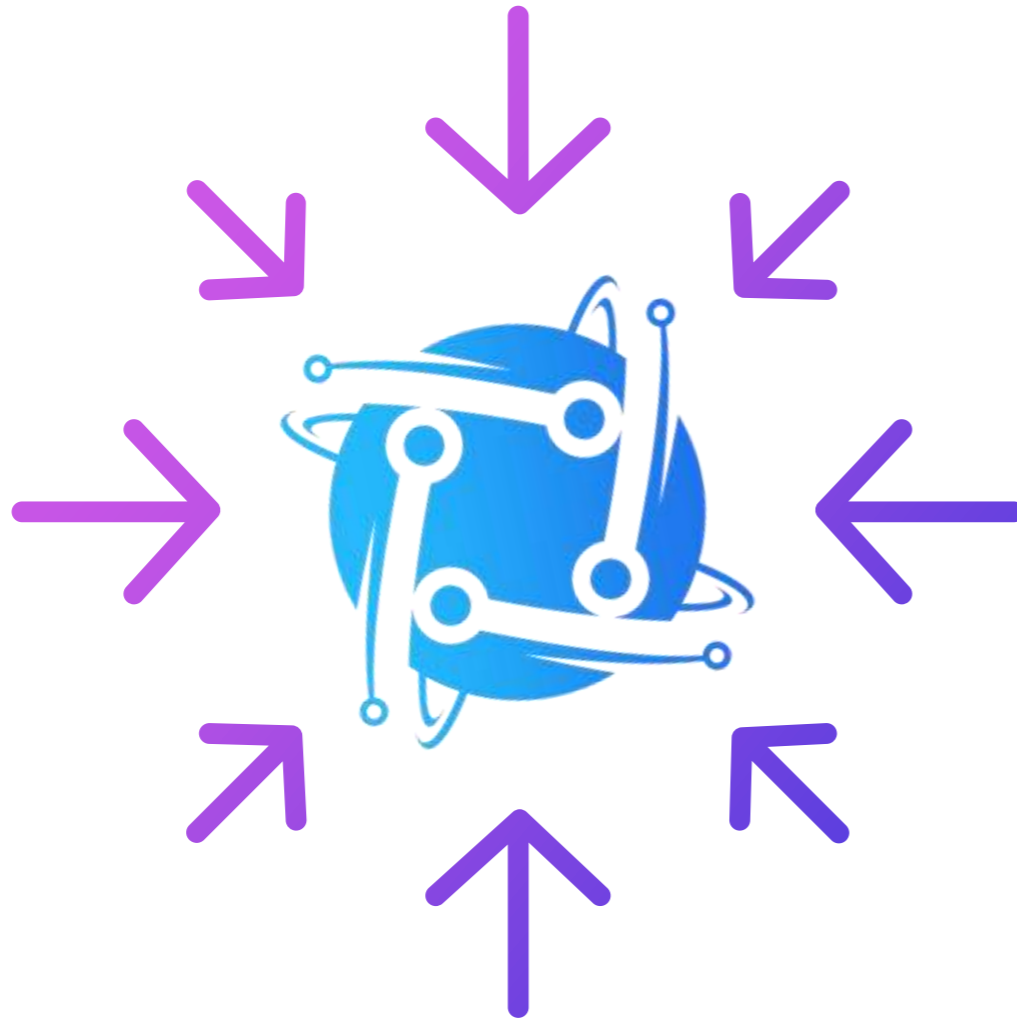

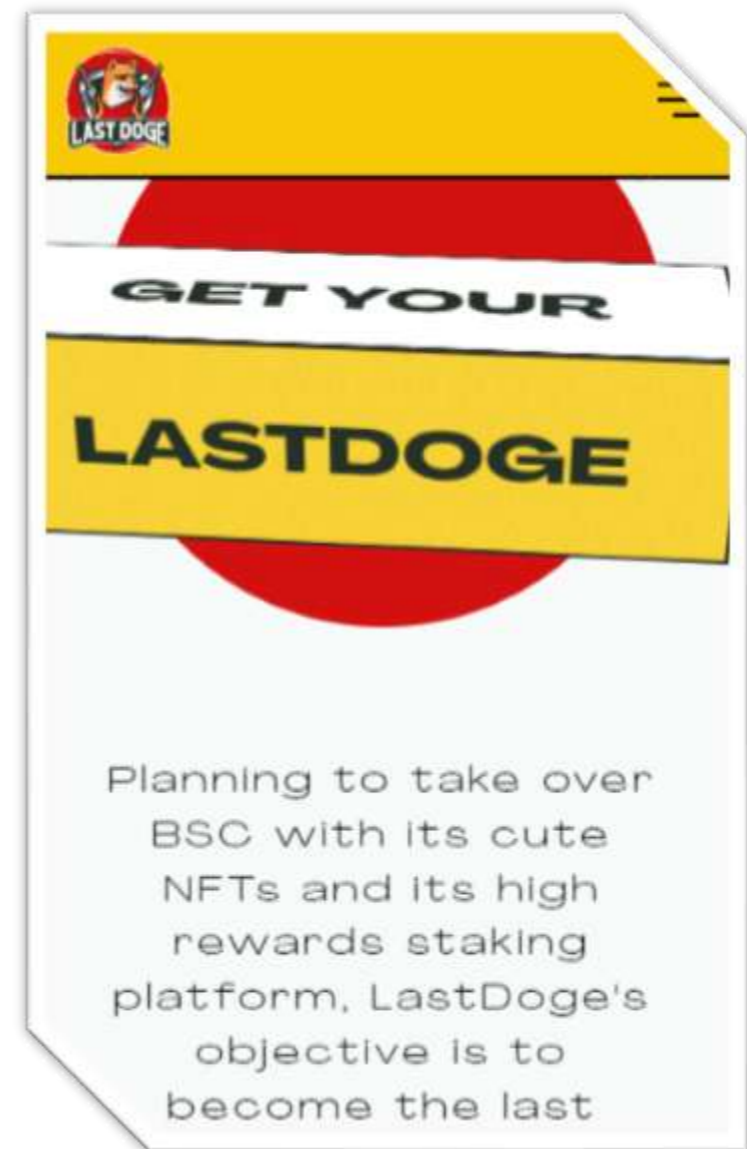
The website contained no JavaScript errors. No typos, or grammatical errors were present, and we found a valid SSL certificate allowing for access via https.

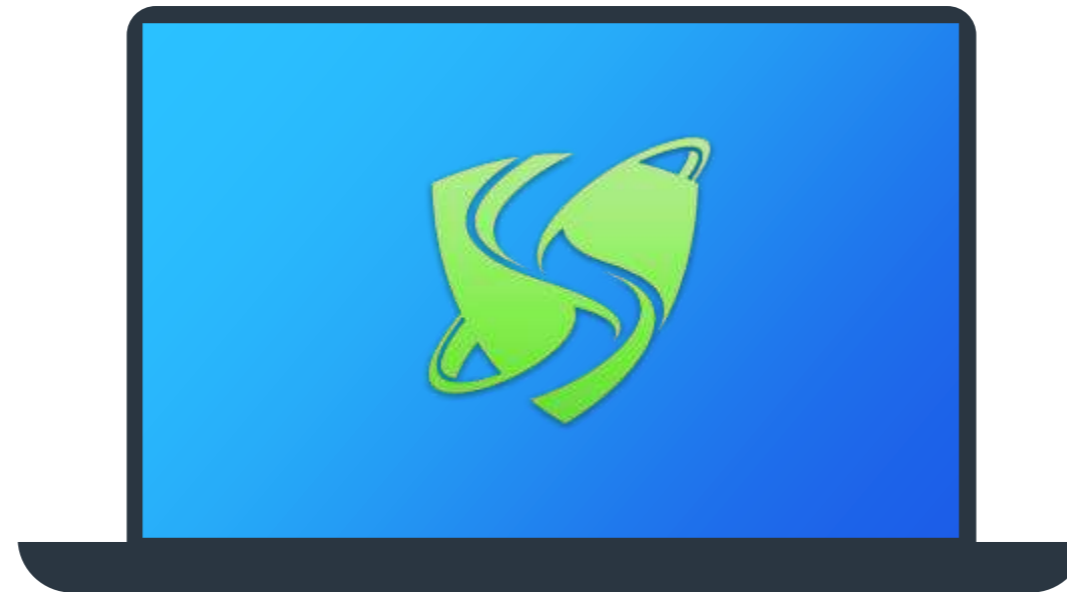

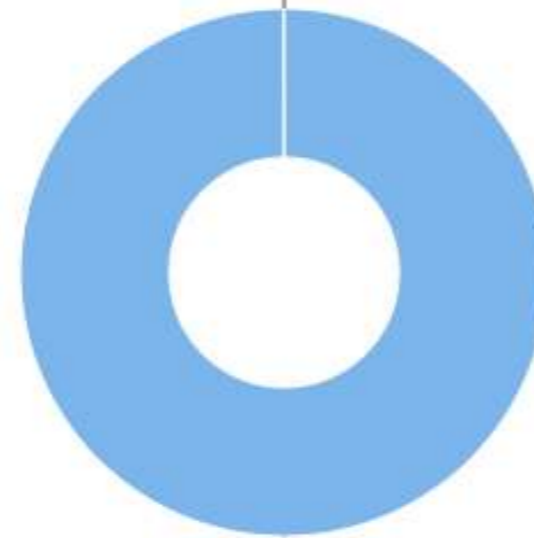

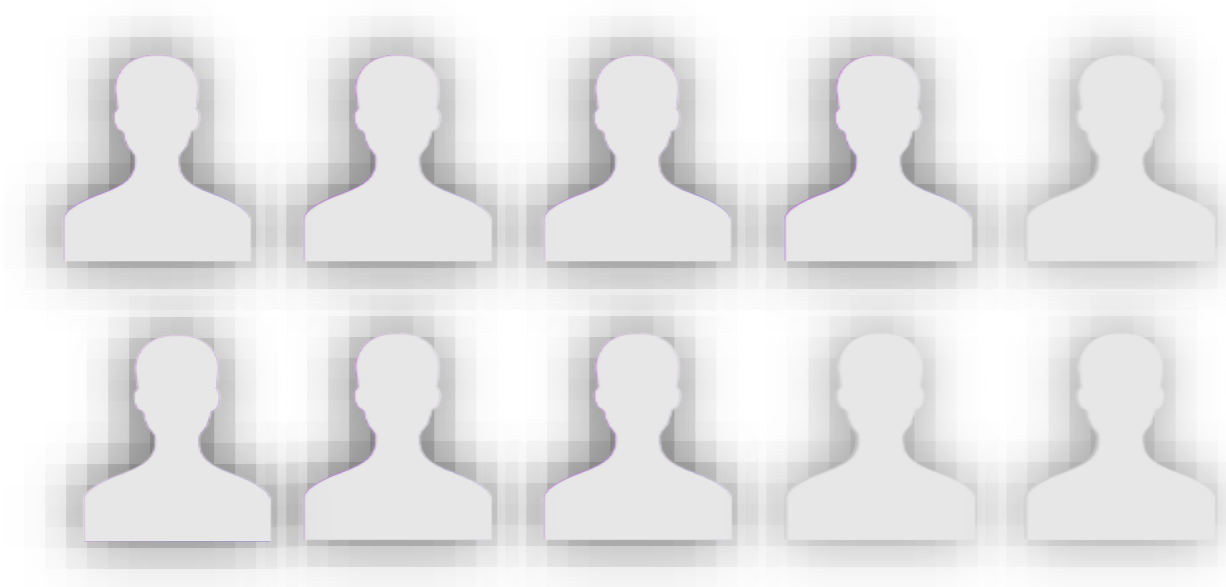
