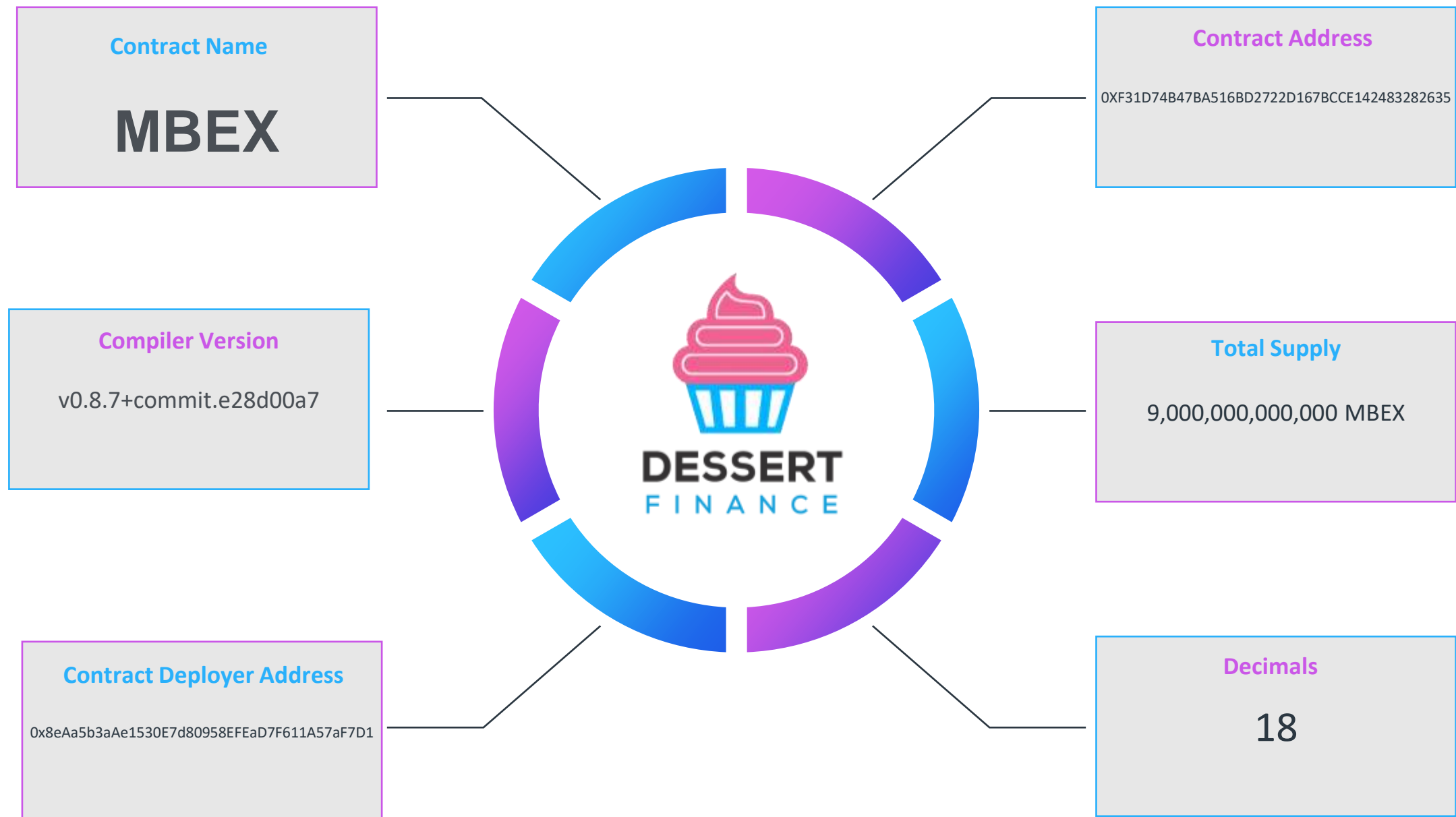

We have a designated charity wallet that receives 2% redistributions that are used to support our charity partners.

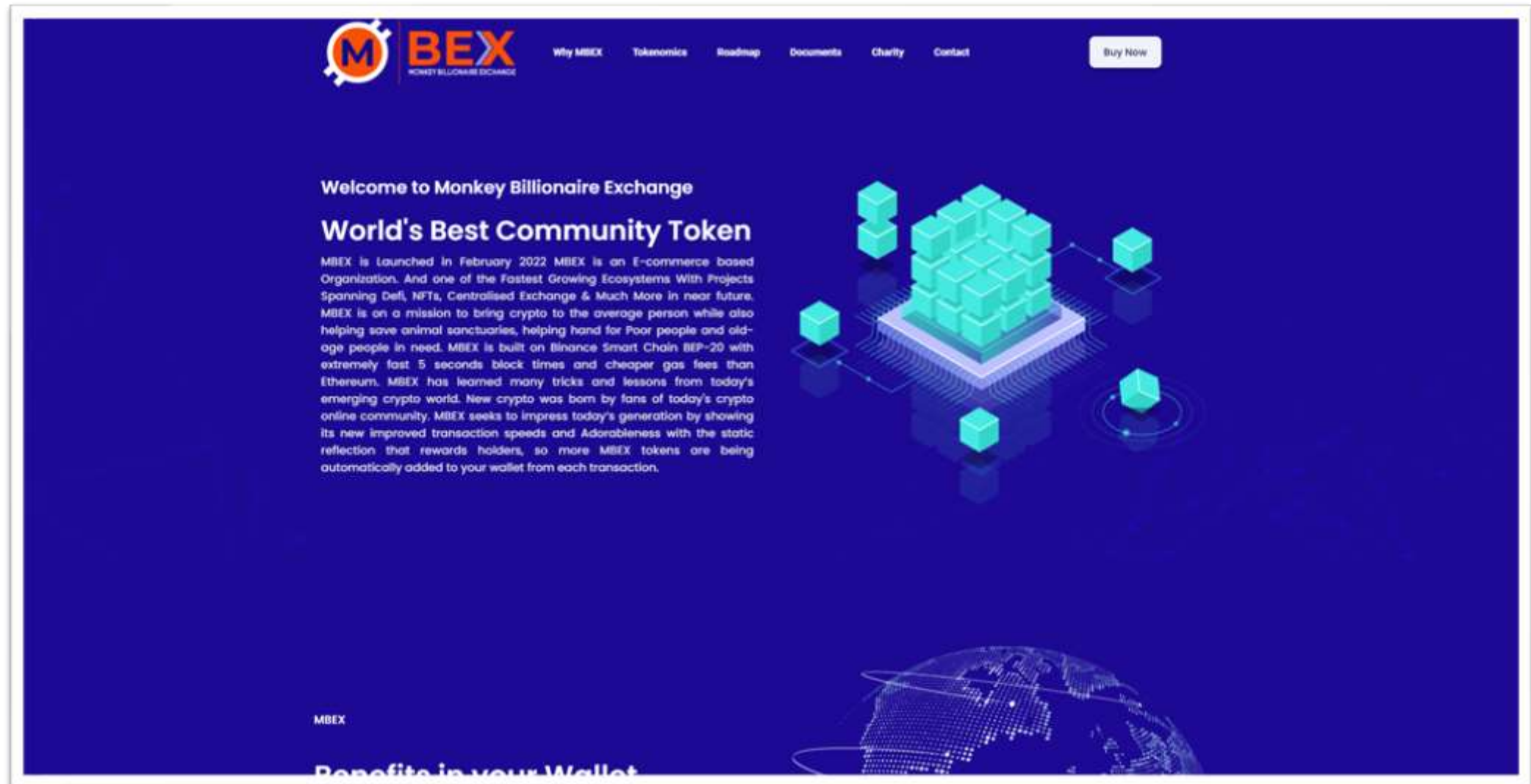

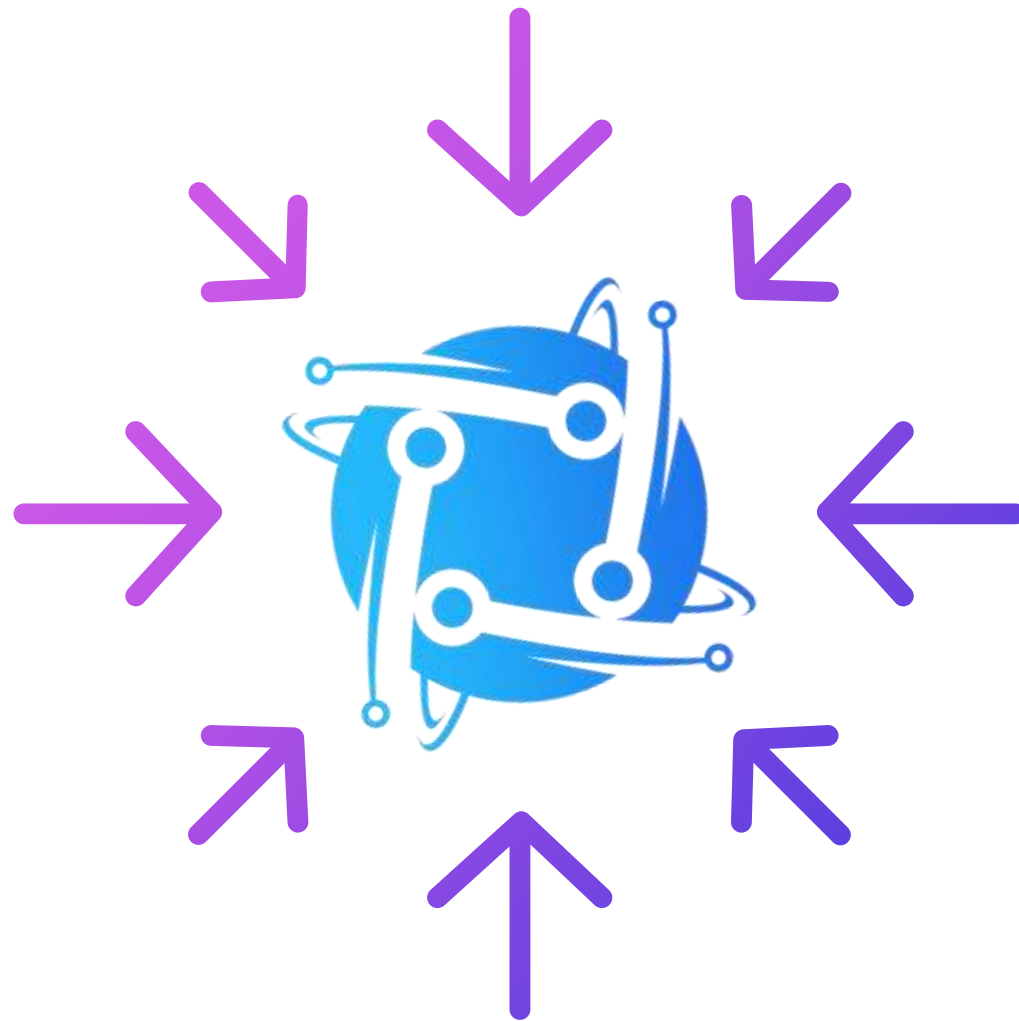

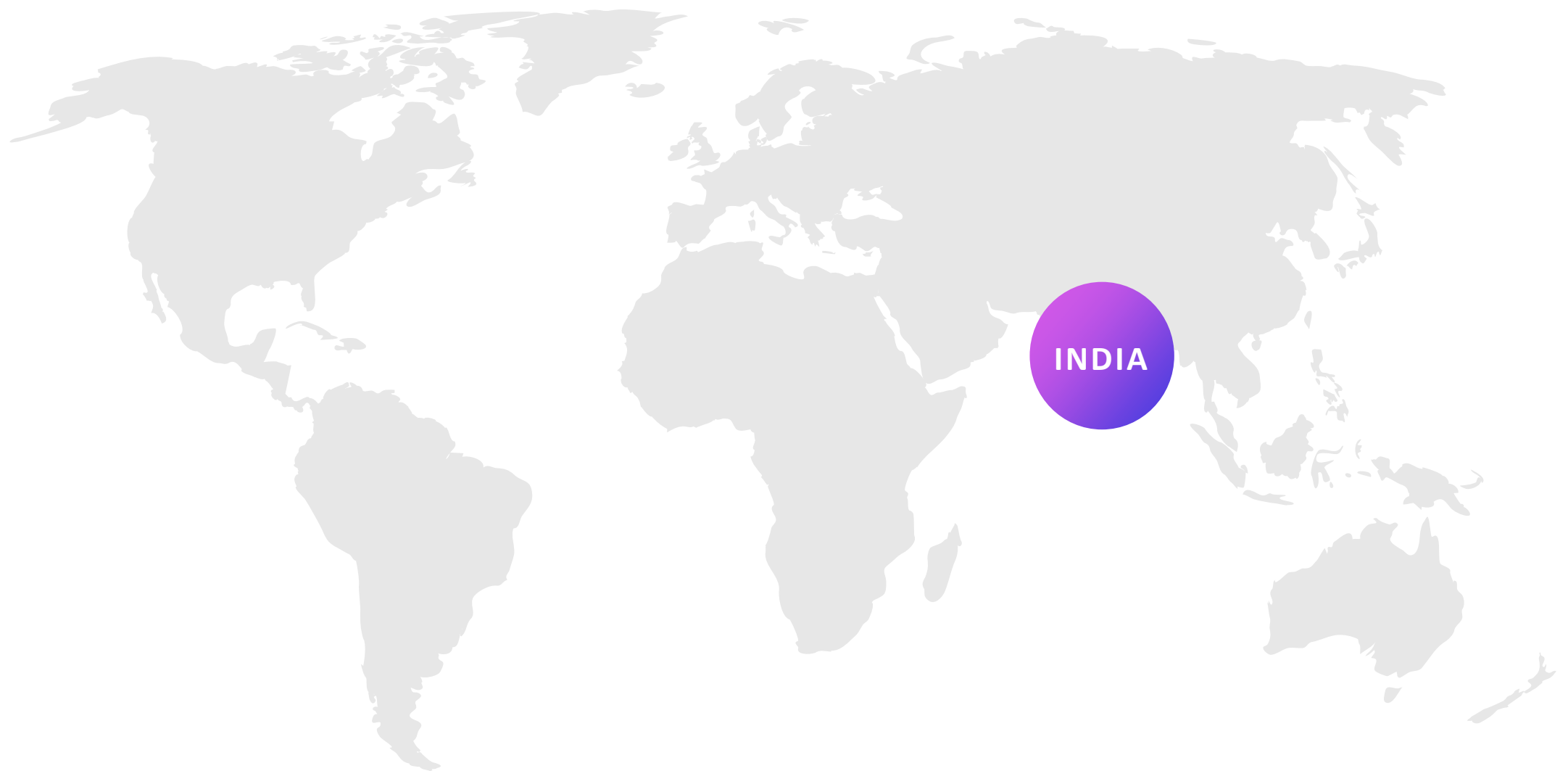
