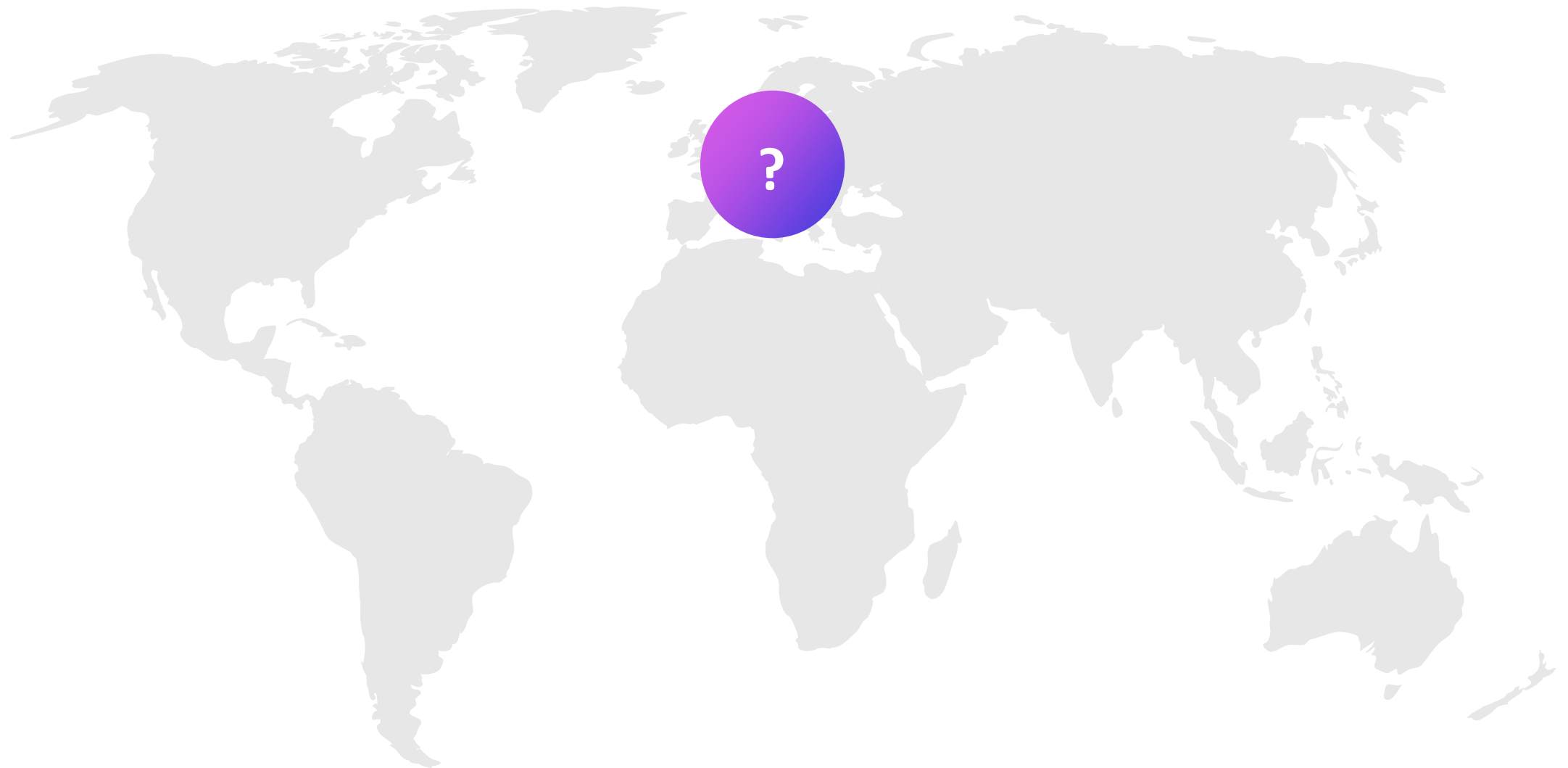
MarioFloki Top 100 Token Holders

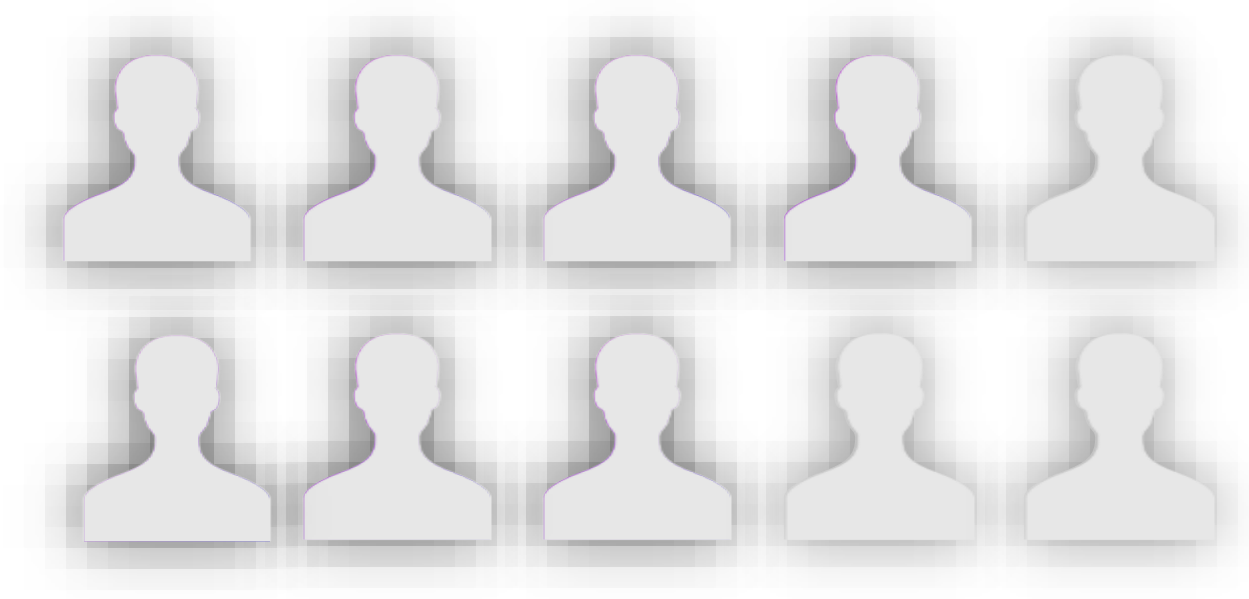
