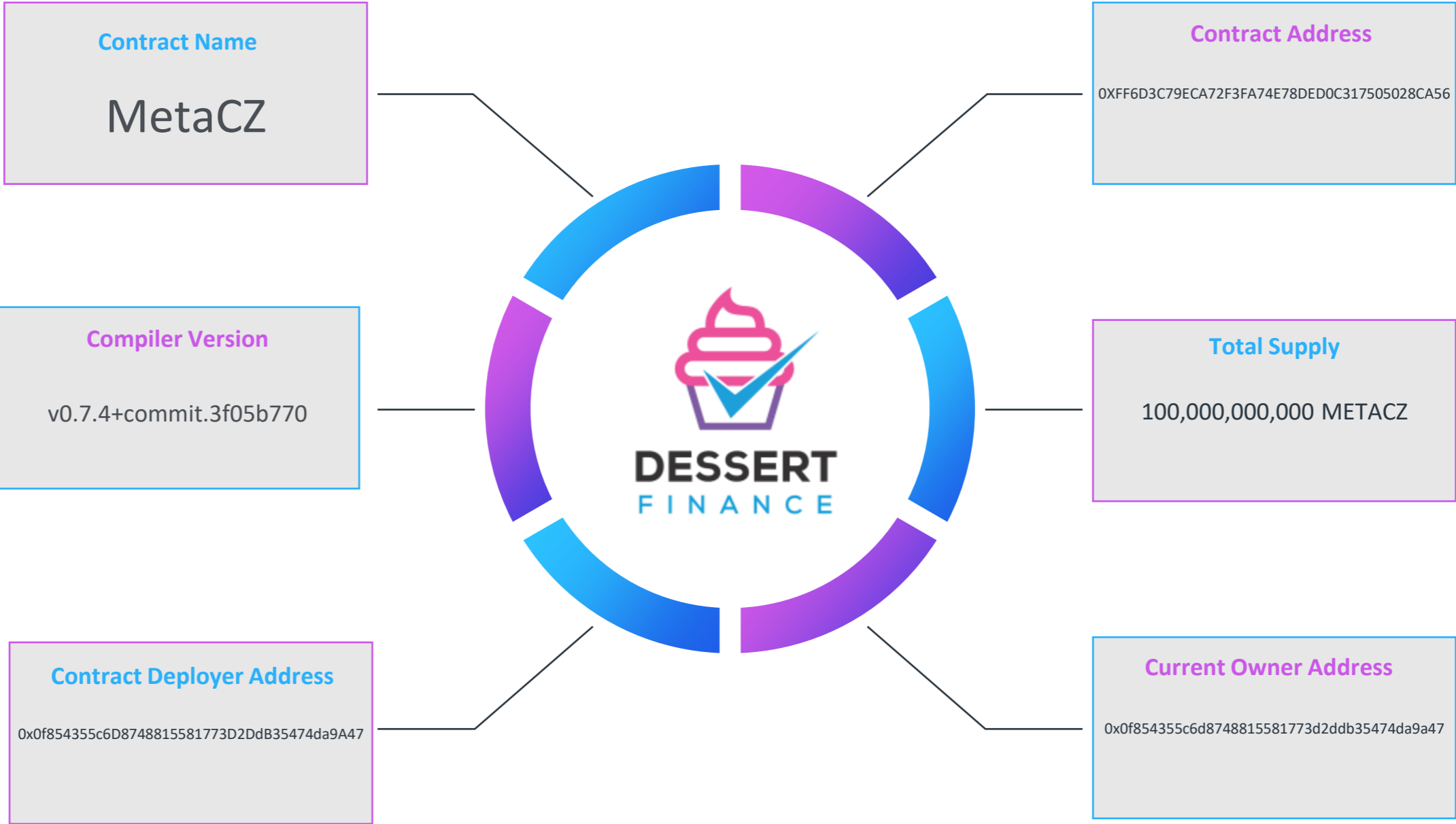

## 7% Marketing

MetaCZ utilizes a 7% buy & sell fee to spread his name and grow his fame, bringing more people to the right side of the cause.

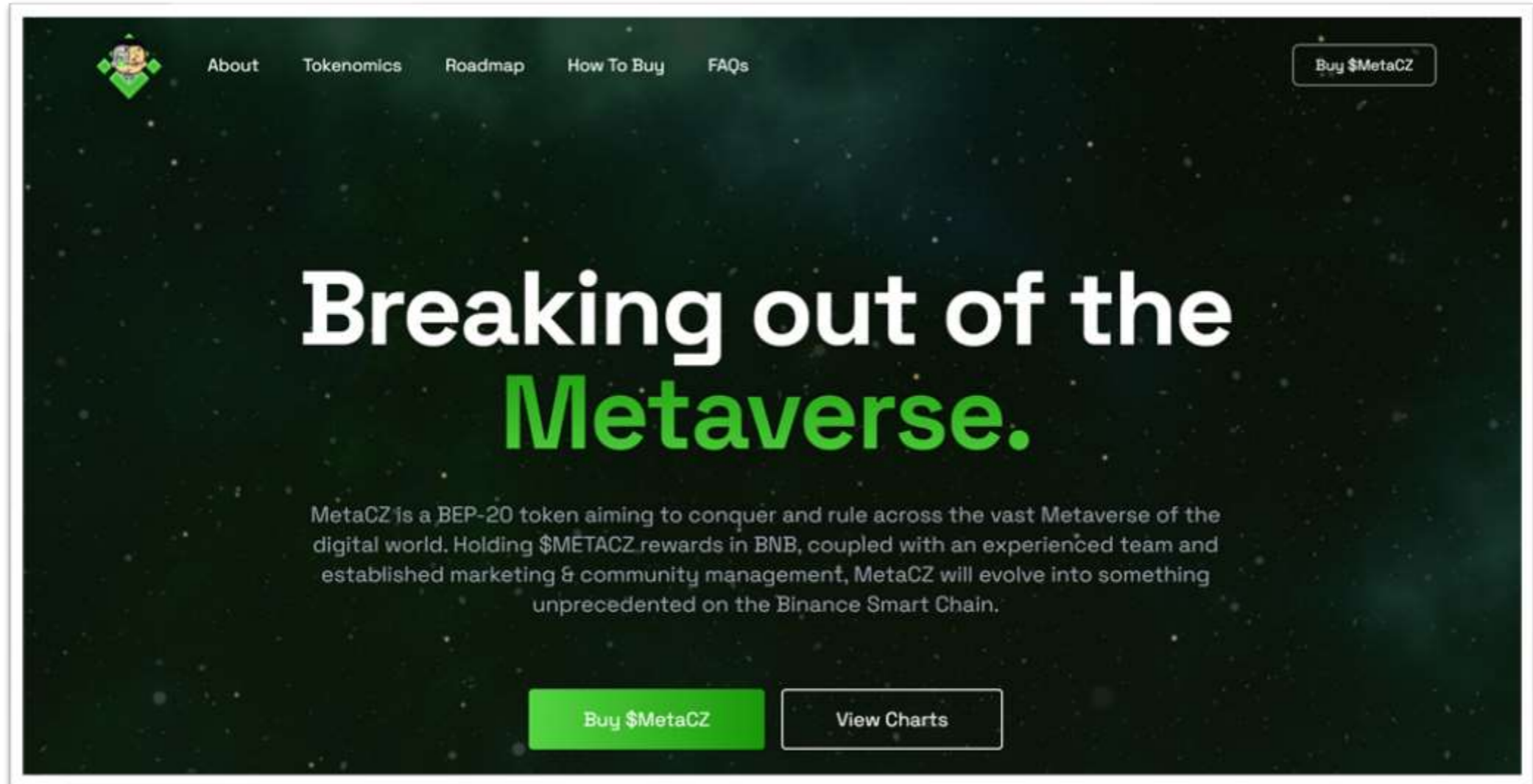


## 3% Auto Liquidity
