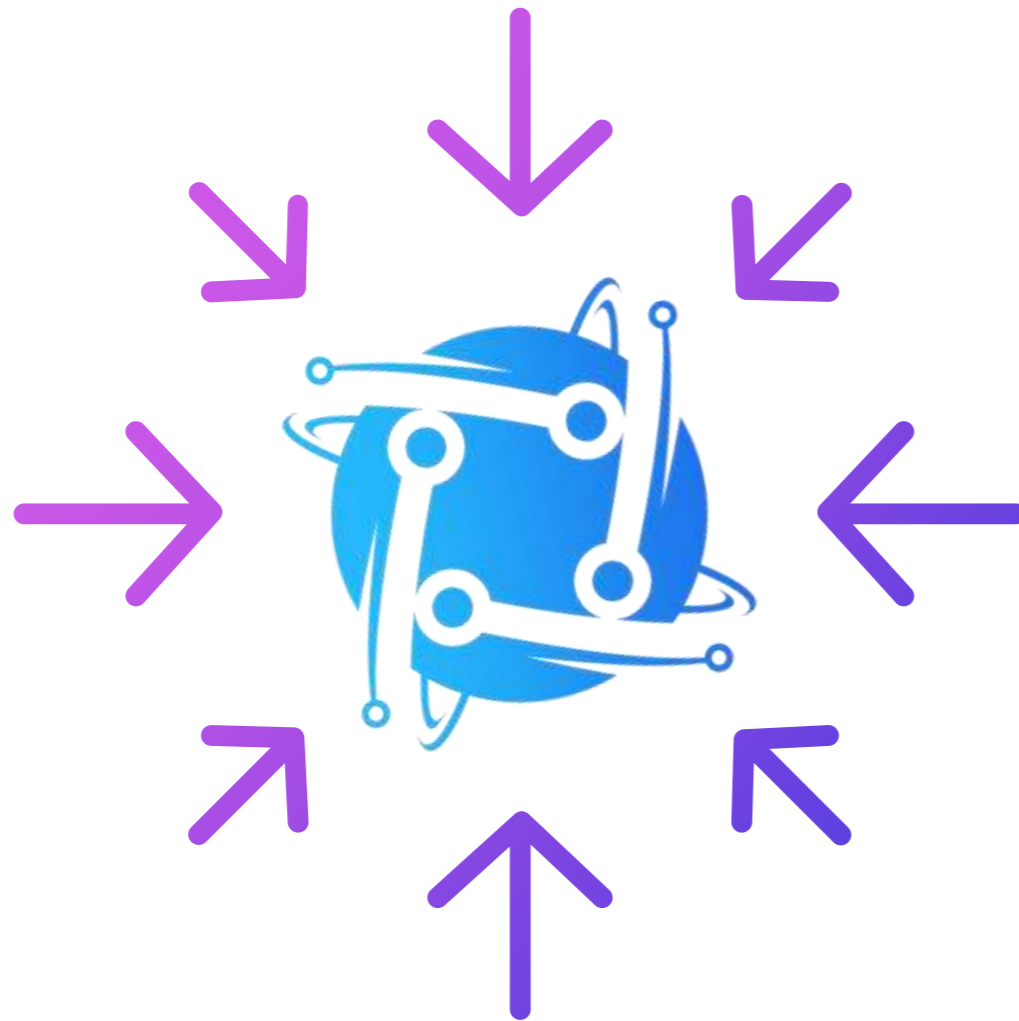

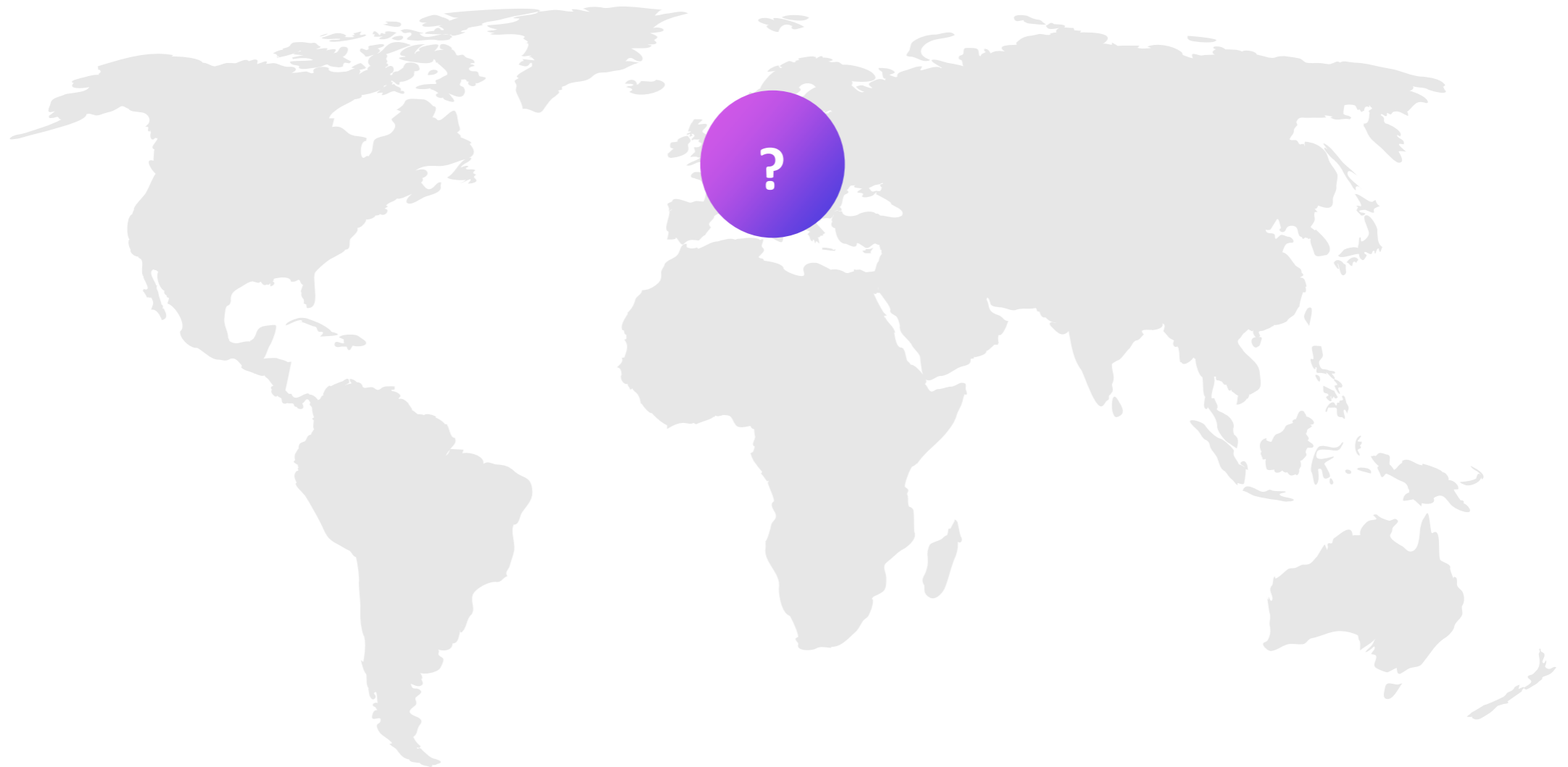
## Mewnbase Top 100 Token Holders

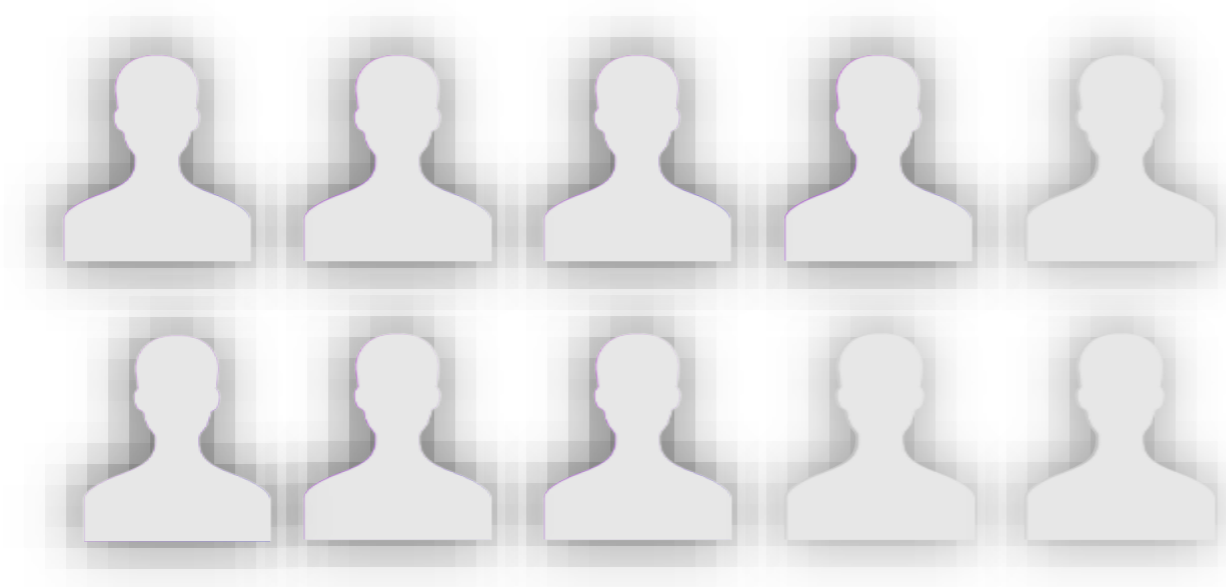
