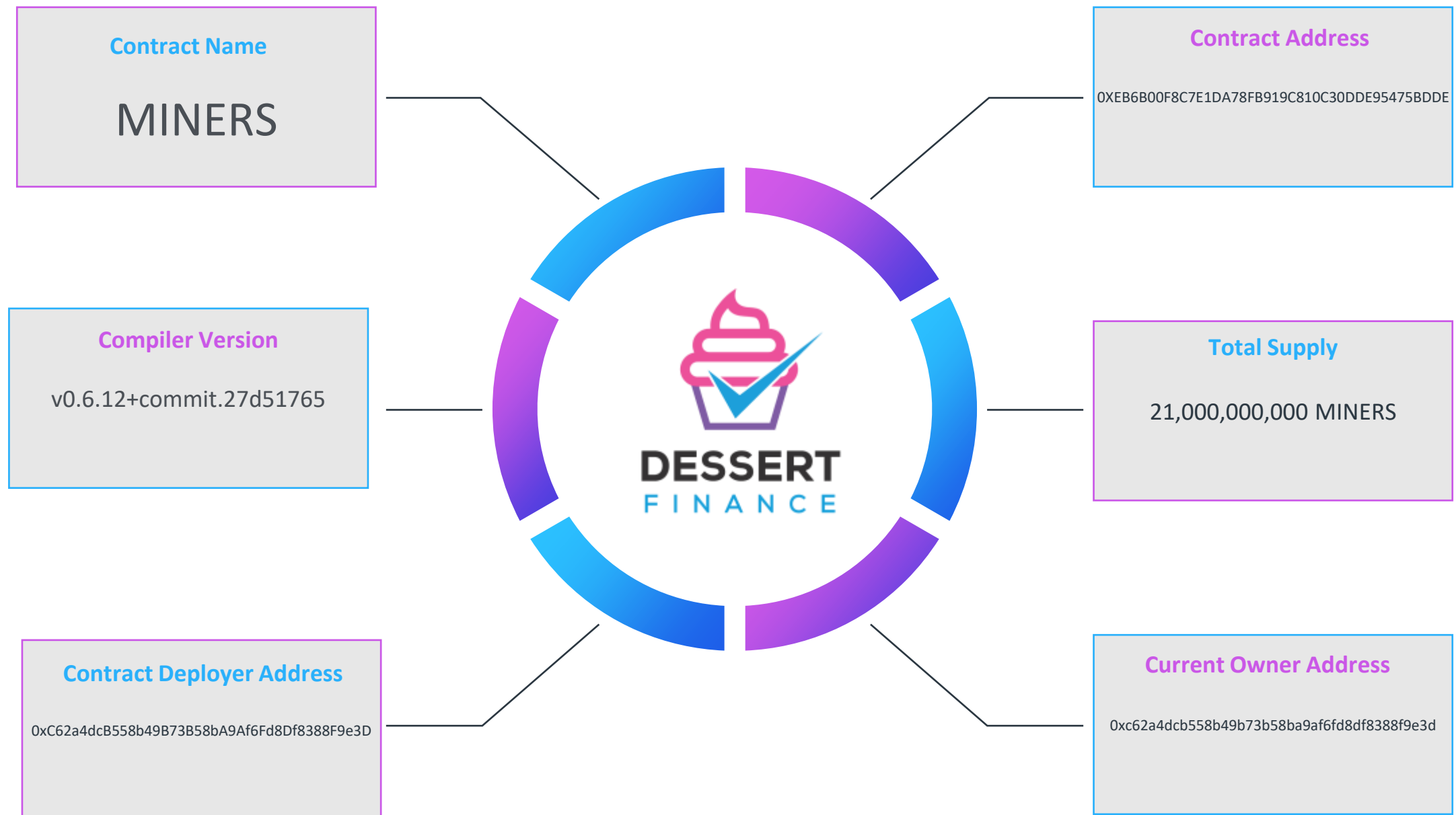

A mint function was not found in the contract code.

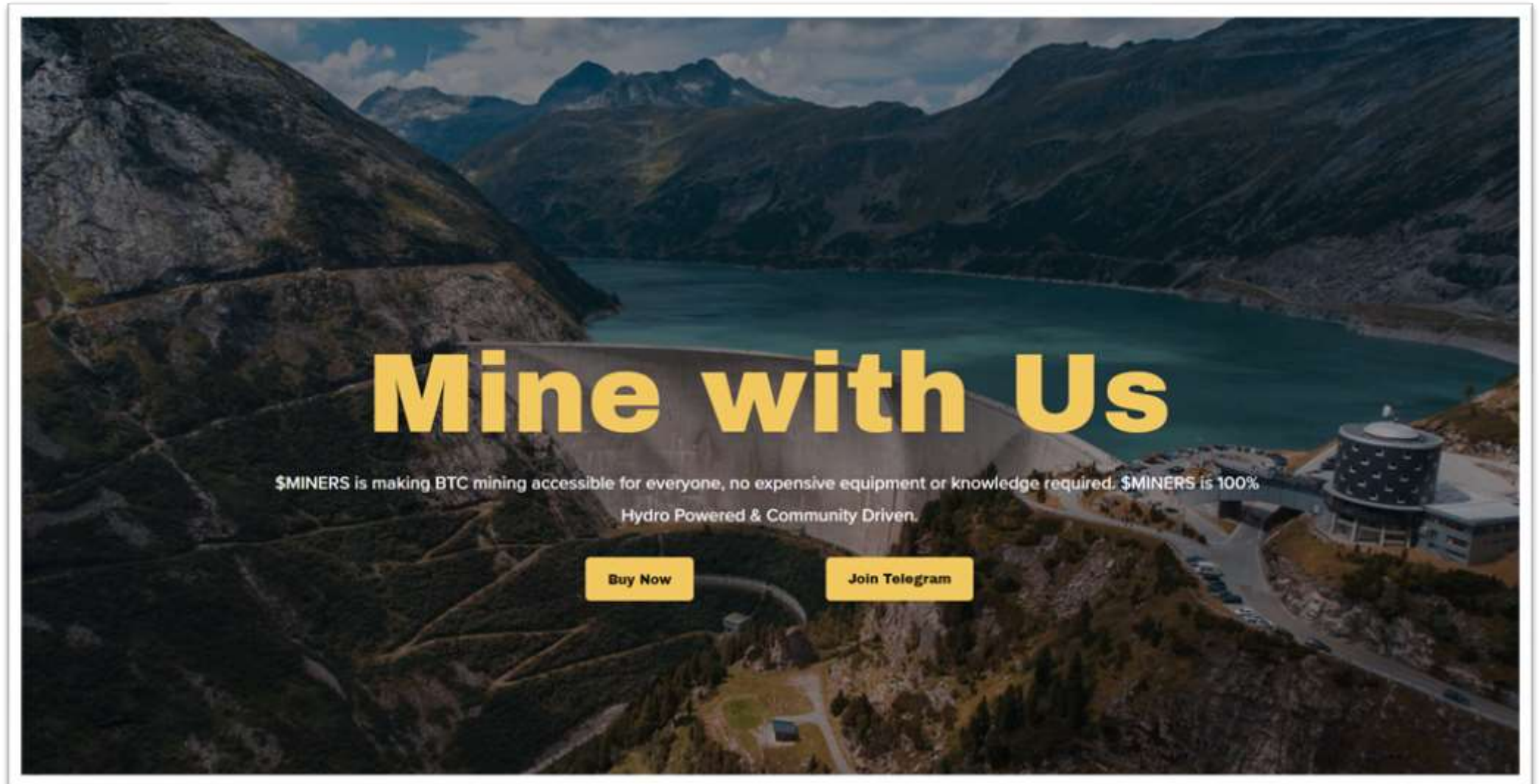
Contract Transaction Fees

At the time of Audit the transaction fees (“tax”) listed below are the fees associated with trading. These fees are taken from every buy and sell transaction unless otherwise stated.

12% Transaction Tax		
4% BTC Mining	4% Locked in LP	4% BTC Reflections
4% of each transaction goes straight to fund mining, furthering the long-term mission of the token.	4% of each transaction is locked in Pancakeswap v2 liquidity, ensuring the stability and liquidity of the token.	4% of each transaction is sent as a BTC reflection to all holders, incentivizing long-term holding.

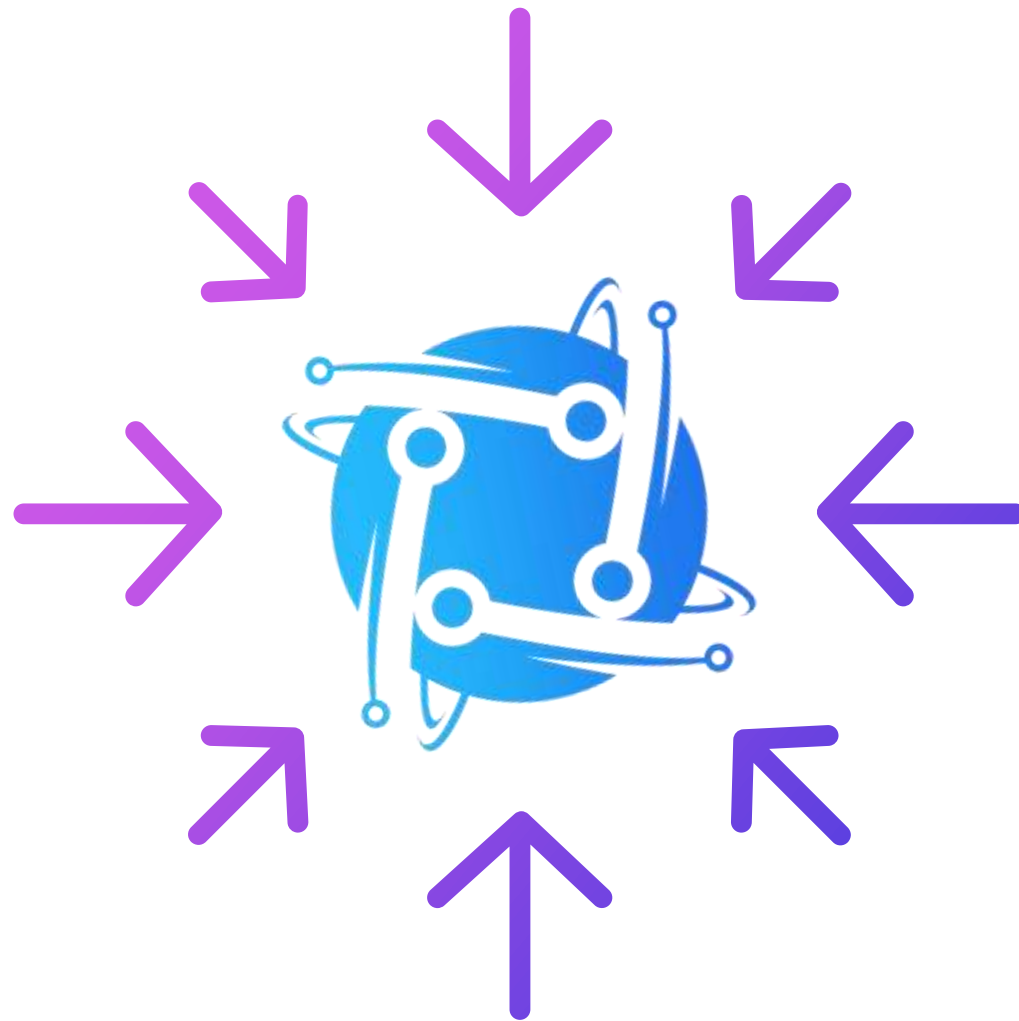

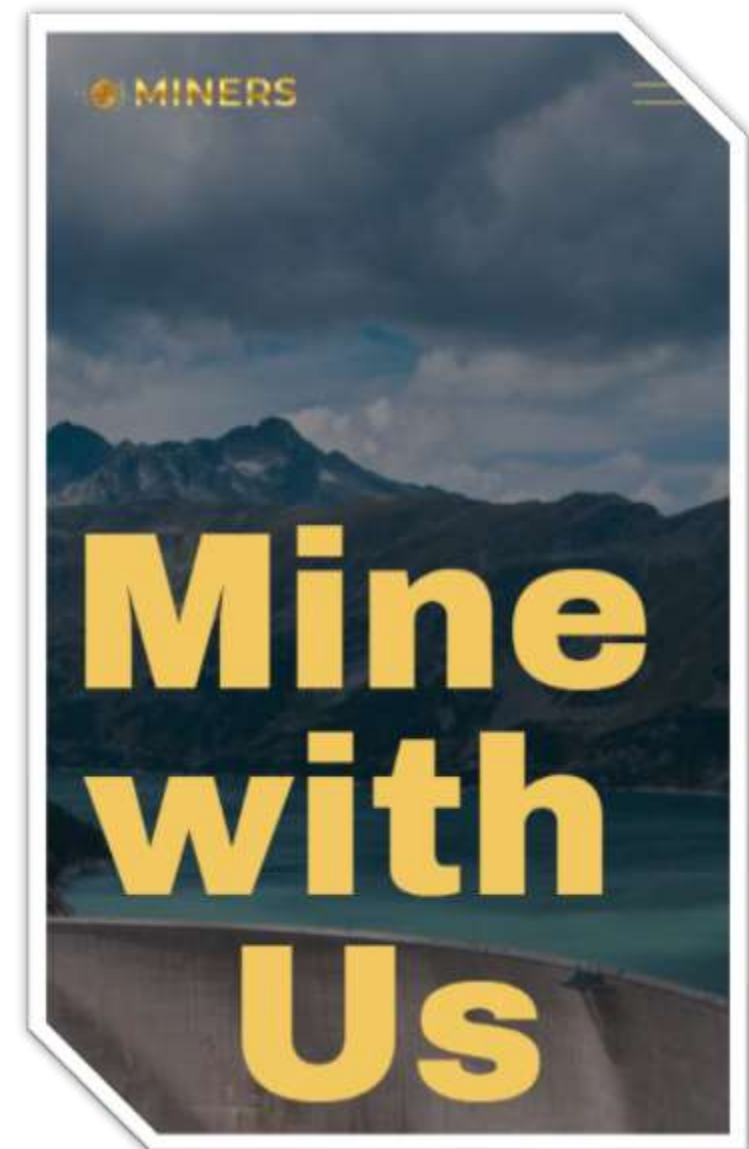
The website contained no JavaScript errors. No typos, or grammatical errors were present, and we found a valid SSL certificate allowing for access via https.

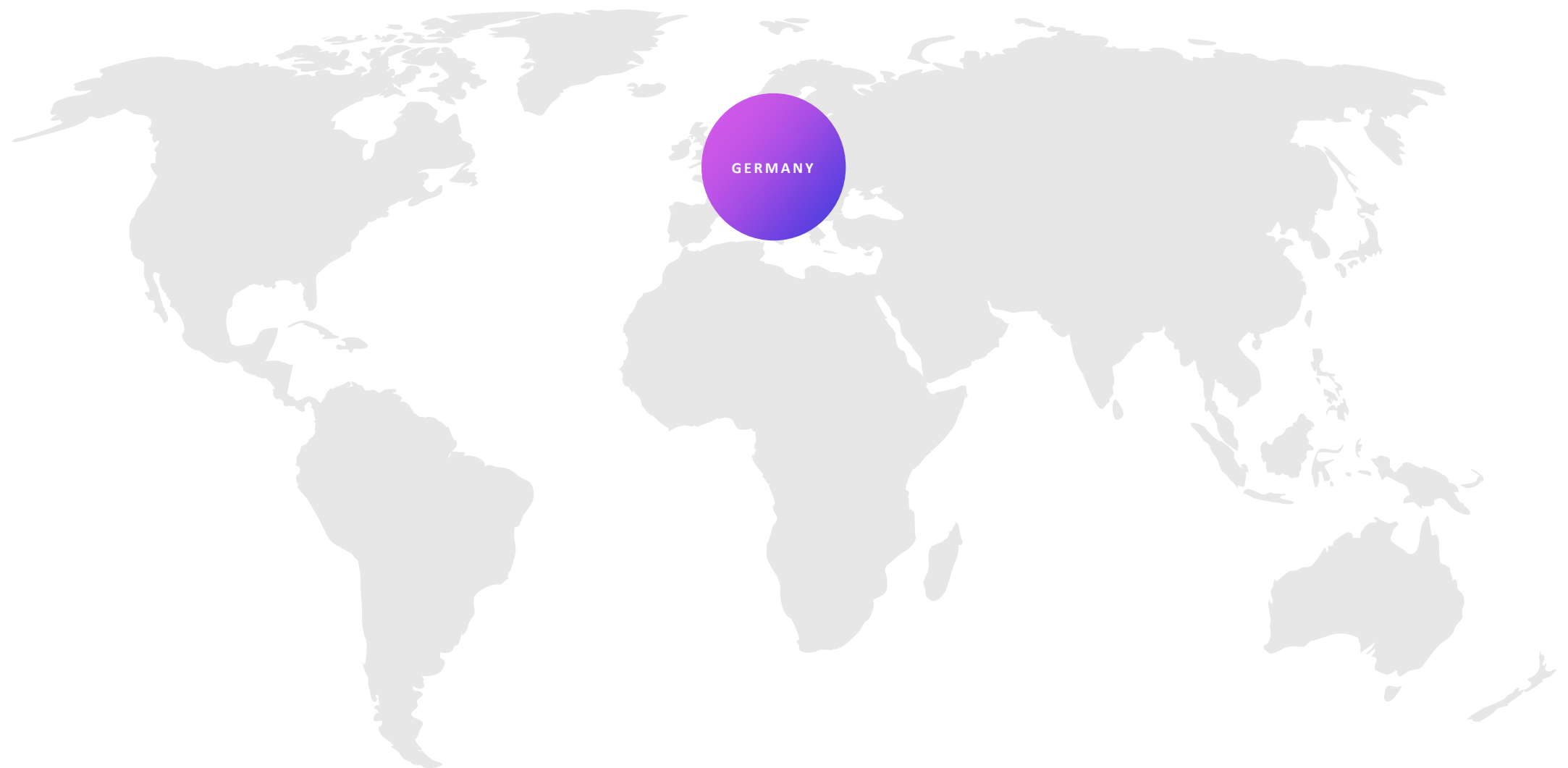

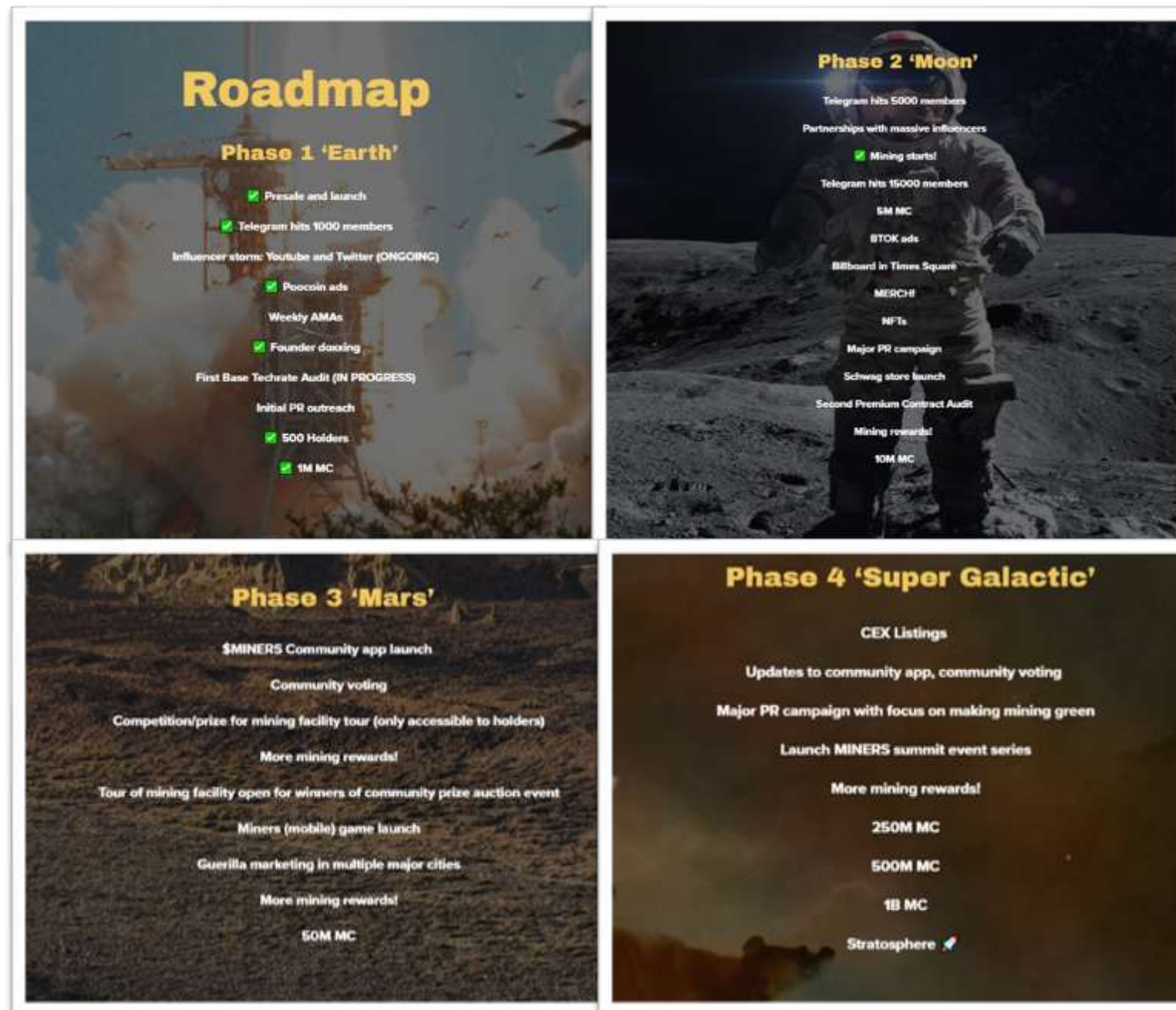
