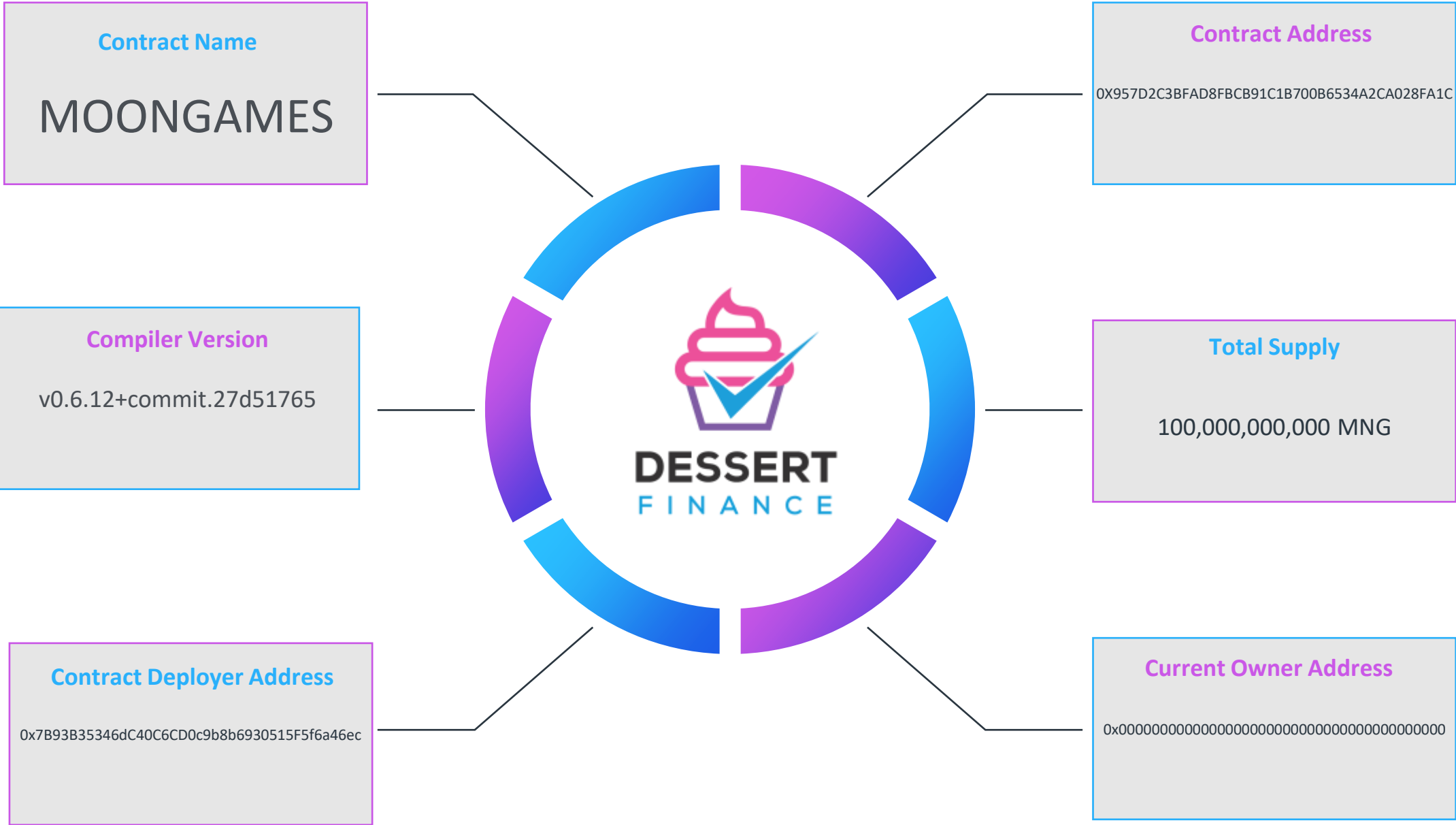

# Contract Transaction Fees

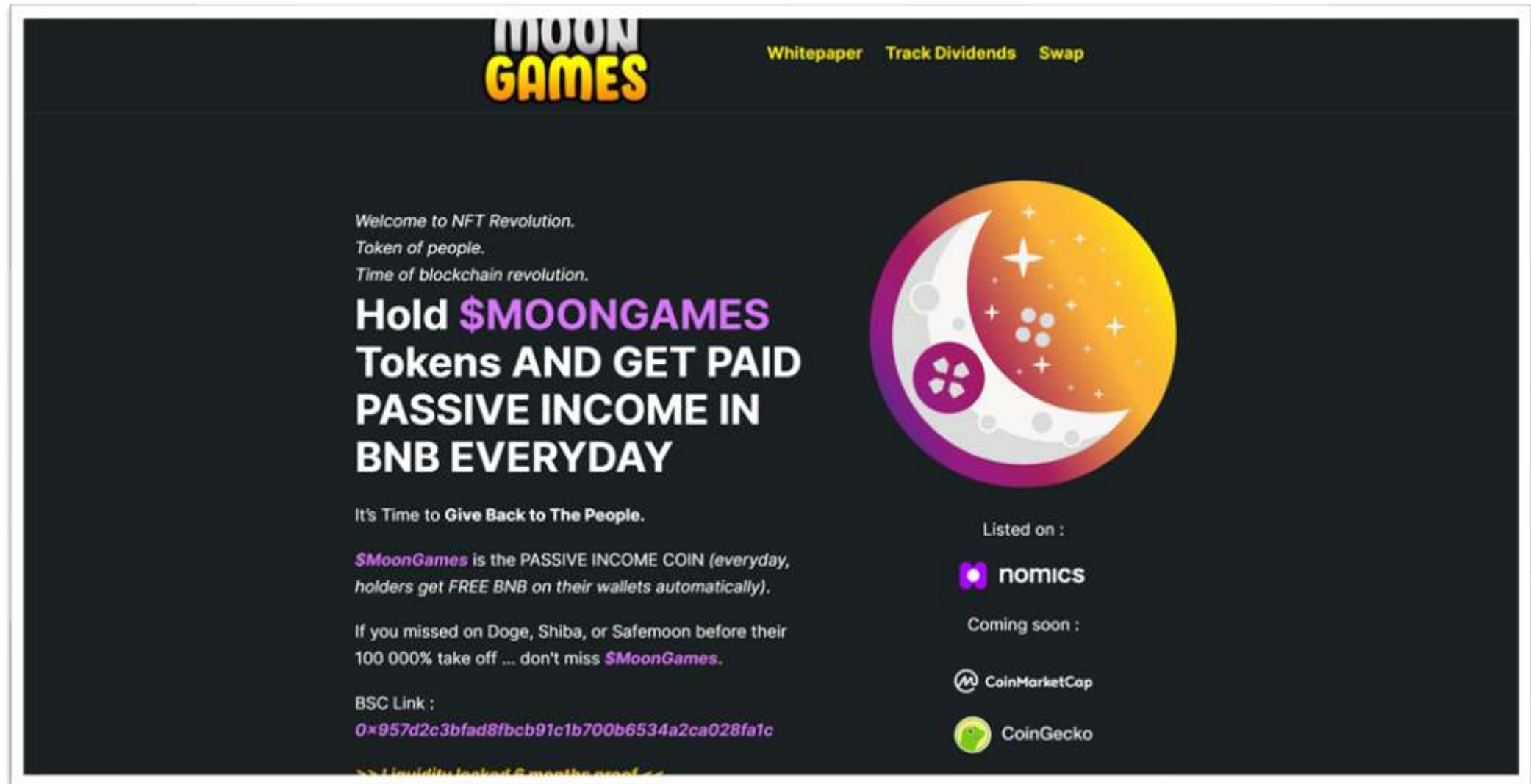
At the time of Audit the transaction fees (“tax”) listed below are the fees associated with trading. These fees are taken from every buy and sell transaction unless otherwise stated.

## Transaction Fees to Fund the 2021 Financial Liberation Movement

- ✓ Transaction Tax: 20%
- ✓ 12% is used to purchase BNB which is automatically paid out in dividends to holders
- ✓ 2% is split between the buy-back mechanism and the team/marketing fund. Development Fund which is 1.5% can be used in extreme circumstances to correct market volatility.
- ✓ 3% is allocated to the locked liquidity pool (burned)

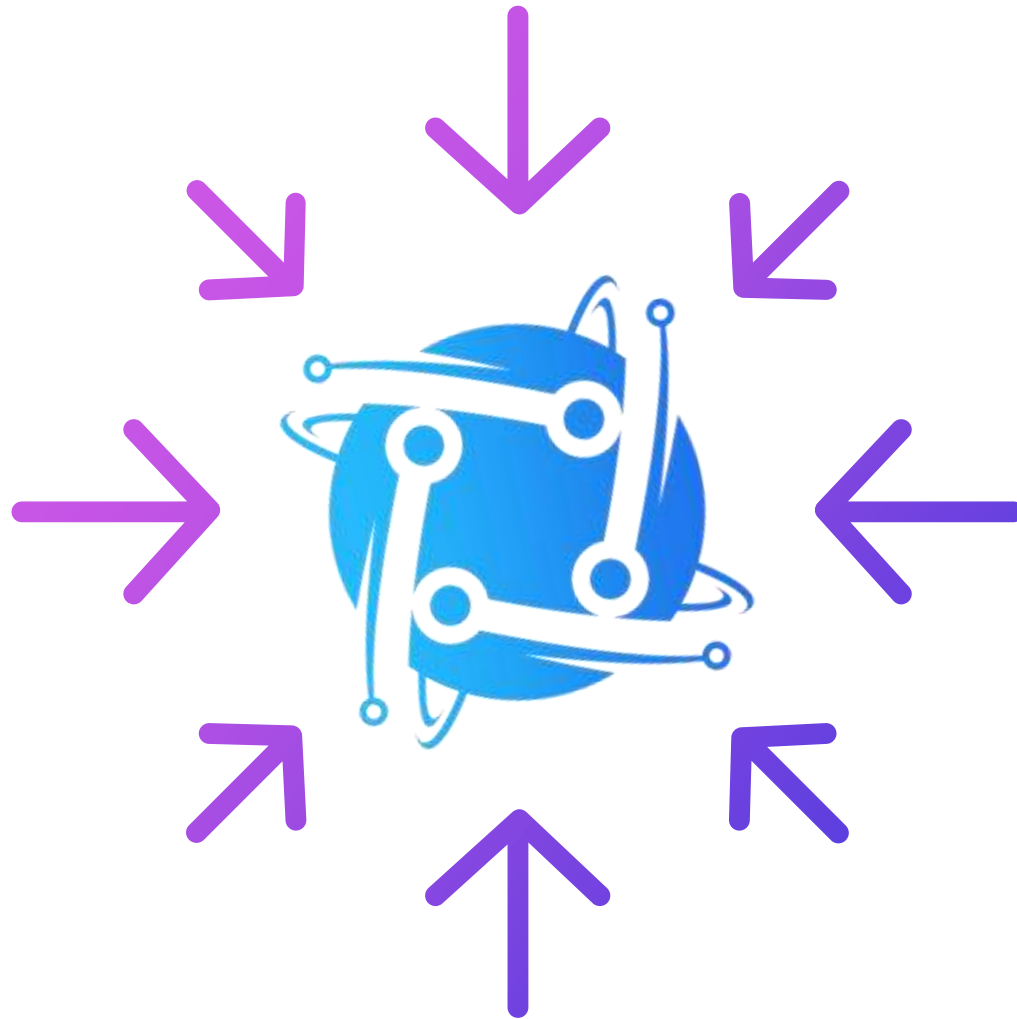

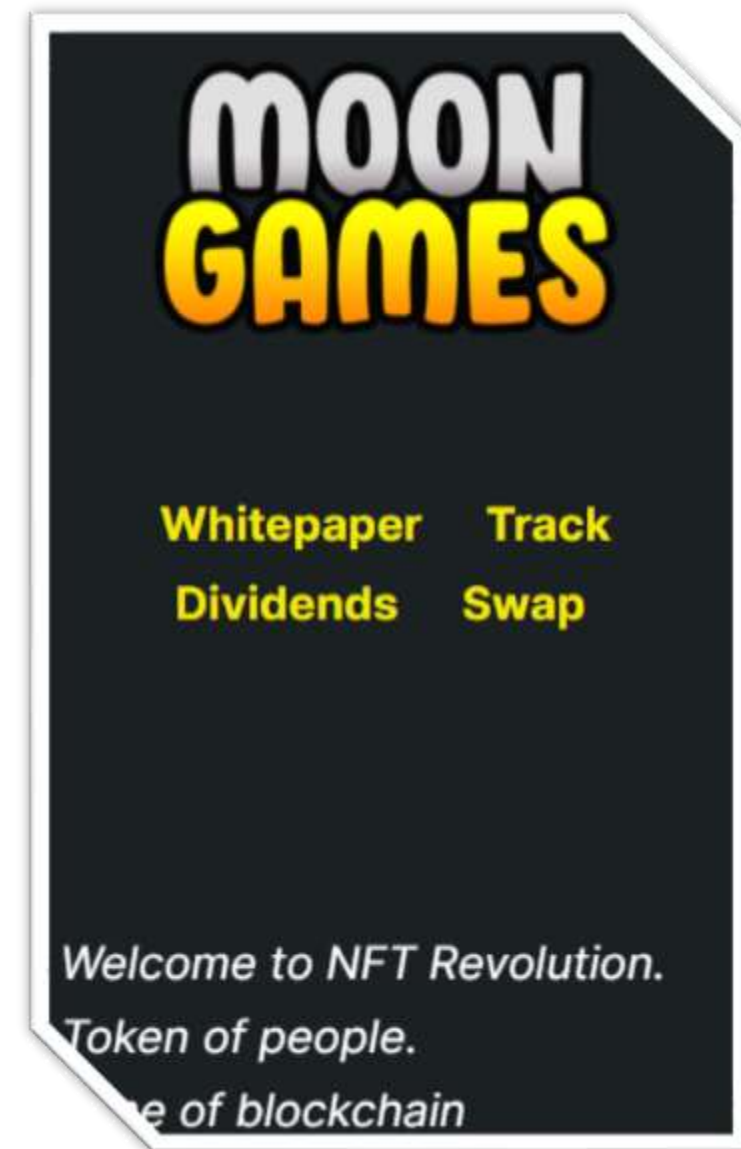
The website contained no JavaScript errors. No typos, or grammatical errors were present, and we found a valid SSL certificate allowing for access via https.
