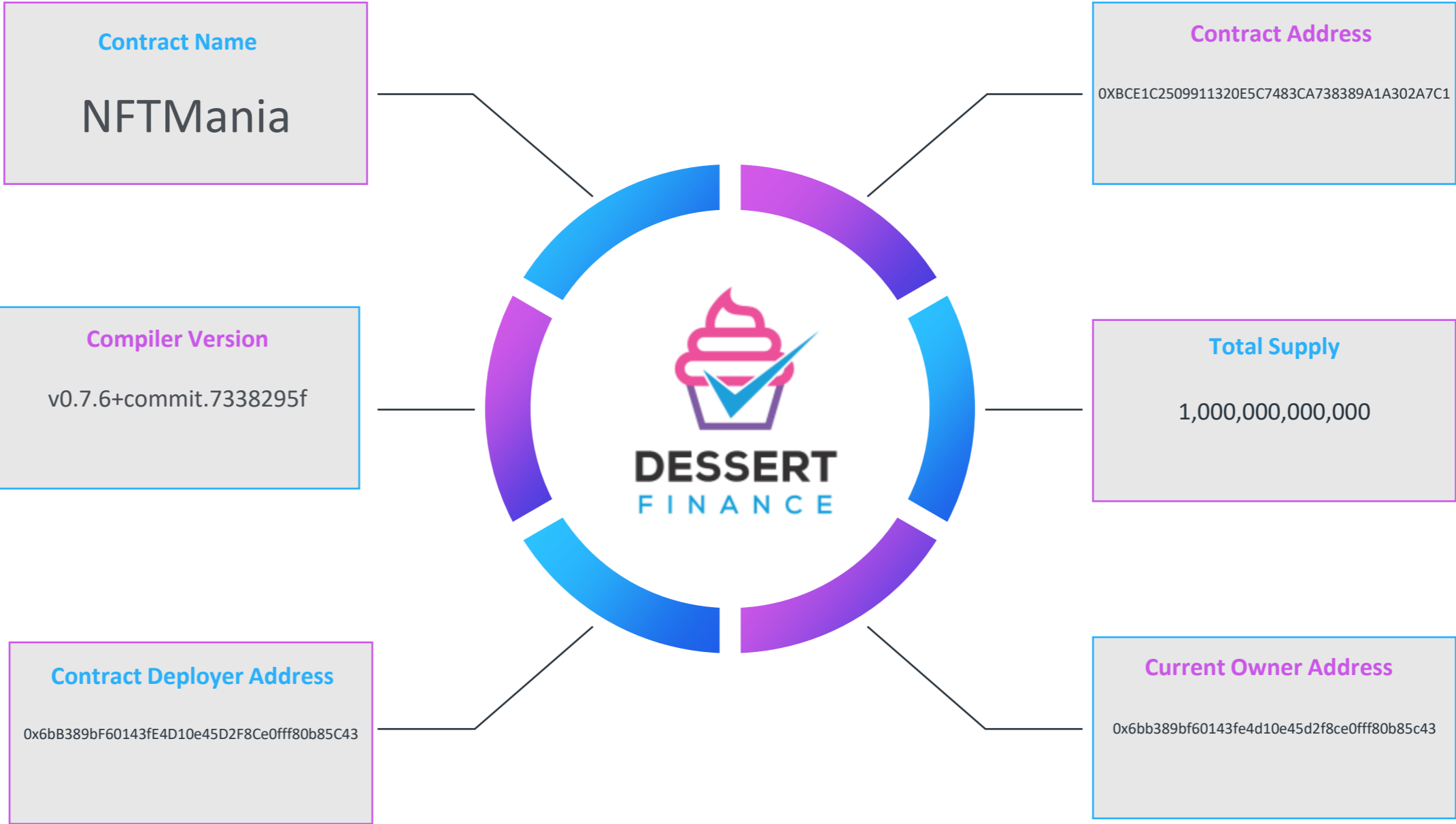

- Establishing a Time-Lock with reasonable latency
- Assignment of privileged roles to multi-signature wallets

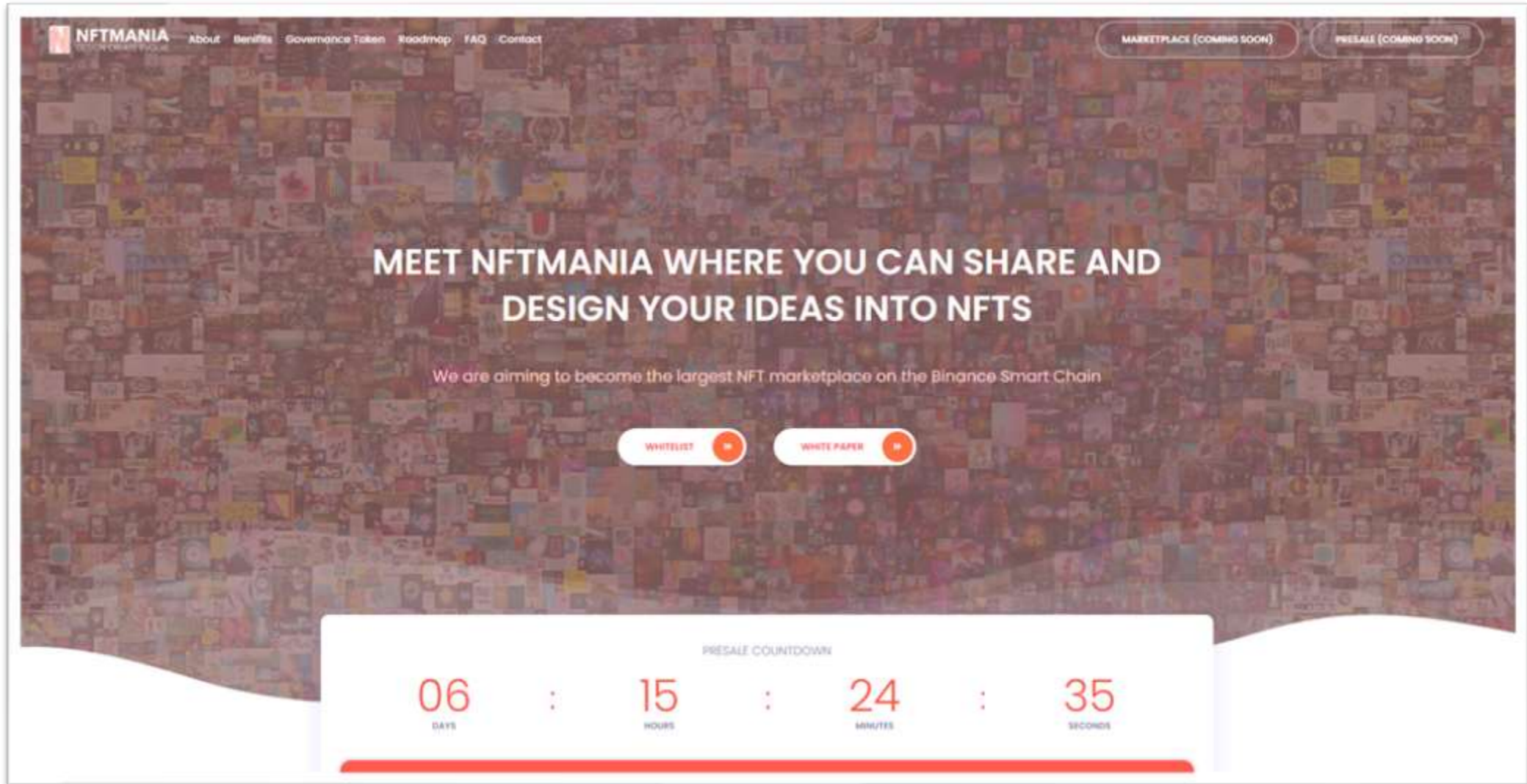

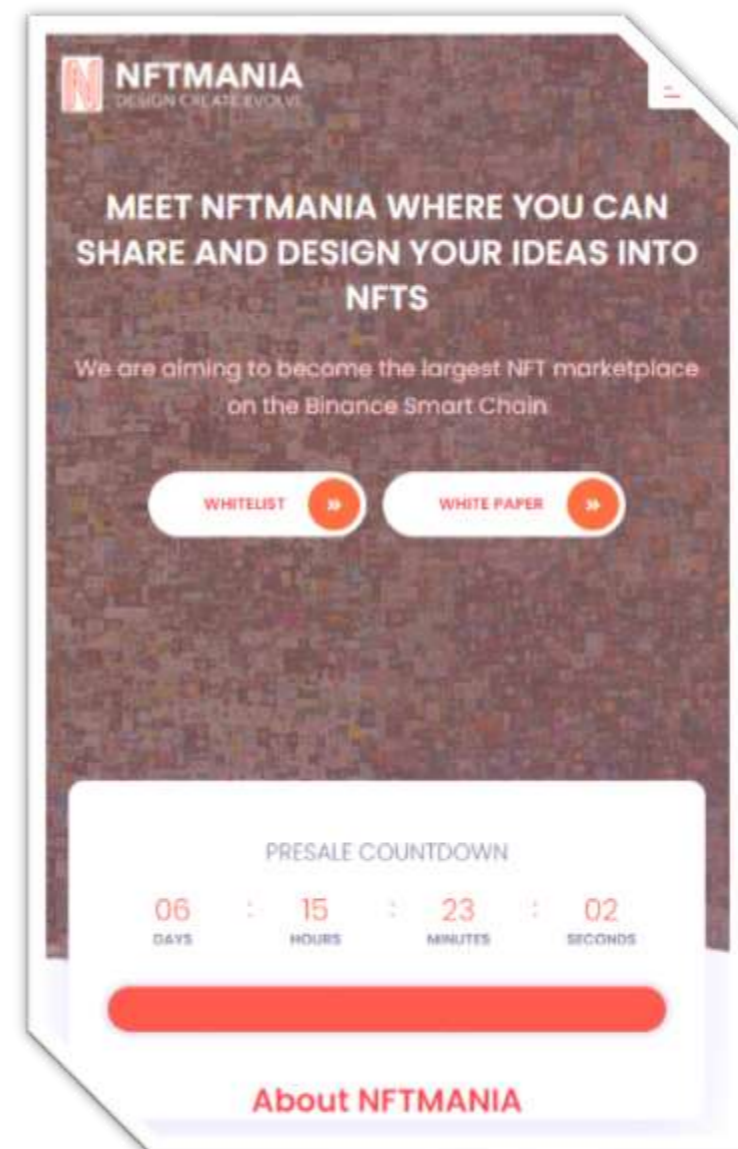
The website contained no JavaScript errors. No typos, or grammatical errors were present, and we found a valid SSL certificate allowing for access via https.

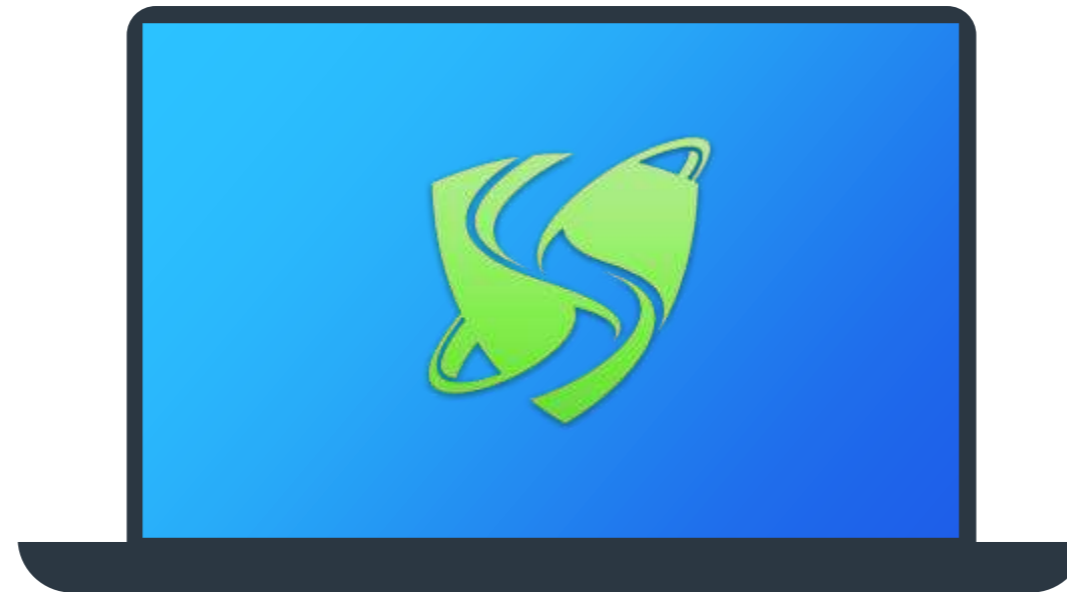

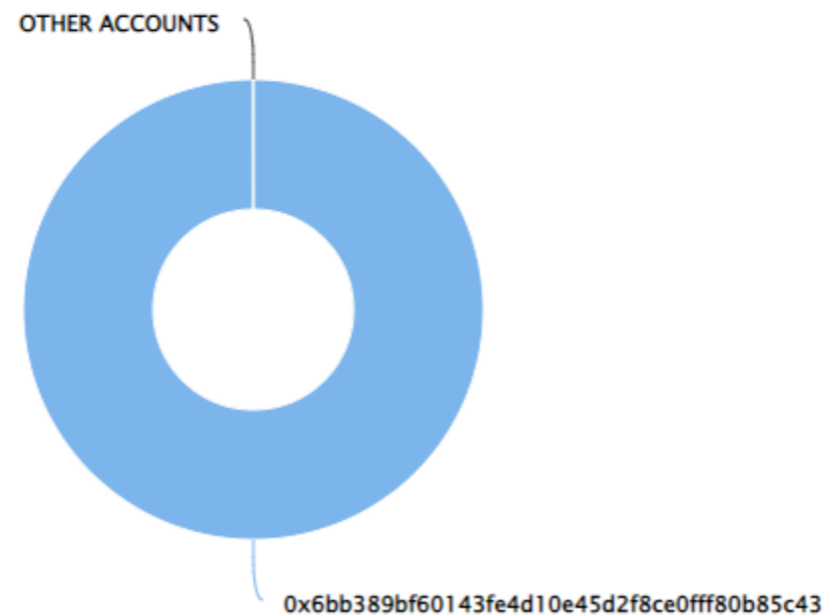

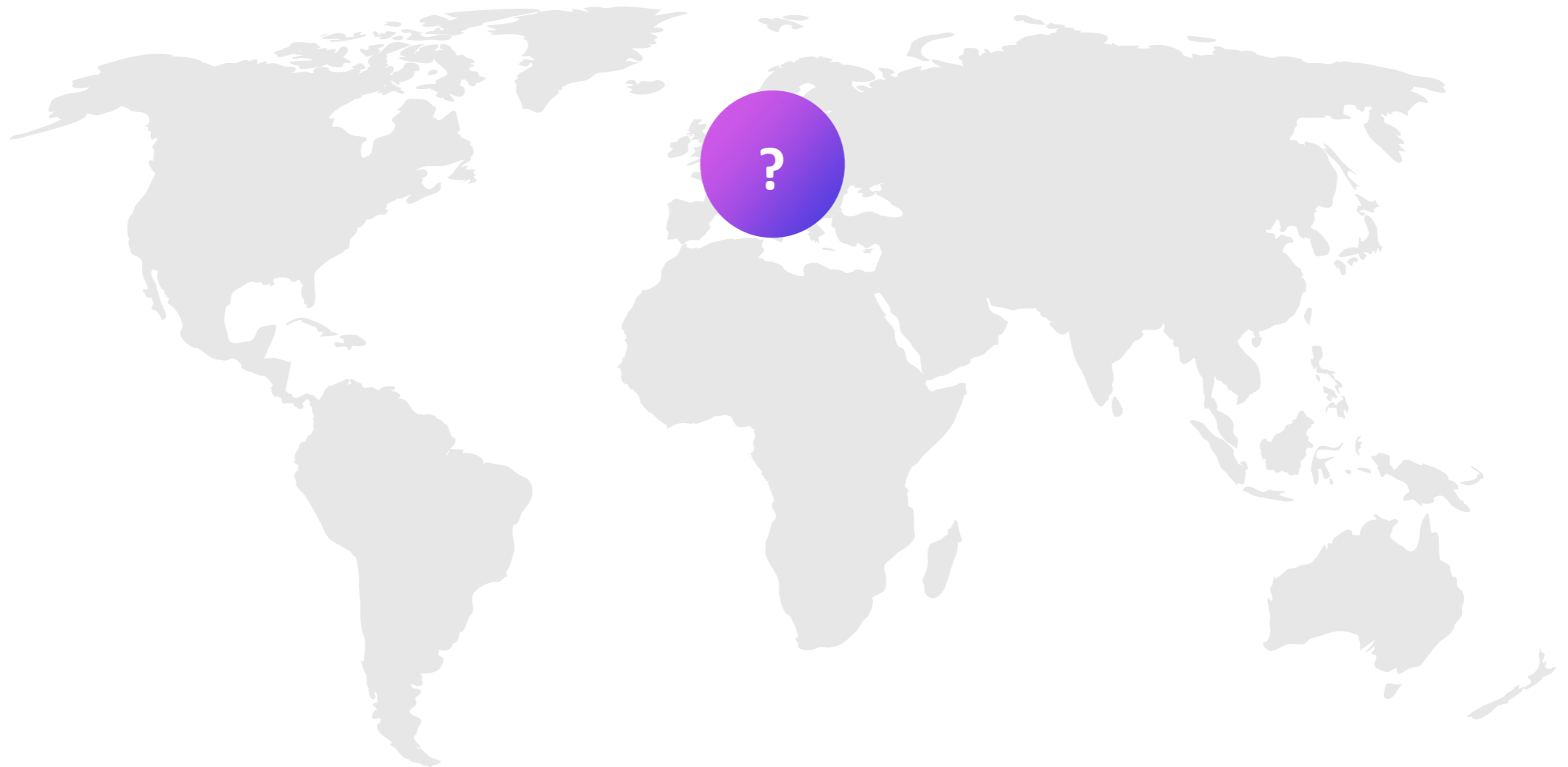
NFTMania Top 100 Token Holders

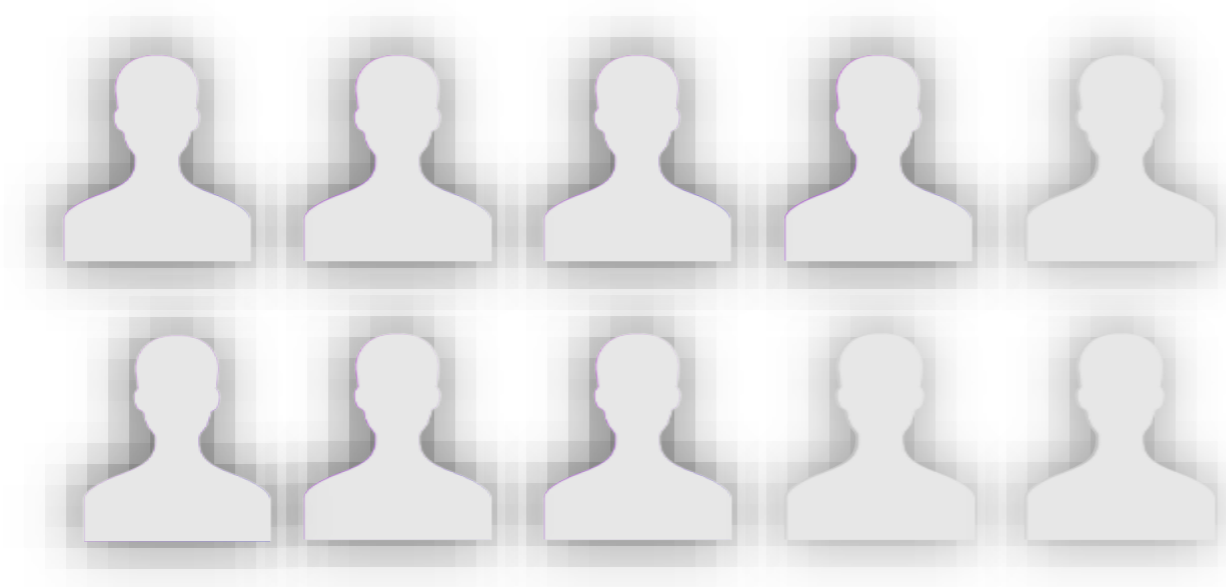

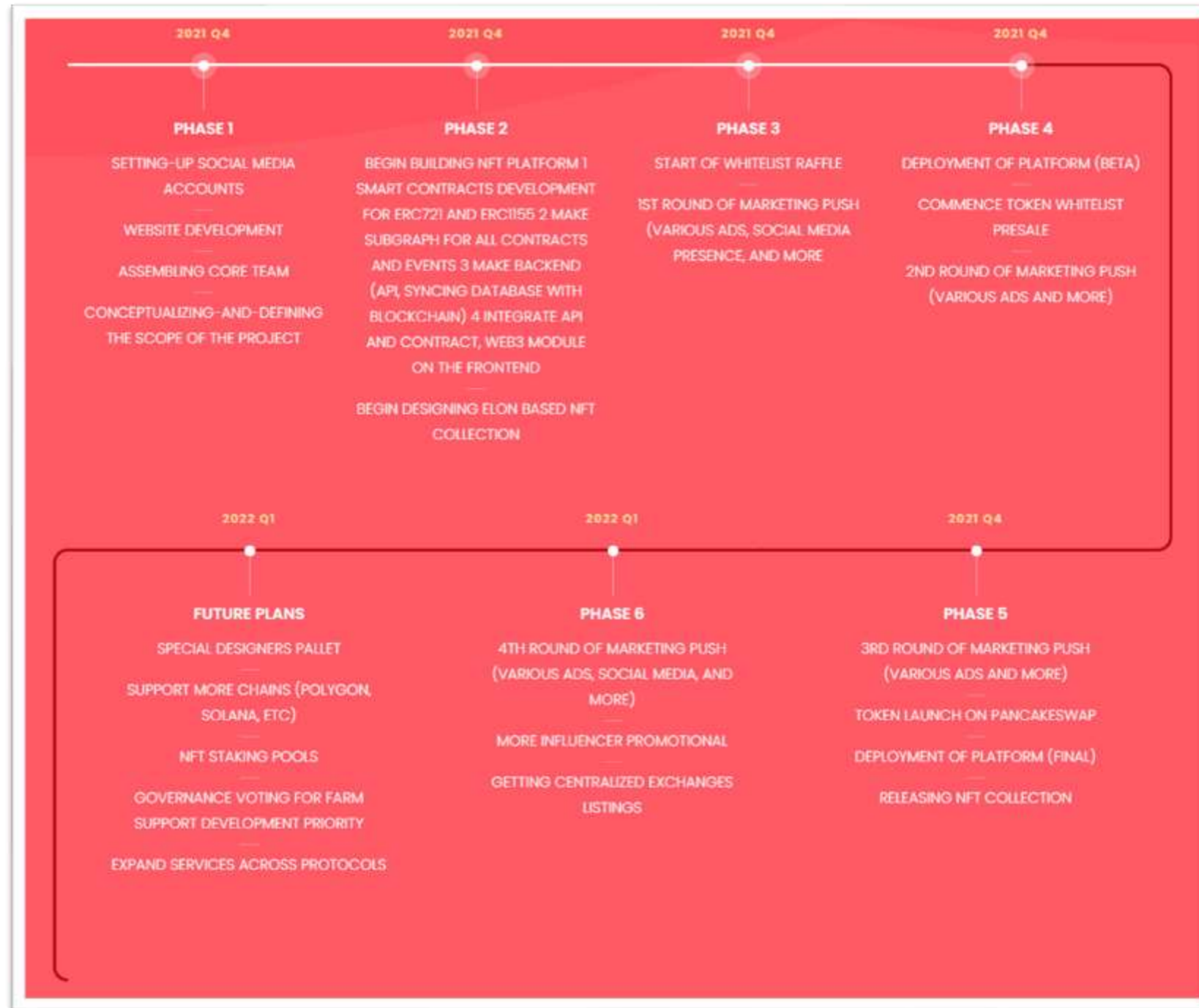
