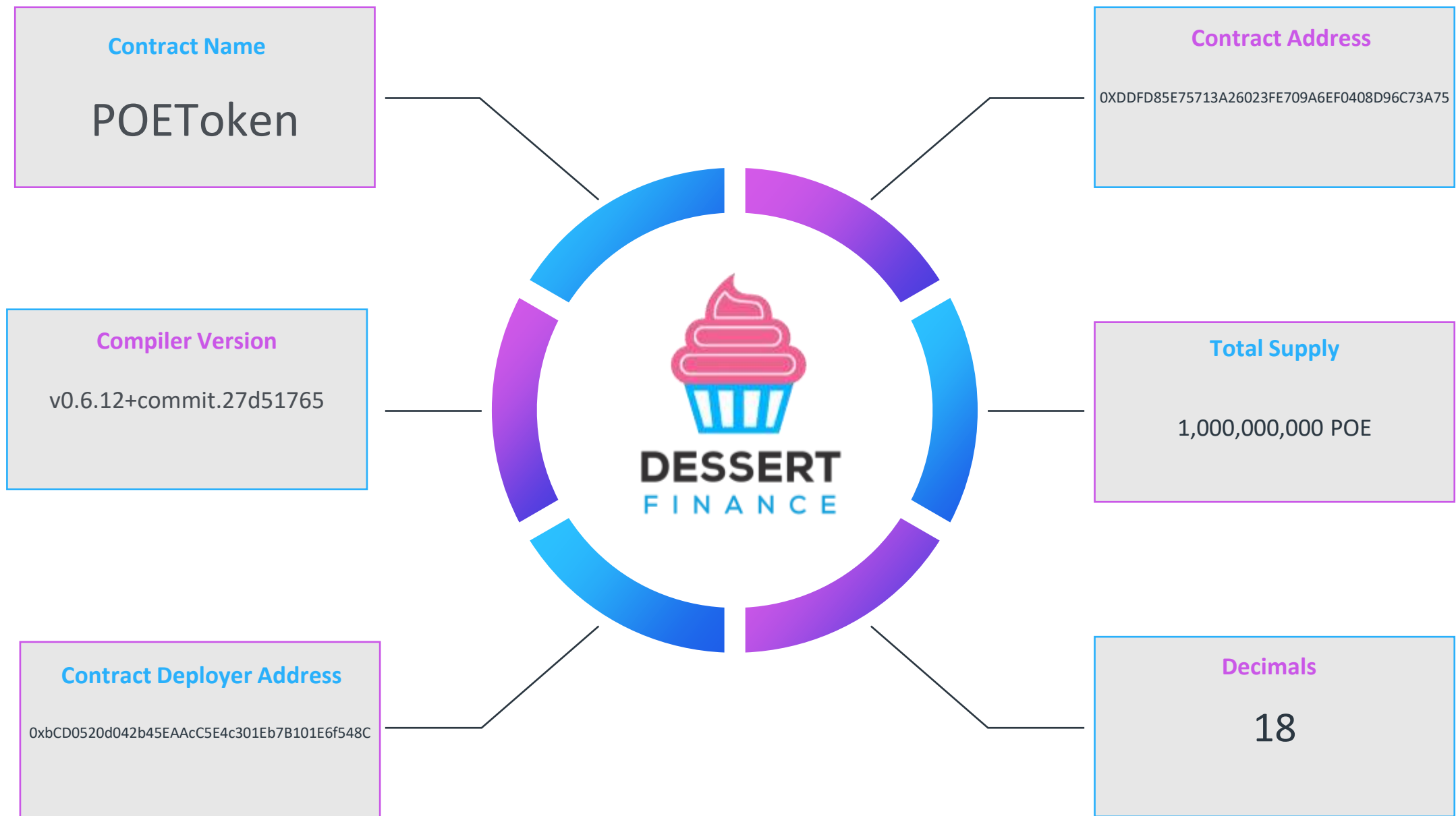

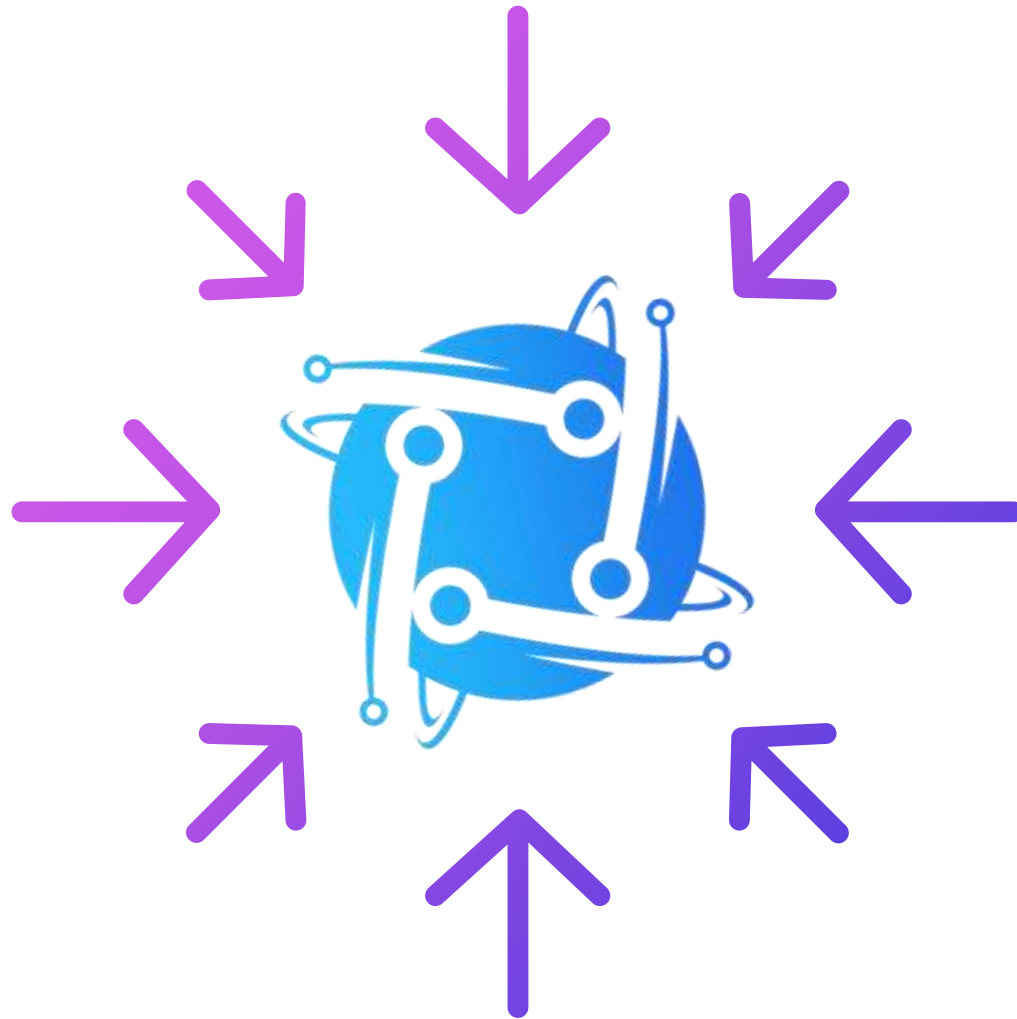

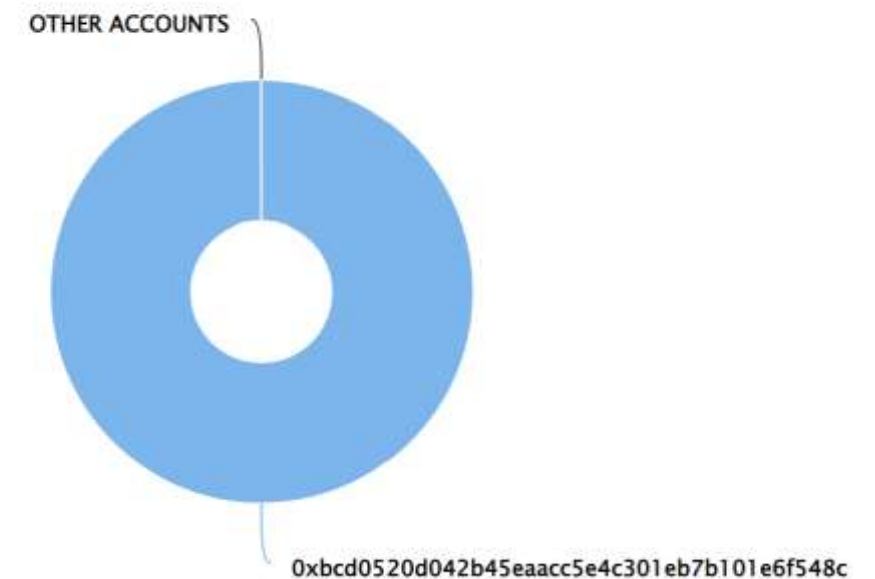
Pets Of Elon Top 100 Token Holders

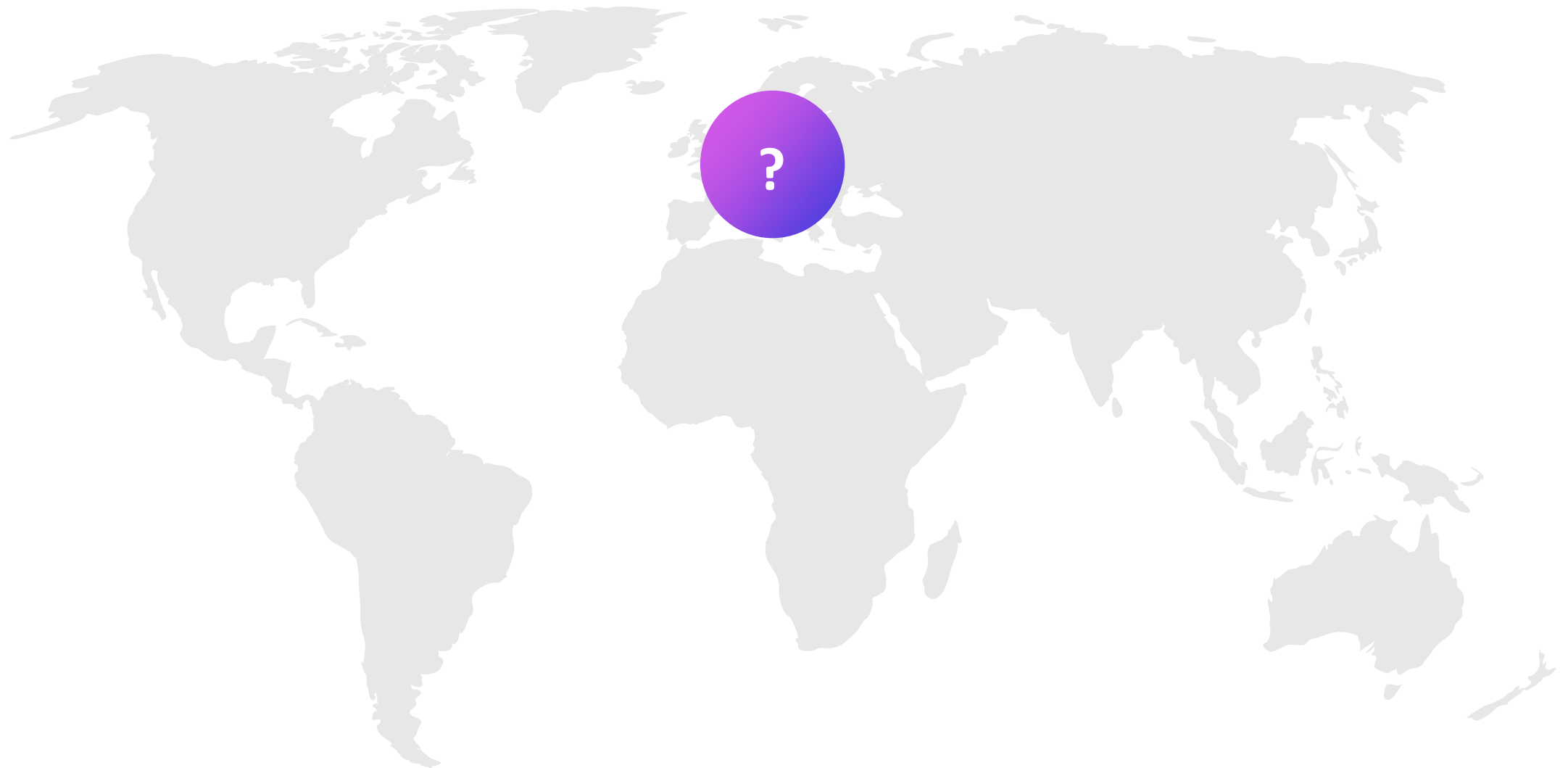

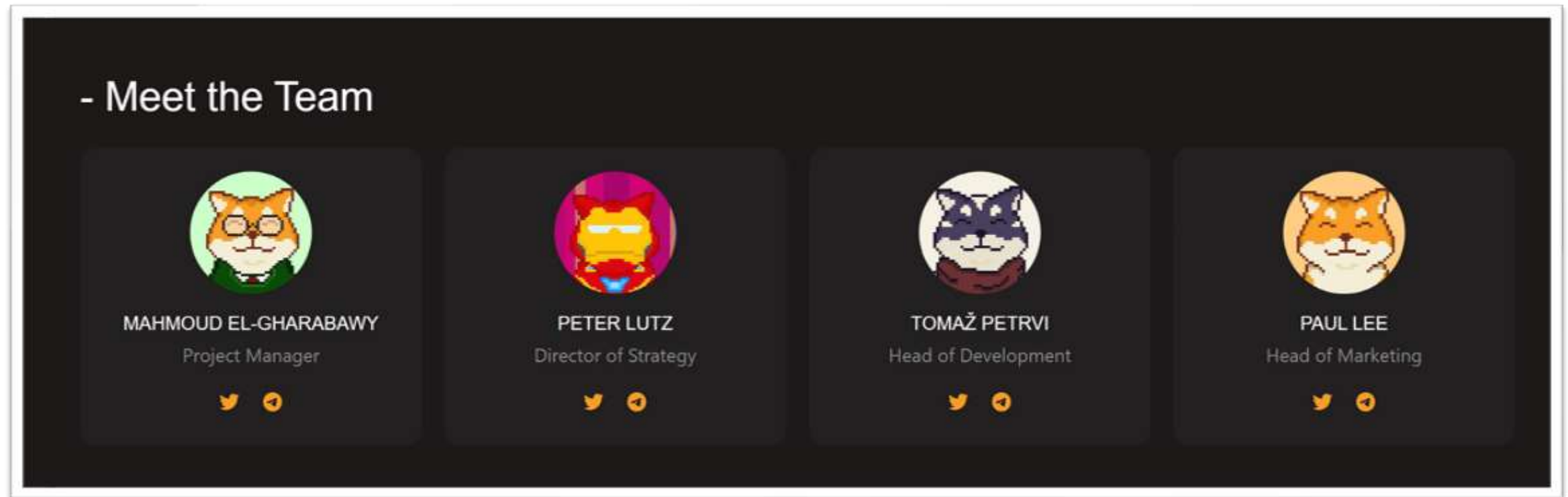

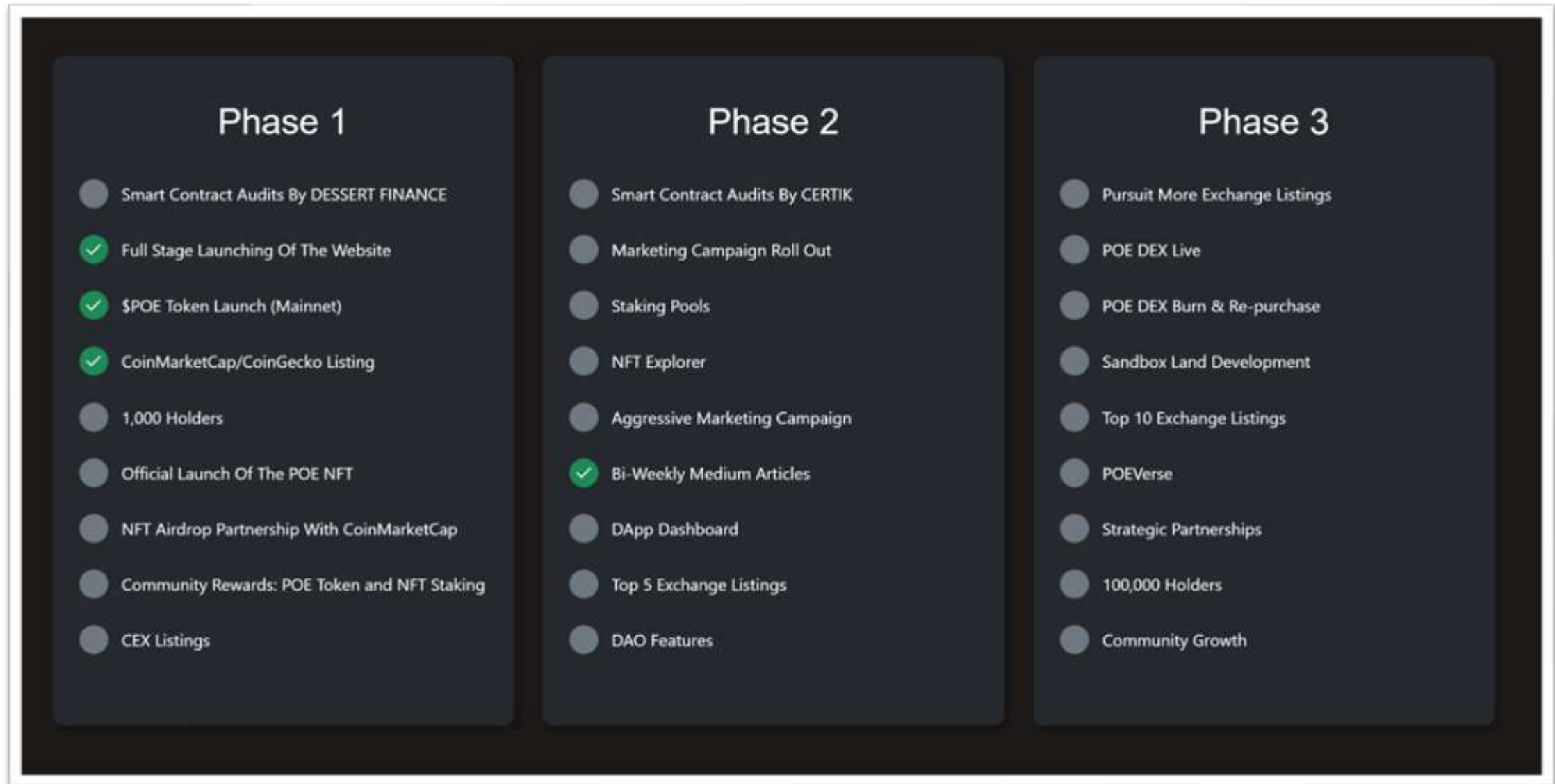
