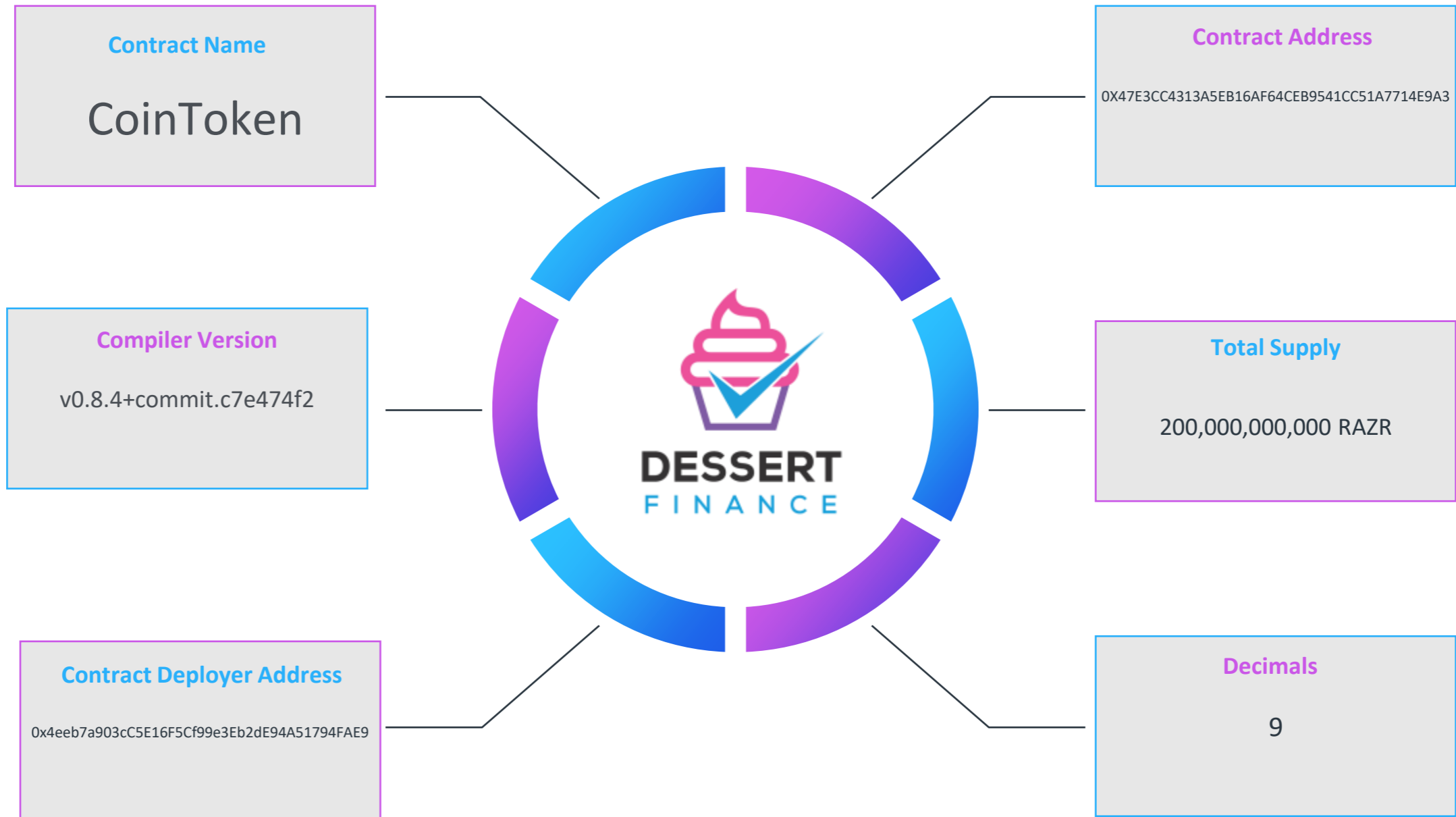

Contract Transaction Fees

At the time of Audit the transaction fees (“tax”) listed below are the fees associated with trading. These fees are taken from every buy and sell transaction unless otherwise stated.

Tokenomics

RAZR Edge Coin has a tax of 6% on all transactions. This “cost” has been kept much lower than many similar tokens to ensure holders and potential holders are encouraged to trade in, and make use of the asset.

With each trade, three simple functions occur creating benefits for all RAZR Edge Coin holders as follows:

- Marketing Contribution**
2% of each transaction is automatically sent to the marketing wallet. This creates a continual source of funding for the on-going marketing for value accretion of RAZR Edge.
- Static Reflection**
Holders of RAZR Edge Coin earn passive rewards through static reflection as 2% of each transaction is returned and they watch their balance of RAZR Edge Coin grow.
- Automatic Liquidity**
2% of every trade contributes towards automatically generating liquidity that goes into multiple pools used by exchanges.

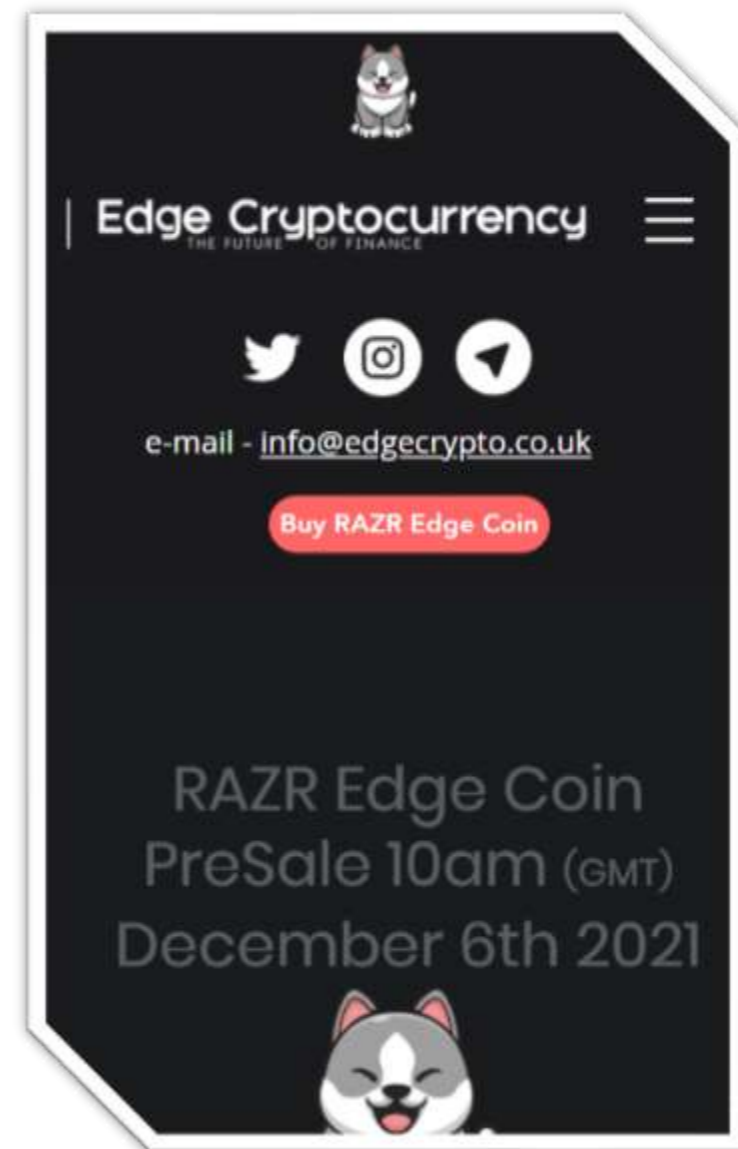
The website contained no JavaScript errors. No typos, or grammatical errors were present, and we found a valid SSL certificate allowing for access via https.

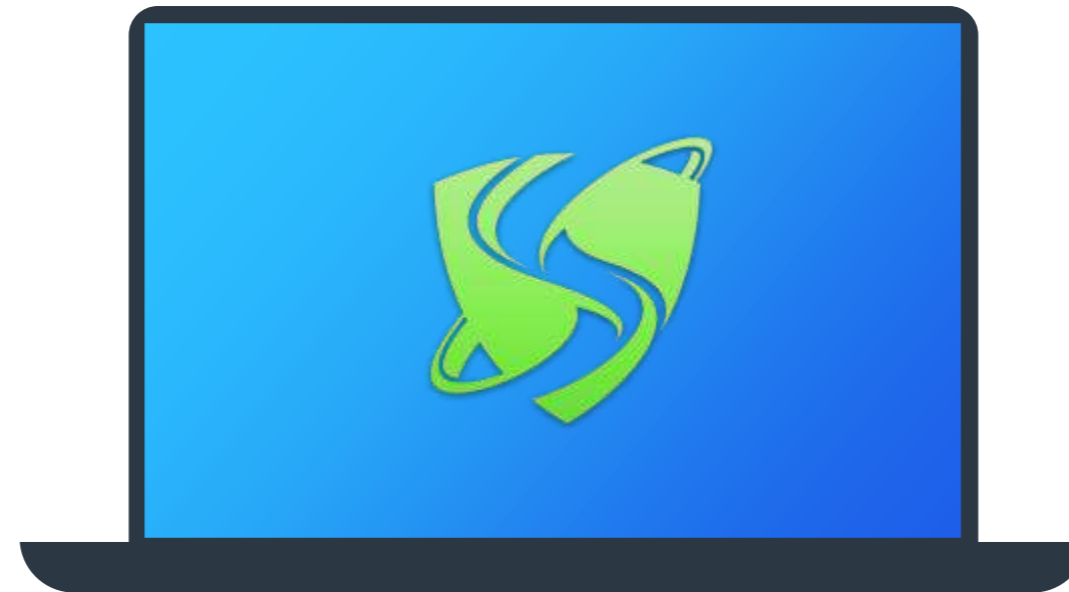

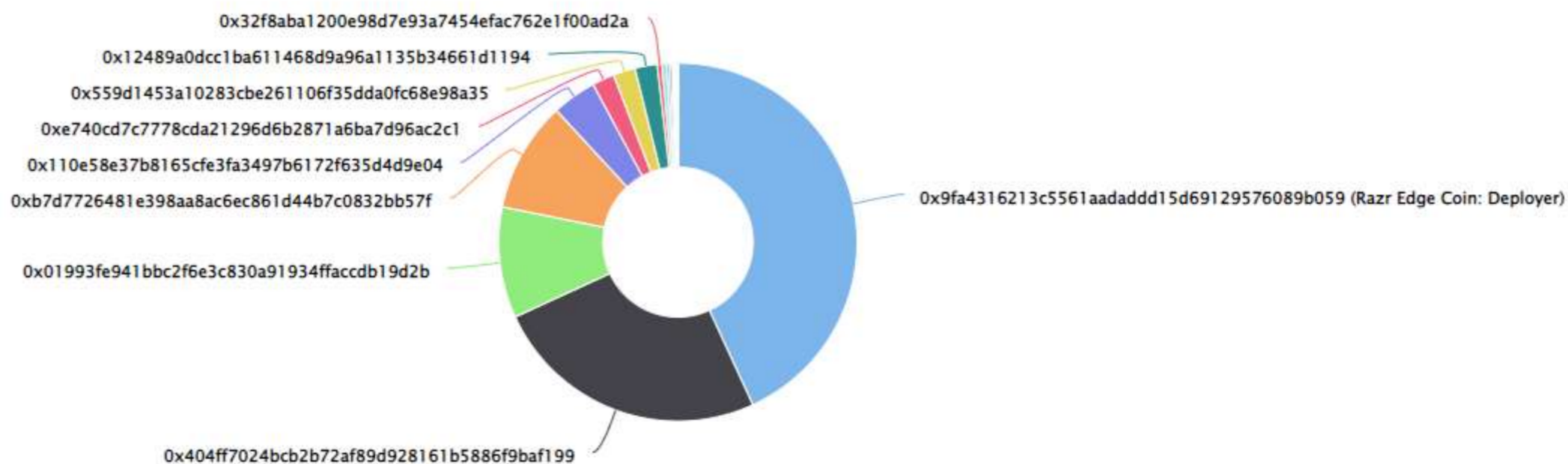

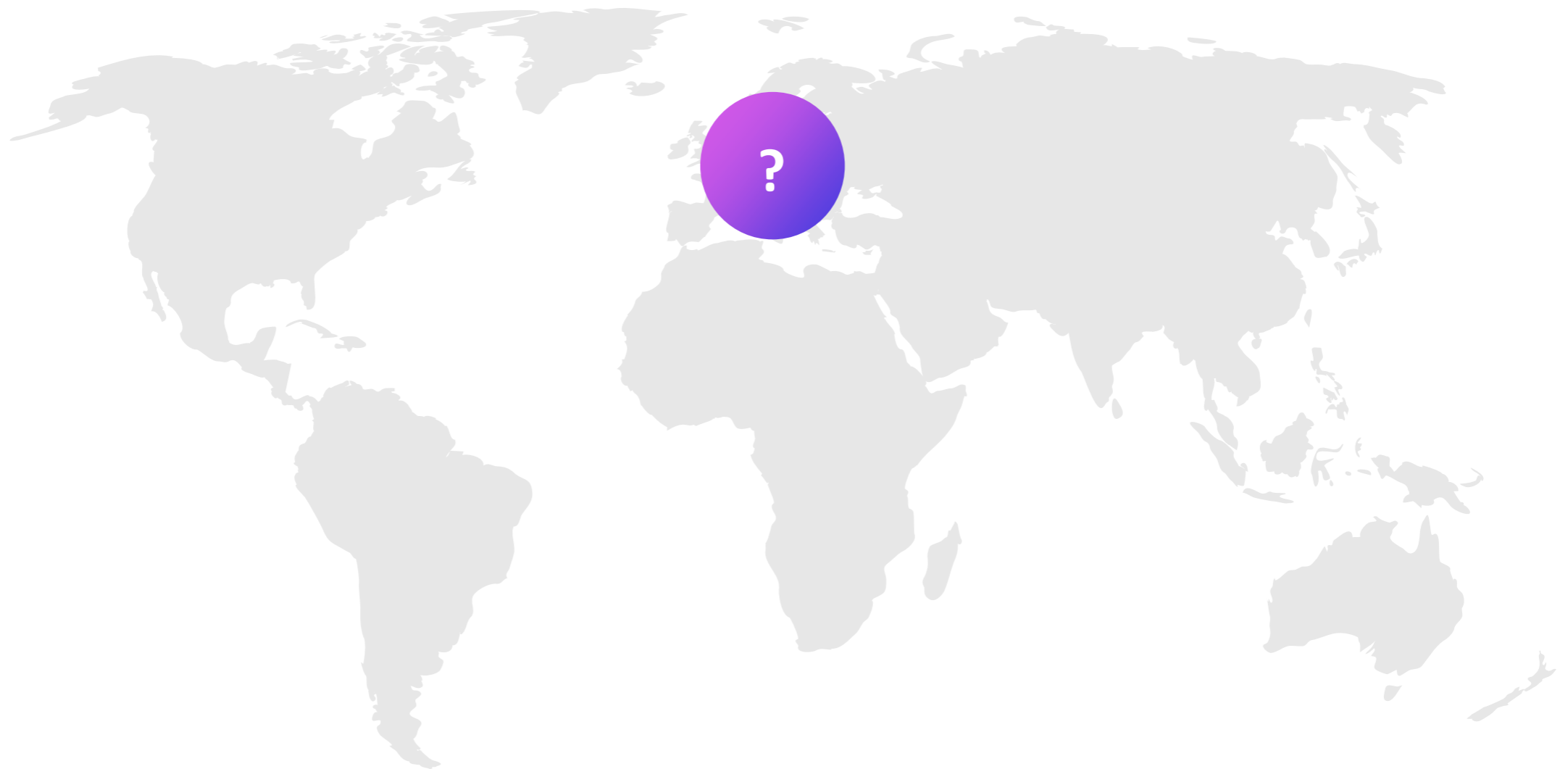
