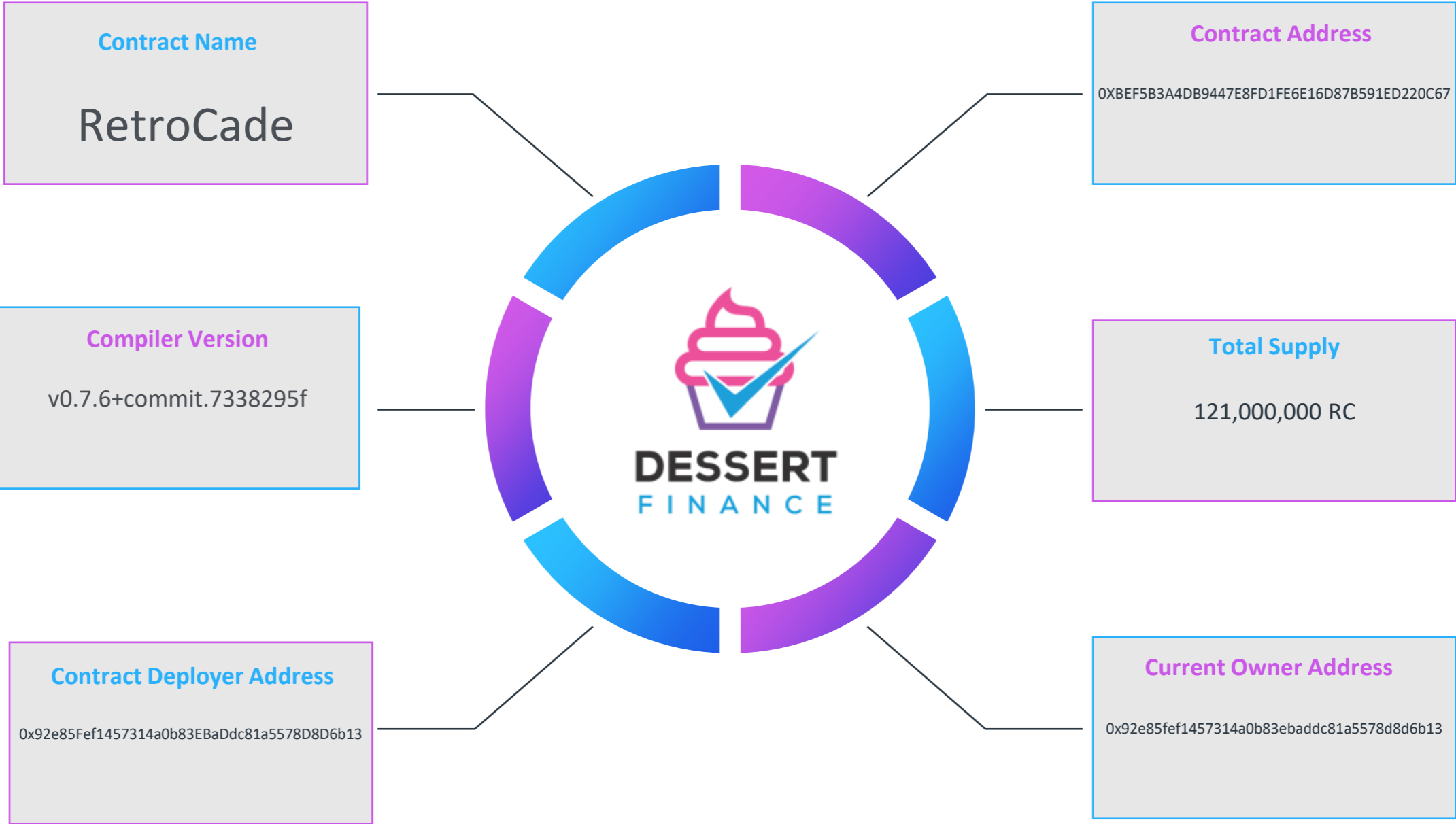




We do understand that sometimes mint functions are essential to the functionality of the project.

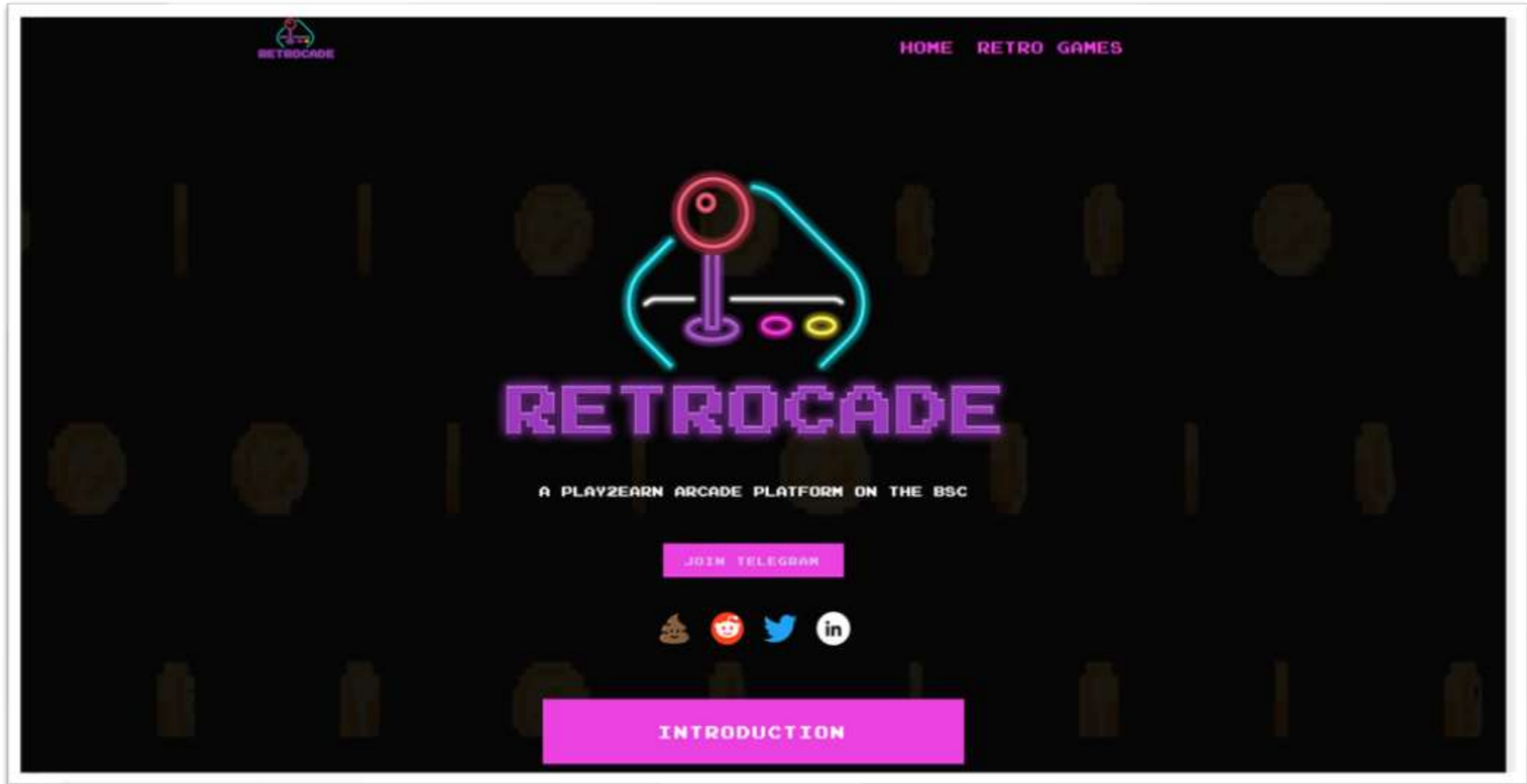
