


#### Website Part 1 – Overview <u>www.richierichcoin.com</u>








### Social and Web – Final Thoughts & Suggestions for Improvement

We were able to track down multiple social media channels for Richie Rich Coin. Social Media channels included Twitter, Telegram, Instagram, and Reddit. All social media channels had a healthy amount of activity.

The domain is set to expire in 4 years which is greater than the 3 years we like to see and far exceeds the 1 year registration that most new tokens register for.

It is important to note that there is a 15% luxury tax on EVERY transaction including buys, sells, and transfers.

#### **Suggestions for Improvement**

- 1. Consider having a pinned post on the subreddit.
- 2. Fix slippage on website.
- 3. Fix link to technical paper on website.

The majority of the supply (98%) was in one wallet at the time of the audit however it is important to note that the project has not begun its presale or launch yet.



The top token holders at the time of the audit are shown as above.


