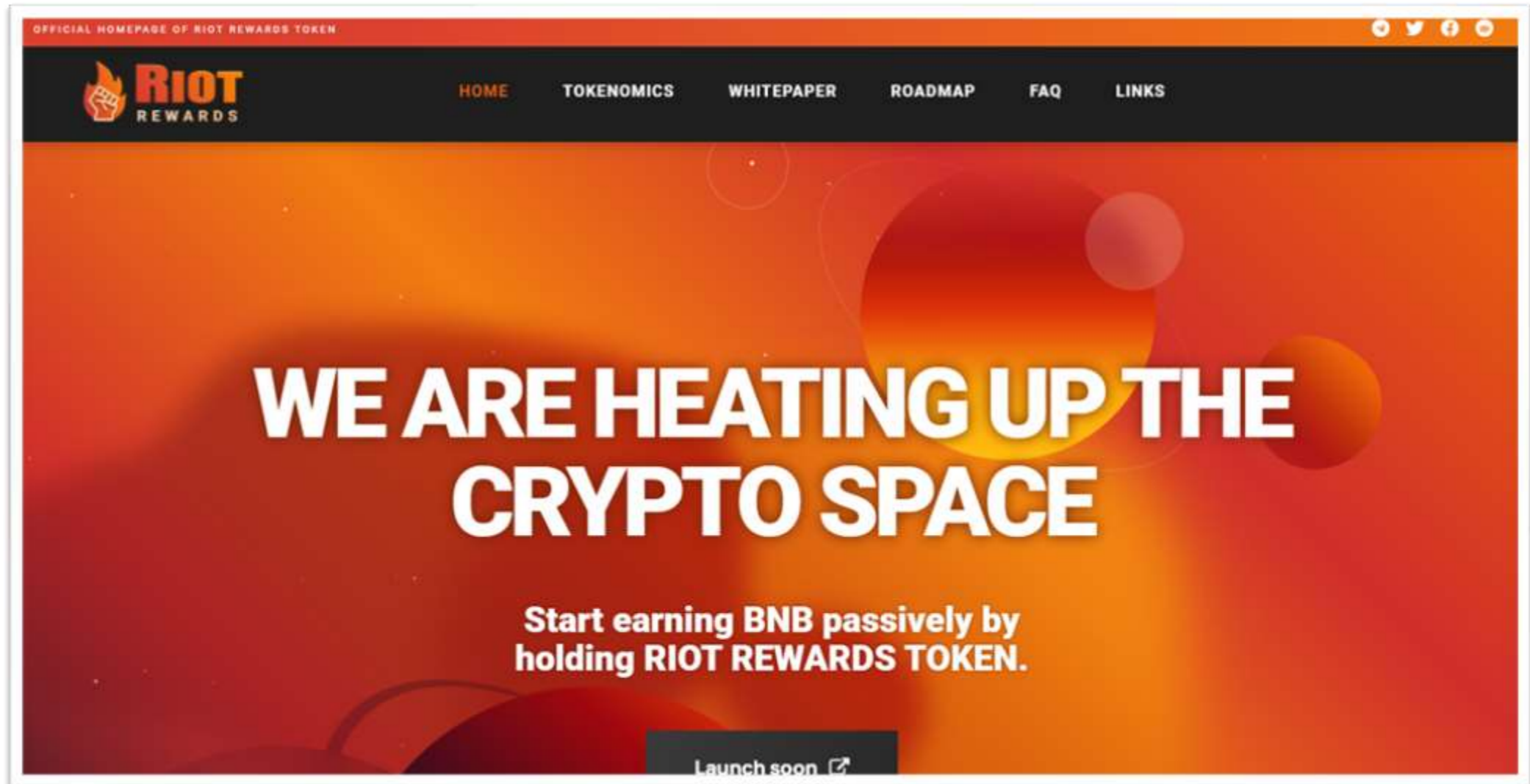

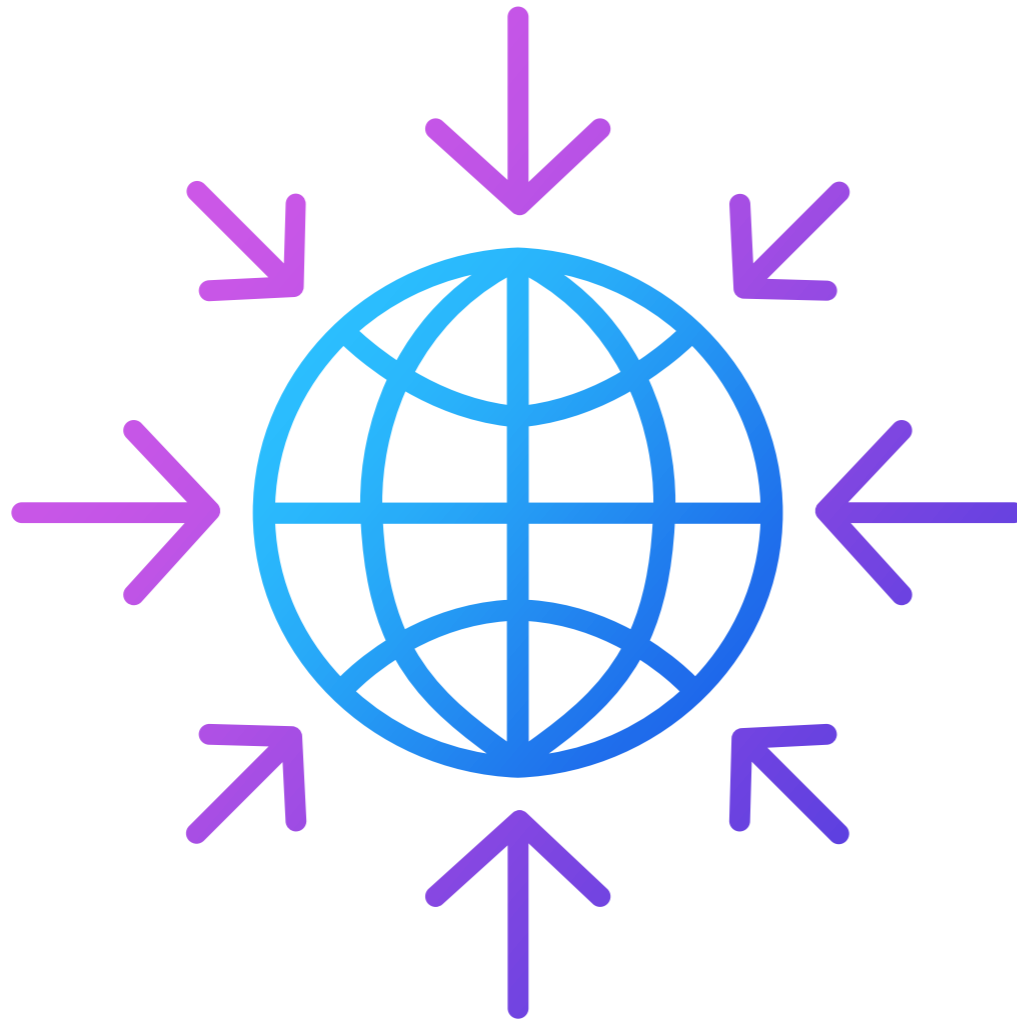


Above images are actual snapshots of the current live website of the project.

Social and Web – Final Thoughts & Suggestions for Improvement

We were able to track down multiple social media channels for the project. Social Media channels included Twitter, Telegram, Reddit and Facebook. All social media channels had a healthy amount of activity.

It is important to note that there is an 15% tax on EVERY buy transaction and a 19% tax on EVERY sell transaction. 2% goes to providing liquidity on buys and sells, 4.5% is to be used for marketing on buys and sells, 8% is distributed to the token holders in BNB on buys and 12% is distributed to the token holders in BNB on sells and .5% is distributed back to the development team to be used for marketing purposes.

This project is being audited before launch. We expect many things to change post-launch. Please review the links on all the pages to make sure that the most up-to-date information is being reviewed. Dessert Finance conducts the audit at or prior to the block number written on the cover of this report.

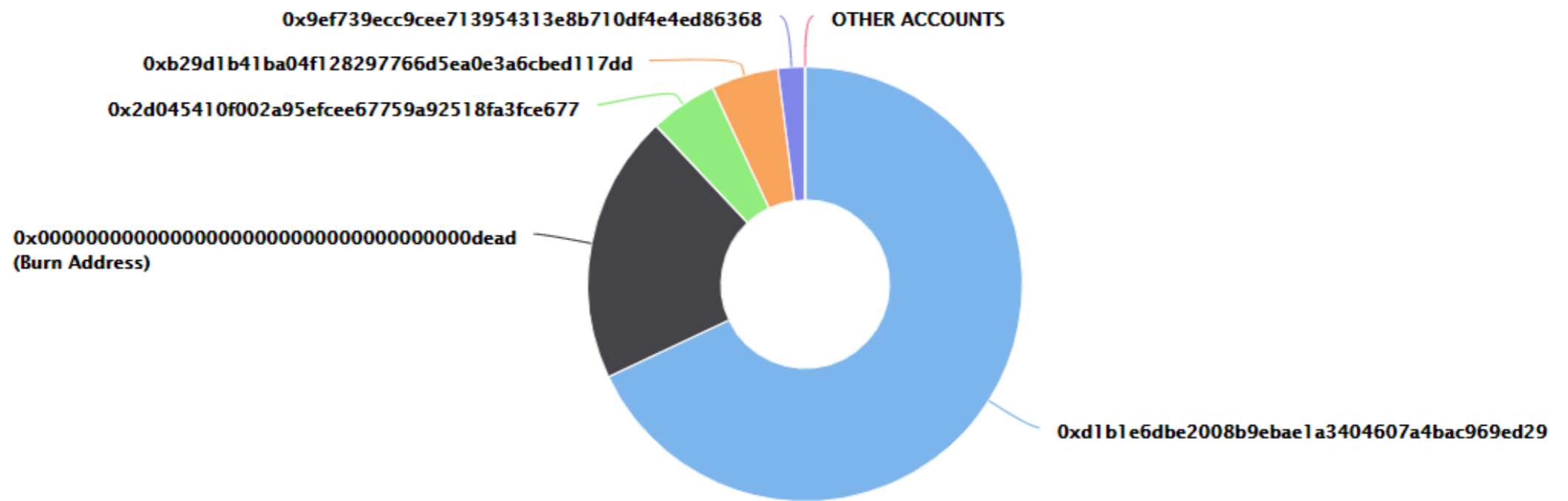
Top Token Holders

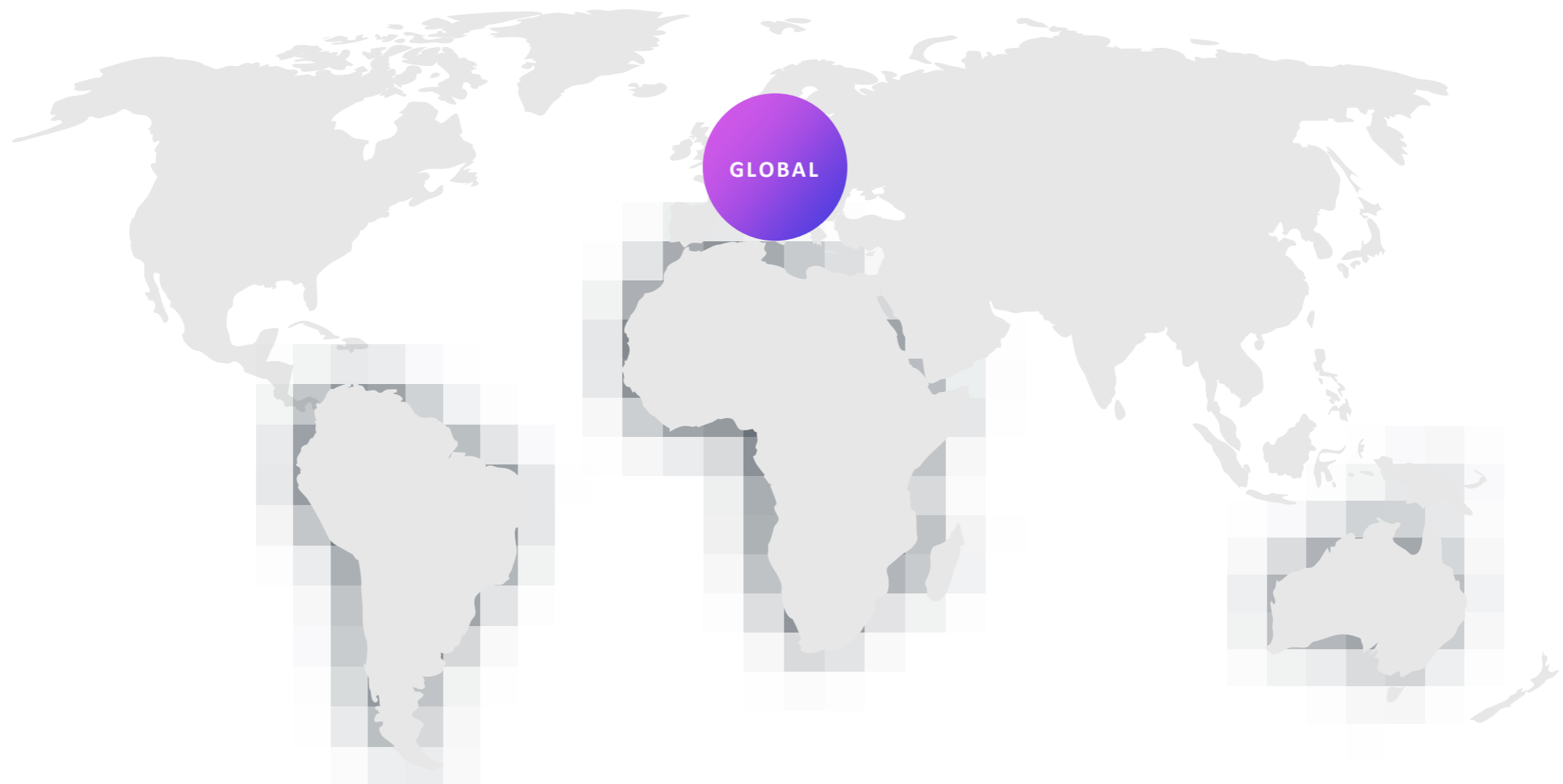
Riot Rewards Top 100 Token Holders

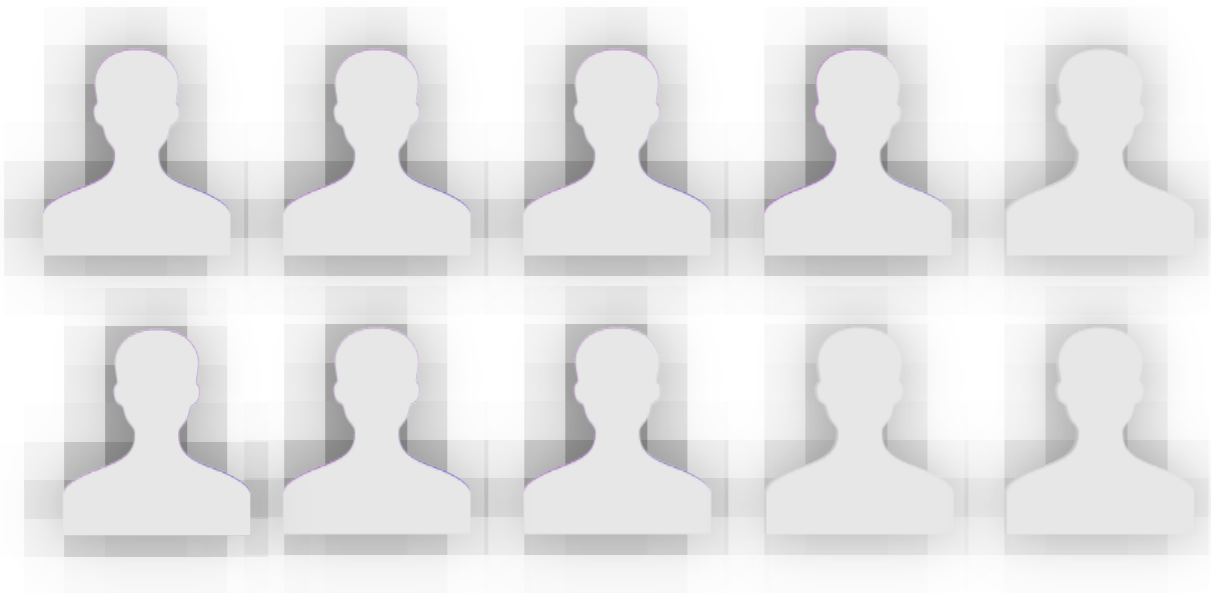

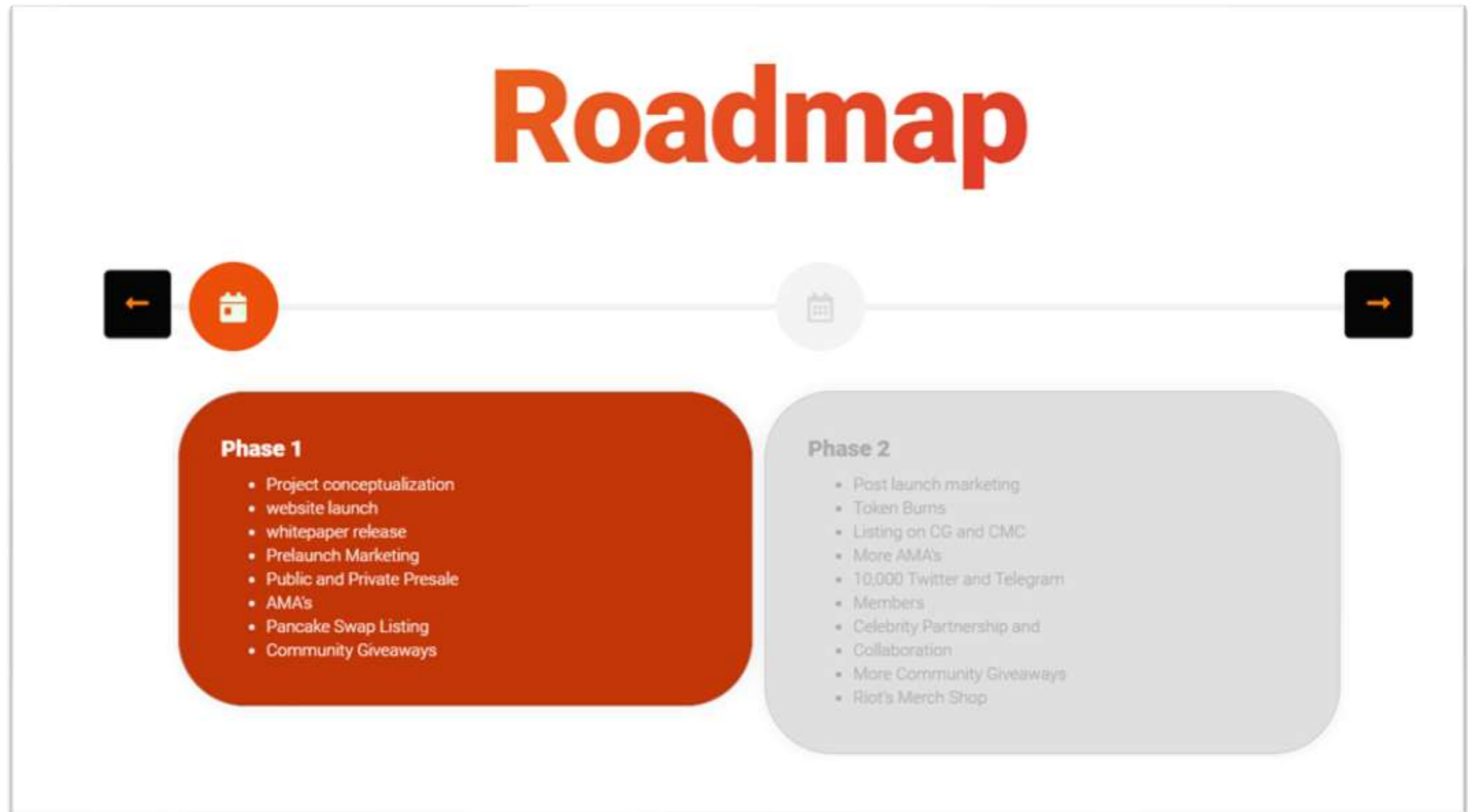
