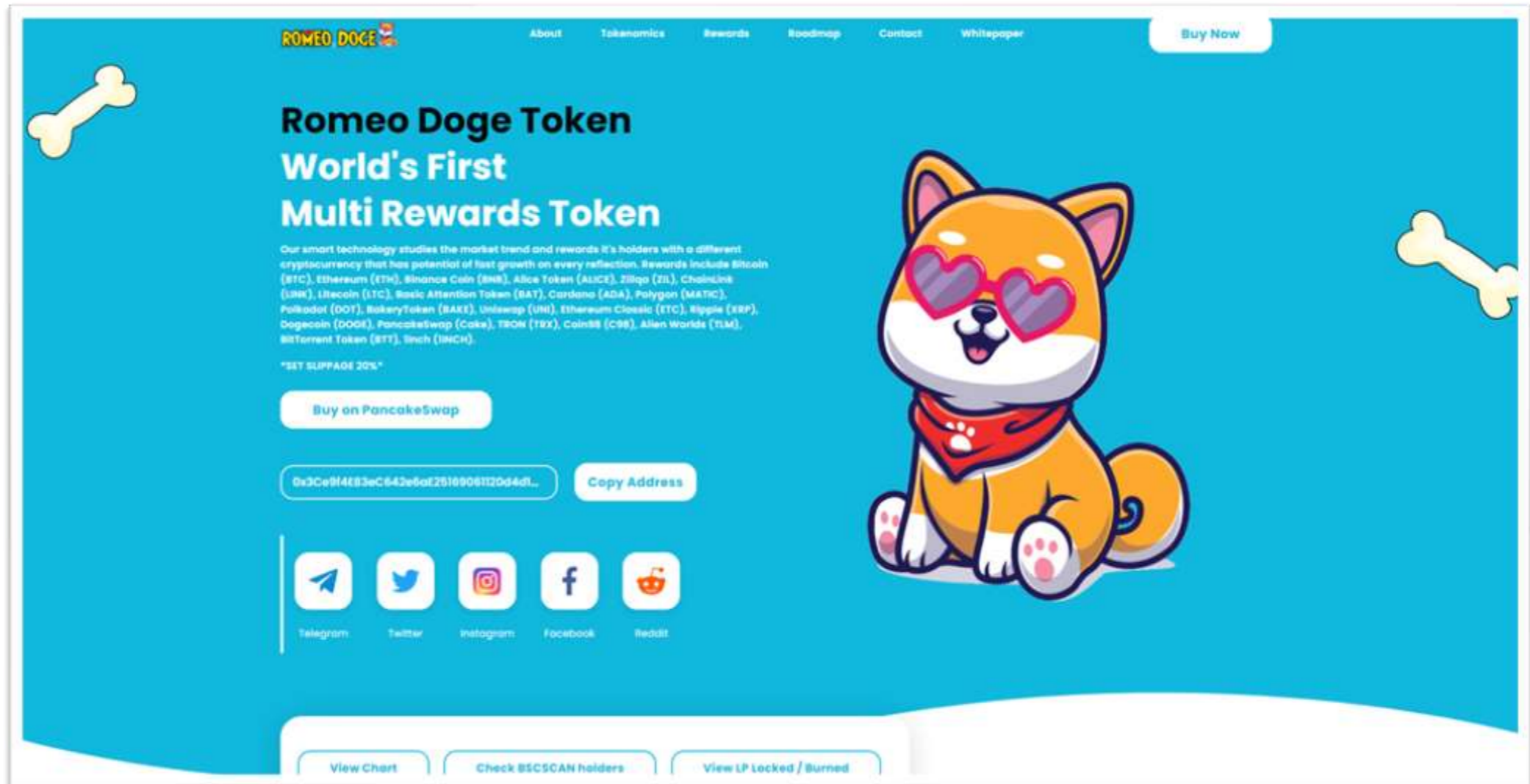

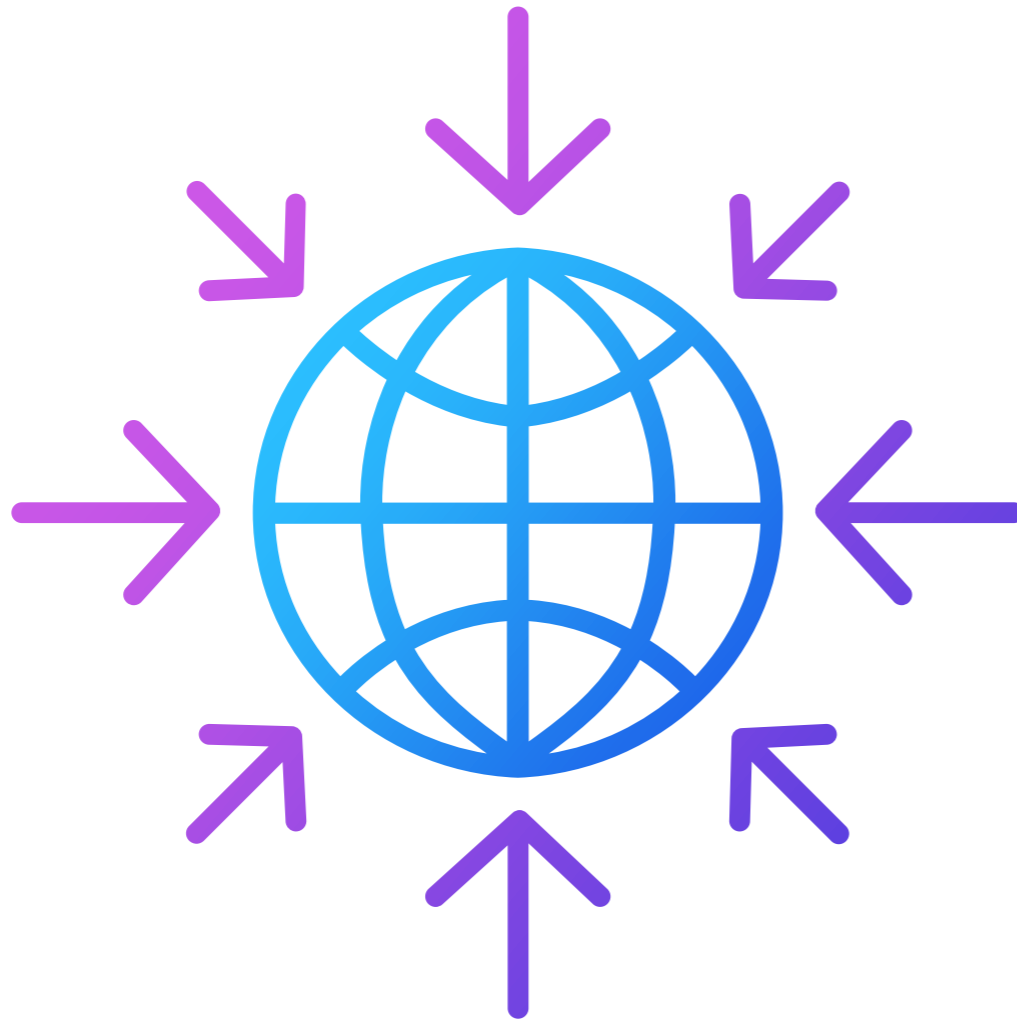

No additional issues were found on the website.

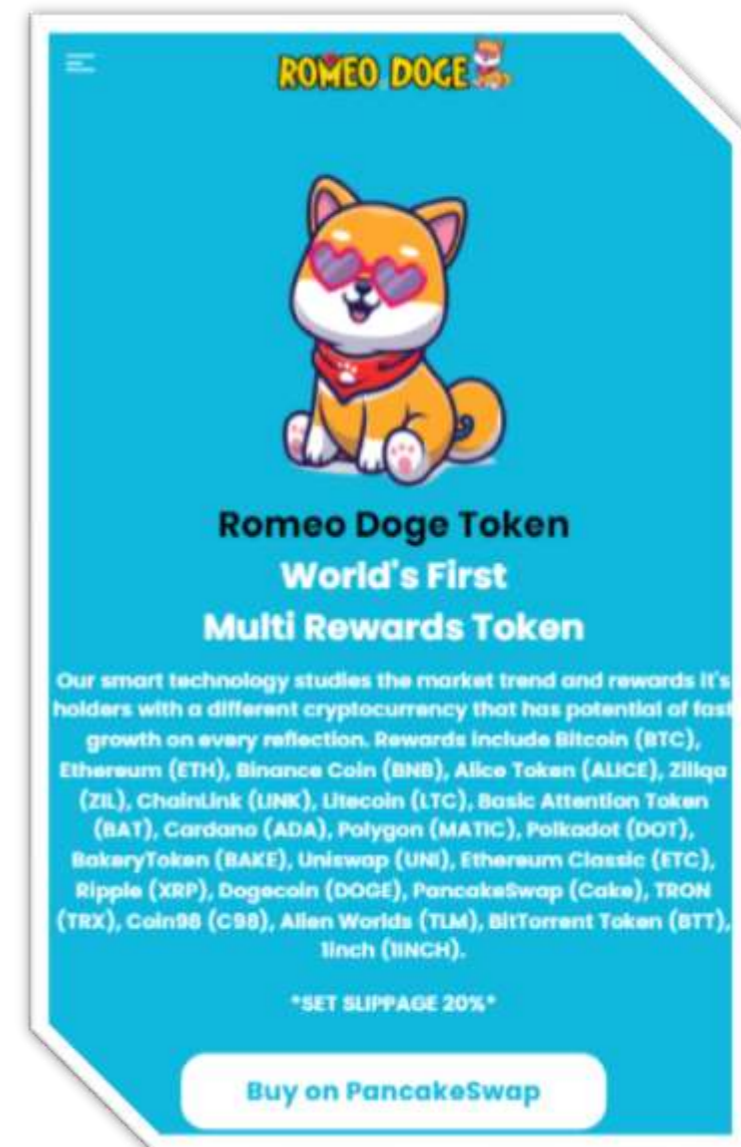
Website Part 3 – Responsive HTML5 & CSS3

Social and Web – Final Thoughts & Suggestions for Improvement

We were able to track down multiple social media channels for the project. Social Media channels included Twitter, Telegram, Reddit, Facebook and Instagram. All social media channels had a healthy amount of activity.

Please note the transaction fees are not clear on the website but we were able to find all transaction fees in the whitepaper. There is an 18% tax on EVERY buy transaction and a 21% on every sell transaction. 10% goes to reward token holders on all buys and 11% on sells, 5% is to be used for marketing on buys and 6% on sells, 3% goes to liquidity on buys and 4% on sells.

It is important to note that although 20% slippage is recommended by Romeo Doge we suggest setting slippage to 21% or higher on all sell transactions to ensure they properly execute

Dessert Finance appreciates projects that self identify as meme coins without the need to solve a greater purpose as long as it is clearly stated as in the case with Romeo Doge.

Suggestions for Improvement

1. Fix JavaScript errors on website ✓ *Fixed*
2. Update Tokenomics section to reflect all fees
3. Update Slippage recommendation on website to cover sell fees.



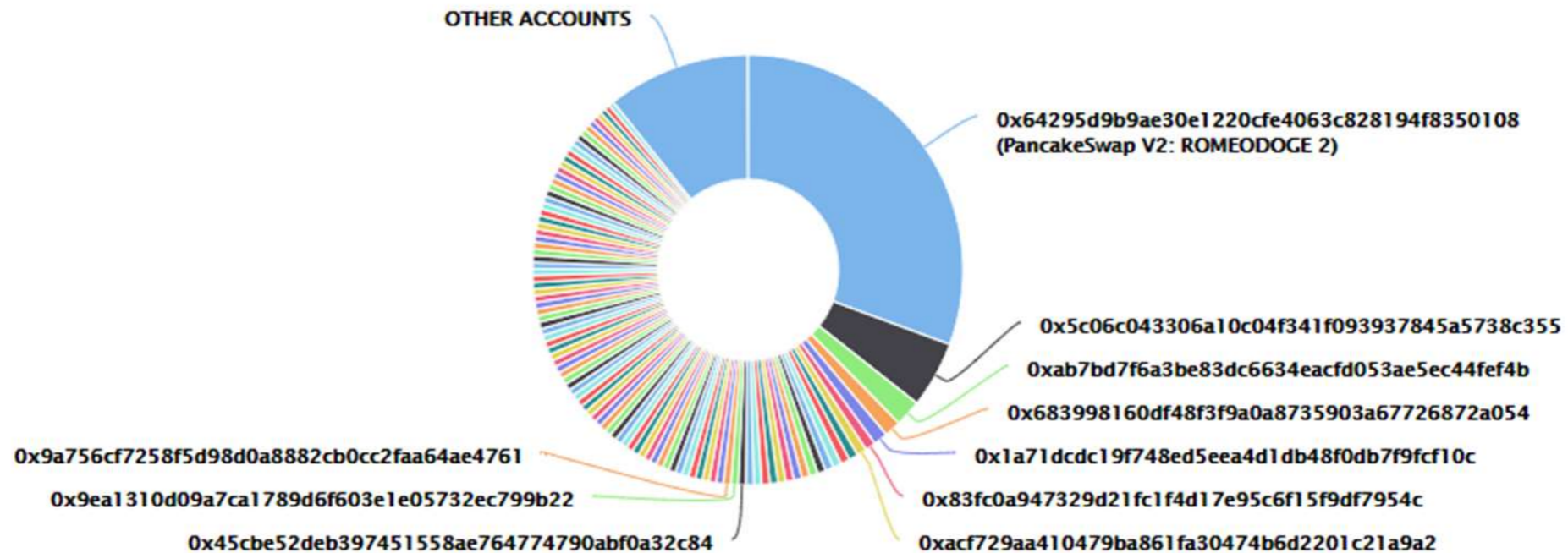

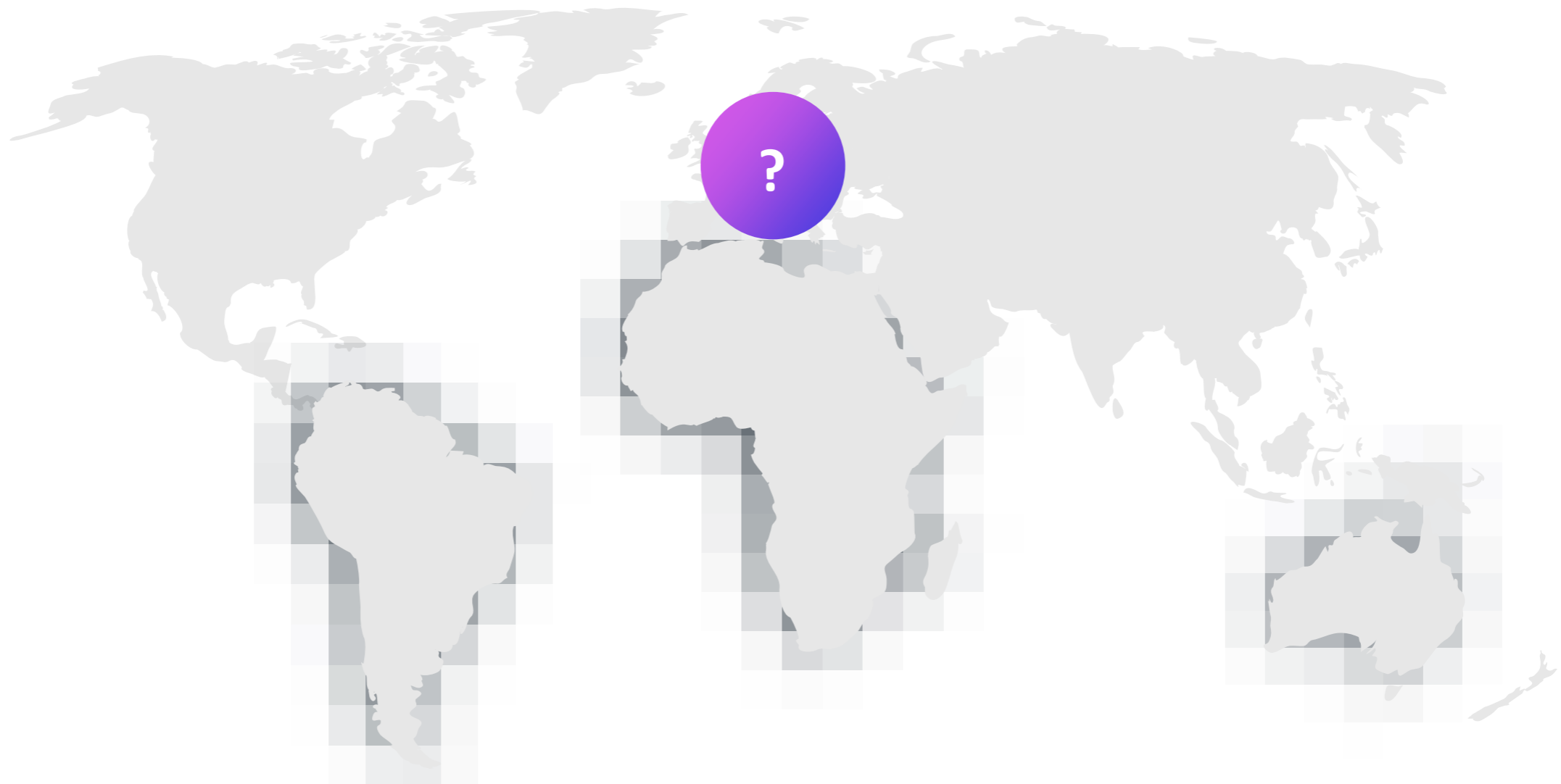

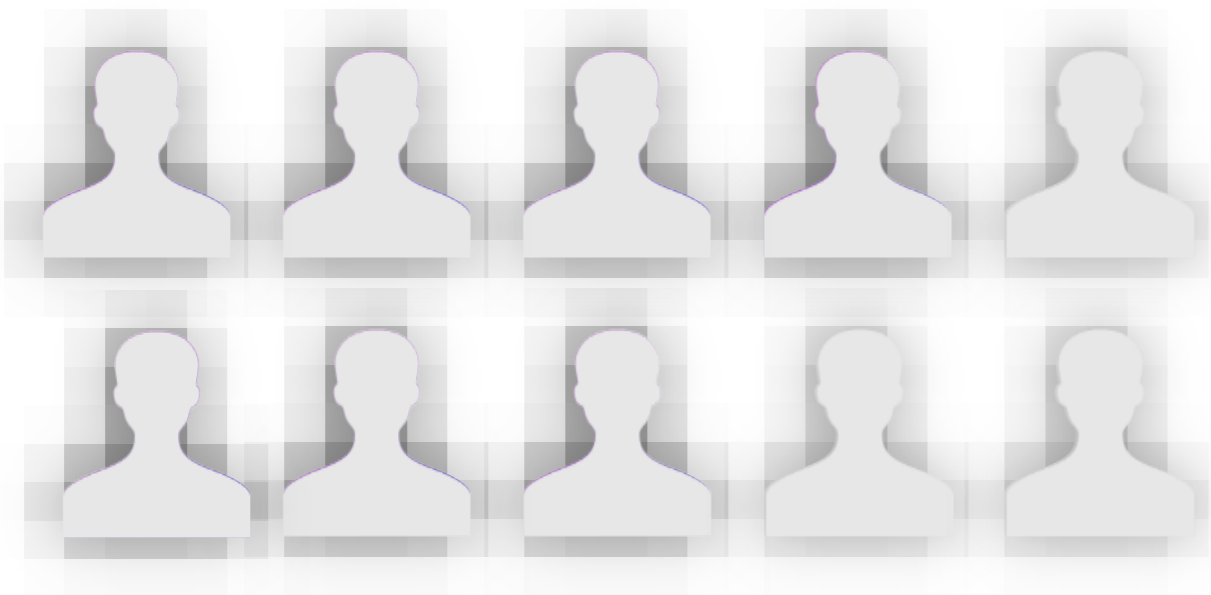
