# Social and Web – Final Thoughts & Suggestions for Improvement

We were able to track down multiple social media channels for the project. Social Media channels included Twitter, Telegram, Discord, Reddit and Twitch. All social media channels had a healthy amount of activity.

It is important to note that there is a 10% tax on EVERY transaction including buys and sells. 5% goes to providing liquidity, and 5% is distributed to the token holders.

Steam Exchange approached Dessert Finance to receive a contract audit on their test contract. The team has verified government IDs of all core team members and sent a copy of the Certificate of Incorporation to Dessert Finance to add to this audit report. The team plans to be as transparent as possible with the supporters of the project.

2. Change official subreddit from private to public ✓ *Fixed*

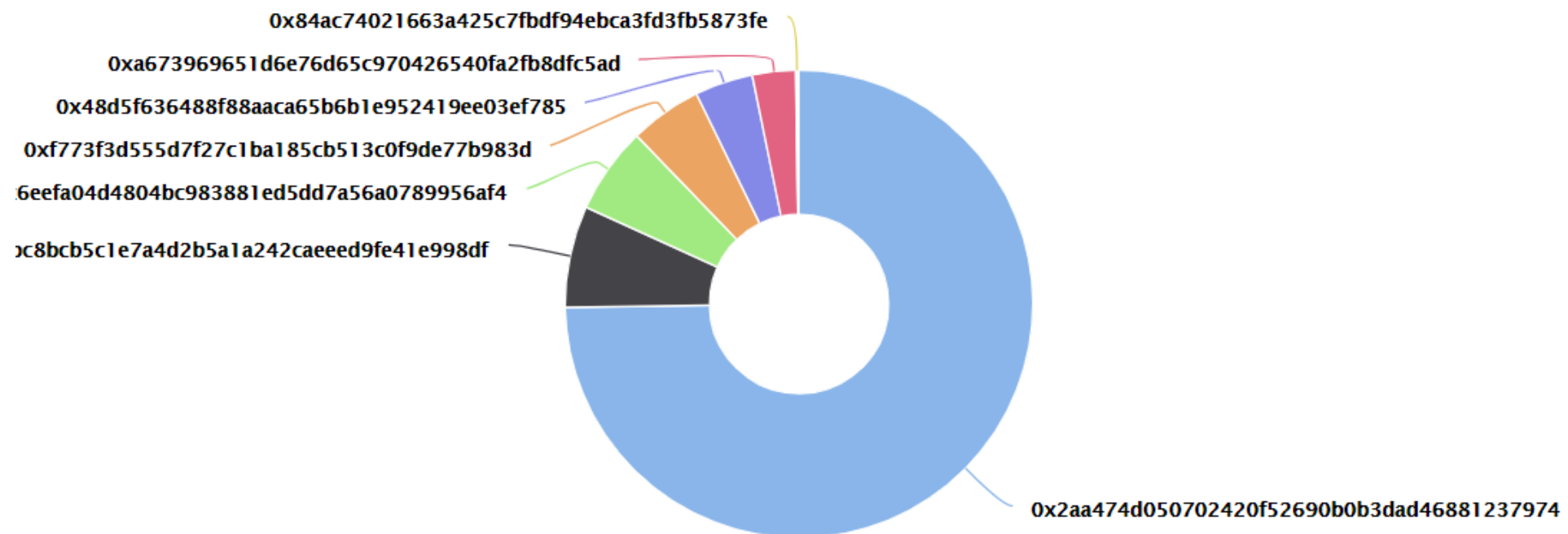

STEAM EXCHANGE Top 100 Token Holders

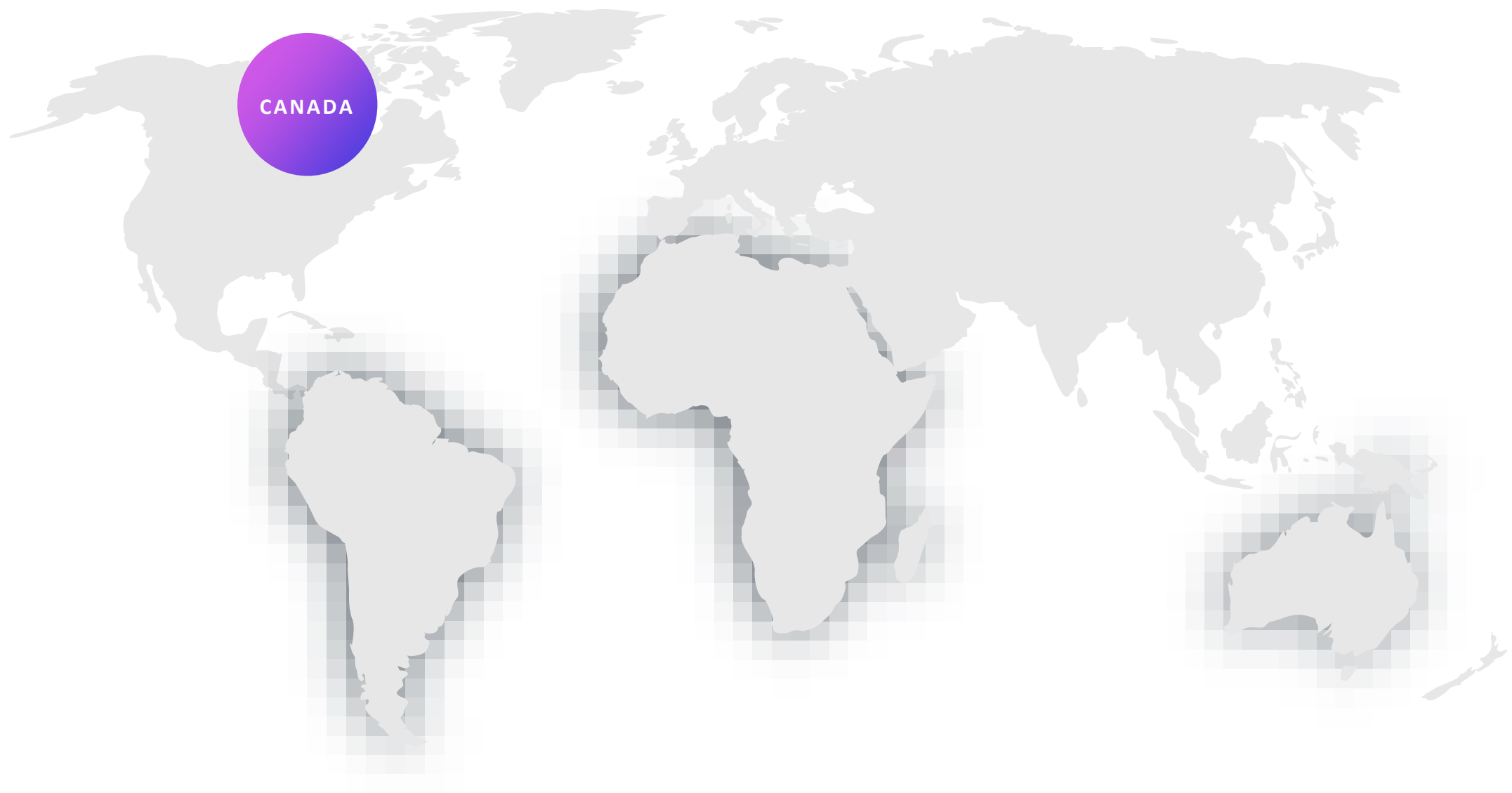
