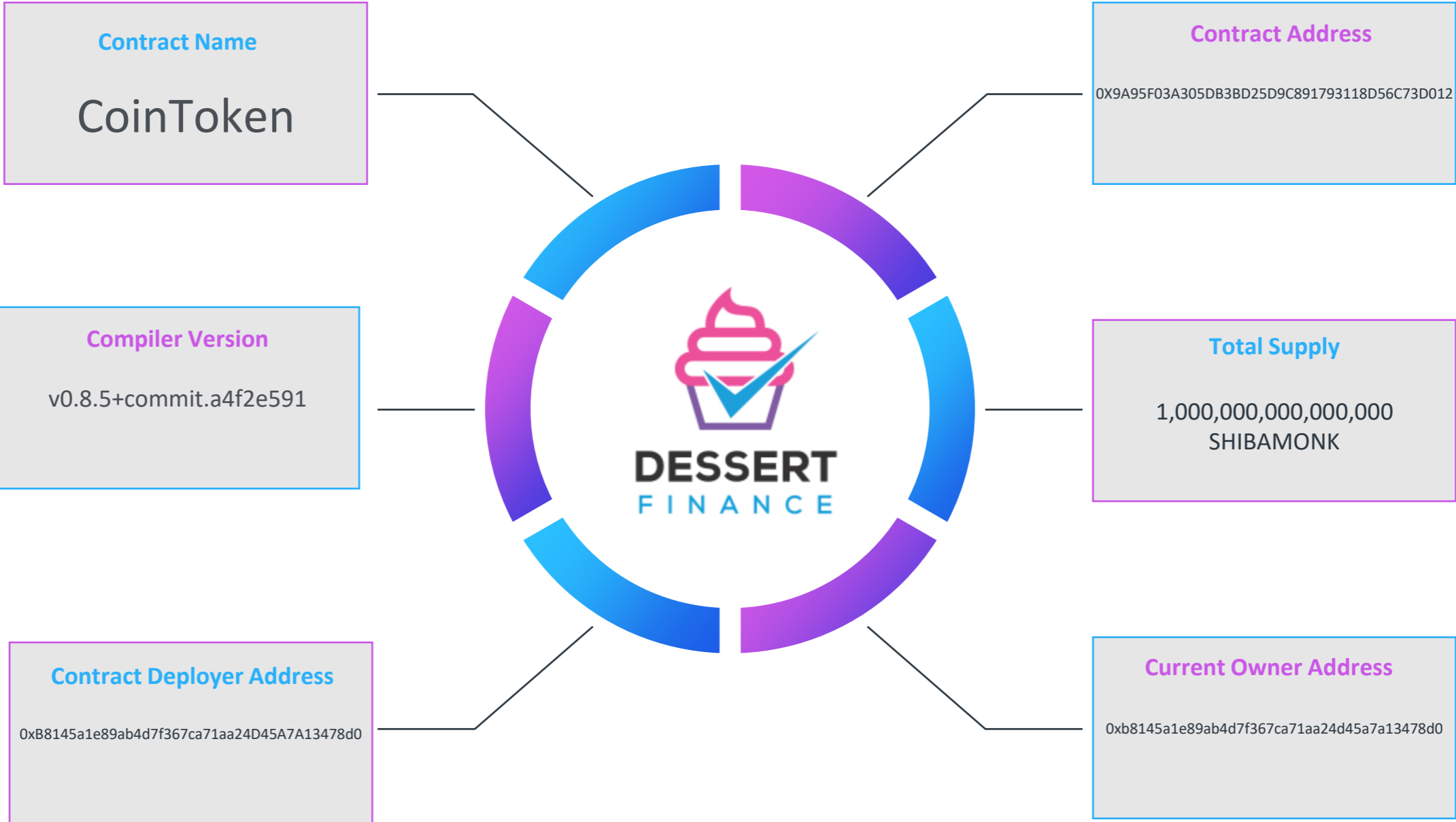

2% of the taxes will be used by our Auto-BuyBacks system to ensure token price keeps rising.

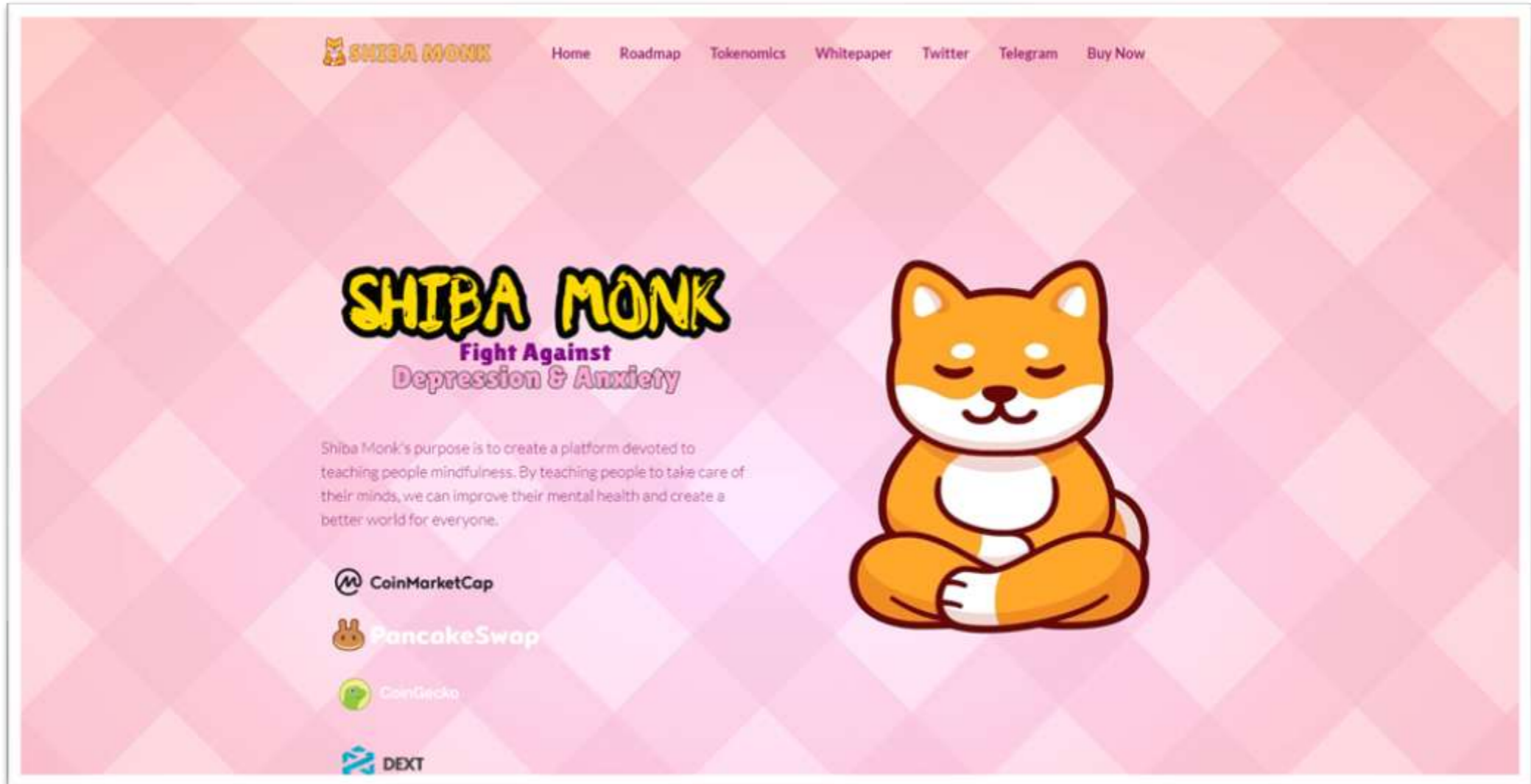


## 2% Auto Liquidity Pool

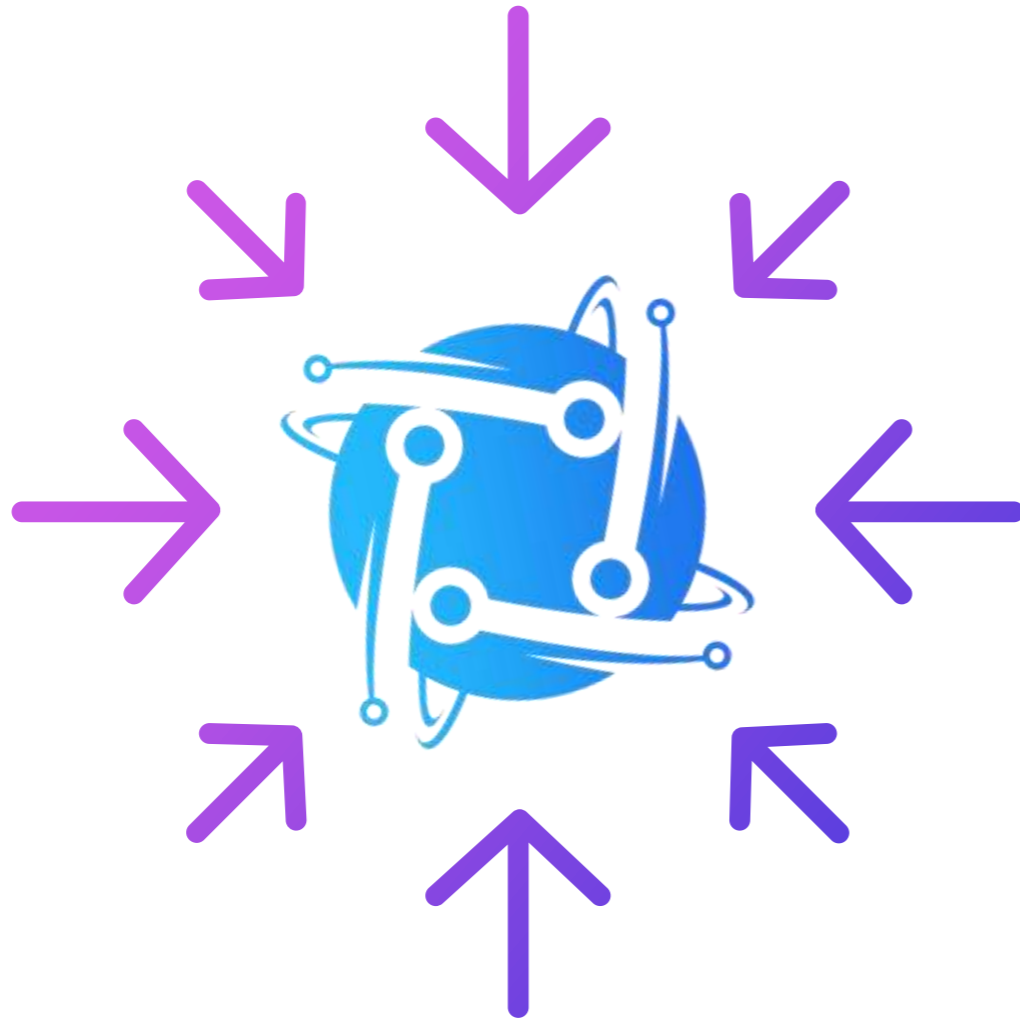

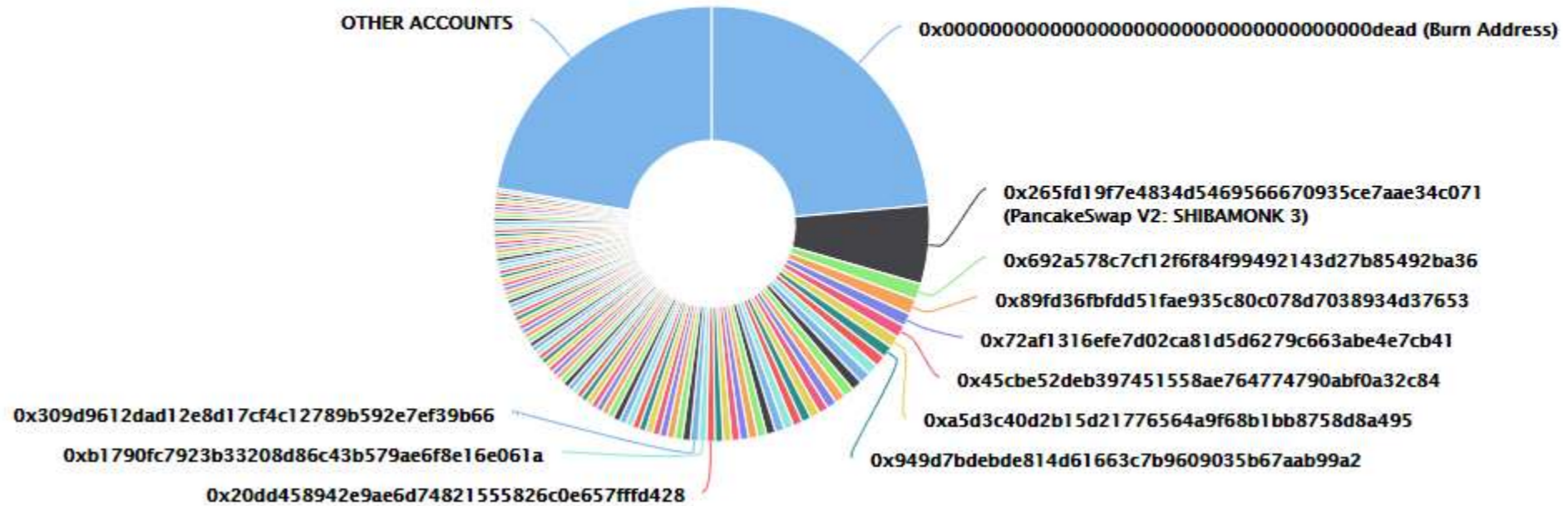
