

Website Preview & Mobile Test




Above images are actual snapshots of the current live website of the project.


The website contained no JavaScript errors, typos, or grammatical errors and we found a valid SSL certificate allowing for access via https.

## Website Part 3 – Responsive HTML5 & CSS3 www.spaceowl.co





#### **Social Media – Final Thoughts & Suggestions for Improvement**

We were able to track down two social media networks (Twitter and Telegram) for SpaceOwl. No official contact email was found on the main website. Overall there is a healthy amount of content on both social media networks and there appears to be a healthy amount of engagement with the devs on Telegram.

The team appears to be very transparent about the initial supply, 4% transaction tax which consists of 2% distribution to token holders and 2% added to liquidity.


#### **Suggestions for Improvement**

- 1. Add official contact email on homepage and to the Twitter bio. **/Fixed**
- 2. Consider lengthening Twitter bio.
- 3. Consider adding SpaceOwl Facebook page, Medium, or Subreddit.
- 4. Consider adding link to BSCScan for token on homepage for users. *Fixed*



### **Top Token Holders**

At the block number indicated on the cover page of this report, 52% of the supply appears to be burned. The largest holder is the dead wallet of burned tokens.



<u>PancakeSwap: SPOWL</u> – 2.2% of maximum supply is in the Liquidity Pool on PancakeSwap. This makes the liquidity pool the largest holder aside from the dead wallet.

<u>0xcc915ecd15b892c8e4ab919fe985a9ef31d3370c</u> – 2% of the maximum supply was located in the 3<sup>rd</sup> top wallet. The team has confirmed that this is the deployer and dev wallet.






