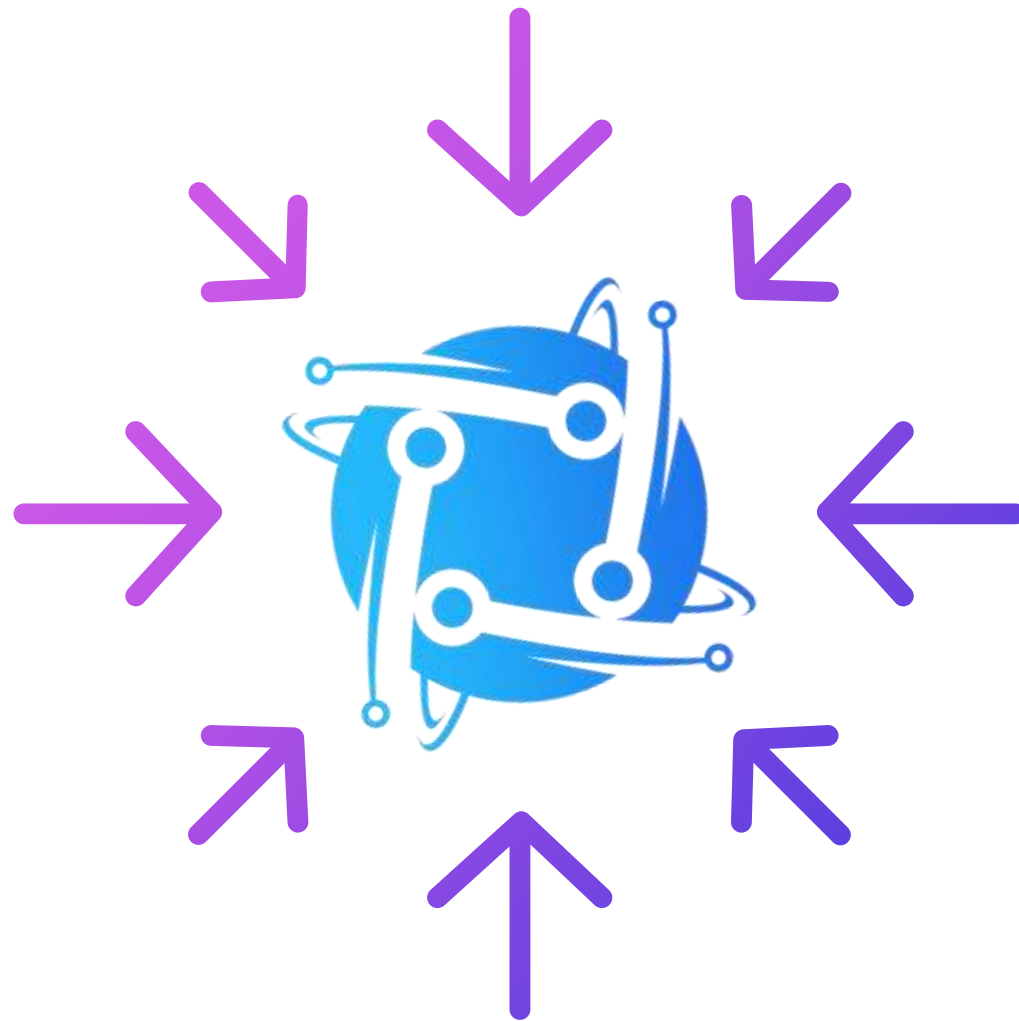

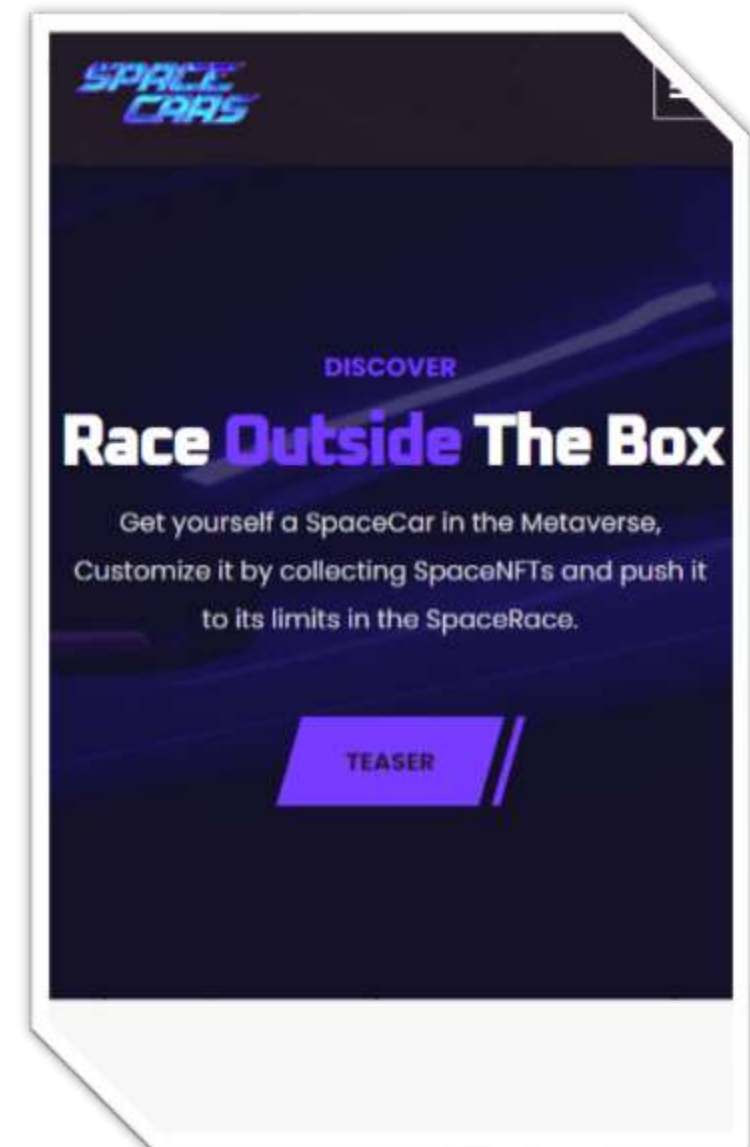
No additional issues were found on the website.

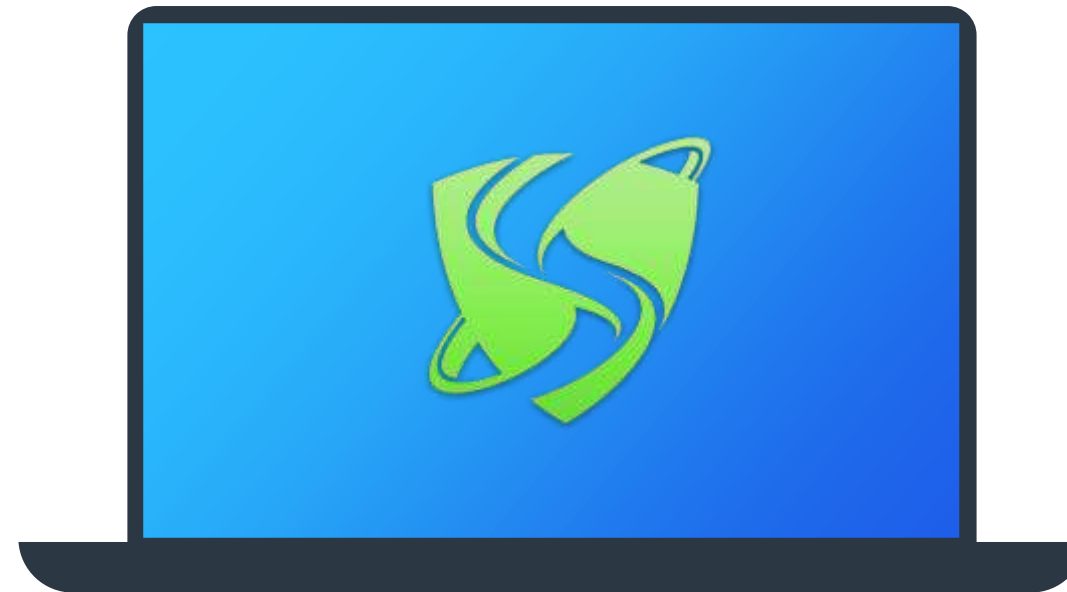

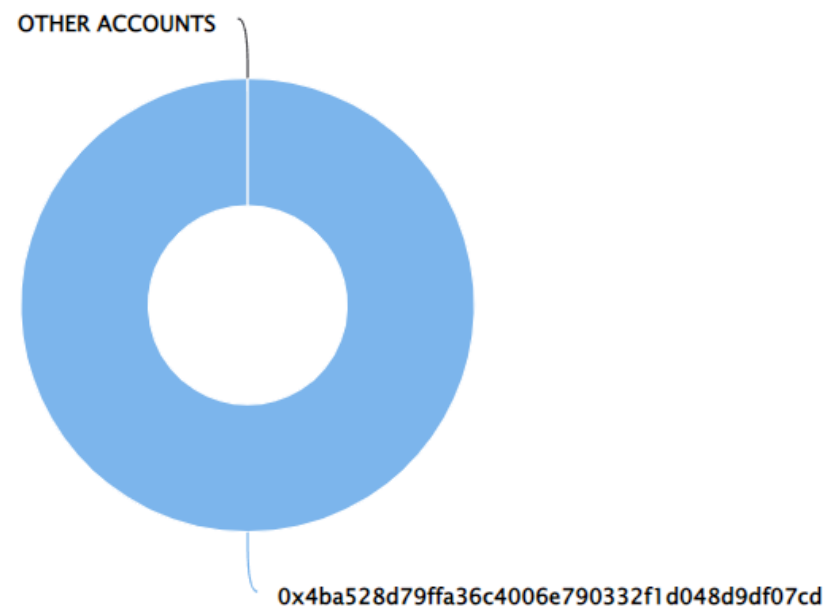

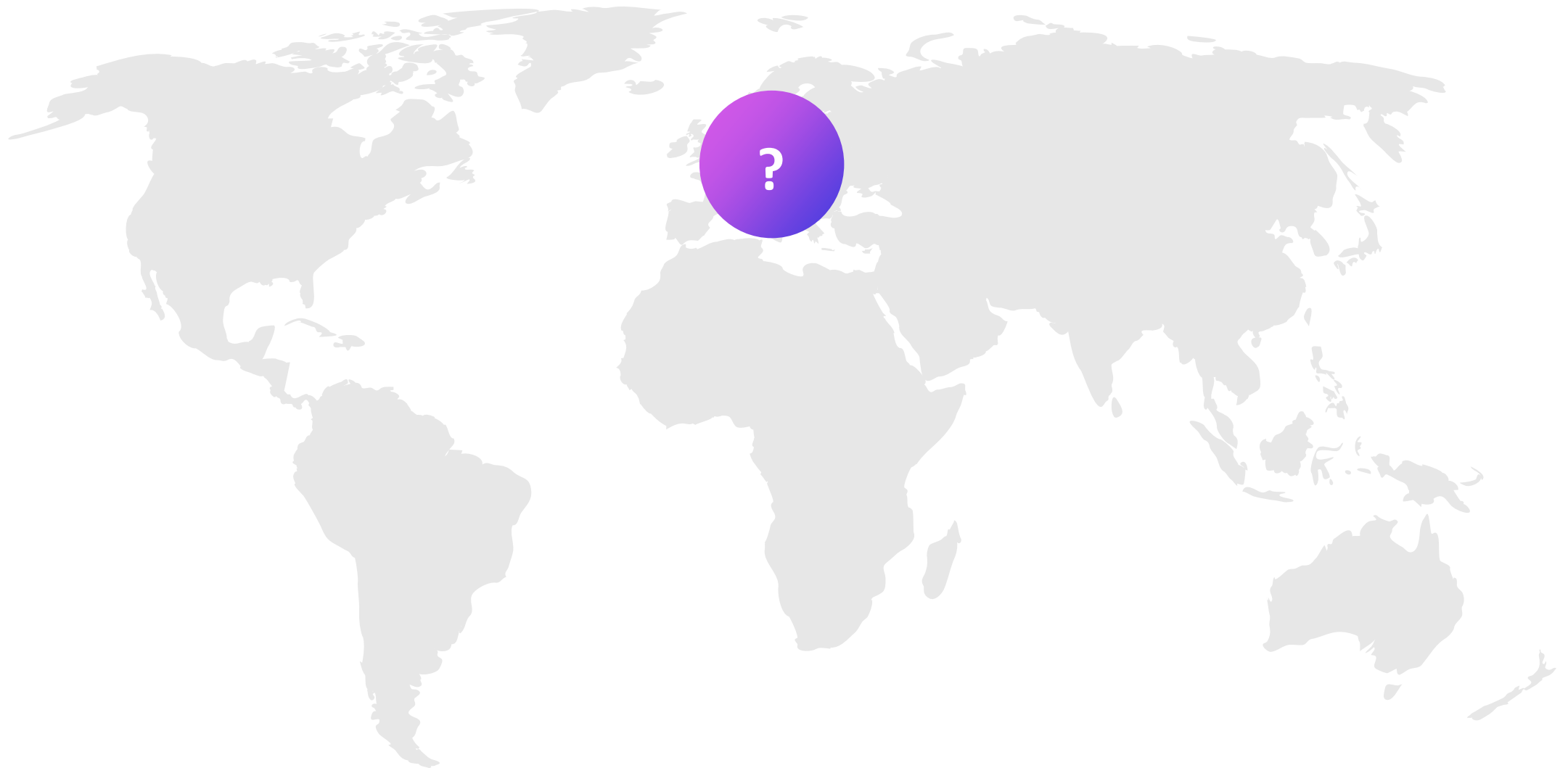
SpaceCars Top 100 Token Holders

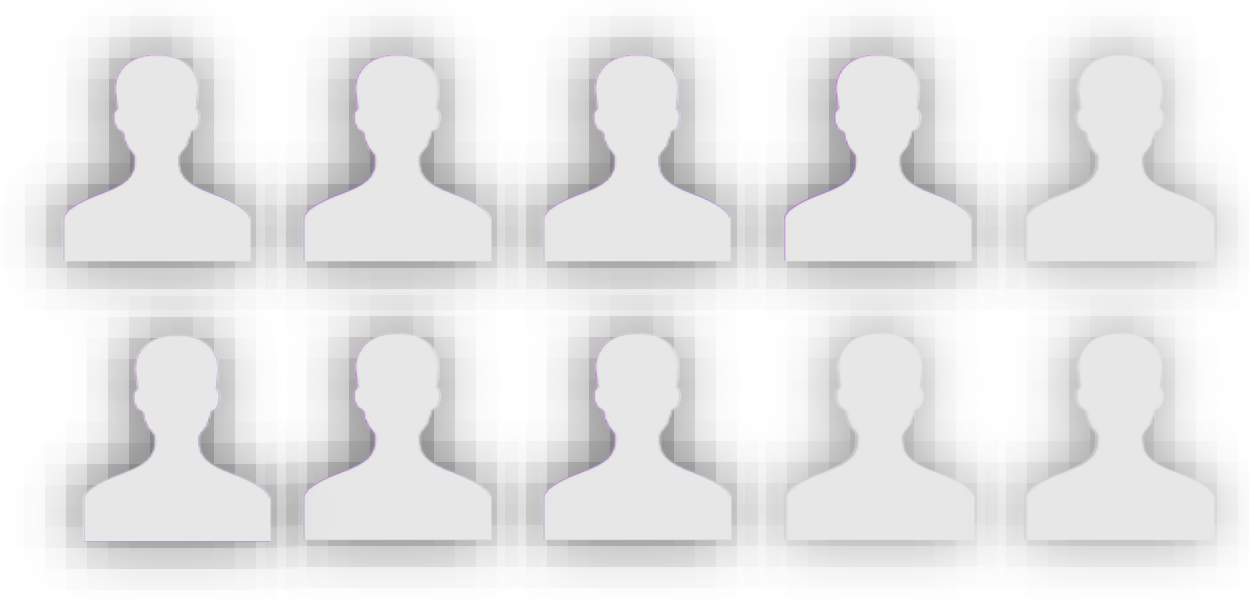
