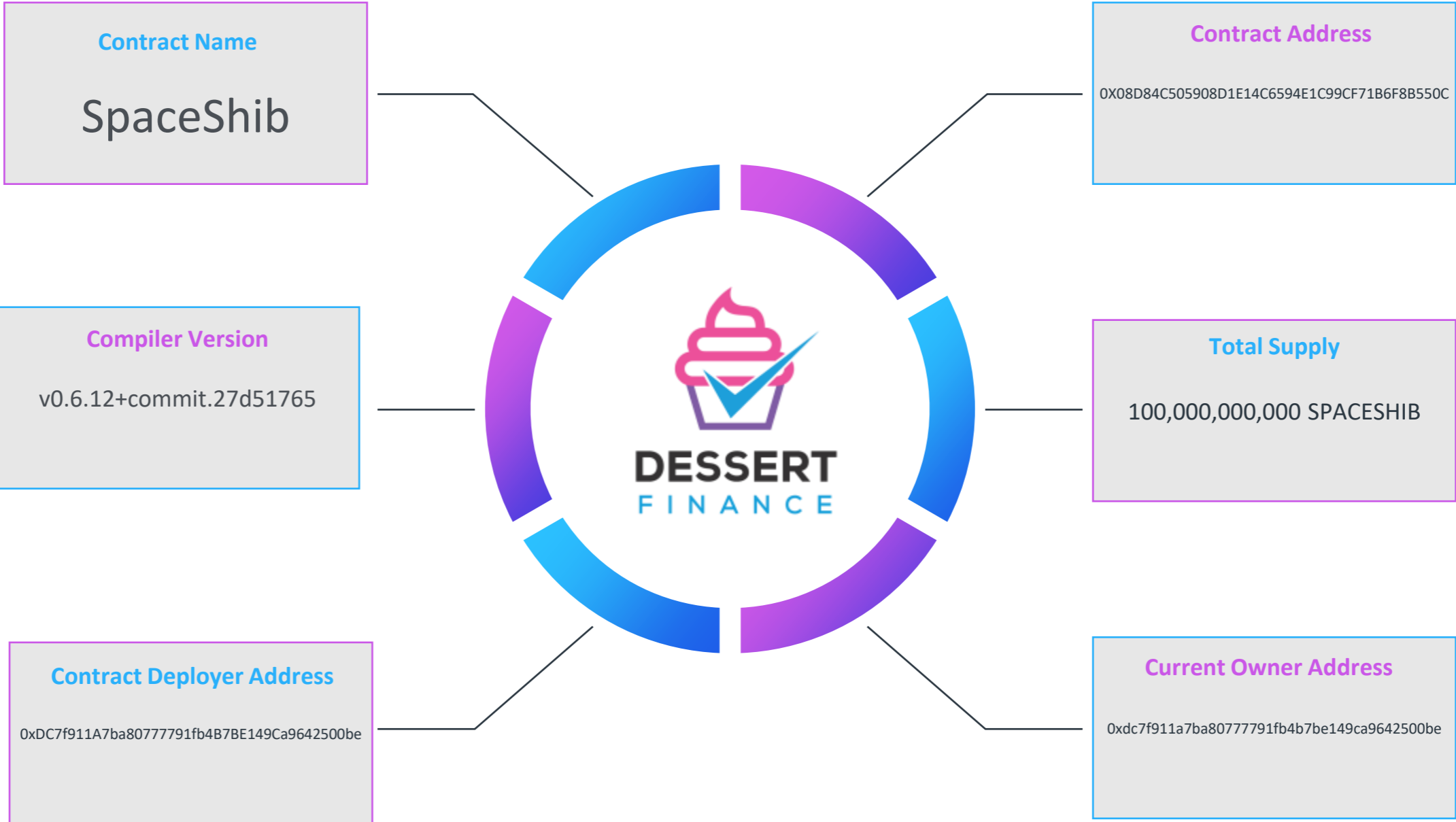

# Contract Transaction Fees

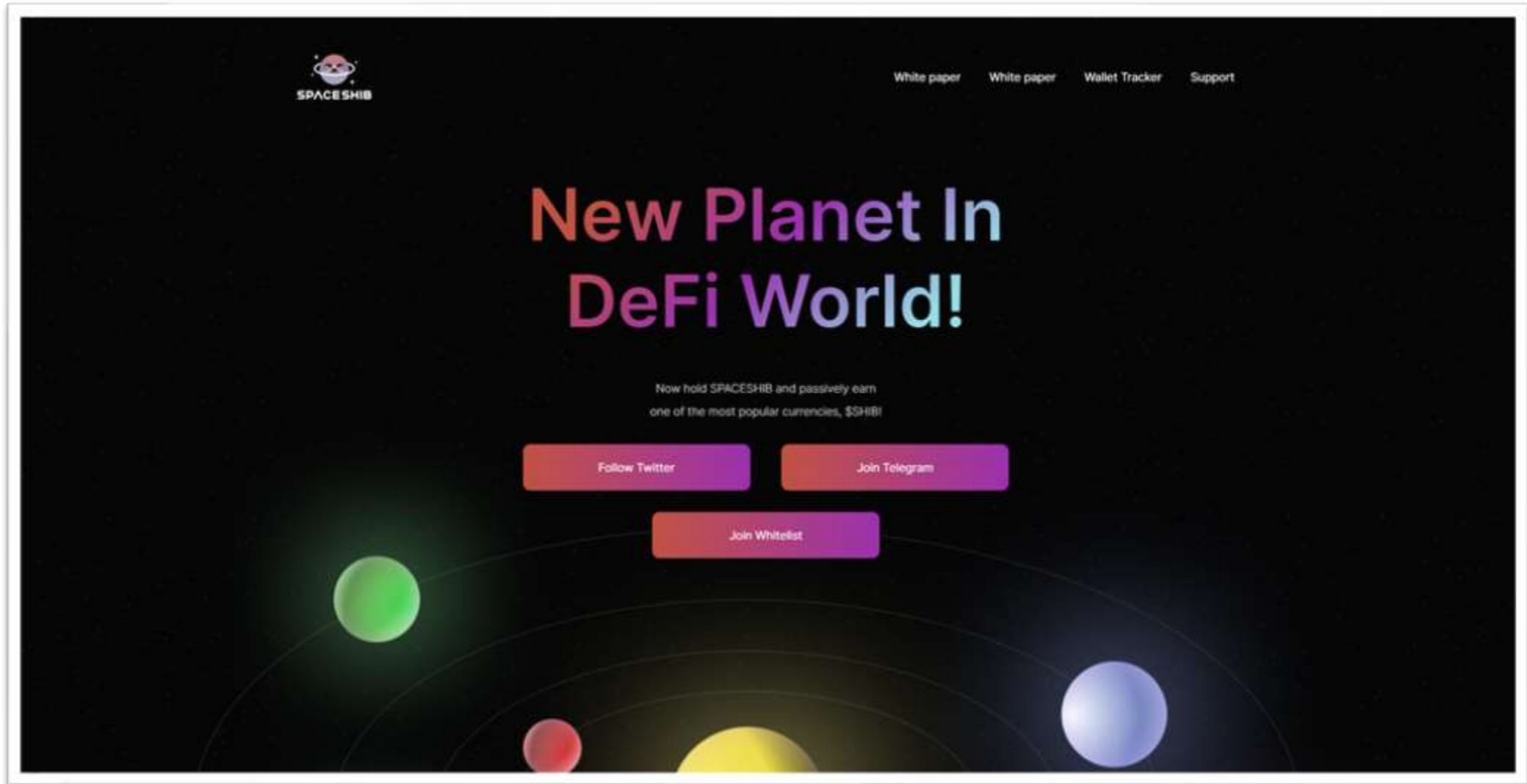
At the time of Audit the transaction fees (“tax”) listed below are the fees associated with trading. These fees are taken from every buy and sell transaction unless otherwise stated.

- 2% Redistribution in SHIB**  
2% of every buy/sell is taken and redistributed to all holders. Hold \$SPACESHIB tokens, earn SHIB. A minimum of 200,000 tokens is required in order to receive rewards.
- Rewards Paid Automatically**  
You don't need to claim your earned SHIB. It's automatically sent to your wallet. Just add the Shiba Inu token (\$SHIB) address to your wallet and you're set.
- Massive Marketing Plan**  
2% of every transaction is allocated to Marketing in SHIB (swapped to SHIB in real-time to avoid dumps). This allows us to fuel our most ambitious projects in service of further rewarding our community.
- 1% Sell Fee**  
An extra 1% fee is applied to all sells. This will allow us to reduce swing-trading and break whales' control.
- Secured By PinkLock**  
Initial Liquidity Provided is locked with PinkLock for more than 100 days. Fully Audited by Dessert Finance.
- 2% Auto Liquidity Pool**  
2% of every transaction is converted into liquidity for Pancakeswap. It's automatic and helps create a price floor (stability).

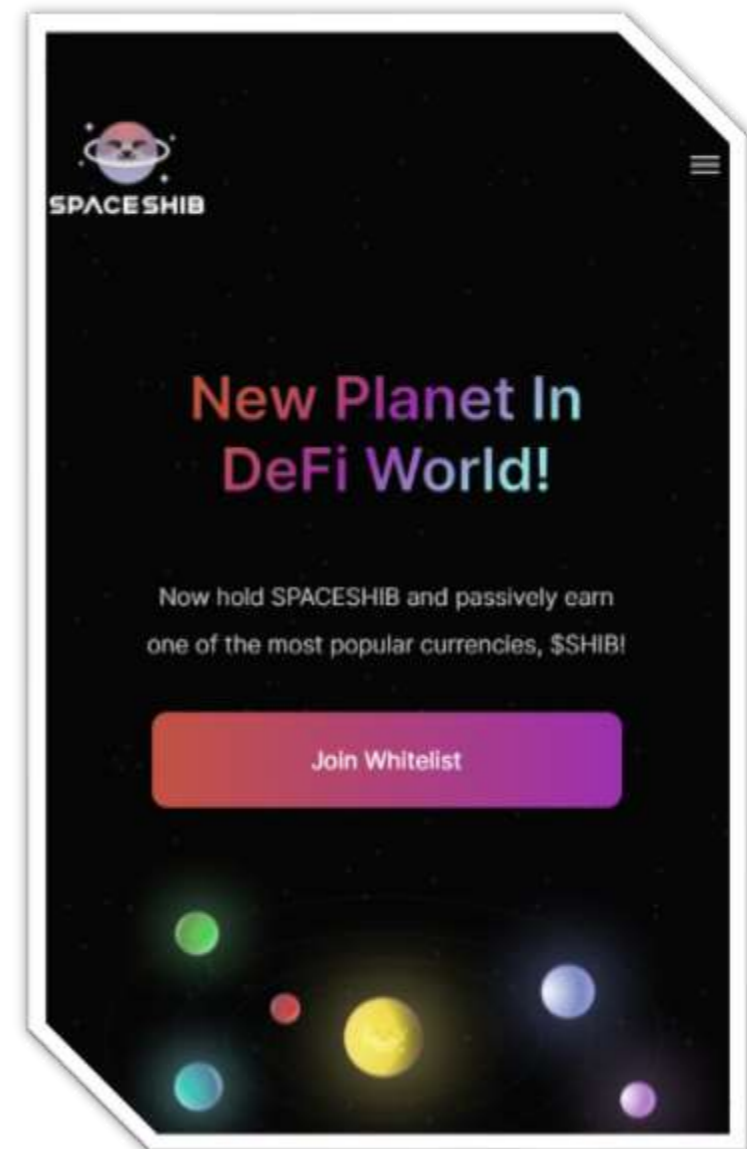
The website contained no JavaScript errors. No typos, or grammatical errors were present, and we found a valid SSL certificate allowing for access via https.
