
The contract code is **verified** on BSCScan.

We were able to locate a variety of Social Media networks for the project including Twitter, Telegram, Reddit, Instagram and Medium. All links have been conveniently placed below.




At least 3 social media networks were found.

There are 12% fees on all buys and 15% transaction fees on all sells. Kraken fees are to be used for buybacks & burns. Transaction fees are as follows:






