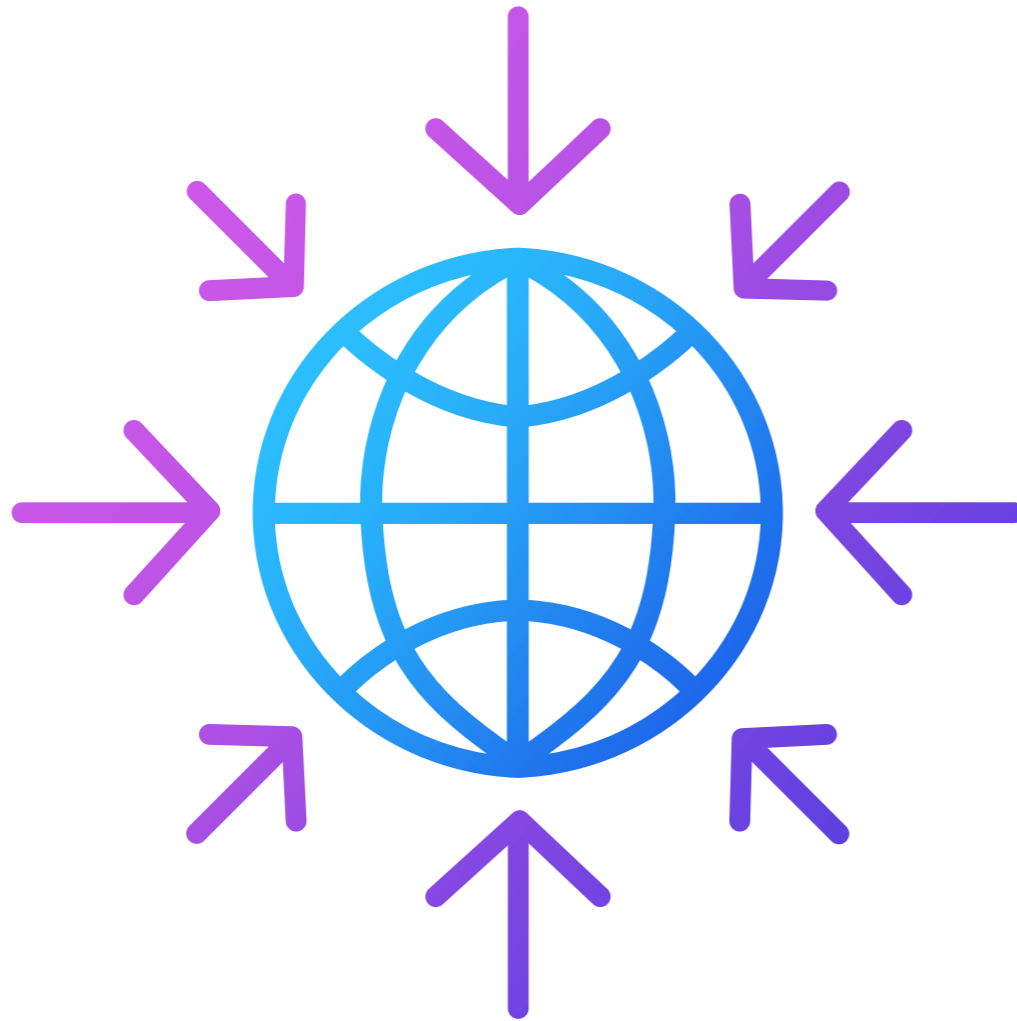

Social and Web – Final Thoughts & Suggestions for Improvement

We were able to track down multiple social media channels for the project. Social Media channels included Twitter, Telegram, Reddit, Instagram, and YouTube. All social media channels had a healthy amount of activity.

The only issue we found in the social media was that the Reddit link led to an empty profile. We would like to see this fixed. ✓ *Resolved*

It is important to note that there is an 10% tax on EVERY transaction including buys and sells. 3% goes to providing liquidity, 4% is distributed to the token holders and 3% is sent back to the team for Marketing purposes.

It is important that meme tokens identify themselves as such and we are happy to see that USA President Doge has taken the time to make sure it is extremely clear that they are a meme coin.

Suggestions for Improvement

1. The reddit profile was completely empty. ✓ *Resolved*



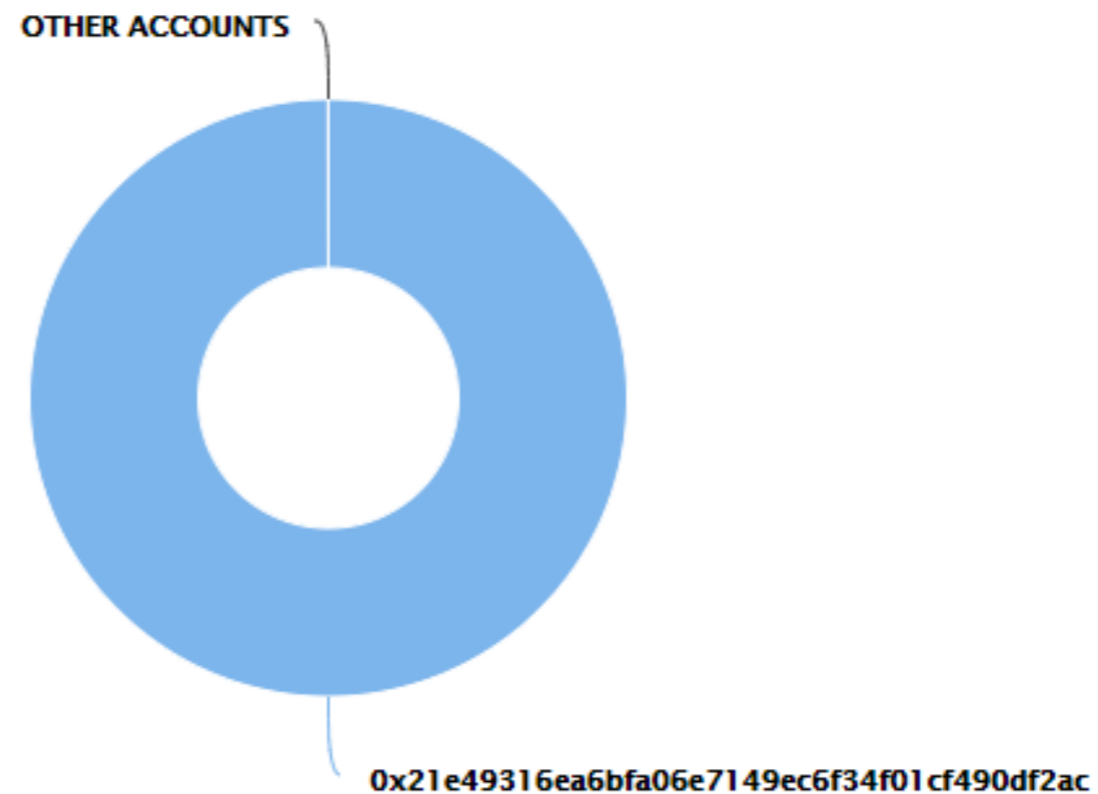

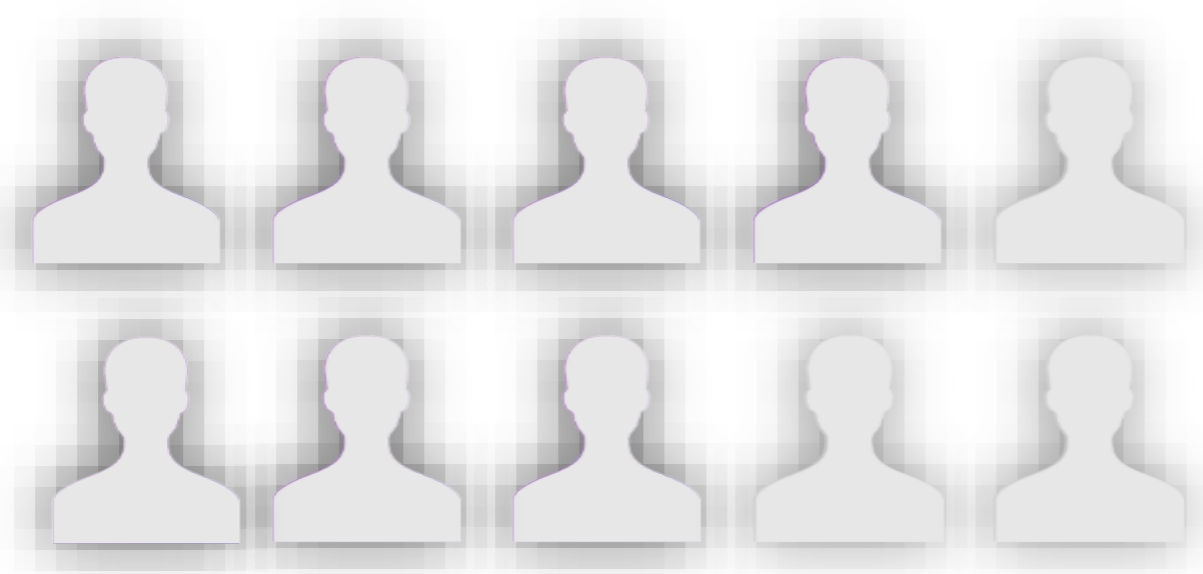
