A mint function was found within the contract.

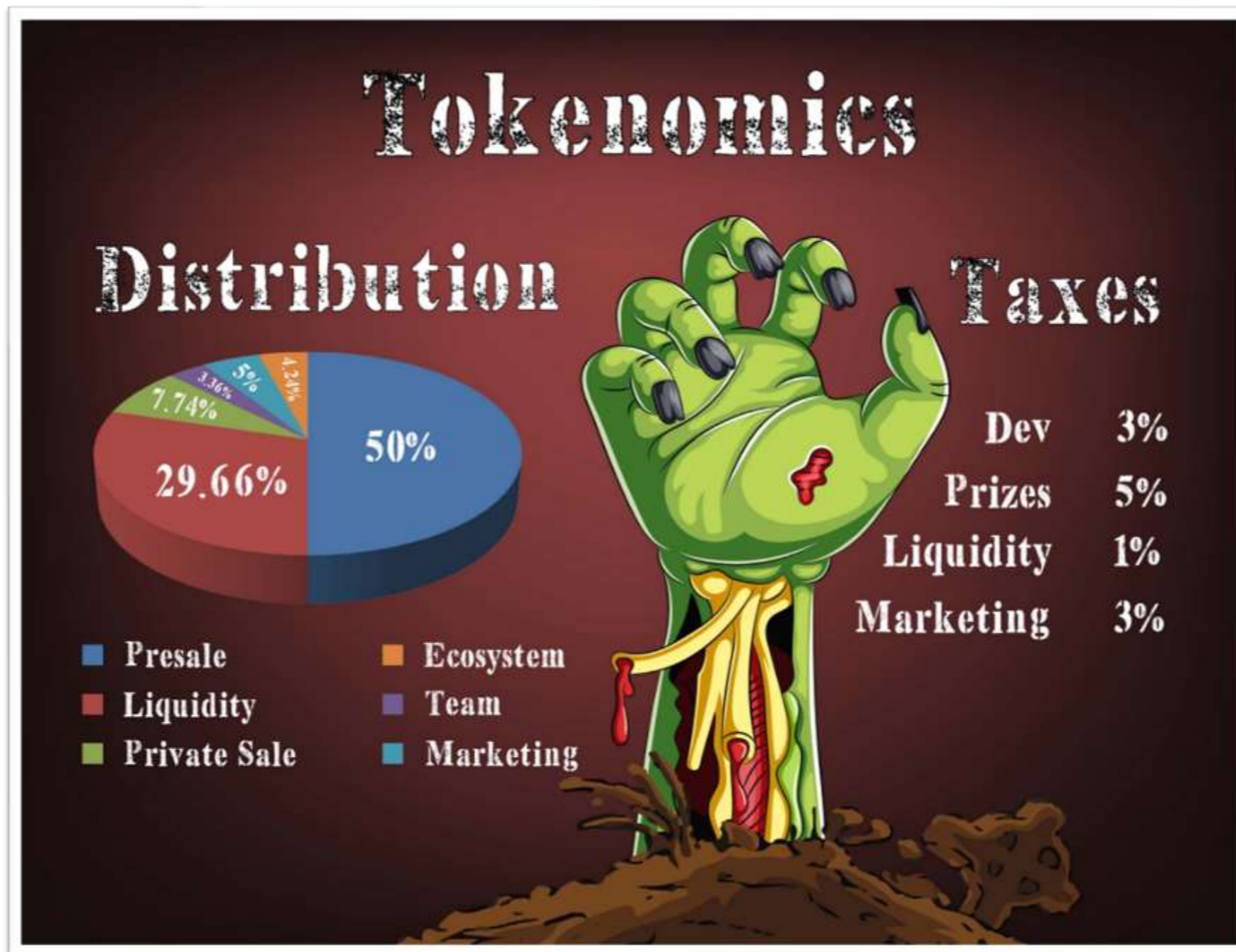


We do understand that sometimes mint functions are essential to the functionality of the project.

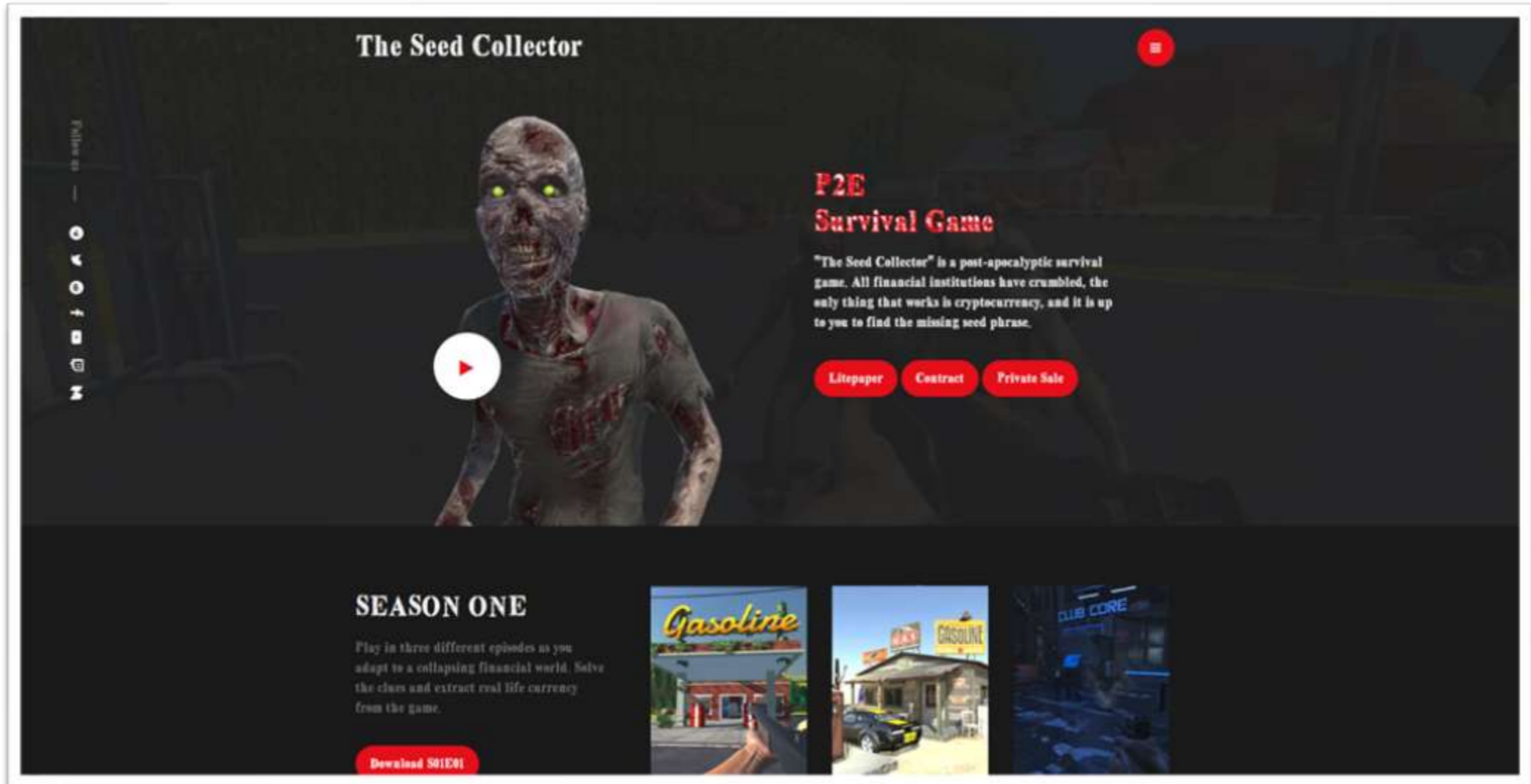

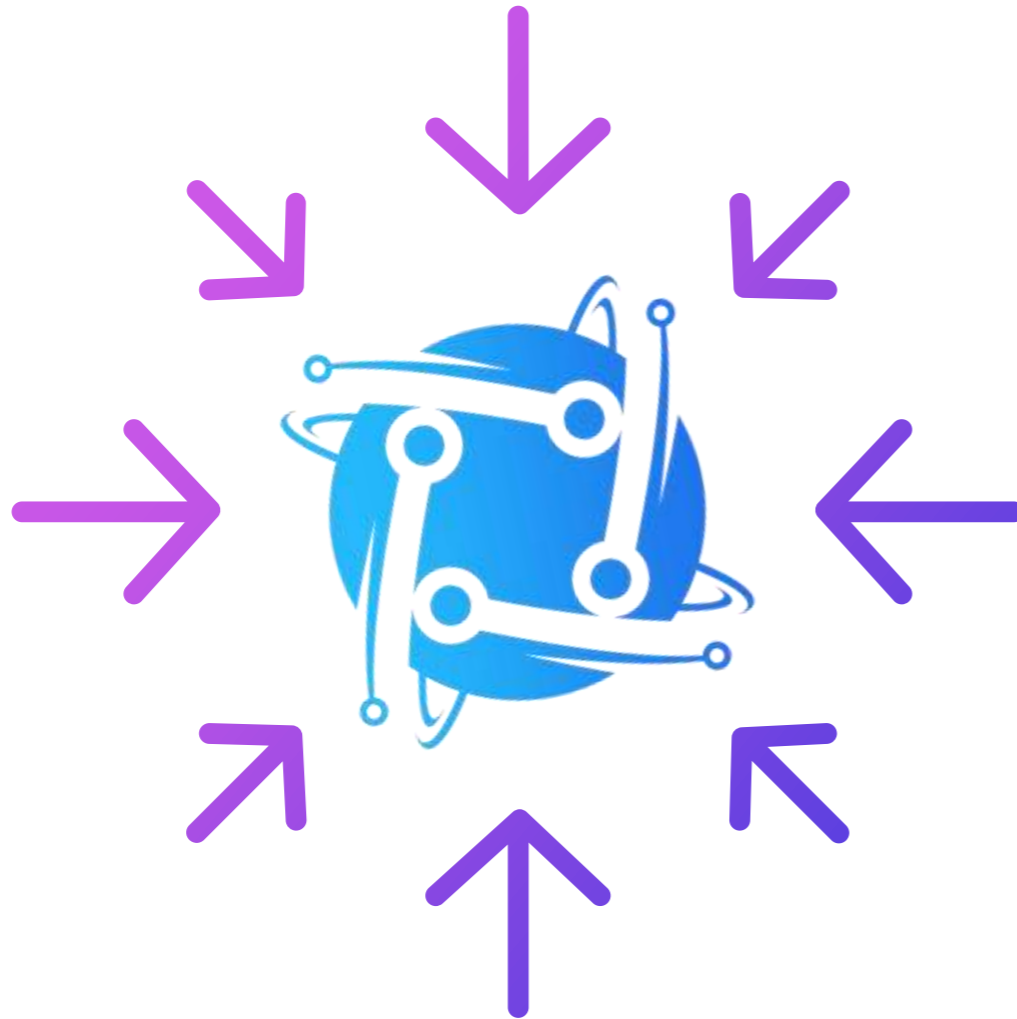
